JUDGMENT

NIAZ MUHAMMAD KHAN, CHAIRMAN: - Arguments of the learned
counsel for the parties heard and record perused.

FACTS

2. The appellant was aggrieved from his transfer order dated 31.05.2013 whereby he was transferred from GMS Sarahdna to GMS Sumbal Mohri. Against this impugned order he filed departmental appeal on 03.06.2013 which was not responded to and then the appellant filed the present service appeal on 29.10.2013.

ARGUMENTS

3. The learned counsel for the appellant argued that the normal tenure of posting is two years in settled areas and one year in hard areas. That the appellant was transferred before the completion of his normal tenure. That even prior to the impugned order he was transferred before completion of his normal tenure.

4. On the other hand the learned counsel for private respondent No. 5 argued that under Section 10 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 as interpreted by the august Supreme Court of Pakistan reported as 2017-SCMR-798 a civil servant is liable to be posted anywhere and he could not seek for his choice posting. He further argued that respondent No. 5 had already served for four years in GMS Sarhadna before Sumbal Mohri.


5. The learned Deputy District Attorney endorsed the arguments of the learned counsel for private respondent No. 5.


CONCLUSION.

6. Section 10 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 only makes a civil servant liable to serve anywhere but never gives unbridled powers to executive to order transfers. Powers under the law is impliedly limited to its judicious exercise. The Government has issued instructions to executive that how the power under Section 10 are to be exercised. These instructions are shaped in the form of a posting/transfer policy. The judgment cited by the learned counsel for the respondent No. 5 also speaks about honoring the tenure for the posting/transfer. Admittedly, the tenure of the appellant was not completed and he was transferred from GMS Sumbal Mohri. Since this transfer took place in the year, 2013 and four and half years have passed and both the appellant and private respondents No. 5 have again completed their tenure after the institution of the present appeal.

7. This Tribunal therefore, accepts this appeal and orders for the retransfers of appellant and respondent No. 5 to their place of postings prior to the impugned order.

Parties are left to bear their own costs. File be consigned to the record room.

SERVICE APPEAL UNDER THE KPK SERVICE TRIBUNAL ACT AGAINST THE TRANSFER ORDER DATED 31.05.2013 COMMUNICATED THE APPELLANT VIDE OFFICE ORDER NO. 5709-11 WHEREBY THE APPELLANT IS TRANSFERRED WITHOUT COMPLETING HIS NORMAL TENURE WAS IMPOSED UPON THE APPELLANT.

PRAYER: *On acceptance of this service appeal, the impugned order dated 31.05.2013 with regard to the transfer of appellant without completing his tenure may graciously be set aside and appellant may kindly be posted at least serving place.*

The brief facts arise in the instant service appeal are following:-

1. That the Appellant was appointed as Drawing Master on 13.05.1993 and Appellant took the charge on 17.05.1993. Copy of which is attached as **Annexure "A"**
2. That the Appellant was transferred from GHS Kariplian to GHS Rehana on 31.03.1999. Copy of order is annexed as **Annexure "B"**.

3. That the Appellant was transferred on 28.06.2003 from GHS Rehana to GHS Noordi, and the Appellant took charge on 01.07.2003 and performed his duties at Noordi upto 01.08.2004. Copies are attached as **Annexure "C"**
4. That the Appellant was again transferred from Noordi to Saradhana on 31.07.2004 and took charge in GMS on 02.08.2004 and performed his duties at Saradhna upto 27.02.2006. Copies are attached as **Annexure "D"**
5. That on 20.02.2006 the Appellant was transferred and took charge at GMS Ghari Serian and remain there upto 01.12.2006. Copies are attached as **Annexure "E"**.
6. That the Appellant again posted and took charge at GMS Saradhna on 04.12.2006 and performed his duties upto 02.09.2009. Copies are attached as **Annexure "F"**.
7. That again the Appellant was posted and took charge on 31.08.2009 at GHS Laban Bandi (Changi Bandi) and performed his duties upto 14.04.2012. Copies are attached as **Annexure "G"**
8. That on 30.03.2012 the Appellant was transferred at GHS Noordi and performed his duties at GHS Noordi upto 09.03.2013. Copy of which is attached as **Annexure "H"**
9. That on 04.03.2013 the Appellant was again transfer from Noordi to GHS Sumbal Mohri and performed his duties at GMS Sumbal Mohri upto 31.05.2013. Copy of order is annexed as **Annexure "I"**
- 10 That on 31.05.2013 the Appellant was lastly transferred from GMS Sumbal Mohri to GMS Saradhna. Copies are attached as **Annexure "J"**

11. That the Appellant has filed the departmental appeal before the department Director of Education Department Peshawar. Copy of appeal is attached as **Annexure "K"**.
12. That the last transfer of the Appellant GMS Sumbal Mohri to GMS Sarahdna is against the law and rules, and against the constitutional right of the petitioner.
13. That the appellant filed W.P before the Honourable Peshawar High Court Bench Abbottabad against the impugned order but the Honourable High Court, Abbottabad directed to file service appeal before this Honourable Court. Copy of Writ petition and order are annexed as **Annexure M & N**.
14. That regarding the above said grievance and discrimination, the Appellant seeks his redresses through instant writ petition, inter-alia on the following grounds:-

GROUND

- (a) That the impugned order is based on material arbitrary, perverse, unauthorized, illegal, fanciful and colourful exercise of powers which is liable to be set aside.
- (b) That the impugned order of the respondent is against the judgment of learned Supreme Court and violation of order passed by the Honourable Supreme Court which tantamount to contempt of court.
- (c) That the respondents have not treated with a Appellant in accordance with law and rules on the subject and acted in violation of the Constitution.

- (d) That the previous service record of Appellant from date of appointment based on good reputation and hard work, and there is no complaint against the petitioner.
- (e) That the impugned action of respondent is based on political nepotism, personal liking, disliking which is against the norms of justice.
- (d) That it has been reported in judgment PLD-95-SC-530 the normal period of servant at service stations as per policy decision of Govt. Serving for three years has to be followed in ordinary circumstances. But the official respondents intentionally and deliberately violated the principles laid down by the Apex Court, hence the impugned order is required to be re-interfered by this Honourable Tribunal.
- (e) That no complaint from any corner against the appellant and his service at the present place of posting is only 2½ months, therefore the act of respondents for repeated transfer of the Appellant is illegal, unlawful, capricious and against the principle of natural justice, hence the impugned order is liable to be set aside.
- (f) That it has been held by the court of law that the authority has no right to issue posting orders repeatedly which are capricious and against the principle of natural justice and the impugned order is liable to be set aside.
- (g) That the appellant always performed his duties diligently and obeyed the legal orders of his superiors therefore without assigning any reasons or

justification his transfer is against the principle of natural justice.


- (h) That the appellant has been transferred before completion his normal tenure, hence the impugned order is against the transfer policy of civil servants.
- (i) That the impugned order is void ab-initio, untenable, misplaced, misdirected erroneous contrary to law and same is liable to be interfered and take a serious notice by the court of law.
- (j) That the impugned order has been imposed deliberately, maliciously and the same is gross violation of principle of natural justice, good conscience, fair play and equity and the same is liable to be declared as void and of no legal effect.
- (k) That the impugned order is unwarranted, misconceived, without lawful authority and nullity in the eye of law and is repugnant, violation of fundamental rights granted by the Constitution of Islamic Republic of Pakistan and the same is liable to be set aside.
- (l) That the impugned order suffer from serious legal infirmities and the same is not sustainable in the eye of law. Therefore the same is liable to be set aside.
- (m) That the previous service record of Appellant from date of appointment based on good reputation and hard work, and there is no complaint against the appellant.

It is therefore most humbly prayed that on acceptance of the instant appeal, the impugned order dated 31.05.2013 may graciously be declared as against the law, discriminatory, perverse, and against the basic legal and constitutional rights of petitioner. It is further requested that the impugned order is void and liable to be cancelled and any other relief which this Honourable court deems just & proper may also be granted.

MRS. IRSHAD QAISER, J:- Abid Mehmood, petitioner seeks the Constitutional jurisdiction of this Court and praying that;

“The impugned order dated 31.05.2013 may graciously be declared as against the law, discriminatory, perverse, and against the basic legal and constitutional rights of petitioner. It is further requested that the impugned order is void and liable to be cancelled and any other relief which this Honourable Court deems just & proper may also be granted.”

1. The brief facts as per contents of writ petition are that petitioner was appointed as drawing master on 13.05.1993 and he took the charge on 17.05.1993. That since the time of appointment he has been made rolling stone and has been transferred from one place to another without any sufficient cause and complaint. Along with the petition he also annexed his transfer posting orders marked as Annexed-B to Annexure-J.

2. We have heard learned counsel for petitioner and perused the available record with his assistance.

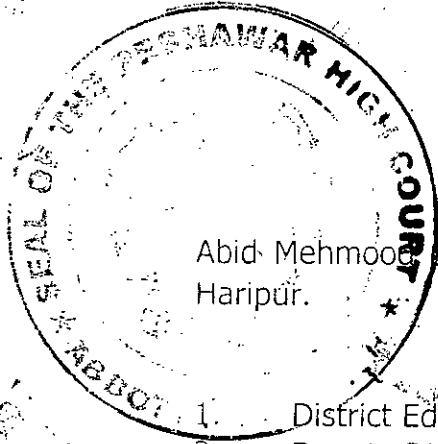
3. Admittedly, petitioner is a provincial government employee and according to service rules he has to serve any where, as per order of his superior and not on the place of his choice. Moreover, transfer of the petitioner falls within the scope of terms and conditions of service and this Court under the Constitutional jurisdiction in view of bar contained in Article 212 cannot exercise jurisdiction in such like matter, in particular, after the decision of Constitutional petition in W.P No.3442-P/2012 dated 06.02.2013, wherein it is held that this Court under Article 199 of the Constitution of Islamic Republic of Pakistan 1973 has no jurisdiction to interfere in the matters relating to the terms and conditions of the civil servant. However, this Court is of the view that the alternate remedy is available to the petitioner for redressal of his grievance. As such, case of petitioner is not maintainable under the provision of Article 199 of Constitution.

4. Accordingly, for the reason stated above, the petition being devoid of any merit is dismissed.
