The instant appeal has been filed by the appellant under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act-1974 against the impugned transfer order dated 31.07.2013 of respondent No. 1 and the order dated 17.09.2013, whereby departmental appeal of the appellant has been regretted by respondent No. 2. He prayed that on acceptance of this appeal this Hon'ble Tribunal may be pleased to set aside the impugned order dated 31.07.2013 and order dated 17.09.2013 on the appellant's departmental appeal and restore the appellant to his previous station i-e. GPS Gagra, District Buner.</p>

3. Brief facts giving rise to the instant appeal are that appellant was appointed as PST in the year 1994, at District Buner and performing his duties with efficient and to the entire satisfaction of senior officers without any complaint from any quarter. That appellant was transferred on 21.02.2013 from Govt; Primary School Rega.No. 3 to Govt; Primary School Kuwasar and against the said order, appellant filed departmental appeal on the ground of spouse policy and physical disability. That departmental appeal was allowed and appellant was re-transferred to another school namely, GPS Gagra which is also on some considerable distance from the Home Town of appellant but even then the same was complied by the appellant. That appellant performed duties in the said school for a period of about 3 months, but again was re-transferred to GPS Biamdra vide impugned order dated 31.07.2013 and respondent No. 4 transferred against the appellant post. That appellant being aggrieved filed departmental appeal before respondent No. 2 on 07.08.2013 which was dismissed vide order dated 17.09.2013, hence the instant appeal.

4. The learned counsel for the appellant argued that on promotion of the appellant vide notification dated 21.02.2013 he was posted in GPS Kuwasar and on acceptance of his departmental appeal he was posted in GPS Gagra vide order dated 25.03.2013. He further argued that after a short spell of period he was transferred on 31.07.2013 to GPS Biamdra and his departmental appeal there-against was rejected on 17.09.2013. He further argued that no reasons whatsoever were given by the Competent Authority for rejection of his departmental appeal.

which was mandatory under Section 24-A of the General Clauses Act, 1897. He further argued that impugned order was also against the spouse policy as his wife also a government servant who needed her support due to physical disability. He further contended that impugned orders not allowing him to complete his tenure against his original place of posting and disregard of the spouse policy was against the spirit of the rules and law and judgments, of the superior courts. He further argued that impugned orders were not maintainable under the law after acceptance of his departmental appeal vide order dated 25.03.2013. He prayed that on acceptance of this appeal the impugned order may be set aside and he may be restored to his previous station i.e. GPS Gagra. He relied on PLD 1995 (C.S) 530, 2001 PLC (C.S) 172, 2012 PLC (C.S) 187, 2011 PLC (C.S) 1103, 1998, 2004 PLC (C.S) 622, and 2003 PLS (C.S) 1322.

5. The learned Assistant Advocate General resisted the appeal and argued that under Section-10 of the Civil Servant Act, 1973 a civil servant was required to serve anywhere and the impugned orders were strictly in accordance with law and rules. He further argued that the appellant was transferred within the same Union Council but he wanted to stick to a particular station of his choice which was not tenable. He prayed that the appeal being devoid of any merits may be dismissed.


6. Arguments of learned counsels for the parties heard and record perused with their assistance.

7. From perusal of the record, it transpired that in the first

instance grievance of the appellant was removed on acceptance of his departmental appeal vide order dated 25.3.2013. He was however not allowed to complete his normal tenure under the policy and was transferred after a short spell of time to another station vide impugned order dated 31.07.2013. His departmental appeal against the said order was however rejected by the concerned authority on 17.09.2013 without recording any reasons therein which is not in conformity with Section 24-A of General Clauses Act, 1897. In view of the above and keeping in view the peculiar condition of physical disability of the appellant, the Tribunal is constrained to indulge in the case. The impugned orders dated 31.07.2013 and 17.09.2013 are set aside and the appellant is restored to his original place of posting where he may be allowed to complete his normal tenure as provided in the Posting Transfer policy of the provincial government. The appeal is disposed of accordingly. Parties are left to bear their own costs. File be consigned to the record.





Respectfully Sheweth;

- 1. That the appellant was appointed as PST in the year 1994, at District Buner and performing his duties with efficient and to

the entire satisfaction of senior officers without any complaint from any quarter.

2. That appellant was transferred on 21.02.2013 from Govt; Primary School Rega.No.3 to Govt; Primary School Kuwasar (Annex "A") and against the said order, appellant filed departmental appeal on the ground of spouse policy and physical disability.
3. That departmental appeal was allowed and appellant was re-transferred to another school namely, GPS Gagra which is also on some considerable distance from the Home Town of appellant but even then the same was complied by the appellant. (Copy of corrigendum is attached as Annex "B")
4. That appellant performed duties in the said school for a period of about 3 months, but again was re-transferred to GPS Biamdra vide impugned order dated 31.07.2013. (Annex "C") and respondent No.4 transferred against the appellant post.
5. That appellant being aggrieved filed departmental appeal before respondent No.2 on 07.08.2013 (Annex "D") which was dismissed vide order dated 17.09.2013 (Annex "E")
6. That the appellant being aggrieved from discriminate treatment, approach this Hon'ble Tribunal for redressal of the grievance, inter alia, on the following

GROUND:

- A. That within a short period of 3 months appellant was twice transferred and successive transfer order of a Civil Servant is not only against the transfer and posting policy, but also against the dicta laid down by the Supreme Court of Pakistan in the case

reported as 2007 SCMR 599 and PLD 2013 SC 195, PLD 1995 SC 530.

- B. That as per spouse policy both the spouse should be placed at one station, but in case of appellant the said has vehemently violated because appellant's wife is performing duties in GPS Kalpani, which is too far away from the newly transferred station of the appellant and is not one station.
- C. That the appellant is physically sick and infirm person because of disability in left leg and will face a number of hardship and difficulties while traveling for performance of duties.
- D. That the appellant has not been treated in accordance with law and as such discriminated. The respondents have violated Articles 4, 25 and 27 of the Constitution, 1973.
- E. That the impugned order is coram non-judice, illegal, capricious and without lawful authority, which need interference by this Hon'ble Tribunal.
- F. That the appellant seeks leave of the court to urge additional grounds at the time of arguments.

Prayer

In view of the above said and other facts, it is, therefore, humbly prayed that on acceptance of this appeal this Hon'ble Tribunal may be pleased to set aside the impugned order dated 31.07.2013 and order dated 17.09.2013 on the appellant's departmental appeal and restore the appellant to his previous station i.e. GPS Gagra, District Buner.

Any other remedy to which the appellant is found fit in law, justice and equity may also be allowed.

MINUTES OF THE MEETING OF THE COMMITTEE REGARDING PLACEMENT OF PHTS BPS-15 AND BPS-14(MALE & FEMALE) OF EDUCATION DEPARTMENT BUNER HELD ON 17-4-2013 IN THE OFFICE OF ASSISTANT COMMISSIONER DAGGAR.

A meeting of the subject committee was held in the office of Assistant Commissioner, Daggar in his office today on 17-04-2013 at 10:00 AM. The meeting started with recitation from the Holy Quran. List of participants is attached.

The following points were discussed in the meeting.

The Government of Khyber Pakhtunkhwa awarded/upgraded PST Teachers from BPS-09 to 12,14 and 15 in the light of the above mentioned updation/promotion of PST Teachers. The Education Department Buner finalized promotion cases of BPS14 & 15 and issued posting orders of the PHTs and SPSTs. The result of this order many teachers lost their original stations under the policy. The aggrieved teachers expressed grievances and concern over the placement order and called a strike on 28-03-2013.

Keeping in view the law & order situation and in order to address the genuine concerns of the teachers community, a committee (Annexure-A) was constituted to review the placement order of PHTs. The committee held 3 sessions on 1/4/2013 and 12/4/2013 to scrutinize the placement of PHTs in the light of guidelines of Director Elementary and Secondary Education Peshawar, Khyber Pakhtunkhwa (Annexure-B).

Following are the findings of the committee.

The committee probed into the previous posting order and found the following irregularities.

- a- The Guidelines issued by the Director B&SE Peshawar were not implemented in true spirit in posting order.
- b- Seniority of the teachers was not considered.
- c- Most of the teachers were adjusted in far flung areas away, from the stations as they deserved. *According to merit.*
- d- Despite the availability of sanctioned posts/vacancies in the schools and being on merit they were posted away and thereby accommodating those who were low in merit/seniority.

Having gone through the above said guidelines and irregularities noticed the committee proposes the revision of the previous posting as per the following criteria.

- 1- The senior most teachers as per the seniority list be adjusted in the same Union Council where they were previously, subject to the availability of sanctioned post/vacancy.

- 2- The teachers over and above the sanctioned posts/ vacancies with in a union council be adjusted in the nearest /adjacent union councils with in ADO circle.
- 3- The teachers over and above of the sanctioned posts/vacancies with in an ADO circle be adjusted in the nearest/ adjacent ADO circle.

It is recommended that the circle wise revised posting proposal as attached (Annexure-c) be notified at the earliest through office of the District Education Officer Buner.


It is further recommended that the appeals pending on the transfer posting issues of female teachers including CT, AT, TT, DM (Male & Female) be disposed off by the DO (Education) female in the like manner in the light of the aforementioned guidelines and recommendations of the committee.

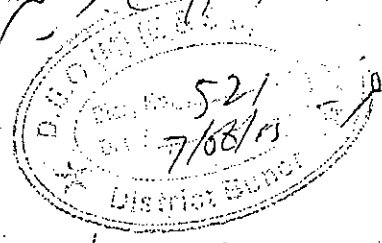
