APPEAL AGAINST THE ORDER DATED 24.08.2013, WHEREBY THE APPELLANT, ALREADY HAVING A HISTORY OF FREQUENT, DISCRIMINATORY AND PREMATURE TRANSFER ORDERS SINCE THE DATE OF HER APPOINTMENT ON 14.02.2005 AS P.S.T, HARDLY AFTER 04 MONTHS OF HER PRESENT POSTING, HAS BEEN TRANSFERRED AND INSTEAD THEREOF RESPONDENT NO.3, HARDLY AFTER 03 MONTHS OF HER PREVIOUS POSTING, HAS BEEN READJUSTED ACCORDING TO HER WISHES, AND RESPONDENT NO.4, VIDE A SUBSEQUENT ORDER DATED 25.09.2013 HAS BEEN ADJUSTED AGAINST AN EXISTING VACANT POST ON PREFERENTIAL BASIS IN THE SAME SCHOOL, ARE ABSOLUTELY ILLEGAL, DISCRIMINATORY, HAVING NO NEXUS EITHER WITH THE PUBLIC INTEREST OR EXIGENCY OF SERVICE, TAINTED WITH ELEMENTS OF MALAFIDE, NEPOTISM, UNDUE FAVOUR, RESULT OF POLITICAL INFLUENCE, ABUSE OF POWER, AGAINST THE PRINCIPLE OF JUSTICE, EQUITY AND FAIR PLAY

PRAYER:-

ON ACCEPTANCE OF THE INSTANT APPEAL, THE IMPUGNED ORDERS DATED 24.08.2013 AND 25.09.2013 TO THE EXTENT OF THE APPELLANT'S TRANSFER AS BEING ILLEGAL, AGAINST ALL CANONS OF JUSTICE AND FAIR PLAY, THE RESULT OF ABUSE OF POWER, WITHOUT JURISDICTION AND VOID, AB-INITIO, BASED ON MALAFIDE, MAY GRACIOUSLY BE SET ASIDE AND CANCELLED AND THE APPELLANT MAY GRACIOUSLY BE ORDERED TO BE ALLOWED TO COMPLETE NORMAL TENURE OF HER PRESENT POSTING IN G.G.M.S MIRPUR OR ANY OTHER RELIEF AS THIS HON'BLE TRIBUNAL DEEMS PROPER, JUST AND EQUITABLE, MAY GRACIOUSLY BE GRANTED.

Respectfully Sheweth,

1. That, the appellant, after having been appointed as Primary School Teacher in the year 2005, has remained victim of frequent, discriminatory and premature transfer orders of which a brief account is submitted as under:-
 - i) That, the appellant, vide appointment letter dated 14.02.2005, was posted in Government Girls Primary School Sumble Dhera, a very remote rural village of Tehsil Havelian. *(Copy of the posting letter alongwith appointment letter is attached as Annexure "A")*

- ii) That, on 14.11.2005, hardly after 9 months, the appellant was again transferred to another more remotely situated school of village Chanjah, Tehsil Havelian. ***(Copy of the transfer order is attached as Annexure "B")***

- iii) That, vide another transfer order dated 30.07.2007, the appellant after 18 months of her previous posting, was again ordered to be posted in GGMS Mohri Badhben, a rural village within the jurisdiction of P.S Nara, Tehsil Havelian. ***(Copy of the transfer order is attached as Annexure "C")***

- iv) That, hardly 10 months later, the appellant, vide another transfer order dated 11.05.2008 was transferred to GGMS Bharwal, a rural school of Tehsil Havelian. ***(Copy of the letter is attached as Annexure "D")***

- v) That, appellant, remained undisturbed in the above mentioned school for about 3½ years, the reason whereof is not known to the appellant and then was transferred to GGPS, Thanda Choa vide the order dated 30.05.2012. ***(Copy of the order dated 30.05.2012 is attached as Annexure "E")***

- vi) That, in April 2013, the appellant, alongwith many others, was upgraded to Grade-14 but despite existence of upgraded post BPS-14 in the same school where appellant was posted, the appellant's request for adjustment in the same

school, was turned down and another teacher namely Nasreen Akhtar was accommodated in the place of the appellant and, consequently, the appellant was ordered to be posted in GGMS Mirpur. ***(Copy of the order dated 13.04.2013 is attached as Annexure "F")***

- vii) That, it is pertinent to submit that while amending the order dated 13.04.2013, the respondents, vide their order dated 15.05.2013, ordered respondent No.3 to be posted in GGMS Rehmat Abad, but she never complied with the same nor the respondents No.1 & 2, insisted on its compliance or implementation thereof. ***(Copy of the transfer order dated 15.05.2013 is attached as Annexure "G")***
- viii) That, the reason for the respondents to remain indolent over the implementation of the transfer order of respondent No.3 dated 15.05.2013, was non else except that of nepotism, undue favour, malafide and political influence which, ultimately, resulted into the impugned transfer order whereby the appellant, hardly after 04 months of her posting, has been compelled to vacate her post for the adjustment of respondent No.3. ***(Copy of the impugned order dated 24.08.2013 is attached as Annexure "H")***
- ix) That, on appellant's failure to convince respondents to do justice to the appellant, the appellant, on the alternative, vehemently requested the respondents to adjust her on the

post of equivalent grade in the same school, which, in the mean while, had fallen vacant due to retirement of another teacher namely "Sobia Bibi" on medical ground. ***(Copies of Appellant's written application submitted to respondent No.1 and the order thereon are attached as Annexure "I")***

- x) That, having left with no reasonable excuse to turn down the appellant's abovementioned request for her adjustment against the post so fallen vacant, as mentioned above, respondent No.1 vide her endorsement dated 06.09.2013 on the appellant's application, directed the appellant to be adjusted till further order. ***(Copy of the aforementioned application containing direction of respondent No.1 is already annexed above as Annexure "I")***

- xi) That, respondent No.2, is not only prejudiced against the appellant but is also annoyed against the aforementioned restraining note of respondent No.1 and has warned the appellant to comply with the impugned order or face consequences.

- xii) That, instead of adjusting appellant on the post having become vacant due to retirement of Sobia Bibi on medical ground the respondents, vide their order dated 25.09.2013, preferred respondent NO.4 on the above mentioned vacant post and now pressurizing the appellant to follow the order of her transfer dated 24.08.2013. ***(Copy of the impugned order dated 25.09.2013 is attached as Annexure "J")***

- xiii) That, the appellant has no other efficacious remedy and the impugned order, being absolutely illegal, discriminatory, against the dictum of the Superior Courts, without jurisdiction, result of abuse of powers, political influence and based on malafide, is amenable to the appellate jurisdiction of this Honourable Tribunal, inter-alia, on the following grounds:-

GRUNDS:-

- a. That, the impugned transfer orders have no nexus with the exigency of service nor made in the public interest or on administrative grounds. The same, on the other hand, is based on extraneous considerations replete with the elements of malafide, nepotism, favouritism and political influence, and also discriminatory and, therefore, the same are not maintainable in the eyes of law.
- b. That, without prejudice to the incidence of transfers, as being part of the terms and conditions of employment, the impugned orders, ex-facie, are indiscriminate, premature, against the cannon of justice, equity and fair play, the result of abuse and arbitrary exercise of powers, absolutely made for the convenience of the respondents No.3 & 4 and to the prejudice of the appellant's rights.

- c. That, the respondent authority, while making the impugned transfer orders, has not considered the necessary prerequisites for making premature transfer orders such as, exigencies of service, public or administrative interest etc, hence, the impugned orders being nullity in the eyes of law are liable to be cancelled.
- d. That, the impugned transfer orders have not been made in accordance with the established principle of law as enunciated by the Honourable Apex Courts in *Anita Turab's* Petition No.23/2012 decided on 12-03-2012 as well as in the light of other judgments of the Superior Courts to be cited at the bar and thus the same are liable to be declared as ineffective and void.
- e. That, the impugned transfer orders have not been made in transparent manners, nor has the competent authority exercised its discretionary powers in accordance with the settled principles of law relating to the transfer of the employee and, therefore, the same deserves to be declared as void ab-inito, illegal and ineffective as against the appellant.
- f. That, the order/direction of respondent No.1, as endorsed upon the appellant's application *Annexure "I"*, tentamounts to acknowledging the appellant's grievance as being genuine which could be redressed through her adjustment

against the existing vacant post in the same school.

g. That, being aggrieved against the impugned orders and having no other efficacious and alternate remedy, the appellant is compelled to invoke the Appellate jurisdiction of this Honourable Tribunal.

h. That, the order dated 24.08.2013 was an original order whereas the directions/orders dated 06.09.2013, recorded on the appellant's application/departmental appeal by respondent NO.1, and subsequently the order of posting dated 25.09.2013 of respondent NO.4 on vacant post where the appellant was directed to be adjusted, tantamounts to rejection of the application/departmental appeal dated 28.08.2013, hence the order of respondent No.1 dated 06.09.2013 and subsequently of respondent No.4 dated 25.09.2013 are the final orders giving rise to the instant appeal. This appeal, therefore, is competent.

PRAYER:-

In view of what has been submitted above, it is, humbly prayed that the impugned transfer orders dated 24.08.2013 and 25.09.2013 whereby the appellant, after hardly 04 months of her posting, has been transferred and, in her

stead, respondent No.3 & 4 have been adjusted, may graciously be declared as being the result of malafide, nepotism, undue favour, against the settled principle of justice, equity and fair play, having no nexus with the necessary prerequisites of exigency, public or administrative interests, being without jurisdiction, illegal, void and coram non-judice. Resultantly the impugned orders may graciously be quashed with further direction to the respondents authority to restore status-quo with regard to the appellant's place of posting as prevailed prior to the date of impugned orders or any other relief as this Honourable Tribunal deems proper, just and equitable, may graciously be granted.
