



PRAER:-

ON ACCEPTANCE OF INSTANT SERVICE APPEAL, OFFICE
ORDER DATED 11/05/2023 ISSUED BY THE RESPONDENT NO 2
(DEO (M) ABBOTTABAD) UNDER ENDORSEMENT NO 3165-74,
TO THE EXTENT OF PSHT TO PET RESPONDENTS NO 03 AND 04
MAY PLEASE BE SET ASIDE AND RESPONDENTS MAY PLEASE
BE DIRECTED TO ISSUE PROMOTION ORDER OF APPELLANT
AS PET WITH EFFECT FROM 11/05/2023, ON SENIORITY BASIS
AND GRANT OF CONSEQUENTIAL BENEFITS/ PROMOTION
(BACK BENEFITS ETC).

Respectfully Sheweth,

FACTS

- 1) That appellant joined Elementary & Secondary Education Department as a PST on 16/05/2005 and presently he is working in the capacity of PSHT. Copy of appointment Order is annexed as **Annexure "A"**
- 2) That appellant during his service, promoted from the post of PST to SPST in BPS 14, on the basis of seniority cum fitness through promotion order dated 18/05/2013. Copy of promotion order dated 18/05/2013 is annexed as **Annexure "B"**.
- 3) That similarly appellant was further promoted as SPHT in BPS 15 on 07/03/2020 and he is working in same capacity in his present station. Copy of Order dated 07/03/2020 is annexed as **Annexure "C"**
- 4) That appellant passed his higher professional qualification, MSc HPE (Health & Physical Education) on 07/03/2023, for the post of PET(Physical Education Teacher). Copy of degree is annexed as **Annexure "D"**
- 5) That on 12/04/2023, respondent No 02, wrote a letter to SDEO Abbottabad, wherein invited documents for promotion on seniority cum fitness, including appellant's cadre, PSHT etc to PET, and appellant was informed/directed through his circle officer (ADEO) for submission of required documents, appellant submitted his personal file for promotion. Copy of letter dated 12/04/2023 is annexed as **Annexure "E"**
- 6) That when it came in to the knowledge of appellant that promotion orders have been issued on 11/05/2023, and it found that his two most juniors (respondents No 3 & 4) of appellant have promoted to the PET post by superseding the appellant. Copy of Promotion Order is annexed as **Annexure "F"**

7) That under the above circumstances, appellant submitted his departmental appeal on 29/05/2023 to the respondent no 1 through registered post, which is not decided yet with in the statutory period of 90 days, Consequently this appeal is being filed with time of 120 days of submission of his departmental appeal Copy of Departmental Appeal along with registered receipt, is annexed as Annexure "G" Hence this appeal inters-alia on the following ground.

Grounds

- a) That the seniority position of appellant and his juniors is quite clear, appellant joined his service on 16/05/2005, and seniority No is 506 in present seniority list while his both juniors joined his service on 21/12/2010, and their seniority nos are 619 & 625 in present seniority list, but during the preparation of working papers, respondents did not took any trouble to examine the case properly, and committed misreading and non-reading the relevant law and facts.
- b) That later appellant got information from the office of respondent No 02 and it found that appellant, being higher professional qualified (MSc HPE) for the post of PET, and minimum professional qualification is JDP (Junior Diploma of Physical), under the law higher qualification could not be treated ineligibility, such act of respondent No 2 is highly arbitrary and colourable fashion, has not only defeated & frustrated the Constitutional guarantees, available to the appellant, but also has exhibited naked disregard to the principles of fair play, and rule of law.
- c) That it is undoubted facts that respondents illegally snatched the legal rights of the appellant in an uncivilized

way in a very haste manner, which is against the equity and there is no single example is available in the civilized society.

- d) That during the preparation of working papers, concerned officers/officials have totally ignored the legal position of promotion in respect of appellant, and totally side tracked the lawful position and wrongly ignored the appellant in impugned promotion order.
- e) That the impugned action of non considering of seniority position of appellant, by respondents is apparent activity of serious disapproval of the law as settled by the Courts of Law, which is beyond the jurisdiction of respondents and tried to create self made complications.
- f) That appellant is dragged into litigation, the conduct of the respondents is admittedly arbitrary capricious unjust and against all norms of justice and as such requires indulgence of this Honourable Court by awarding appropriate Cost to the respondents.
- g) That respondents ignored the provisions of Article 4 and 25 of the Constitution of Pakistan while exercising their illegal impugned office order and their exercising discretionary powers in refusing the relief to the appellant.

It is, therefore, respectfully prayed that on acceptance of instant service appeal, office order dated 11/05/2023 issued by the respondent no 2 (DEO (M) Abbottabad) under Endorsement no 3165-74, to the extent of PSHT to PET respondents no 03 and 04 may please be set aside and respondents may please be directed to issue promotion order of appellant as PET with effect from 11/05/2023, on seniority basis and grant of consequential benefits/ promotion (back benefits etc).

1. They will sign the Agreement Form before joining service.
