WRITTEN REPLY BY THE RESPONDENT NO. 4.

Respectfully Sheweth:

Preliminary Objections:

- a. That the Appellant has got no cause of action to file
the instant service appeal.*
- b. That the service appeal is liable to dismissed being
barred by law.*
- c. That the service appeal is also liable to dismissed
being hit by law of limitation.*
- d. That the instant service appeal is also not
maintainable as no departmental appeal has been
filed.*

- e. *That the Appellant has not approached this Honourable Tribunal with clean hands.*
- f. *That this Honourable Tribunal, very respectfully, lacks the jurisdiction to adjudicate upon the instant service appeal.*
- g. *That the instant service appeal has rendered as infructuous in light of the Notification No. SO(SM)E&SED/5-17/2023 dated Peshawar the 29-05-2023, copy of which is enclosed as Annexure "A".*

On Facts:

1. *Para 1 of the service appeal as drafted pertain to record and irrelevant as far as the answering Respondent is concerned.*
2. *Para 2 of the service appeal as drafted also is irrelevant and relates to the Official Respondents.*
3. *Para 3 of the service appeal as drafted the Official Respondents will be in position to reply, as the answering Respondent was communicated order / corrigendum No. SO. (MC) E&SE/4-1/2023/Posting/Transfer/MC/TC dated 15th May, 2023 and took over the charge after the said corrigendum. Copy of the charge report is enclosed as Annexure "B". Moreover the transfer of the Appellant was never pre-mature, thus the para is denied in the manner.*

4. *Para 4 of the service appeal as drafted relates to the Official Respondents as well.*
5. *Para 5 of the service appeal as drafted also relates to the Official Respondents.*
6. *Para 6 of the service appeal as drafted is correct as per the record.*
7. *Para 7 of the service appeal as drafted shows the highhandedness of the Appellant as the same amounts to breaking the chain of command.*
8. *Para 8 of the service appeal as drafted is incorrect and based on concealment. The Appellant has intentionally concealed the Notification dated 29-05-2023, which makes the instant service appeal infructuous, thus the para is denied in the manner.*
9. *Para 9 of the service appeal as drafted also is incorrect, hence denied.*
10. *Para 10 of the service appeal as drafted also is based on misstatements and concealment of material facts. The Appellant has regularly been performing the duties as SDEO Bahrain since 2019, which is clear from various documents annexed as Annexure "C" herewith, which clearly shows that the Appellant has been holding the charge of the post of SDEO since long, thus the para is denied.*
11. *Para 11 of the service appeal as drafted also is incorrect and based on misstatements and*

concealment of facts as discussed above, thus the para is denied as well.

That in light of the above the instant service appeal is liable to be dismissed on the grounds mentioned in the preliminary objections with cost throughout.



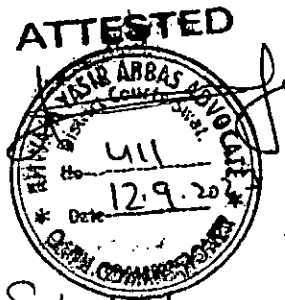


