JOINT PARAWISE COMMENTS ON BEHALF OF RESPONDENTS NO. 1 To 4.

Respectfully Sheweth:-

Comments / Reply on behalf of respondents Nos. 1, 2, 3 & 4 are submitted as under:-

Preliminary Objections:-

- 1. That the appellant has no cause of action to file the instant service appeal.
- 2. That the instant appeal is not maintainable in its present form.
- 3. That the appellant has no locus standi to file instant appeal.
- 4. That the instant service appeal is hopelessly pre-mature as appellant cannot challenge the transfer order without completing the statutory period of 90 days after submission of departmental appeal.
- 5. That the appellant has filed the present appeal just to pressurize the respondents.
- 6. That the appellant has not come to this Honorable Tribunal with clean hands, hence, not entitled for any relief.
- 7. That the appellant is estopped to sue due to his own conduct.
- 8. That the instant appeal is not maintainable due to non-joinder and misjoinder of necessary parties.
- 9. That the instant appeal is against the Rules and Policy of the Government.

10. That the appellant has suppressed the material facts from this Honorable Tribunal, Hence, not entitled for any relief and appeal is liable to be dismissed without any further proceedings.

Factual Objections:

- 1. That the Para No. 1 of the instant service appeal as pertains to record.
- 2. That the Para No. 2 of the instant service appeal is incorrect. Factual position is that the appellant Joined his service on 19/05/2010, and was posted at Abbottabad on 24/08/2010, and as a junior clerk, he served at about 10 years in District Abbottabad, and on his promotion as Senior Clerk on 16/09/2020, he was posted at Peshawar in the office of Respondent No. 2 and without completing his normal tenure he was again posted/transferred in the office of Respondent No. 3 at Abbottabad, while in his total 13 years service he served at Abbottabad more then 10 years and now through 24 May 2023 order, the appellant was adjusted adjacent District Mansehra in the office of Respondent No. 4. Moreover, instant appeal is pre-mature and appellant received his charge on 31/05/2023 in the office of respondent no 4 and private respondent No. 5 received her charge on 30/05/2023 in the office of Respondent No. 3. Appellant as well as Respondent No. 5 received their salaries from their present stations, i.e. Appellant (Mansehra) and Respondent No. 3(Abbottabad) and performing their duties in their same present stations. Furthermore appellant after taking his charge and received salary, filed instant appeal on 21/08/2023, without completing the statutory period of 90 days, after submission of departmental appeal which is also premature and appellant by concealing material facts of his present duty station from this Honorable Tribunal, due to this reason, the order of 24/08/2023 passed by this Honorable Tribunal relating to suspension of 24 May 2023 order was infructuous. Hence appeal is liable to be dismissed. (Copies of arrival reports/charge reports of appellant as well as respondent No. 5 and Salary slips of appellant and respondent No. 5 are attached as annexure "A", "B").
- 3. That Para No. 3 of the instant appeal is incorrect, appellant concealed the facts of the case, he filed departmental appeal (intentionally without showing/mentioning the date of its submission) against the whole order dated

24/05/2023 and prayed for cancellation of transfer order wherein 39 officers/officials were transferred and it is a general posting transfer order in the best public interest and appellant did not array 38 officers/officials in his instant appeal. Furthermore the appellant did not attach/annex complete transfer order, in his service appeal. Hence, appeal is liable to be dismissed. (Copies of relevant Promotion/transfer Orders & Complete impugned transfer order dated 24/05/2023 is attached as annexure "C").

GROUNDS:

- a) That the ground (a) as composed is incorrect, hence, denied and not admitted. Factually in the transfer order, 39 officers/officials were transferred which is general posting transfer order, was issued for the whole province in the best interest of public service, but the appellant did not made party any of them except respondent No. 5, because the appellant challenged the whole transfer order in his departmental appeal and under the law, the appellant cannot change/converse of his basic legal document (departmental appeal), hence the instant appeal of appellant is liable to be dismissed.
- b) That the ground (b) as composed is incorrect as complete reply already given in the preceding Para's.
- c) That the ground (c) as composed is incorrect. It is submitted that appellant could be transferred during period of his service anywhere which would fall under terms and condition of service and he could not be demanded to be transferred on his desired station, while no civil servant had a right to remain posted at a particular place it is legally the right of Govt. who posted individual under the best public interest. No one can get or wish to transfer or posting him on his own wishes/demands.
- d) That the ground (e) as composed is incorrect. Detail reply has been given in the above Para's.
- e) That the ground (f) as composed is incorrect, Hence denied as replied in above paras.

- g) That the ground (h) as composed is incorrect. Service appeal is pre-mature, not maintainable and instant appeal is not continuation of departmental appeal, Hence, liable to be dismissed.
- h) That the ground (i) as composed is incorrect.
- i) That other points may be raised during the course of arguments with the permission of Tribunal.

Prayer:

Under the circumstances it is humbly requested that in the light of above referred facts, Service Appeal in hand may please be dismissed with cost.
