

- That the appellant has filed the instant appeal just to pressurize the respondents.

- 5. Incorrect and not admitted. That the petitioner was absented himself from duty since 07-05-2022, the Superintendent District Jail Buner served a notice at his home addressed with the direction to resume his duty and explain his position in written reply within 03 days vide letter No. 1045 dated 19-05-2022. Copy attached as "Annex-B". He resumed duty on 08-06-2022 after lapse of 31 days willful absence and submitted his resignation from service as intimated by Superintendent District Jail Buner vide letter No. 1225-WE dated 08-06-2022. Copy attached as "Annex-C".
- 6. Incorrect and not admitted. That the petitioner was absented himself from duty since 07-05-2022, while attached to District Jail Buner. He was repeteadly informed to resume his duty but instead of resuming duty he submitted his resignation alongwith affidavit. Copy of resignation letter alonwith affidavit is attached as "Annex-D". The competent authority in exercise of power conferred U/R 3 and 9 of Khyber Pakhtunkhwa, Government Servants (Efficiency & Discipline) Rule, 2011 amended in 2021 to resume his duty within 15 days, after lapse of stipulated time the petitioner neither resume duty nor any intimation was received from him, therefore as required U/R of 9 of ibid rules notice was published in daily newspaper (Daily Mashraq) Peshawar dated 31-08-2022 by directing him to resume his duty within 15 days of publication of notice, he didn't resume his duty nor submit any oral or written defence/justification for his wilfull absence. Therefore in exercise of power conferred U/R 9 of ibid rule the competent authority award him major penalty of "Removal from Service". Copy of impugned order is attached as "Annex-E".
- 7. The answer has been given in para above.

OBJECTION ON GROUNDS:

- A. Incorrect and not admitted. That the impugned order dated 19-09-2022 of the respondant No. 01 is according to rules and procedure, the detail answer has been given in para 6 of the fact above. Moreover, the appellant preferred departmental appeal which was examined by competent authority after affording the opportunity of personal hearing on 02-03-2023. Copy attached as "Annex-F". The appeal was filled on 13-02-2023 and is time barred by 03 months and 26 days. Copy of departmental appeal is attached as "Annex-G".
- B. Incorrect and not admitted. That the appellant wilfully absented himself from duty and line w.e.f 07-05-2022 to 19-09-2022. He was proceeded U/R 3 and 9 of the Khyber Pakhtunkhwa, Government Servants (Efficiency and Discipline) Rules, 2011 amended in 2021. Copy attached as "Annex-H".
- C. Incorrect and not admitted. That the appellant wilfully absented himself from duty and line w.e.f 07-05-2022 to 19-09-2022. He was intimated time and again to resume his duty but instead to resuming his duty he submitted resignation from service.
- D. Incorrect and not admitted. The answer has been given in para 6 of the facts above.

- E. Incorrect and not admitted. The appellant instead of joining duty has straight away submitted resignation fom Job which need no further inquiry, moreover during personal hearing in the course of departmental appeal the appellant does not give satisfactory answer for his resignation from duty. The competent authority in exercise of power conferred U/R 3 and 9 of Khyber Pakhtunkhwa, Government Servants (Efficiency and Discipline) Rules, 2011 amended in 2021 awarded him major penalty of "Removal from Service".

THE KHYBER PAKHTUNKHWA PRISONS RULES, 2018.

Chapter-1 General Provision

- 1. Short title and commencement.--(1) These rules may be called the Khyber Pakhtunkhwa Prisons Rules, 2018.
 - (2) It shall come into force at once.
- 2. Definitions.—(1) In these rules, unless otherwise prescribed the following expressions shall have the meaning hereby respectively assigned to them, that is to say-
 - (a) "Act" means the Prisons Act, 1894 (Act IX of 1894):
 - (b) "Additional Inspector General" means Additional Inspector General of Prisons appointed by Government under these rules:
 - (c) "Assistant Superintendent" means Assistant Superintendent of the Prisons and includes Senior Assistant Superintendent or Senior Lady Assistant Superintendent appointed by Government:
 - (d) "Central Prison" means a Central Prison declared as such by Government;
 - (e) "Chief Warder" means Chief Warder either male or female, as the case may be, in respective ward in a Prison;
 - (f) "Code" means the Code of Criminal Procedure, 1898 (V of 1898);

1082. Leave to Subordinate Officers.—(1) No subordinate officer shall, at any time, without the permission of the Deputy Superintendent, if such officer is subordinate to him, and, in any other case, of the Superintendent, be absent from the prison premises, whether by day or night.

- (2) The Deputy Superintendent shall not, without the sanction of the Superintendent, grant leave of absence to any subordinate officer, or permit any such officer to remain absent, for any period exceeding four hours at any one time.
- (3) Whenever any leave is granted by the Deputy Superintendent to any subordinate officer he shall, at the time the leave is granted, record the fact, and the period of leave in his report book.
- (4) Every subordinate officer shall immediately on return from leave report the fact to the Deputy Superintendent, who shall forthwith record his arrival in his report book.
- (5) The Deputy Superintendent shall similarly record in his report book, all leave granted by the Superintendent and all reports made of return from leave.
- (6) Fifteen (15) days recreation leave shall be granted to every employee of Department once in a calendar year on rotation basis.
- 1083. Absence caused by illness or other unavoidable cause.—Whenever any subordinate officer is at any time prevented by sudden illness or other unavoidable cause, from attending the prison or performing his duties he shall forth-with give notice to the Superintendent along with his reasons for absence. The Superintendent shall then make suitable arrangements for the due performance of his duties.

1084. Acquaintance with these rules and directions.—It shall be the duty of every prison officer to make himself thoroughly acquainted with the duties of his office and these rules and directions. He shall discharge his duties with zeal, efficiency, honesty, alacrity and regularity.

1085. Note Book.---Every subordinate officer shall keep a notebook with him in which he shall record every order given to him by his superior officers.



- 4. That few days before the doctor of the appellant opined that he has gained his health and can perform his duties.(opinion of the doctor attached).
- 5. That after the above opinion of the doctor the appellant went for performing his duties to the district fall buner at daggar but was told by the concerned that he was no more in service hence he demanded his dismissal order but he was not given any order hence he filled an application for joining his duties but the same was not taken hence he sent the afore said application and application for providing the impugned dismissal order through the post office.

That the appellant have now received the impugned removal order which is not according to law hence this appeal.

- 1. <u>Short title, application and commencement.----(1)</u> These rules may be called the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011.
 - (2) These shall apply to every person who is a member of the civil service of the Province or is the holder of a civil post in connection with the affairs of the Province and shall also apply to or in relation to a person in temporary employment in the civil service or post in connection with affairs of the Province.
 - (3) These shall come into force at once.
- 2. <u>Definitions</u>.---(1) In these rules, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say-
 - (a) "accused" means a person in Government service against whom action is initiated under these rules;
 - (b) "appellate authority" means the authority next above the competent authority to which an appeal lies against the orders of the competent authority;
 - (c) "appointing authority" means an authority declared or notified as such by an order of Government under the Khyber Pakhtunkhwa Civil Servants -Act, 1973 (Khyber Pakhtunkhwa Act No XVIII of 1973) and the rules made there under or an authority as notified under the specific laws/rules of Government;
 - (d) "charges" means allegations framed against the accused pertaining to acts of omission or commission cognizable under these rules;
 - (e) "Chief Minister" means the Chief Minister of the Khyber Pakhtunkhwa;
 - (f) "competent authority" means-

AN EXTRACT COPY OF RULE-03 & 09 OF E&D RULES-2011

- 3. <u>Grounds for proceedings.</u>—A Government servant shall be liable to be proceeded against under these rules, if he is-
 - (a) inefficient or has ceased to be efficient for any reason; or
 - (b) guilty of misconduct; or
 - (c) guilty of corruption; or
 - (d) guilty of habitually absenting himself from duty without prior approval of leave; or
 - (e) engaged or is reasonably believed to be engaged in subversive activities, or is reasonably believed to be associated with others engaged in subversive activities, or is guilty of disclosure of official secrets to any un-authorized person, and his retention in service is prejudicial to national security; or
 - (f)- entered into <u>voluntary return or</u> plea bargaining under any law for the time being in force and has returned the assets or gains acquired through corruption or corrupt practices voluntarily.
- 9. Procedure in case of willful absence.— Notwithstanding anything to the contrary contained in these rules, in case of willful absence from duty by a Government servant for seven or more days, a notice shall be issued by the competent authority through registered acknowledgement on his home address directing him to resume duty within fifteen days of issuance of the notice. If the same is received back as undelivered or no response is received from the absentee within stipulated time, a notice shall be published in at least two leading newspapers directing him to resume duty within fifteen days of the publication of that notice, failing which an ex-parte decision shall be taken against the absentee. One expiry of the stipulated period given in the notice, major penalty of removal from service may be imposed upon such Government servant.
