Brief Facts giving rise to the instant appeal are as under:

**FACTS:**

1. That the appellant was appointed as constable in the respondent/department and after fulfilling the criteria for different promotions was promoted to List "E" and as such lastly was promoted to the rank of Sub-Inspector.
2. That throughout his service the appellant served the department with zeal and zest and never remained disobedient to any one i.e. his high-up's and as such is enjoying the status of the Sub-Inspector, this fact can well be seen in the seniority list that was prepared from time to time. (Copy of seniority list is attached).
3. That according to Police Rules, 1934 for promotion to the Rank of Inspector every police officer firstly should be listed/promoted on List "F" according to his seniority then he will be promoted to the rank of Inspector.
4. That as the promotion to the post of confirmed inspector is made through DPC when the posts of inspectors fall vacant as in all there are lying vacant seats of inspectors

the appellant being senior police officer was hopeful to be promoted to next higher rank but surprisingly the respondents/department make a hurdle for his promotion in shape not performing the Upper Police Course though the same was not mandatory for promotion to List "F".

5. That when the department realized that there are posts of Inspector are lying vacant and it was badly needed that DPC should arrange its meeting so that promotions of the senior most Sub-Inspectors be made. Hence it was on 04/07/2013 when the proceedings of departmental selection committee was held where the respondents No.4 to 17 were promoted to List "F" without caring for the rules and seniority. (Copy of notification dated:04.07.2013 is attached).
6. That the case of Resp .No.4 to 17 was sent to respondent No.1 for approval of issuing notification of Inspectors but nothing is heard in writing but verbally the appellant was informed that they could not be promoted to the rank of inspectors with some hidden defects, so the appellant when realized then he submitted an appeal/representation to Resp No.2 but that was too dismissed

vide Office order dated:12.08.2013. (Copy of the appeal and order are attached).

That being aggrieved the appellant prefers this appeal on the following grounds amongst others inter-alia:

**GROUND:**

- A. That the conduct of respondents is arbitrary, mechanical with a willful purpose to deprive the appellant to be promoted to the post of inspector, hence needs interference of this august Tribunal.
- B. That the appellant has undertaken the required courses and on that score he was gradually promoted to the rank of Sub-Inspector. The appellant served the department honestly and never ever involved in negative activities and even this fact is realized by the proceeding to the Departmental Promotion Committee.
- C. That it is evident from record that the promotion up to the rank of Sub-Inspectors is done departmentally where as from Sub-Inspector to the post of confirm inspector by the DPC and this practice is in vogue since long .

- D. That actions and inactions of the respondents are based on discrimination and favoritism as numerous have been favoured and promoted where as the case of the appellant has been suppressed with the hope of getting retired in near future despite the fact that per seniority list this is the vested right of the appellant to be promoted when the DPC has already recommended and the case has already been sent to the competent authority for approval.
- E. That the appellant has been treated differently and discriminated which act of the respondent is against the fundamental rights guaranteed by the constitution.
- F. That the appellant has not been treated in accordance with rules and policy laid down for the purpose and his rights secured and guaranteed under the constitution have been violated.
- G. That the appellant seeks the permission of this august Court to rely on additional grounds at the hearing of this petition.

It is, therefore humbly prayed that on acceptance of this appeal the respondents Nos.1 to 3 may kindly be directed.



**PARAWISE COMMENTS ON BEHALF OF PRIVATE RESPONDENTS  
NO.4,5,6,8,9,10 & 11**

**Respectfully Sheweth:**

**Preliminary Objections:**

1. *That the instant Appeal is time barred.*
2. *That the Appellant has got no cause of action and locus standi against the respondents.*
3. *That the Appellant has not come to this Tribunal with clean hands.*
4. *The Appeal is bad in the present form and is liable to be dismissed.*
5. *The current Appeal is not maintainable in its present form.*
6. *That the Appeal is bad due to non joinder and misjoinder of necessary parties.*
7. *That the Appellant is estopped due to his own conduct.*
8. *That the appellant suppressed / cancelled material facts from the Honorable Tribunal.*
9. *Joint Departmental appeal carries no legal sanctity under the service laws, hence liable to dismissed.*

**ON FACTS:**

1. *Para No. 1 of the Appeal relates to the Service Record of the appellant therefore needs no comments.*
2. *Para No. 2 is subject to proof, hence no comments.*
3. *Para No. 3 of the Appeal is incorrect. Every Police Officer who has qualified Upper College Course, spent 1 year period as SHO*

or other equivalent period is confirmed in the Rank of Sub Inspector. After confirmation in the Rank of SI, his name is brought on promotion list "F" and then promoted to the rank of Inspector subject to the availability of vacancies according to their order of seniority.

4. *Incorrect. Qualification of Upper of College Course is mandatory for confirmation in the rank of Sub Inspector, promotion to list "F" and subsequent promotion to the rank of Inspector. The Appellant has not qualified Upper College Course, therefore not eligible for confirmation followed by further promotion.*

5. *Admitted to the extent that DPC was held for confirmation of qualified Sub Inspectors. The rest is denied. Respondent No. 4 to 11 and other qualified SIs were confirmed by Respondent No. 2, whereas confirmed SIs were brought on list "F" and promoted to the rank of Inspector by Respondent No. 1. The Respondents No. 4 to 11 were qualified in all respect fulfilling the required criteria for confirmation and further promotion. They all were confirmed and Respondents No.4,5,6,9 & 11 were promoted to the rank of Inspectors after observing all legal, codal and procedural formalities, whereas the Respondent No. 7 has died while in service and the seniority list of Respondent No. 10 is separate from those of others. Respondent No. 10 belongs to legal cadre and his nothing to do with the promotion, confirmation etc of the Appellant.*

6. *Para No. 6 is admitted to extent that Respondent No. 2 forwarded cases of confirmed Sub Inspectors to Respondent No. 1 for bringing their names on list "F", the rest is denied. The Appellant has not been called for DPC as he has not qualified Upper College Course. The Appellant never preferred departmental Appeal, he just submitted Joint application along with other applicants / appellants before Respondent No. 2. Their application was turned down, because they were over age for the said course and more to say there is no provision in any Law / Rules applied to Police for preferring joint departmental application / appeal before the appellate authority.*


ON GROUNDS:

- A. *Incorrect. The Respondents No. 1 to 3 did not promote the Appellant as he has not qualified Upper College Course which is a amendatory requirement for confirmation as Sub Inspector and subsequent promotion to the next higher rank.*
- B. *Admitted to the extent that Appellant has been promoted to SI, the rest is denied. The appellant has not qualified the Upper College Course, therefore he was not considered for confirmation as Sub Inspector followed by further promotion to the next Higher Rank. The confirmed and promoted respondents (private) were qualified in all respects on the criteria set out for confirmation and promotion.*
- C. *Incorrect. Every promotion to next rank is carried through Departmental Promotion Committee i.e DPC. Every qualified candidate is promoted to next rank on the basis of seniority-cum-fitness after qualifying mandatory courses for promotion purposes subject to the availability of vacancies. The official respondents therefore, confirmed and promoted private respondents as they were qualified, whereas the appellant was not qualified.*
- D. *Incorrect. Neither official nor private Respondents have acted in violation of Laws, Rules and procedures. Neither the private respondents Respondents have been favored nor has the Appellant been discriminated. The Appellant was not eligible for confirmation followed by further promotion to the rank of Inspector as he has not qualified Upper College Course, being mandatory for promotion to the Post of Inspector.*
- E. *Incorrect. The official respondents have not infringed constitutional and legal rights of the appellant. He has not been discriminated.*
- F. *Incorrect. The Appellant has not been treated against Rules and Law on the subject by the official Respondents. No rights are violated at all.*


G. That the respondents also seek the permission of this Honorable Tribunal to adduce further grounds / points at the time of arguments.

**PRAYER:**


Hence in view of the above comments, it is most humbly prayed that the appeal of the appellant may graciously be dismissed with costs.





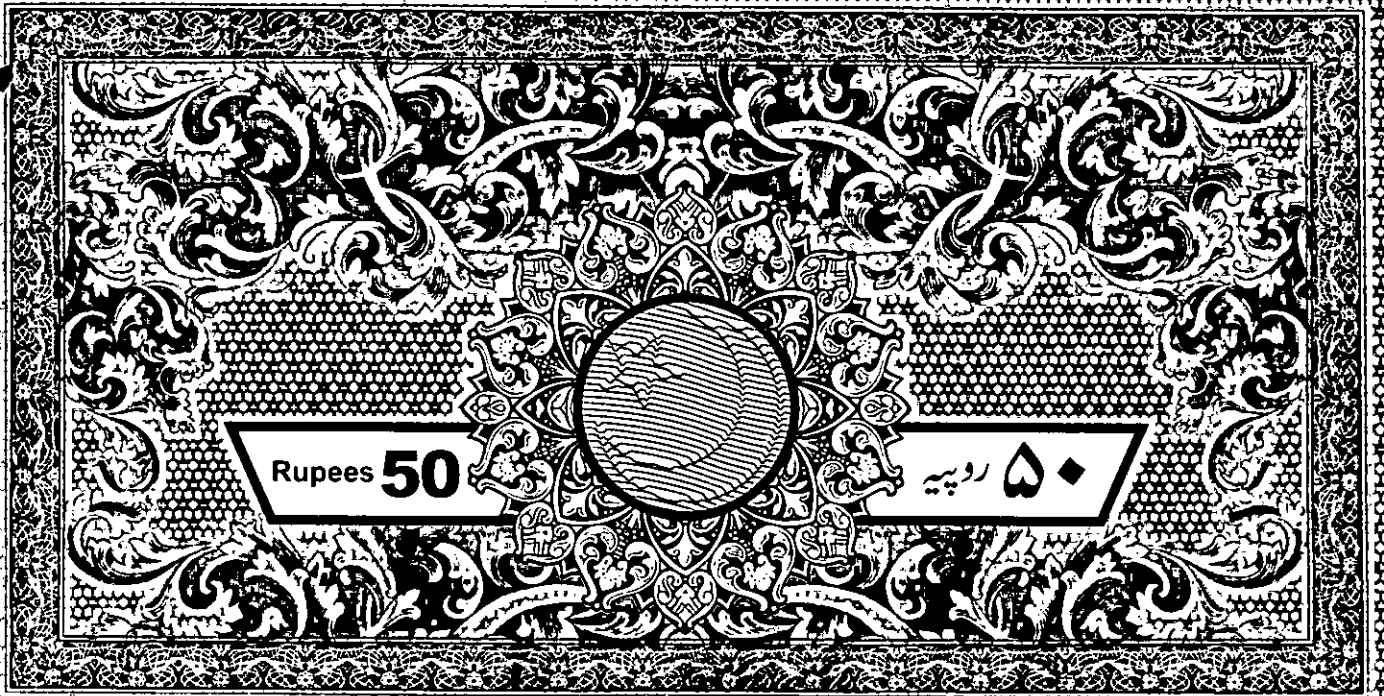
