#### **PRELIMINARY OBJECTIONS:-**

- 1. That the appeal is badly barred by law & limitation.
- 2. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
- 3. That the appellant has no cause of action and locus stand to file the instant appeal.
- 4. That the appellant has not come to this Honorable Tribunal with clean hands.
- 5. That the appellant is estopped due to his own conduct to file the instant Service Appeal.
- 6. That the appellant is trying to conceal the material facts from this Honorable Tribunal.

#### FACTS:-

- 1. Correct to the extent that every police officer is under obligation to perform his assigned duty with great zeal and zest.
- 2. Incorrect. From perusal of record the appellant is found to be an efficient police officer in official duties for which he has been awarded punishments including major punishment of compulsory retirement from service vide order dated 19.08.2014. The appellant was awarded the punishment as his involvement in illegal practices regarding FRP recruitment in year 2013 which was proved against him. (Copy of punishment order dated 19.08.2014 is attached herewith as annexure "A").
- 3. Incorrect. A complaint against the appellant has been received to respondent No. 1 which was thoroughly examined. However, he was not awarded any punishment. In fact, the appellant was transferred from CCP Peshawar to FRP Unit in the year 2012 as Head constable on deputation basis and he was promoted to the rank of SI/PC for the purpose of duty in FRP. Subsequently, he was reverted to his substantive rank on repatriation to his parent district i.e CCP Peshawar.
- 4. Incorrect. The appellant was not awarded any punishment rather he was repatriated to his district of domicile in his original rank i.e Head constable.
- 5. Incorrect. As already explained in the preceding Paras.

Incorrect. As the appellant was not awarded any punishment and it is evident from reversion order dated 23.01.2023.

- 7. Incorrect, the services of the appellant were no more required to FRP Unit therefore, the competent authority reverted the appellant to his substantive rank of Head constable and repatriated him to his home district i.e CCP Peshawar in his original rank.
- 8. Incorrect. The departmental appeal submitted by the appellant was thoroughly examined and has been rejected on sound grounds. (Copy attached herewith as annexure "B").
- Incorrect. The appellant has not come to this Honorable Tribunal with clean hands, hence this appeal being devoid of merits may kindly be dismissed on the following grounds.

#### **GROUNDS:-**

- A. Incorrect. All orders issued by the respondents in the case of appellant are legally justified and accordance to law/rules and policy.
- B. Incorrect. No punishment has been imposed upon the appellant, rather he was repatriated to his district of domicile in his substantive rank of Head constable. Hence, the respondent did not commit violation of any provision of the constitution, of Islamic Republic of Pakistan.
- C. Incorrect. As already discussed in the instant reply, the appellant was not awarded any punishment rather he was repatriated to his parent district i.e CCP Peshawar. Therefore, he was reverted to his substantive rank of head constable as per policy rule in vogue.
- D. The respondents may also be permitted to raise additional grounds at the time of arguments.

#### PRAYERS:-

Keeping in view the above facts and circumstances, it is most humbly prayed that the instant service appeal being devoid of merits may kindly be dismissed with costs please.

Dated Peshawar 🖉 August 2014. <u>ORD</u>ER This order is issued to conclude the departmental enquiry proceedings against SI Amin Khan who was charge sheeted on account of providing connivance and facilitating the officers in the illegal recruitment of 378 candidates in FRP Recruitment in 2013. An Enquiry Committee vide Order No. 763-69/SE-I, dated 09.04.2014 was constituted to probe the allegations against the defaulting officer. As per the enquiry report, the defaulting officer enjoys the reputation of being a corrupt officer and he lives beyond ostensible means. It has also been proved against the defaulting officer in the enquiry report that he has been the dealing hand in collecting money from candidates in the FRP Recruitment 2013. On the basis of this, the Enquiry Committee has recommended the imposition of major penaity on the defaulting officer. In view of the findings/recommer dations of the Enquiry Committee and after going through the relevant enquiry papers with regard to the recruitment in FRP, it transpires that the defaulter h: s involved himself in illegal practices whereby the Police Department has bee I brought into disrepute. Therefore, his retention in the department will definitely affect the moral of the Knyber Pakhtunkhwa Police. Per a p In view of the above serious allegations I, Mubarak Zeb, the DIG Headquarters Khyber Pakhtunkhwa (Co npetent Authority), in agreement with the findings of the Enquiry Committee hald the officer guilty of misconduct as the charges have been proved against him, and under the KPK Police Rules 1975 vide Rule 5(5), I hereby impose major panalty of Compulsory Retirement on SI Amin Khan (under suspension) from service with immediate effect.
