# PRELIMINARY OBJECTIONS

- 1. That the Appellant has got no locus standai to file the instant appeal.
- 2. That the appeal is wrong and based on illegal and unlawful presumptions.
- 3. That the Appellant is estopped by his own conduct to file the instant appeal.
- 4. That the appeal is not maintainable in its present form.
- 5. That the appeal is barred by law and limitation.

#### Respectfully Sheweth:

- 1. Correct
- 2. Correct to the extent that Appellant was bound to perform his duty as per terms and condition of his appointment order.
- 3. Correct to the extent that Appellant will get retired from service on 02-01- 2024.
- 4. Correct to the extent that Appellant was transferred from District Haripur to District Abbottabad on 04-05- 2023 in best public interest (Annexure- A). The Appellant filed departmental appeal against this order before Respondent No. 1 (Annexure- B). The same appeal was forwaded by the Respondent No. 1 to Respondent No. 2 for considereation as per law/ rules (Annexure- C). It is pertinent to mention that the appeal of Appellant was considered but immediate relief to the Appellant could not be provided due to ban on transfer/ posting by Government of Khyber Pakhtunkhwa, Establishment Department, vide letter No. SO (Policy) (E&AD)/1-4/2023, dated 29-05- 2023 and non availability of vacant post of Veterinary Supervisor at District Haripur. (Annexure- D)
- 5. Incorrect. The Appellant relieved his post on 17-05- 2023, however, he has not taken charge at his new place of posting till date. (Annexure- E)
- 6. Incorrect. The Respondents has passed an order in response to the Appellant's appeal.as replied in para 4.

- 7. Correct to the extent that due to ban on posting/ transfer by the provincial government and non availability of vacant post, the Appellant could not be provided immediate relief but he will be transfer to his native district subject to relaxation of ban and availability of vacant post.
- 8. Incorrect. Transfer/ posting are routine activity, required for smooth functioning of government business. The Appellant being provincial cadre employee can be transferred to any district of province in best public interest.
- 9. The transfer of Appellant has been made in the best public interest. However, keeping in view the last year of Appellant in service, he will be transferred on priority basis to his native district after lifting ban and availability of post.
- 10. The Respondent may be allowed to raise additional grounds at the time of arguments, if required.

Keeping in view the above submissions, it is, therefore, most humbly prayed that the writ petition may be dismissed, please.

# BAN ON POSTINGS AND TRANSFERS IN KHYBER PAKHTUNKHWA

I am directed to refer to the above cited subject and to convey, that in view of the fragile fiscal position of the Provincial Government, the Hon'ble Chief Minister Khyber Pakhtunkhwa has been pleased to impose ban on inter-district posting and transfers of officers and officials under the Government of Khyber Pakhtunkhwa as per the following:

i. There shall be complete ban on inter-district transfers in all the departments;

- This ban shall not apply on transfers within the districts and within the Secretariat and Directorates. However, while proposing such transfers of officers/officials within the district, Directorates or the Secretariat, as the case may be, due diligence must be observed and tenure, suitability of the officers/officials for the posts and past performance must be taken into account;
- iii. In cases posting and transfer is necessitated due to some court orders or some administrative exigencies, ban relaxation will be obtained from Chief Minister through summary. For such posting/transfers, departments will put forth sound justifications. Subsequently in cases where NOC from Election Commission is required, cases will be taken up with FCP for ban relaxation by the concerned Administrative Departments.
  - This ban shall not apply on filling of vacant posts through recommendations of the Khyber Pakhtunkhwa Public Service Commission as Election Commission of Pakistan has already granted exemption in such cases.
