**RESPECTFULLY SHEWETH:**

**PRELIMINARY OBJECTIONS:-**

1. That the Appellant has no cause of action and locus standi.
2. That the appellant cannot claim choice posting under the law.
3. That if the actual record is perused it would reveal that the appellant is not a BPS-20 employee due to non actualization of his promotion order as Professor BPS-20.
4. That the appellant has not come with clean hands and he maneuvered to insert his name in the summary at the time when he was not promoted to BPS-20 which shows high handedness and ill-intention on the part of the appellant.
5. That the appellant, as per Latest Judgments of the Supreme Court cannot claim choice posting nor this august Tribunal has the jurisdiction to issue direction for a posting of a person against a particular post.
6. That the appellant is liable to serve anywhere posted by the competent authority under section 10 of the Civil Servant Act, 1973.

**FACTS**

**RESPECTFULLY SHEWETH,**

1. Denied for the reasons that the appellant was in Scale 19 when he was given a look after charge in violation of government instructions dated 07.12.2022 and instruction contained in Estta Code, wherein, it is mandatory that look after /additional charge can only be given to an official of equal grade ,secondly, the high handedness of the appellant is also evident from the fact that on 13.12.2022 he was promoted to BPS-20 as professor and in pursuant to that order he had not actualized the promotion order and managed to insert his name in the summary for the post of Director Higher Education wherein on 11.08.2022, para-8 of the summary the Secretary Establishment referred to the same panel and on 11.08.2022 the appellant was in BPS-19 as he was promoted on 13.12.2022. Even if the note Para-10 of Chief Secretary KP is look into, it is signed on 23.08.2022. So it is safely contended that the appellant is a person with un-cleaned hands.
2. Incorrect and denied. Moreover as explained in Para-1 above.
3. Incorrect. As stated above the appellant had not actualized his promotion and wrongly been shown as BPS-20 on 21.12.2022. Moreover the order dated 21.12.2022 was obtained by fraud as explained above that he made insertion of his name in the summary and shown himself in BPS-20 on 11.08.2022 where in fact he was promoted on 13.12.2022 and that after look after charge in BPS-20 was also in violation of Govt: instruction issued from time to time.
4. Incorrect and denied for want of proof because the conduct of the appellant shows otherwise, as explained hearing above. Moreover the appellant is a junior most Officer/Official at Sr. No. 186 of the seniority list which is a question mark for making a junior most official Head/Boss of the senior most Officials. It is further added that as per verdicts of the Superior Courts it is the domain of the government to post a civil servant against the post and under section 10 , a good Civil Servant is liable to serve where posted.
5. Incorrect and misleading. A proper NOC from ECP was obtained prior to passing of the transfer order.

6. Incorrect and misconceived the order has been passed after obtaining of the NOC from ECP. Moreover the appellant cannot claim choice posting against a post and that too which is not a tenure post under the law.
7. Incorrect hence denied. The order has been passed keeping in view Rule-17 Read With Schedule-III of the KP Rules of Business, 1985.
8. Incorrect and denied. The order dated 14.03.2023 and 22.03.2023 have been passed in accordance with law and rules as per procedure indicated in the KP Rules of Business 1985.
9. Denied for want of knowledge, however, if an order has been issued on the direction of worthy CM being Competent Authority in such cases remedy of reviewed is available and not of appeal.
10. Incorrect the appellant is not an aggrieved person, especially seeking choice posting and more so this august Tribunal lacks jurisdiction for issuing direction of posting against a particular post.

**GROUND:**

- A. Incorrect. The appellant cannot be stated to be an aggrieved person because under section 10 he is liable to serve against the post where posted by Competent Authority. Moreover the period provided in Section 04 of the KP Civil Tribunal Act, 1974 is to be prevailed over a policy.
- B. Incorrect posting/transfer cannot be terms as fundamental right because for enforcement of fundamental right, this august Tribunal has no jurisdiction and for enforcement of fundamental rights the Article-199 (1) (c) is available with the jurisdiction of Honorable High Court.
- C. Incorrect and misconceived. The impugned orders are passed after observing Rule-17 of the Rules of Business 1985 and after the approval of competent authority the orders were issued accordingly which are legal and competent.

- D. Incorrect and misconceived. The orders were passed after proper NOC duly granted by the ECP which shows fair handedness of the respondents.
- E. Incorrect and misconceived. The disputed post is not a tenure post. Moreover the reaching of appellant to the post of Director of HED is fully explained in Para-1 above of this reply.
- F. Misconceived. Keeping in view the latest judgment of Superior Court's the case referred herein is not applicable to the instant case.
- G. Misconceived. The disputed post is not a tenure post, and the appellant got posting against the disputed post through unfair means. More so the appellant was not appointed/posted to serve in a particular area or station. Therefore the factor of tenure cannot be made applicable to the instant case. Moreover, especially, when the appellant got his posting against the dispute post through unfair means.
- H. Incorrect and misconceived. The impugned order has been passed after proper NOC of the ECP and after observing all codal formalities.
- I. Incorrect hence denied. In cases of posting/transfer the principles of legitimate expectancy is not applicable, especially, when the appellant is transferred within Peshawar i.e Directorate of Higher Education Peshawar to Degree College Hayatabad Peshawar.
- J. Incorrect and hence denied. Rather the appellant tried to get the posting through unfair means.
- K. Incorrect hence denied. The appellant has been treated in accordance with law and rules nor the order is less favorable or disadvantageous in terms and conditions of his posting.
- L. Incorrect. As explained in Para-2 above.
- M. Incorrect and misconceived. The Article-8 is not applicable in the instant case at all.
- N. Incorrect. The appellant has been simply transferred without any loss in his pay and scale etc.

O. Incorrect as explained in Para-F above.

P. Legal, otherwise, the appellant has no case at all.

It is, therefore, most humbly prayed that the appeal of the appellant being divide of merits may be dismissed with costs throughout.

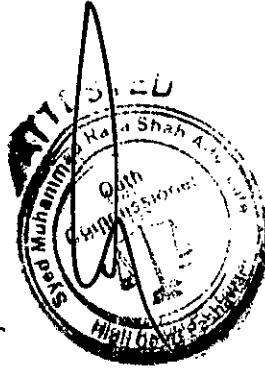

Subject: - CLARIFICATION REGARDING ASSIGNING LOOK AFTER CHARGE

Dear Sir,

I am directed to refer to the above cited subject and to state that although in the Khyber Pakhtunkhwa Civil Servant Act, 1973 and rules made thereunder, there is no provision for assigning additional charge/look after charge of a post which becomes vacant due to the transfer of an officer or temporarily becomes vacant due to the officer's proceeding on a visit/leave, however, in such a situation the official business cannot be left to suffer, hence, officer of an equivalent grade is assigned additional charge of the post which is regulated under Finance Department's instructions dated 12<sup>th</sup> August, 1997. As per Finance Department's instructions such an arrangement is made for a period which is not less than one month and should not exceed three months. However, it can be extended for another three months with the approval of next higher authority.

2. Moreover, in certain conditions where the duration for which a post is likely to remain is short, hence, as a practice, in such a situation an officer is temporarily deputed to look after charge of that post so that routine official business may not suffer. Such an officer is required and expected to run the day to day affairs of that post only and not to take major administrative and financial decisions having far reaching implications. He can take decisions with regard to day to day business of that post which can be reviewed by the competent authority depending upon the merit of the case.

3. However, it has come to the notice that in certain cases officers who have been assigned look after charge have taken major decisions like recruitments expenditure of huge amount etc. which involve major administrative and financial implications which is contrary to the established norms. An officer looking after the charge of a post cannot exercise financial and administrative powers as the same have not been delegated to him by the competent authority.

4. I am therefore directed that the position explained in Para-2&3 above may be disseminated to all concerned for information and compliance.

### Posting of Junior Officers on Posts in Higher Scale

This Department's Circular letter No.SORI(S&GAD)1-29/75(A), dated 13.2.1993, on the subject noted above and to state that it has been noticed that certain Provincial Government Departments are resorting to the practice of posting officers in a lower scale on posts in higher scales. This practice is against the provisions of NWFP Civil Servants Act, 1973 and rules made thereunder as well as the instructions of the Establishment Division reproduced below:-

"The grant of higher appointments to junior officers against senior posts amounts to accelerated promotion in view of the decision given by the Supreme Court of Pakistan in the case of Government of Pakistan Versus Qazi Abdul Karim. The Ministries/Divisions or Provincial Governments can only fill vacancies in a particular grade by officers of the same grade, and officers in a junior grade will not be appointed against a vacancy in a higher grade".

2. It may be pointed out that in the light of rule 9 of the NWFP Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, the methods prescribed for posting a junior officer to a higher post are restricted to the following only:-

i) ACTING CHARGE APPOINTMENT AGAINST A HIGHER POST

Where the senior most officer in a cadre is otherwise fully eligible for promotion but does not possess the specified length of service, the competent authority may appoint him to the higher post on acting charge basis, but only on the recommendation of Departmental Promotion Committee/Selection Board and subject to the condition that such officer lacks the prescribed length of service not more than (one year).

ii) CURRENT CHARGE APPOINTMENT OF A HIGHER POST

Only the senior-most officer of a cadre can be given current charge appointment of a higher post with the approval of the competent authority. However, this can only be an arrangement upto a maximum of six months.

iii) ADDITIONAL CHARGE APPOINTMENT OF AN EQUIVALENT POST

An officer can be given the additional charge of a second post but only of a post in an equivalent grade, upto a period of six months by the competent authority.

3. Adherence to the above rules is a legal requirement so that the actions taken by officers are not held at any stage to be irregular. Also, appointments in violation of the rules constitute administrative indiscipline.

4. I am, therefore, directed to request that all such cases of irregular appointments be reviewed and ensure not to resort to such appointments that violate the provisions of the Civil Servants Act and the statutory rules framed thereunder.

5. I am further directed to request that these instructions may be brought to the notice of all concerned for strict compliance.



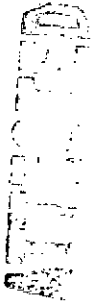
