

Respectfully Sheweth,

- Brief but relevant facts of the case are as follows:
 - 1. That the appellant was appointed as Cook (BPS-03) on 09-01-2016 in the respondent Department, the Appellant has qualified B.A and DIT. (Copies of the appointment order and Academic Degrees are attached as Annex-A and B respectively)
 - 2. That ever since his appointment, the Appellant has performed his duties to the entire satisfaction of his superiors. During this period, the appellant has

performed duties in different Units of the respondent department along with his duty as cook and has gained sufficient experience in performing clerical duties i.e., computer skill, typing, file maintenance, Diary Dispatch etc, the same has been duly appreciated by the authorities as evident from different office orders issued by the respondents. (Copies of the office orders are attached as **Annex-C**)

- 3. That the Government of Khyber Pakhtunkhwa, Health Department issued a Notification dated 04th February, 2020 whereby 40% of the posts of Junior Clerks (BPS-11) shall be filled by promotion on the basis of seniority-cumfitness from amongst the holders of the post of Class-IV employees of Provincial Health Services Academy with at least two years service as such, who have passed Intermediate Examination or its equivalent qualification from a recognized board and a speed of thirty words per minute in typing. (Copy of Notification is attached as Annex-D)
- 4. That the Appellant has served the Department for more than 05 years as Cook (BPS-03) and has qualified the B.A and DIT, thus fulfills the aforementioned criteria for promotion to the post of Junior Clerk.
- 5. That few posts of Junior Clerk fell vacant in the respondent Department, as the said posts were falling in the promotion quota, thus all the eligible Class-IV employees including the appellant, serving in the respondent Department were called for typing test. The appellant appeared in the test and qualified the typing test by securing typing test net speed 30 words per minute. (Copy of the result and seniority list is attached as **Annex-E & F**)
- 6. That it is worth mentioning here that some of the colleagues of the Appellant who had failed the typing test have been promoted to the posts of Junior Clerks, including one Arif Nawaz S/o Naik Nawaz, Junior Clerk, Divisional Health Development Center, (DHDC) Bannu, while the appellant is ignored. (Copies of the Promotion Orders are attached as Annex-G)
- 7. That feeling aggrieved of the aforesaid promotion orders, the appellant filed Departmental Appeal for promoting him against the post of Junior Clerk which has been rejected vide order dated 24-08-2021. (Copy of Departmental Appeal and final order is attached as Annex-H & I).

Hence the instant service appeal on the following amongst other grounds:

Grounds:

- a. That the treatment met to the Appellant is against the law, illegal, unlawful and without lawful authority, hence calling interference of this learned Tribunal.
- b. That the treatment met to the Appellant is not only against the settled principles of administrative law but also the same is against the fundamental

rights enshrined and protected under the Constitution of Islamic Republic of Pakistan, 1973.

- c. That the Government of Khyber Pakhtunkhwa, Health Department issued a Notification dated 04th February, 2020 whereby 40% of the posts of Junior Clerks (BPS-11) shall be filled by promotion on the basis of seniority-cumfitness from amongst the holders of the post of Class-IV employees of Provincial Health Services Academy with at least two years service as such, who have passed Intermediate Examination or its equivalent qualification from a recognized board and a speed of thirty words per minute in typing, the appellant fulfills the said pre-requisites for promotion.
- d. That the Appellant has been given discriminatory treatment as some of the colleagues of the Appellant who had failed the typing test have been promoted to the post of Junior Clerks whereas the appellant has been deprived from the same, which is not warranted under law.
- e. That the appellant has not been treated in accordance with the law, rules and policy on the subject matter which is his inalienable right.
- f. That the Appellant craves permission of this Honorable Court to rely on other grounds at the time of arguments and produce any additional document if required in support of his Petition.

It is, therefore, prayed that on acceptance of this Service Appeal, the impugned order dated 24-08-2021 whereby the appeal of the appellant is dismissed and order whereby the respondent No 6 is promoted to the post of Junior Clerk may kindly be declared as against the law, illegal, unlawful and ineffective upon the rights of the appellant and the respondents may kindly be directed to promote the Appellant to the post of Junior Clerk with all back benefits.

Any other relief deemed appropriate by this Honorable Tribunal in the circumstances of the case which has not been prayed for, may graciously be granted.

Furthermore, the DPC agreed upon the point that those Class-IV who have at least the typing speed of 12 words per minute with at least SSC qualification will be considered for promotion to fill the available vacant seats under 40% quota lying vacant since 2013 i.e. before the introduction of amendments in service rules in 2020. The appellant although secured his fitness by securing the typing speed of 30 w.p.m, however could not qualify as per his seniority. (DPC meeting minutes along with seniority list of Class-IV employee placed at Annexure-A)
