Respectfully Sheweth;

1. That, the appellant permanent resident of District Bannu, educated persons, peaceful citizen and was Govt. Servant in capacity of Constables in Police Department (FRP) District Bannu.

- 2. That, the appellants was performed his duty with zeal and zest in district Bannu and on dated 23.11.2022 the respondents transferred the appellant to Abbotabad for performing of special service period of almost 50 days, after the laps of some days of duty in Abbotabad the mother of appellant was badly affected from different chronic disease i.e. heart problem, diabetics, enteric fever, chest infection, headic and was reached to death bed condition, the appellant after getting knowledge about his mother disease he left the duty and leaved for Bannu to his house after proper oral approval of leave from his group commander for his mother care and treatment. (Copy of doctor prescription and laboratory medical test are hereby attached as annexure A to A.11)
- 3. That, the appellant while during the course of mother treatment he joined the duty on 05.01.2023 but where he shocked to know about dismissal of his service, without giving any proper opportunity of defense and justification about the leave, thereafter the appellant was started approach to his high ups and crave for setting aside his dismissal of service and for reinstatement but duly ignored.
- That the appellant was lastly on 13.04.2023 approached to the respondent No.1 for reinstatement of his service where the respondent No.1 handed over the impugned dismissal order No.OB 238, in which the respondent mentioned that after conducting of proper departmental inquiry issued the said impugned order. (Copy of impugned order dated 13.04.2023 is hereby attached as annexure B).
- 5. That the appellant has got no knowledge about the departmental inquiry and there is no notice what so ever has

been served to the appellant and there is also no opportunity of personal hearing is given to the appellant which is against the law, norms of justice and illegal and having no enforcement in the eye of law and the inquiry officer has failed to hear both the parties while issued an ex parte charge sheet against the appellant.

- 6. That on the appellant feeling aggrieved from the impugned order No. OB 238/2023 forward departmental appeal on dated 17.04.2023 to respondent No.2 which is thereby rejected on dated 11.08.2023 through office order No.7688/SI LEGAL, DATED PESHAWAR.(Copy of departmental appeal and rejection order No. 7688 is hereby attached as annexure C-D).
- 7. That the appellant is belong to poor family and the only person of earning for maintenance of his family and have no other source of living in the worst situation of country, the act of the appellant was not intentionally.
- 8. That being aggrieved, and having no other remedy available, the appellants now approaches this Hon'ble Tribunal against the impugned order dated 13.04.2023 and order No. 7688/2023.

GROUNDS:

A. That, the act of respondents by dismissing the service of the appellant and rejection of departmental appeal, despite of the fact that appellant had properly got permission from the group commander he was allowed to leave, is against the law,

unjust, based on malafide intention, ulterior motive; hence, such act is not sustainable in the eye of law.

- B. That, the respondents, were duty bound to issued notice for proper hearing for his justification and defense and due to malafide, ulterior motive and having personal grudges with appellants issued the ex parte charge sheet and dismissal order.
- C. That, the appellant was discharging duty in District Bannu with zeal and zest and there is nothing on record that he has absented him from duty or ever shown negligence in performance of official duty.
- D. That, the instant departmental appeal is a classic example of discrimination. The appellant is regular employee of District Bannu Police (FRP) and on the basis of ulterior motive on part of respondents he has been dismissed from service without any cogent reason and despite of the fact that he was permitted by the high-ups for leave.
- E. That, in light of above, the act of respondents is totally unwarranted and against the law and as such the same is liable to be set at naught.
- F. That, the very act of respondents is violation of Articles 4, 8,10A, 25 and 27 of the Constitution of Islamic Republic of Pakistan, 1973.
- G. That, the appellants counsel respectfully seeks permission of this Hon'ble Court to advance and rely on additional grounds at the time of hearing of instant appeal.

PRAYER:

ON ACCEPTANCE OF THE INSTANT APPEAL, THIS HON'BLE COURT MAY VERY GRACIOUSLY BE PLEASED TO, SUSPEND/CANCEL IMPUGNED OFFICE ORDER # OB NO.238 DATED 13/04/2023 AND TO DIRECT THE RESPONDENTS TO REINSTATE THE SERVICE OF APPELLANTS ALONG WITH ALL THE BACK BENIFITE AND MAY KINDLY SET ASIDE THR REJECTION OF DEPARTMENTAL APPEAL ORDER NO.7688/2023, JUST TO MEET THE ENDS OF JUSTICE AND TO ENABLE THE APPELLANT FOR DUTY TO EARN FOR HIS LIVEHOOD. ANY OTHER RELIEF DEEMED APPROPRIATE BY THIS HON'BLE COURT AND NOT SPECIFICALLY PRAYED FOR; MAY KINDLY BE ALSO GRANTED.



ORDER

My this order will dispose off the departmental proceedings so initiated against Constable Rehan Ullah No. 6955 /FRP who remained absent from Govt: duty vide daily dairy No.55 dated 23-11-2022 to 05-01-2023 for a total period of (43) days at Police Lines District Abbotabad without any leave or prior permission of the competent authority and again absented vide daily dairy No.20 dated 04-04-2023 till date dismissal of FRP Police lines II District Bannu. On the basis of his prolong absence he was charge sheeted a appointment of Enquiry Officer of FRP Bannu Raige to conduct proper Departmental Enquiry against the delinquent official.

The Enquiry Officer deeply probed into the facts and conducted through enquiry with submission of his findings report wherein the Enquiry Officer reported that the charge cheet was properly enved upon him on 23-01-2023, but the defaulter official replied to the charge sheet within stipulated period. Finally Enquiry Officer declared him willful and habitual absence and recommended him for imposition of Major Funishment. Even did not bother to make arrival back for duty. He was also summoned from time to time to appear before the undersigned for personal hearing but he did not appear so far hence it is reasonably presumed that he does not want to produce any defense and seems to be dis-interested in continuous of I office service. Moreover on perusal of service record of the defaulter official, it also came to light that a result shy hears absenced himself for (275) days with awarded of certain punishments for the same but you did not mend his way.

ORDER

This order will dispose of the departmental appeal preferred by ex-This order will display the constable Rehan Ullah No. 6955 of FRP Bannu Range, against the order of SP FRP Bannu Range, Bannu Issued vide OB No. 238, dated 13.04.2023, wherein he was awarded major punishment of dismissal from service.

Brief facts of the case are that the above named applicant absented himself from lawful duty with effect from 23.11.2022 to 05.01.2023 for total period of . (43) days and again absented himself with effect from 04.04.2023 till the date of dismissal from service i.e 13.04.2023 for total period of (52) days, without any leave or prior permission of the competent authority.

In this regard, proper departmental enquiry was initiated against him as he was issued Charge Sheet alongwith Summary of Allegations, which was properly served upon him on 23.01.2023, and Enquiry Officer of FRP Bannu Range was nominated to conduct proper enquiry against him. After completion of enquiry, the Enquiry Officer submitted his finding report, wherein the above named constable found a willful and habitual absentee. The Enquiry Officer found him guilty of the charges leveled against him and recommended for imposition of major punishment.

Upon the flading of Enquiry Officer, he was called in orderly room for

personal hearing, but he did not appear before the competent authority.

Keeping in view the above narrated facts and other material available on record, he was awarded major punishment of dismissal from service vide OB No. 233, dated 13.04,2023.

Feeling aggreed against the impugned order of SP FRP Bannu Range, Bannu, the applicant preferred the instant appeal. The applicant was summoned and

heard in person in Orderly Room held on 08.08.2023.

During the course of personal hearing, the applicant falled to present any justification regarding to his prolong absence. Perusal of enquiry file reveals that the allegations leveled against the appallant were fully established by the Enquiry Officer during the course of enquiry. Perusal of his service record the appellant found a habitual absentee as he was remained absent from duty on different occasions for a long period of 275 days, which he was awarded different punishments including major punishment of dismissal from service previously. Thus the applicant has been found to be an irresponsible person in utter disregard the discipline of the force. Therefore any leniency or complacency would further embolden the accused officer and impinge upon adversely on the overall discipline and conduct of the force. There doesn't seem any infirmity in the order passed by the competent authority, therefore no ground exist to interfere in same.

Based on the findings narrated above, I, Commandant FRP Khyber Pakhtunkhwa, Peshawar, being the competent authority, has found no substance in

the appeal, therefore, the same is rejected and filed being meritless Order Announced LINA
