



Prayer in Appeal:

On acceptance of this service appeal, the impugned seniority list dated 29/03/2023 issued by the respondents may kindly be declare unlawful, un-constitutional and void-ab-initio and the seniority of the appellant may considered from 01/01/2010 instead of 14/05/2010 and confirmation from 01/01/2012 instead 14/05/2012.

Respectfully Sheweth:

1. That the appellant was appointed on 05/07/1996 as constable in the respondent's department by the competent authority after fulfillment of all procedural and legal formalities later on the appellant verified the Lower College Course and securing first cadet position in the term ending 20/03/2001.
2. That later on the appellant qualified intermediate college course and securing 3rd Cadet Position in

the term ending 20/03/2006 from the Police Training College Hangu.

3. That after that, the appellant applied for recruitment as in service PASI through Public Service Commission vide advertisement No. 1/2005 and then appointed as PASI. **(Copy of notification is attached as Annexure-A)**
4. That on the post of SI, the revise seniority list was issued vide No. 68-CPO-CPB dated 28/02/2022 in which the appellant was not placed on correct number. **(Copy of revise seniority list is attached as Annexure-B)**
5. That now the appellant is DSP Circle Pir Baba, Buner and vide Notification No. 848/CPO. E-I-Seniority List, the seniority list was issued by the respondents in which the appellant is placed as Serial No. 193, inspite of that the other colleague of the appellant were confirmed on 01/01/2012 as SI and the appellant was confirmed as SI 14/05/2012. **(Copies notifications are attached as Annexure-C)**
6. That the appellant seniority is not considered from 01/01/2010 instead of 14/05/2010 and confirmation from 01/01/2012 instead

14/05/2012 which is against the rights of the appellant.

7. That the impugned seniority list dated 29/03/2023, on serial No. 113 namely DSP Zaka Ullah is the colleague of the appellant and he is at Serial No. 26 while the appellant is at Serial No. 22 as per the result of the Public Service Commission. **(Copy of impugned seniority list is attached as Annexure-D)**
8. That the appellant submitted an application for redressal of his grievances but in vain. **(Copy of application is attached as Annexure-E)**
9. hence the appellant feeling aggrieved from the action and inaction of the respondents, approaches this Hon'ble Tribunal inter alia on the following grounds:

GROUND S:

- A. That the impugned actions and inactions of the respondents are illegal, unlawful, without lawful authority and jurisdiction, liable to be struck down.

- B. That in the whole province, the seniority list of any department is prepared according to the result of Public Service Commission while in the case of the appellant, the respondents are not considered the result of the Public Service Commission.
- C. That same nature cases already argued by this Hon'ble Tribunal and also decided in favour of the aggrieved persons.
- D. That the act of the respondents is also violation of the fundamental rights of the appellant.
- E. That due to the act of the respondents, the whole service carrier is now disturbed which cause huge loss to the appellant at the time of further promotion and retirement.
- F. That any other grounds will be raised at the time of arguments with prior permission of this Hon'ble Tribunal.



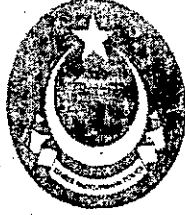


NOTE: - The Seniority list being considered for promotions from the rank of DSsP to SsP is the same one issued vide Order No. 1594/SE-I, dated 05.08.2022 with changes mentioned as under: -

However, in compliance of Order of Hon'ble Supreme Court of Pakistan dated 26.01.2023 in Suo Moto Contempt proceedings vide CrI.O. Petition No. 38/2021 and in pursuance of Judgments passed by Hon'ble Supreme Court of Pakistan in 2013 SCMR 1752, Civil Review Petition No. 193/2003 reported in 2015 SCMR 456, 2016 SCMR 1254, 2017 SCMR 206, 2018 SCMR 1218 and consolidated Judgment dated 30.06.2020 in Civil Petitions No. 1996, 2026, 2431, 2437 to 2450, 2501 and 2502 of 2019 on issues of Out of Turn Promotions, Seniority of DSsP demoted under withdrawal of Out of Turn Promotion Orders has been readjusted in respective ranks in which such DSsP got demoted. Besides, as a result of withdrawal of Out of Turn Promotion Orders, Seniority of few DSsP has been affected within same rank and their seniority has also been readjusted within existing seniority list of DSsP.

Moreover, names of those DSsP who got interim relief from different courts before issuance of withdrawal of Out of Turn Promotion Orders and six (06) DSsP who were repatriated to their parent Provinces/Departments vide Notifications No. CPO/594/E-I, dated 16.03.2023 & No. CPO/719/Legal/E-I, dated 21.03.2023 have not been displaced/removed from existing Seniority list of DSsP as above mentioned Notifications have been suspended as interim relief by High Court Mingora Bench vide Writ Petition No. 1163-P/2023 & Writ Petition No. 1164-P/2023, dated 28.03.2023.

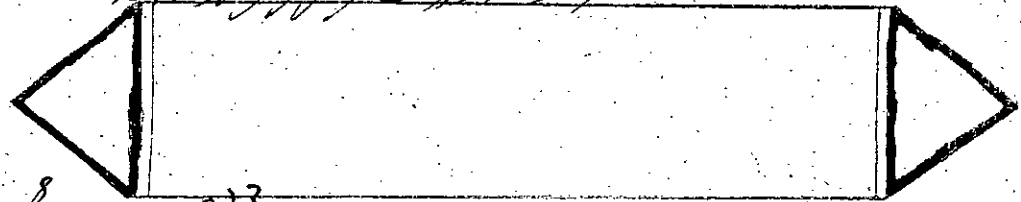
