

3. That the matter involves urgency as appellant has not received salaries for the last 07 months and is running from pillar to the post in this era of high inflation.
4. That since the matter is of urgent nature, therefore, the appellant requests that the service appeal may please be heard at the Principal seat instead of hearing at D.I Khan.

Appeal under section 4 of Service Tribunal Act for inaction of the respondent no 5 to give effect to the appellate order dated 28.02.2023 passed by Director General Health Services KP, order dated 19.05.2023 passed by Director (HRM) Directorate General Health Services KP and orders dated 21st July 2023 & 1st August 2023 passed by Section Officer-III to worthy Secretary Health KP wherein appellant is not adjusted as Chief PHC Technician (MP) (BPS-16) in the Sanitation Unit in the office of DHO D.I Khan and non-release of salary of appellant since February 2023 till date and onwards inspite of promotion & posting order dated 11.11.2022 and adjustment order dated 28.02.2023 and thereafter departmental appeal dated 06.06.2023 for implementation of aforementioned orders remained un-responded even after lapse of 90 days which are illegal against law and facts.

Respected Sir,

Appellant humbly submits as under:

1. That appellant is a permanent resident of District D.I Khan as evident from his CNIC (**Copy of the CNIC of appellant is attached as Annexure A**)
2. That appellant is working in the Health Department.
3. That appellant is promoted from the post of PHC Technician (MP) (BPS-14) to the post of Chief PHC Technician (MP) (BPS-16) vide promotion order dated 11.11.2022 at serial no 290 and posted/retained in the office of DHO D.I Khan at serial no 290 vide the same order (**Copy of the promotion order & posting dated 11.11.2022 is attached as Annexure B**)
4. That in pursuance of the promotion & posting order dated 11.11.2022, appellant submitted arrival report on 11.11.2022 (**Copy of the arrival report dated 11.11.2022 is attached as Annexure C**)
5. That appellant is relieved by the District Health Officer D.I Khan and his services are placed at the disposal of the Directorate Health vide order/letter dated 06.02.2023 (**Copy of the order/letter dated 06.02.2023 is attached as Annexure D**)
6. That the allegations levelled against the appellant in the letter dated 06.02.2023 are illegal and no evidence whatsoever is available to substantiate the said allegations regarding the non-performance of duty by the appellant. The appellant regularly performed duty as evident from attendance register and received remuneration till the passage of the relieving order dated 06.02.2023 (**Copy of the attendance register is attached as Annexure E & Copies of pay slips of September 2022 and October 2022 are attached as Annexure F**)
7. That vide order dated 17.02.2023, the worthy Director General Health Services (respondent no 3) has requested the DHO D.I Khan (respondent no 5) to withdraw the relieving order dated 06.02.2023 (**Copy of the order dated 17.02.2023 is attached as Annexure G**)
8. That vide order dated 28.02.2023, the worthy Director General Health Services KP (respondent no 3) has adjusted the appellant against the vacant post of Chief PHC Technician (MP) (BPS-16) in Sanitation Unit of the office of DHO D.I Khan (**Copy of the order dated 28.02.2023 is attached as Annexure H**)
9. That in pursuance of the order dated 28.02.2023, appellant submitted arrival report & certificate of transfer of charge through registered post receipt (**Copy of the post office receipt along with charge report & certificate of transfer of charge is attached as Annexure I**)
10. That DHO D.I Khan has stopped salary of the appellant since February 2023 till date and onwards which is illegal against law and facts.
11. That vide order dated 19.05.2023, the Director (HRM) Directorate General Health Services KP has directed the DHO D.I Khan (respondent no 5) to implement the order dated 28.02.2023 and

immediately withdraw the relieving order of the appellant and release the salary of the appellant (Copy of the order dated 19.05.2023 is attached as Annexure J)

- 12. That appellant filed departmental appeal dated 06.06.2023 to the Director General Health Services KP for implementation of the aforementioned orders regarding adjustment as Chief PHC Technician (MP) (BPS-16) and release of salary which is diarised vide diary no 5533 which remained un-responded despite lapse of 90 days (Copy of the departmental appeal dated 06.06.2023 is attached as Annexure K)
- 13. That appellant filed another application/appeal to the worthy Secretary Health KP which is diarised vide no diary no 6359 dated 11.07.2023 wherein upon the appeal of the appellant, directions are issued to the DHO D.I Khan vide order dated 21st July 2023 and 1st August 2023 to implement the order of the DG Health and release the salary of the appellant (Copies of the appeal dated 11.07.2023, order dated 21st July 2023 and order dated 1st August 2023 are attached as Annexure L)
- 14. That despite repeated orders of the superiors, the DHO D.I Khan has flouted all the orders of the superiors and blatantly dis-regarded all the orders of his superiors by not giving effect to the same.
- 15. That not giving effect to the promotion & posting order dated 11.11.2022, appellate order dated 28.02.2023 passed by Director General Health Services KP, order dated 19.05.2023 passed by Director (HRM) Directorate General Health Services KP and orders dated 21st July 2023 & 1st August 2023 passed by Section Officer-III to worthy Secretary Health KP are illegal against law and facts on the following grounds:

GROUND:

- A. Because the attitude of the respondent no 5 (DHO D.I Khan) is totally illegal, unwarranted in the facts and circumstances of the case as he is deliberately and intentionally dis-obeying the orders of his superiors i.e worthy Secretary Health KP and DG Health Services.
- B. Because even otherwise, the DHO is bound to obey the orders of his superiors being a matter of service discipline.
- C. Because the dis-obedient attitude and disrespect to the orders of the superiors by the DHO D.I Khan namely Dr Mahmood Jan is falling within the penalties of misconduct described in the rule 3 of the KP Government Servants E&D Rules 2011 and thereafter punishable upto dismissal of services in rule 4 of the rules ibid.
- D. Because the non-implementation of the orders of the superiors is a serious offence under the service law.
- E. Because even non-responding the applications & appeals for implementation of the explicit written orders of the worthy Secretary & DG Health Services within a specific designation and posting upon promotion of the appellant is also illegal and against law.

- F. Because non-payment of salary and non-adjustment in the Sanitation Unit of the office of DHO D.I Khan is a recurring cause of action which is causing loss to the appellant by the end of every month in the shape of salary, perks & privileges despite performance of duty.
- G. Because the DHO D.I Khan (respondent no 5), Head Clerk DHO Office D.I Khan (respondent no 7), Accounts Clerk DHO Office D.I Khan (respondent no 8) are adamant not to implement the aforementioned orders and openly demanding for heavy bribe money for which appellant is not ready being a genuine and lawful order and this act of the respondent no 5, 7 and 8 is by itself an offence under section 5 of the Prevention of Corruption Act 1947. Section 5 of the Act *ibid* is reproduced as under:

5. Criminal misconduct: (1) A public servant is said to commit the offence of criminal misconduct.

- (a) if he accepts or obtains, or agrees to accept or attempts to obtain from any person for himself or for any other person, any gratification (other than legal remuneration) as a motive or reward such as is mentioned in Section 161 of the Pakistan Penal Code, or
- (b) if he accepts or agrees to accept or attempts to obtain for himself or for any other person, any valuable thing without consideration or for a consideration which he knows to be inadequate, from any person whom he knows to have been, or to be, or to be likely to be concerned in any proceeding or business, transacted by him, or having any connection with the official functions of himself or of any public servant to whom he is subordinate, or from any person whom he is subordinate, or from any person whom he knows to be interested in or related to the person so concerned, or
- (c) if he dishonestly or fraudulently misappropriates or otherwise converts for his own use any property entrusted to him or under his control as a public servant or allows any person to do so, or
- (d) if he, by corrupt or illegal means, or by otherwise abusing his position as public servant, obtains for himself or for any other person any valuable thing or pecuniary advantage, or
- (e) If he, or any of his dependants, is in possession, for which the public servant cannot reasonably account of pecuniary resources or of property disproportionate to his known sources of income.

Explanation : In this clause, "dependant" in relation to a public servant, means, his wife, children and step-children, parents , sisters and minor brothers residing with and wholly dependent on him.

(2) Any public servant who commits or attempts to commit criminal misconduct shall be punishable with imprisonment for a term which may extend to seven years or with fine or with both.

- H. Because salary is a guaranteed right of the appellant and non-payment of salary from February 2023 till date and onwards on the part of the DHO D.I Khan namely Dr Mahmood Jan (respondent no 5), District Account Officer D.I Khan (respondent no 6), Head Clerk DHO Office D.I Khan (respondent no 7) and Accounts Clerk DHO

Office D.I Khan (respondent no 8) is a brutal act on their part, especially in the present environment of high inflation.

- I. Because grant of salary is not a bounty but a guaranteed right rather fundamental right as per Article 11 of the Constitution of Pakistan 1973 as well as celebrated judgments of the Honorable Supreme Court of Pakistan. Article 11 is reproduced as under:

"Slavery, forced labour, etc., prohibited

11. (1) Slavery is non-existent and forbidden and no law shall permit or facilitate its introduction into Pakistan in any form."

- J. Because non-payment of salary amounts to slavery which is prohibited by Article 11 of the Constitution of Pakistan 1973.
- K. Because appellant has not been dealt in accordance with law which is his fundamental right as per Article 4 of the Constitution of Pakistan 1973 in the sense that orders of superiors has to be implemented by the DHO concerned and grant of salary is his fundamental right as per law.
- L. Because appellant has been discriminated as all other employees/civil servants promoted are adjusted as per the same promotion order in which appellant is promoted and receiving salaries, perks & privileges whereas appellant is singled out for no good reason which is prohibited as per Article 25 and 27 of the Constitution of Pakistan 1973.

It is therefore humbly prayed that on acceptance of this service appeal,

- I. This Honourable Tribunal may pass a gracious order by giving effect to appellate order dated 28.02.2023 passed by Director General Health Services KP, order dated 19.05.2023 passed by Director (HRM) Directorate General Health Services KP and orders dated 21st July 2023 & 1st August 2023 passed by Section Officer-III to worthy Secretary Health KP by adjusting appellant as Chief PHC Technician (MP) (BPS-16) in the Sanitation Unit of the office of DHO D.I Khan and salary of the appellant may please be released w.e.f February 2023 till date and onwards in pursuance of his promotion & posting order dated 11.11.2022.
- II. Respondent no 2 (i.e worthy Secretary Health KP) and respondent no 3 (i.e worthy Director General Health KP) may please be directed to initiate disciplinary proceedings under KP Government Servant E&D Rules 2011 against respondent no 5 (i.e Dr. Mahmood Jan, District Health Officer D.I Khan), respondent no 7 (i.e Abdul Qudoos, Head Clerk DHO Office D.I Khan) and respondent no 8 (i.e Ghulam Abbas, Accounts Clerks DHO Office D.I Khan for disobeying the appellate orders detailed in the heading of the appeal.
- III. This Honourable Tribunal may be pleased to graciously forward the case to Director Anti Corruption KP for lodging FIR under section 5(2) of the Prevention of Corruption Act 1947 against respondent no 5 (i.e Dr. Mahmood Jan, District Health Officer D.I Khan), respondent no 7 (i.e Abdul Qudoos, Head Clerk DHO Office D.I

Khan) and respondent no 8 (i.e Ghulam Abbas, Accounts Clerks DHO Office D.I Khan for demanding bribe from the appellant for giving effect to lawful orders of his superiors regarding adjustment and release of salary of the appellant.

IV. Any other relief deemed fit in the circumstances of the case and not specifically asked for may also be graciously granted.
