
Appeal under section 4 of Service Tribunal Act against order dated 28/02/2018 (received through own efforts on 15.05.2023) passed by District Education Officer (Female) Mardan and partial promotion order dated 15/05/2023 passed by the District Education Officer (Female) Mardan whereby appellant is promoted to the post of SPST (BPS-14) from the post of PST (BPS-12) w.e.f 29/04/2023 whereas appellant is entitled to be considered for proforma promotion w.e.f 28/02/2018 when vide order dated 28/02/2018 juniors to the appellant were promoted and appellant is ignored for no good reason and thereafter appellant filed departmental appeal dated 03/06/2023 which is dispatched through registered post which remained unresponded after lapse of 90 days which are illegal against law and facts and liable to be set aside.

Respected Sir,

Appellant humbly submits as under:

- That appellant is permanent resident of District Mardan as evident from her CNIC (Copy of the CNIC of appellant is attached as Annexure A)
- 2. That appellant is equipped with qualification such as M.A, B.Ed along with PTC (Copies of the academic documents of appellant are attached as Annexure B)
- 3. That appellant is appointed on contract basis vide appointment order dated 02/01/2003 and posted at GGPS Spin Kai (Copy of the posting order is attached as Annexure C)
- 4. That services of the appellant were regularized as evident from her service book (Copy of the service book is attached as Annexure D)







- 6. That appellant is adjusted at GGPS Kunj Mardan vide order dated 27/10/2008 (Copy of the adjustment order dated 27/10/2008 is attached as Annexure E)
- 7. That as per seniority list, name of appellant is placed at serial no 1366 whereas the below named civil servants are junior to the appellant namely Nagina (at serial no 1368), Nabeela Muzaffar (at serial no 1369), Shagufta (at serial no 1372), Andaleeb (at serial no 1373), Maimoona Aleem (at serial no 1382), Neelum Aman (at serial no 1389), Musarat Jabin (at serial no1391), Ghazala Ambareen (at serial no 1392) and Farhana Naeem (at serial no 1401) (Copy of the seniority list is attached as Annexure F)
- 8. That juniors to the appellant at serial no 146 to 154 of the notification dated 28/03/2018 (received on 15/05/2023 through own efforts of the appellant) namely Nagina (at serial no 1368 of seniority list), Nabeela Muzaffar (at serial no 1369 of seniority list), Shagufta (at serial no 1372 of seniority list), Andaleeb (at serial no 1373 of seniority list), Maimoona Aleem (at serial no 1382 of seniority list), Neelum Aman (at serial no 1389 of seniority list), Musarat Jabin (at serial no1391of seniority list), Ghazala Ambareen (at serial no 1392 of seniority list) and Farhana Naeem (at serial no 1401 of seniority list) are promoted from PST (BPS-12) to SPST (BPS-14) vide notification dated 28/02/2018 (Copy of the notification dated 28/02/2018 is attached as Annexure G)
- 9. That appellant is promoted from PST (BPS-12) to SPST (BPS-14) at serial no 22 w.e.f 29/04/2023 vide notification dated 15/05/2023 (Copy of the notification dated 15/05/2023 is attached as Annexure H)
- 10. That appellant preferred departmental appeal dated 03.06.2023 duly dispatched through registered post which remained unresponded even after lapse of 90 days (Copy of the departmental appeal dated 03.06.2023 along with post office receipt is attached as Annexure I)
- 11. That giving notification dated 15/05/2023 effect from 29/04/2023 instead of 28/02/2018 is illegal against law and facts and liable to be modified on the following grounds:

GROUNDS:

- A. Because appellant is admittedly senior to the officials mentioned in the body of the appeal and is entitled to be considered for promotion along with her batchmates.
- B. Because junior to the appellant have been promoted vide order dated 28/02/2018 from the post of PST (BPS-12) to SPST (BPS-14) whereas appellant is ignored and not considered for promotion which is illegal against law and facts.
- C. Because the officials mentioned above are later entrant in service than the appellant in District Mardan
- D. Because admittedly, appellant is senior to the officials mentioned above.

- E. Because appellant is entitled to be considered for promotion earlier than the said officials/civil servants who are junior to the appellant.
- F. Because as appellant was transferred from Nowshera to Mardan, so she didn't know regarding the promotion order dated 28/02/2018 and came to know regarding the promotion order dated 28/02/2018 on 15/05/2023 when her promotion order was passed.
- G. Because appellant is entitled to be promoted w.e.f 28/02/2018 when her juniors were promoted.
- H. Because there is no reason, much less plausible, as to why appellant has been deprived of promotion vide order dated 28/02/2018.
- Because order dated 28/02/2018 is a void order to the extent of not considering appellant for promotion whereas junior to the appellant were considered for promotion and were promoted.
- J. Because there is no limitation against a void order.
- K. Because void order is a nullity in the eye of law.
- L. Because as per section 8 of the KP Civil Servant Act 1973, the seniority list maintained in the lower post is to be kept intact in higher post even if promotion orders are made later, so on this score alone, appellant is entitled to be placed senior to the said civil servants in the seniority list. In other words, the seniority positions which they were retaining in the lower posts is to be kept intact (Copy of the Civil Servant Act 1973 is attached as Annexure J)
- M. Because appellant is entitled for back benefits of the post of SPST (BPS-14) since 28/02/2018.

It is therefore humbly prayed that on acceptance of this service appeal, impugned office order dated 15/05/2023 passed by District Officer (Female) Mardan may please be modified by giving it effect from 28/02/2018 when juniors to the appellant were promoted, with all back benefits.

It is further prayed that the seniority list of PSTs (BPS-12) may please be maintained in SPSTs (BPS-14) by placing appellant senior to Nagina, Nabeela Muzaffar, Shagufta, Andaleeb, Maimoona Aleem, Neelum Aman, Musarat Jabin, Ghazala Ambareen and Farhana Naeem as per seniority position in the lower post as per Section 8 of the KP Civil Servant Act 1973 in the seniority list for the year 2023 and onwards.

- 4. That services of the appellant were regularized.
- 5. That appellant is transferred from District Nowshera to District Mardan

- 7. That as per seniority list, name of appellant is placed at serial no 1366 whereas the below named civil servants are junior to the appellant namely Nagina (at serial no 1368), Nabeela Muzaffar (at serial no 1369), Shagufta (at serial no 1372), Andaleeb (at serial no 1373), Maimoona Aleem (at serial no 1382), Neelum Aman (at serial no 1389), Musarat Jabin (at serial no1391), Ghazala Ambareen (at serial no 1392) and Farhana Naeem (at serial no 1401) (Copy of the seniority list is attached as Annexure E)
- 8. That juniors to the appellant at serial no 148 to 154 of the notification dated 28/03/2018 (received on 15/05/2023 through own efforts of the appellant) namely Nagina (at serial no 1368 of seniority list), Nabeela Muzaffar (at serial no 1369of seniority list), Shagufta (at serial no 1372 of seniority list), Andaleeb (at serial no 1373 of seniority list), Maimoona Aleem (at serial no 1382 of seniority list), Neelum Aman (at serial no 1389 of seniority list), Musarat Jabin (at serial no1391of seniority list), Ghazala Ambareen (at serial no 1392 of seniority list) and Farhana Naeem (at serial no 1401 of seniority list) are promoted from PST (BPS-12) to SPST (BPS-14) vide notification dated 28/02/2018 (Copy of the notification dated 28/02/2018 is attached as Annexure F)
- 9. That appellant is promoted from PST (BPS-12) to SPST (BPS-14) at serial no 22 w.e.f 29/04/2023 vide notification dated 15/05/2023 (Copy of the notification dated 15/05/2023 is attached as Annexure G)
- 10. That giving notification dated 15/05/2023 effect from 29/04/2023 instead of 28/02/2018 is illegal against law and facts and liable to be modified on the following grounds:

GROUNDS:

- A. Because appellant is admittedly senior to the officials mentioned in the body of the appeal and is entitled to be considered for promotion along with her batchmates.
- B. Because junior to the appellant have been promoted vide order dated 28/02/2018 from the post of PST (BPS-12) to SPST (BPS-14) whereas appellant is ignored and not considered for promotion which is illegal against law and facts.
- C. Because the officials mentioned above are later entrant in service than the appellant in District Mardan
- Because admittedly, appellant is senior to the officials mentioned above.
 - E. Because appellant is entitled to be considered for promotion earlier than the said officials/civil servants who are junior to the appellant.
 - F. Because as appellant was transferred from Nowshera to Mardan, so she didn't know regarding the promotion order dated 28/02/2018 and came to know regarding the promotion order dated 28/02/2018 on 15/05/2023 when her promotion order was passed.

- G. Because appellant is entitled to be promoted w.e.f 28/02/2018 when her juniors were promoted.
- H. Because there is no reason, much less plausible, as to why appellant has been deprived of promotion vide order dated 28/02/2018.
- I. Because order dated 28/02/2018 is a void order to the extent of not considering appellant for promotion whereas junior to the appellant were considered for promotion and were promoted.
- J. Because there is no limitation against a void order.
- K. Because void order is a nullity in the eye of law.
- L. Because as per section 8 of the KP Civil Servant Act 1973, the seniority list maintained in the lower post is to be kept intact in higher post even if promotion orders are made later, so on this score alone, appellant is entitled to be placed senior to the said civil servants in the seniority list. In other words, the seniority positions which they were retaining in the lower posts is to be kept intact (Copy of the Civil Servant Act 1973 is attached as Annexure H)
- M. Because appellant is entitled for back benefits of the post of SPST (BPS-14) since 28/02/2018.

It is therefore humbly prayed that On acceptance of this departmental appeal, impugned office order dated 15/05/2023 passed by District Education Officer (Female) Mardan may please be modified by giving it effect from 28/02/2018 when juniors to the appellant were promoted, with all back benefits.

It is further prayed that the seniority list of PSTs (BPS-12) may please be maintained in SPSTs (BPS-14) by placing appellant senior to Nagina, Nabeela Muzaffar, Shagufta, Andaleeb, Maimoona Aleem, Neelum Aman, Musarat Jabin, Ghazala Ambareen and Farhana Naeem as per seniority position in the lower post as per Section 8 of the KP Civil Servant Act 1973 in the seniority list for the year 2023 and onwards.



> AN ACT

to regulate the appointment of persons to, and the terms and conditions of service of persons in the service of the 4[Khyber Pakhtunkhwa].

WHEREAS it is expedient to regulate by law, the appointment of persons Preamble. to and the terms and conditions of service of person in the service of the 5[Khyber Pakhtunkhwa], and to provide for matters connected therewith or ancillary thereto;

It is hereby enacted as follows:-

- (1) This Act may be called the ⁶[Khyber Pakhtunkhwa] Civil Servants Act, 1973.
- (2) This section and section 25, shall apply to persons employed on contract, or on work charged basis, or who are paid from contingencies, and the remaining provisions of this Act including this section, shall apply to all civil servants wherever they may be.

CHAPTER —II.

TERMS AND CONDITIONS OF SERVICE OF SERVANTS.

The terms and conditions of service of a civil servant shall be as provided in this Act and the rules.

Every civil servant shall hold office during the pleasure of the Governor. 4.

Tenure of office of civil servants.

Appointments to a civil service of the Province or to a civil post in Appointment. connection with affairs of the Province shall be made in the prescribed manner by the Governor or by a person authorized by the Governor in that behalf.

An initial appointment to a service or post referred to in section 5, Probation. not being an ad hoc appointment, shall be on probation as may be prescribed.

- Any appointment of a civil servant by promotion or transfer to a service or post may also be made on probation as may be prescribed.
- Where, in respect of any service or post, the satisfactory completion of probation includes the passing of a prescribed examination test or course or successful completion of any training, a person appointed on probation to such service or post who, before the expiry of the original or extended period of his probation has failed to pass such examination or test or to successfully complete course or the training shall, except as may be prescribed otherwise.
 - if he was appointed to such service or post by initial recruitment be discharged; or
 - (b) if he was appointed to such service or post by promotion or transfer, be reverted to the service or post from which he was promoted or transferred and against which he holds a lien or, if there be no such service or post, be discharged:

Provided that in the case of initial appointment to a service or post a civil servant shall not be deemed to have completed his period of probation satisfactorily

until his character and antecedents have been verified as satisfactory in the opinion of the appointing authority.

A person appointed on probation shall on satisfactory completion of Confirmation. his probation, be eligible for confirmation in a service or, as the case may be, a post as may be prescribed.

 - There shall be no confirmation against any temporary post.

- Confirmation of civil servant in a service or post shall take effect from the date of occurrence of permanent vacancy in that service or post or from the date of continuous officiation, in such service or post, whichever is later.
- For proper administration of a service, cadre or ²[post] the Seniority. appointing authority shall cause a seniority list of the members for the time being of such service cadre or ³[post] to be prepared but nothing herein contained shall be construed to confer any vested right to a particular seniority in such service, cadre or ⁴[post] as the case may be.

- Subject to the provisions of sub-section (1), the seniority of a civil servant shall be reckoned in relation to other civil servants belonging to the same service or ⁵[cadre] whether serving in the same department or office or not, as may be prescribed.

A civil servant shall be allowed leave in accordance with the leave rule Leave. 18. applicable to him; provided that the grant of leave will depend on the exigencies of service and be at the discretion of the competent authority.

³[19. Pension and gratuity.—(1) On retirement from service, a civil servant, appointed on regular basis in the prescribed manner, before the commencement of the Khyber Pakhtunkhwa Civil Servants (Amendment) Act, 2022, shall be entitled to receive such pension or gratuity, as are admissible to him under the pension rules for the time being in force:

Provided that in the event of death of such a civil servant as provided in this sub-section, whether before or after retirement, his family shall be entitled to receive such pension or gratuity or both, as admissible under the said rules.

(2) A person to be appointed on regular basis to a service or post in the prescribed manner, on or after the commencement of the Khyber Pakhtunkhwa Civil Servants (Amendment) Act, 2022 shall, for all intents and purpose, be civil servant except for the purpose of pension and gratuity. Such a civil servant shall, in lieu of pension and gratuity, be entitled to receive such amount contributed by him towards the Contributory Provident Fund along with the contributions, made by Government to his account in the said Fund, in the prescribed manner:

Provided that in the event of death of such a civil servant as provided in this sub-section, whether before or after retirement, his family shall be entitled to receive the amount of Contributory Provident Fund, if it has already not been received by such deceased civil servant.

(3) No pension to a civil servant who is otherwise entitled under subsection (1) shall be admissible to him, if he is dismissed or removed from service for reasons of discipline but Government may sanction compassionate allowance to such civil servant, not exceeding two-third of the person or graduity which would have been admissible to him, had he been invalidated from service on the date of such dismissal or removal:

Provided that a civil servant, referred to in sub-section (2), in case of such dismissal or removal, may, in addition to his own contributions to the Contributory Provident Fund, be allowed, on account of such compassionate allowance, a sum not exceeding two-third of Government contributions in his account.

- (4) If the determination of the amount of pension or gratuity, admissible to a civil servant as specified in sub-section (1), is delayed beyond one month of the date of his retirement or death, he or his family, as the case may be, shall be paid provisionally such anticipatory pension or gratuity, as may be determined by the prescribed authority, according to the length of service of the civil servant which qualifies for pension or gratuity, and any over payment, on such provisional payment, shall be adjusted against the amount of pension or gratuity, finally determined as payable to such civil servant or his family.]
- 20. (1) Before the expiry of the third month of every financial year, the Accounts Officer or other officer required to maintain provident fund accounts shall furnish to every civil servant subscribing to a provident fund the account of which he is required to including the interest accruing thereon, if any and withdrawals or advances from, his provident fund during the preceding financial year.

(2) Where any subscription made by a civil servant to his provident fund has not been shown credited in the account by the Accounts Officer or other

officer required to maintain such account such subscription shall be credited to the account of the civil servant on the basis of such evidence as may be prescribed.

All civil servants and their families shall be entitled to the benefits admissible under the West Pakistan Government Employments Welfare Fund Ordinance, 1969 (W.P. Ord I of 1969) or the ¹[Khyber Pakhtunkhwa] Government Servants Benevolent Fund Ordinance, 1972 ²[Khyber Pakhtunkhwa] Ord. VII of 1972), and the rules made thereunder.

Benevolent Fund and Group Insurances.

Where a right to prefer an appeal or apply for review in respect of Right of any order relating to the terms and conditions of his service is provided to a civil servant under any rules applicable to him, such appeal or application shall, except as may be otherwise prescribed be made within thirty days of the date of such order.

appeal or: representation.

Where no provisions for appeal or review exists under the rules in respect of any order or class of orders, a civil servant aggrieved by any such order may within thirty days of the communication to him of such order make a representation against it to the authority next above the authority which made the order:

Provided that no representation shall lie on matters relating to the determination of fitness of a person to hold a particular post or to be promoted to a higher post or grade.

CHAPTER-III. MISCELLANEOUS.

Nothing in this Act or in any rule shall be construed to limit or abridge the Saving. power of the Governor to deal with the case of any civil servant in such manner as may appear to him to be just and equitable:

Provided that where this Act or any rule is applicable to the case of a civil servant the case shall not be dealt with in any manner less favourale to him than that provided by this Act or such rule.

³[23A. Indemnity.— No suit, prosecution or other legal proceedings shall lie against a civil servant for anything done or intended to be done in good faith in his official capacity under this Act or the rules, instructions or direction made or issued thereunder.

Tribunal Act, 1974 (Khyber Pakhtunkhwa Act No.I of 1974), or the rules made thereunder, no order made or proceedings taken under this Act, or the rules made threunder by the Governor or any officer authorised by him shall be called in question in any court and no injunction shall be granted by any court in respect of any decision made, or proceedings taken in pursuance of any power conferred by or under this Act or the rules made thereunder.]

If any difficulty arises in giving effect to any of the provisions of this Act, the Governor may make such order, not inconsistent with the provisions of this Act, as may appear to him to be necessary for the purpose of removing the difficulty:

Removal of difficulties.

Provided that no such power shall be exercised after the expiry of one year from the coming into force of this Act.

The Governor or any person authorized by the Governor in that behalf may, on such terms and conditions as he may specify in each case, appoint persons on contract basis, or on work charged basis or who are paid out of contingencies:

Appointment of persons on contract, etc.

Provided that all such employees who were working in any such capacity immediately before the commencement of this Act shall continue to be so employed on the same terms and conditions on which they were appointed.

The Governor or any person authorized by the Governor in this Rules. 26. behalf, may make such rules as appear to him to be necessary or expedient for carrying out the purposes of this Act.

- Any rules, orders or instructions in respect of any terms and conditions of service of civil servants duly made or issued by an authority competent to make them and in force immediately before the commencement of this Act shall, in so far as such rules, orders or instructions are not inconstant with the provisions of this Act be deemed to be rules made under this Act.
