ASIDE BUT ILLEGAL, MALAFIDE AND
DISCRIMINATORY ORDER FOR INTERVENING
PERIOD SINCE 14-11-2022 TO 5-7-2023 IS TREATED AS
EXTROORDINARY LEAVE (LEAVE WITHOUT PAY) etc.

That the brief facts of the case are as under:

1. That the appellant was serving as PST at GPS Ilyas Khaizai Darazinda. The inquiry was conducted against habitually absent teacher and recommended

for compulsory retirement of appellant due to six days of absence from school reported by monitoring staff. Copy off minutes of meeting and table of absence staff are Annexure A and B.

2. That feeling aggrieved, the appellant filed departmental appeal against the his compulsory retirement from service to respondent No.1 who void order dated 22-3-2023 nominated Muhammad Illyas District Education Officer Lucky Marwat as inquiry officer to probe the matter and submit his report with clear recommendation within 10 days. Copy of Notification Dated 22-3-2023 is annexure C.

3. The inquiry officer conducted inquiry and submit his report with recommendation to reinstate the petitioner. The respondent No.1 vide Letter dated 20-6-2023 directed the respondent No.2 for submission of his report. Copy of letters is Annexure D.

4. That on 8-8-2023 is come to the knowledge of appellant that one of his colleague whose name is also mentioned in inquiry report, was reinstated into service so appellant filed another application for acceptance of his appeal on the basis of inquiry report. On 17-08-2023. The appellant received the order of acceptance of appeal vide notification dated 11-07-2023 via what Sapp. Copies Of Notification dated 11-7-2023 and application along with postal recite are Annexure E and F.

5. That feeling aggrieved from the notification dated 11-07-2023 to the extent of intervening period since 14-11-2022 to 5-07-2023 is treated as extraordinary leave (Leave without Pay) etc, appellant is constrained to approaches this honorable court on the following amongst other:


GROUND S;

1. That the appellant is not treated in accordance with law and the actions of the respondents are malafide besides being discriminatory and harsh to the extent of intervening period since 14-11-2022 to 5-07-2023 is treated as extraordinary leave (Leave without Pay) etc.
2. That it is evident from the minutes of meeting of district steering committee recommended for compulsory retirement of 12 teacher of different schools but most of them are reinstated after acceptance of appeal w.e.f the date of compulsory retirement with all back benefits but the appellant was treated discriminatory to the extent of treating intervening period since 14-11-2022 to 5-07-2023 as extraordinary leave (Leave without Pay) etc. Copy of order Dated 1-03-2023 in Annexure G.
3. It is also evident from inquiry report and letter 20-06-2023, the respondent No.1 directed the Respondent No.2 for such illegal action against appellant for compulsory retirement so due to the fault attributed to respondent no.2, the appellant could not be penalized.
4. That the petitioner was charged for six days absence from duty while dilsoz Khan and other were charge for 10 days absence from duty by the monitoring data but they were reinstated with all back benefits and appellant was treated discriminatory by the respondent No.1.

In view of the above, It is, therefore, most respectfully prayed that on acceptance this appeal this honorable court may please to declare of Notification Dated 11-07-2023 to the extent of intervening period since 14-11-2022 to 5-07-2023 is treated as extraordinary leave (Leave without Pay) etc, is illegal, void, Discriminatory, without lawful authority and of no legal effect


