**APPEAL UNDER SECTION 4 OF THE KPK SERVICES TRIBUNAL ACT, 1974,**

**PRAYER**

On acceptance of this appeal by declaring the impugned office act/order of official concerned, as illegal, without jurisdiction, and without law full authority and based on malafide and the appellant be promoted to junior clerk (bps-11) wef 25.03.2023 with all back benefits.  
Any other relief deemed appropriate in the given circumstances may also be granted to the appellant in the large interest of justice.

**Note:** Addresses given above shall suffice the object of service. All necessary and proper parties have been arrayed in the panel of respondents.

***Respectfully Sheweth;***

Appellant humbly submits and request as under:-

1. That the appellant was appointed on 16.03.2017 in the education Department as Naib Qasid (Class-IV). Copies of CNIC & Appointment Order of appellant enclosed as Annexure A & B.
2. That on 08.12.2021 the department published the seniority list of class-IV employees for promotion, wherein appellant is placed at Sr. No. 136 having qualification BSc. Copy of Notification dated 08.12.2021 enclosed as Annexure C.
3. That on 14.03.2023 the competent authority constituted a committee to scrutinize the documents on 18.03.2023, for promotion/ appointment of Class-IV to junior clerk (BPS-11) under 40% quota (Promotion of class-IV). Copy of Notification dated 14.03.2023 enclosed as Annexure D.

4. That the appellant appeared before the said committee on the day fixed and they scrutinized the documents of appellant.
5. That vide office order Endst. No. 5435-45 dated 25.03.2023 (1) Aman Ullah Khan (2) Javed Iqbal (3) S, Niaz Hussain Shah (4) Inayat Ullah were prompted to Junior Clerk (BPS-11) from class-IV against said quota, without publishing any result/decision/recommendation of said committee. Thereafter on 04.05.2023 vide office order No. 8380-87 one Mr. Syed Muhammad Ubaid Ullah Shah (Class-IV) was promoted to Junior Clerk (BPS-11) against Said quota. Copies of officer orders dated 25.03.2023 & 04.05.2023 enclosed as Annexure E & F.
6. That in the meanwhile on Mr. Ahsan Ali (Class-IV) who is/was placed on Sr. No. 143 of said seniority list (junior to appellant) was promoted to Junior Clerk (BPS-11) against said quota in the month of April/May 2023 through confidential promotion order, and their after transferred as J.C from GHS Raghasir DIK to GGHS Wanda Moazam DIK vide order No. 2936-38 dated 08.05.2023. Copy of office order dated 08.05.2023 enclosed as Annexure G.
7. That despite the fact that appellant serving the department from 16.03.2017 with the qualification BSC the appellant was denied from the promotion / up gradation as Junior Clerk (BPS-11) without any lawful justification thus discriminated as against the law, rules and constitutional provision besides right to get their dully and lawfully rights.
8. That the appellant in due course sought his dully earned promotion by moving applications since 2017 with concerned authority however, could not get any response by authority.
9. That it is settled law, when impugned Act or Action has been protected by a Constitutional Provision by ouster clause, the superior Courts still have the jurisdiction to interfere with 03 categories of the cases, namely, without jurisdiction, Coram non judice and mala fides.
10. That Feeling aggrieved from the act/ order(s) mentioned above, the appellant preferred departmental appeal to respondent No.2/ Director Education Department Elementary and Secondary Education, KPK, Peshawar being appellate authority on 09.06.2023. Copy of departmental appeal enclosed as Annexure-H.
11. That refusal of the departmental appeal of the appellant, the appellant impugned the same by way of instant appeal, on inter alia the following grounds:-

2017  
**GROUNDS: -**

- A. That the acts omission on the part of concerned officials are inconsistent with provisions of constitution as for the right appellant concern, acts/omission of authority are not sustainable in law, being contrary and conflicting to the policy, rules and directive of the government on the subject, hence are liable to be set at naught.
- B. That the appellant as of right is entitled to be treated at park with rest of the similarly placed employees and thus is equally within his rights of promotion, as

have accrued due in lieu of his duty/qualification/seniority and course of employment.


- C. That department/official concerned cannot legally deny the appellant his entitlement to promotion and also benefits having accrued to him in due course of employment.
- D. That the impugned acts and omission on the part of the department /official concerned are vividly extraneously motivated, aimed at harming, victimizing and discriminating the petitioner at the cost of good order of public service, thus are ultra-constitutional and need to be declared as such.
- E. That the impugned acts of official concerned are against law and facts because the petitioner served the department since 2017 with qualification BSC and confidential promotion of Mr. Ahsan Ali ( junior to Appellant) from class-IV to Junior Clerk (BPS-11) shows the mala fide on the part of official concerned. Moreover, the impugned acts of official concerned are against the service rules, hence, on this sole ground, the impugned act/order is liable to be set aside.
- F. That act of the official concerned is without jurisdiction based on mala fide hence liable to be declares as null and void by your kind chair.
- G. That Counsel for the appellant may please be allowed to raise additional grounds during the course of arguments.

It is, therefore, respectfully prayed that on acceptance of this appeal by declaring the impugned office act/order of official concerned, as illegal, without jurisdiction, and without law full authority and based on malafide and the appellant be promoted to junior clerk (bps-11) wef 25.03.2023 with all back benefits.


Any other relief deemed appropriate in the given circumstances may also be granted to the appellant in the large interest of justice.







Respected Sir,

Appellant humbly submits as under,

1. That the appellant was appointed on 16.03.2017 in the education Department as Naib Qasid (Class-IV).
2. That on 08.11.2021 the department published the seniority list of class-IV employees for promotion, wherein appellant is placed at Sr. No. 136 having qualification BSC.
3. That on 14.03.2023 the competent authority constitutes a committee to scrutinize the documents on 18.03.2023, for promotion/ appointment of Class-IV to junior clerk (BPS-11) under 40% quota (Promotion of class-IV).
4. That the appellant appeared before the said committee on the day fixed and they scrutinized the documents of appellant.
5. That vide office order Endst. No. 5435-45 dated 25.03.2023 (1) Aman Ullah Khan (2) Javed Iqbal (3) S, Niaz Hussain Shah (4) Inayat Ullah was prompted to Junior Clerk (BPS-11) from class-IV against said quota, without publishing any result/decision/recommendation of said committee. Thereafter on 04.05.2023 vide office order No. 8380-87 one Mr. Syed Muhammad Ubaid Ullah Shah (Class-IV) was promoted to Junior Clerk (BPS-11) against Said quota.
6. That in the meanwhile on Mr. Ahsan Ali (Class-IV) who is/was placed on Sr. No. 143 of said seniority list (junior to appellant) was promoted to Junior Clerk (BPS-11) against said quota in the month of April/May 2023 through confidential promotion order, and their after transferred as J.C from GHS Raghasir DIK to GGHS Wanda Moazam DIK vide order No. 2936-38 dated 08.05.2023.
7. That despite the fact that appellant serving the department from 16.03.2017 with the qualification BSC the appellant was denied from the promotion / up gradation as Junior Clerk (BPS-11) without any lawful justification thus discriminated as against the law, rules and constitutional provision besides right to get their dully and lawfully rights.
8. That the appellant in due course sought his dully earned promotion by moving applications since 2017 with concerned authority however, could not get any response by authority.

9. That failing to get any relief, as above said and having no other remedy available to him, the appellant being aggrieved from the above mentioned acts and omissions the part of department/ authority instant appeal is being filed with this kind chair seeking its indulgence, requesting to graciously issue appropriate order to the concerned officials, as prayed for, on inter-alia, the following grounds. *filed*

GROUNDS: -

- A. That the acts omission on the part of concerned officials are inconsistent with provisions of constitution as for the right appellant concern, acts/omission of authority are not sustainable in law, being contrary and conflicting to the policy, rules and directive of the government on the subject, hence are liable to be set at naught.
- B. That the appellant as of right is entitled to be treated at par with rest of the similarly placed employees and thus is equally within his rights of promotion, as have accrued due in lieu of his duty/qualification/seniority and course of employment.
- C. That department/official concerned cannot legally deny the appellant his entitlement to promotion and also benefits having accrued to him in due course of employment.
- D. That the impugned acts and omission on the part of the department /official concerned are vividly extraneously motivated, aimed at harming, victimizing and discriminating the petitioner at the cost of good order of public service, thus are ultra-constitutional and need to be declared as such.
- E. That the impugned acts of official concerned are against law and facts because the petitioner served the department since 2017 with qualification BSC and confidential promotion of Mr. Ahsan Ali (junior to Appellant) from class-IV to Junior Clerk (BPS-11) shows the mala fide on the part of official concerned. Moreover, the impugned acts of official concerned are against the service rules, hence, on this sole ground, the impugned act/order is liable to be set aside.
- F. That act of the official concerned is without jurisdiction based on mala fide hence liable to be declared as null and void by your kind chair.

IT IS, THEREFORE, RESPECTFULLY PRAYED THAT ON ACCEPTANCE OF INSTANT DEPARTMENTAL APPEAL/REPRESENTATION BY DECLARING THE IMPUGNED OFFICE ACT/ORDER OF OFFICIAL CONCERNED, AS ILLEGAL, WITHOUT JURISDICTION, AND WITHOUT LAW FULL AUTHORITY AND BASED ON MALAFIDE. AND THE APPELLANT BE PROMOTED TO JUNIOR CLERK (BPS-11) WEF 25.03.2023 WITH ALL BACK BENEFITS.
