PRELIMINARY OBJECTIONS.

1. That the Appellant has got no cause of action.

2. That the Appeal is not maintainable under the law.

3. That the Appeal is barred by law & limitation.

4. That the Appellant has not been discriminated in any way.

5. That the Appeal is bad due to mis-joinder and non-joinder of necessary parties.

6. That the Appellant has approached the Honorable Tribunal with unclean hands.

7. That the Appellant has got no cause of action and locus-standi to file the instant Appeal.


8. That the Appellant has been estopped by his own conduct.

ON FACTS:

- 1. Pertain to record.
- 2. Incorrect, during course of inspection by DSP Rural- II. It was found that the appellant was absent from his official duty and it was also established that a private cook was hired by the appellant and he himself was doing private business instead of performing his official duty therefore proper departmental action was taken against the appellant in which appellant was Removed from Service accordingly.
- 3. Pertain to record.
- 4. Incorrect, after through perusal of record, facts and figure, it was found that the appellant has hired a private person for cooking in PS Kakki therefore, the appellant authority i.e W/RPO reject its appeal and endorsed the punishment of dismissal awarded by DPO. Bannu. Every step taken against appellant was in accordance with law.
- 5. Incorrect.

ON GROUNDS:

- **A.** Incorrect, both the orders issued by competent authority are not against law, facts and natural Justice.
- **B.** Incorrect, both the orders are not against principle of service law. All codal formalities were adopted and nothing was done beyond law.
- C. Incorrect, proper charge sheet and statement of allegations were issued and the impugned orders are not liable to be set aside. (Annexure A & B is annexed)
- **D.** Incorrect, show cause notice was issued according to Police Rules 1975. Every opportunity of defense was given to the appellant but his reply was found un-Plausible. It is pertinent to mention here that, the appellant was dealt with in Police summary proceedings provided in KP Police rules, 1975 (with amendment 2014).
- E. Incorrect, the actions of respondents are not unlawfully, illegal and biased.
- F. Incorrect, proper legal procedure was adopted and nothing was done un lawful.
- G. Incorrect, opportunity of personal hearing was given but his reply was unsatisfactory and all proceedings were carried out according to law/rules.





- H. Incorrect, the whole proceedings was carried out according to Police Rules 1975.
- I. Incorrect, proper show cause notice was issued, the appellant was heard in person but his reply was found un-plausible and convincible therefore, the order of dismissal was issued.
- J. Incorrect, such acts of the appellant, being a member of decipline force cannot be tolerated and the appellant at this form cannot be liable to reinstate him with all back benefits.

The respondents department seeks permission of this Honorable Tribunal for further/additional grounds at the time of arguments.

ORDER:

This order will dispose of departmental appeal, preferred by Ex-Cook Constable lisan Ullah No.53 of District Pol ce Bannu, wherein he has prayed for setting aside the order of major punishment of "Dismissal rom service", imposed upon him by DPO Bannu under Police Rule 1975 (As amended vide Gevt: of Khyber Pakhtu ikhwa Gazette Notification of even No. dated 27th of August 2014) vide OB No.73 dated 10.01.2023 for committing the following misconduct:-

That the appellant hired a private person for cooking in his place, while the appellant himself running private business.

Comments, service record, punishment order were received from DPO Bannu vide his office letter No.973/SRC, dated 21.02.2023 and perused in detail. The DPO Bannu has reported that the appellant was issued Show Cause Notice but his reply was found unsatisfactory. The appellant being habitual absentee, his further reten ion in service would be detrimental and burden over the shoulder of the Department. In the current situation of terrorism, his absence has put other officials of the concerned Police Station at rick. Therefore the appellant was awarded major punishment of dismissal from service vide OB No 73 dated 19.01.2023.

He was also heard in person during orderly room held in RPO Office Bannu on 06.04.2023. Perusal of his service record reveals his tented reputation, and problematic for police department. During argue, he admitted that one "Tabida: Uncle" has been performing his duties as Cook in P.S Kaki. He cheated his superiors by tacking full pay from the government and hiring a private person for performing duties in his place @ of Rs:8000/- per month while he himself was running a private business. He had recruited an "Iwazi" to perform duties at his place while he himself was doing private business. The introduction of this dirty culture is extremely dangerous in police department and cannot be allowed to go unchecked.

Therefore, I, Syed Ashfaq Anwar. PSP/Regional Police Officer. Bannu Region Bannu, in exercise of the powers vested in me under Khyber Pakhtunkhwa Police Rules. 1975 (amended in 2014) hereby reject h s appeal and endorse he punishment awarded to him by DPO Bannu vide O.B No. 73 dated 19.01.2023.
