Respectfully Sheweth,

Preliminary Objection.-

- 1. That the appellant appeal has no- locus standi/cause of action to file instant appeal.
- 2. That the instant appeal is based on mala fide intention.
- 3. That the appellant has not approached this Honorable tribunal with clean hands.
- 4. That the appellant has suppressing the original facts from this Honorable tribunal had not entitled for any relief.
- 5. That the appeal is hopelessly time barred.
- 6. That the appellant is treated as per rules and law and policy, therefore appellant is not entitled for any relief and hence appeal is liable to be dismissed without further proceeding.
- 7. That the appellant played game with the govt, public functionaries and gave huge loss to the govt exchequer through illegal means of litigation.moreover he gained benefits in the way of salary he is not entitled for any arrears of non-performance period.
- 8. That the instant appeal is not maintainable in its present form.
- 9. That the instant appeal is against the law / service rules,hence not maintainable in the eye of law and liable to dismissed.
- 10. That the appellant has filed the present appeal out of law.petitioner neither file departmental appeal nor annexed postal receipt, hence appeal may kindly be struck down.

Factus Objection:-

- 1. That para No 1 of the Service appeal is incorrect subject to proof, hence denied, In pursuance of competent authority respondent No 3/DEO (Female) Abbottabad issue Notification for the nomination of Inquiry officer i.e Principal GGHS No.2 and Vice Principal GGHS Nawanshere regarding absent period of appellant, Assumption of charge and recovery of salaries on the strength of respondent No 7 vide notification Endst No: 05-8 Dated 01-01-2015, Responded No 3 issued show cause notice to the appellant vide dated 25-04-2015 along with copy of show cause sent to the Head Mistress GGMS Ali Abad vide latter No: 7033 Dated 28-04-2015 appellant received and reply show cause submitted on 13-05-2015. Personal hearing was conducted vide latter no: 8383/EB-II Dated 18-05-2015, during personal hearing appellant made" Admission " regarding absent period, illegal salary drawn vide dated 21-05-2015, in the light of admission made by the appellant " deposit salary to the extent of one lack out of Rs. 499147,after conclusion of Proceeding inquiry officer submitted the inquiry report with the recommendations 1 to 7vide dated 07/02/2015. (copy of showcause notice dated 25/04/2015 and 28/04/2015/, reply dated 13/05/2015/personal hearing 18/05/2015 / admission ,deposit of salary receipt(arrears)21/05 2015 /inquiry report dated 07/02/2015 are annexed as annexues "A""B""C" "D" "E and "F")
- 2. That para No 2 of the service appeal is incorrect ,subject to prove,hence denied.while respondent No 3 sent the letter regarding verification of service/appointment record of appellant to the respondent No 7/DEO (M)Kohistanvide letter No 10758 dated 01/01/2020,reply of respondent No 7/DEO(M) Kohistan received with the observation that no such service record /appointment order of appellant was available in both the offices vide letter endst No 6486 dated 8/2/2020 in the above circumstances respondent No 3/DEO(F)ATD issued notification for nomination of inquiry officer Mst Khoula javed V.Principal GGHCSS Atd regarding (verification of service record/appointment order of appellant vide notification No 1581 Dated 05/03/2020, personal hearing was conducted by the inquiry officer vide letter No 4153 dated 30/06/2020 of respondent No 3,questionair was served to the appellant vide dated 02/07/2020 in the light of available records,previous inquiries inquiry officer submitted the report with findings that no record was found in verification vide inquiry report No 504 dated 08/06/2020. (copy of verification letter dated 01/01/2020/ received letter from Kohistan dated 08/02/2020/ nomination of inquiry officer letter dated 05/03/2020/ personal hearing letter dated 30/06/2020/ questionair letter dated 02/07/2020 and inquiry report dated 08/06/2020 are annexed as annexures "G"H"I"J"K and "L)
- 3. That para No 3 of the Sevice appeal is incorrect, subject to prove, hence denied detailed reply have already been given in para No 1 ans 2 as mentioned above.
- 4. That para No 4 of the service appeal as composed is incorrect, subject to prove, hence denied, in the light of departmental appeal of appellant submitted to respondent No 1 for adjustment other than Distt Abbottabad vide appeal no 245/EB-II Dated 18/1/2016, respondent No 1 called comments/detailed report from the respondent No 3 vide letter No 3361/F No:362(F) Appeal, a. abad dated 15/12/2017. respondent No 3 submitted comments/detailed reply vide No 245 dated 18/1/2016 respondent No 1 further probe the matter and issued notification for the nomination of inquiry officer Mr Riaz swati/DEO(F) Torghar vide notification No 2472-79 dated 15/02/2018. later on respondent No 1 issued another notification for nomination of inquiry officer Mr Shehzad Principal GHS Shankiari (mansehra) regarding assumption of charge/without

respondent No 3, reply of questionair vide No 6363 dated 28/08/2018. Inquiry officer after conclusion of inquiry submitted report to respondent No 1 (with one or other observation) that the appellant may be adjusted in her domicile district (mansehra) vide letter No 2863 dated 4/9/2018 along with one report dated 22/4/2018. respondent No 6/DEO(F) Mansehra refuse to adjust the appellant in her domicile district vide letter No 52/98 dated 14/03/2019 (copy of departmental appeal dated 18/01.2016/letter for comments/detailed report dated 15/12/2017/ comments/detailed reply dated 18/01/2016/ nomination of inquiry officer dated 15/02/2018/another letter of nomination inquiry officer dated 10/04/2018/reply of questionair dated 28/08/2018/letter for submission of inquiry report dated 04/09/2018/inquiry report dated 22/04/2018/letter of DEO (F) Mansehra dated 14/03/2019 are annexex as annexure "M"N"O"P"Q"R"S and "T")

- 5. That para No 5 of the service appeal as compared is incorrect, hence denied, detailed reply have already been given in Para 4 of the factual objections in the comments.
- 6. That para No 6 of the Service appeal as composed is incorrect, hence denied detailed reply have already been given in Para 4 of the factual objection of the comments.
- 7. That para No 7 of the Service appeal as composed is incorrect, hence denied detailed reply have already been given in para 2 of the factual objection of comments.
- 8. .That para No 8 of the Service appeal as composed is incorrect, hence denied., while respondent No 1 directed the respondent No 3 in the light of departmental appeal of appellant to implement / adjustment against the vacant post of DM vide letter No 1284 dated 17/09/2018. Respondent No 3 sent the letter to respondent No 1 in the light of departmental appeal of appellant and comments/report of respondentNo 3 should adjust in district mansehra vide letter No 8496 dated 01/12/2018, while respondent No 5 suggested for adjustment of appellant in DEO(F)ATD instead of DEO(F)Mansehra vide letter no 5198 dated 14/03/2019, respondent No 1 called comments/detailed report from respondent No 5 vide letter No 2819 dated 11/04/2019, respondent No 3 submitted detailed report/comments before the respondent No 1 vide letter NO 3724-25 dated 02/05/2019 in the light of reply of respondent No 1 directed the respondent No 3 with complete record vide letter No 1289 dated 17/10/2019, respondent No 3 issued the letter to the local office for provision of complete record of service from/pay stop/ pay roll of salary and deposit of one lac deposit receipt in R/O illegal recovery of appellant vide letter No 9036 dated 26/10/2019, in the light of above circumstances respondent No 1 issued the notification with further direction vidr notification No 5122-25 dated 12/12/2019, furthermore respondent no 1 issued the letter to respondent 3 for detailed comments vide letter No 4541-42 dated 01/09/2021. detailed comments/ report was submitted before the respondent no 1 vide letter No 1000 dated 03/11/2021, respondent No 1 passed the order and issued strict decision under the rule & policy vide letter No 6731 dated 17/12.2021, respondent No 1 issued order that

in passuance of respondent No 1 order sent a letter to respondent No 7 vide letter No 1854 dated

24/02/2022. (copy of letter of respondent No 1 for adjustment dated 17/09/2018/letter of

DEO (F)Abbottabd, dated 01/12/2018/letter of DEO (F) Mansehra dated 14/03/2019/ call comments

That the para No 9 of the Service appeal as composed is incorrect, hence denied.respondent No 3 in pursuance of previous orders of respondent No 1 passed the final order regarding "least intrest for adjustment her order is thus infrectuous and may be considered null and void vide notification No 5219-20 dated 10/08/2020, while appellant prefer departmental appeal to respondent No 1 vide dated 27/07/2021 which is hopelessly time barred. further detail is in para 8 of the factual objection of the comments.

(Copy of final notification dated 10/08/2020/departmental appeal dated 27/07/2021 are annexed as annexure "gg" and "hh"

10. That the para 10 of the Service appeal is incorrect subject to prove ,hence denied,detailed reply have already been mentiond as above.

Grounds

- a. That para (a) of the grounds is incorrect, subject to prove ,hence denied appellant enter and got the benefit from the back door and did not follow the rule, regulation policy on the subject hence does not entitled for benefits, law doesn't support ill will ,deprive the appellant may kindly be struck down
- that para (b) of the ground as composed is incorrect, hence denied, more so in the light of Para and 2 and 8 of the factual objection inference of said final order is more much clear rather interpretation of instant ground of appellant thus the appeal of the appellant may kindly be struck down.
- c. That para (c) of the grounds as composed is incorrect ,hence denied,para 1,2,,4 and 8 of factual objection of comments are much more clear ,inference draw by the appellant is illegal,against the law and fact,hence the appeal of the appellant may kindly be struck down.

- That the para (d) of the ground as composed is incorrect, hence denied, more than 1 official were terminated of the illegal act of appellant, many had been faced several inquiries, many of authorities have refused to adjust the appellant due to the illegal act and their consequences of the appellant furthermore loss the exchequer of govt with her illegal act and thus the appeal of the appellant may kindly be struck down.
- e. That the para (e) of the grounds as composed is incorrect,hence denied,more so the appellant have use political as well as public pressure, which is clear from the official records, therefore appeal in hand is not mentionable hernce may kindly be struck down.
- f. That para (f) of the ground as composed is incorrect, hence denied, more so almost all the inquires appellant received the show cause notice, Replies the same and also give proper opportunity of personal hearing in the result of admission made by the appellant therefore Principal of "Audi alteram preterm" is not applicable in the instant case thus appeal in hand may kindly he struck down.
- g. That para (g) of the ground as compassed is incorrect, hence denied, appellant—herself use nepotism therefore service record/ appointment—order is the result / outcome of nepotism against the law and fact hence appeal in hand is not mentionable due to time barred under the limitation act hence appeal may kindly be struck down.

That the other point shall be agitated at the time of arguments by the permission of honorable tribunal .



It is therefore humbly prayed that the instant appeal may kindly be dismissed with cost.

I hope that being female and only earning hand and I will be provided justice.



Mst Faiza Musharraf was transferred to GGMS Ali Abad from Distt. Caption of Enquiry: Kohistan, through inter district transfer but failed to join her duty with in stipulated time. **Enquiry Committee:** Mst Farhat Bashir Principal GGHS No.2 Atd and Mr. Abdur Rashid V/P GHSS Nawan Shehr vide notification issued under Endst No. 05-8 dated 01-01-2015 by DEO(F) Atd. TOR's Willful absence from duty / not resumption of charge of the post properly. Drawal of pay from Govt, treasury for not being at the strength of DEO(F) Abbottabad. Procedure: For the puropose probing into the TORs, the enquiry committee served the questionnaire to-I/C GGMS Ali Abad, Mst. Saceda Bibi. 2. Dy DEO(F) the DDO also, Miss Abida Shaheen. The accused teacher Mst Faiza Mushariaf DM and also persued the record as under: Service Book of the accused. First appointment order, change of Cadre order, and transfer (Inter Distt) order. Cash Book, Pay print for the month of April, May, June 2013, Arear drawn from 01-09-2012 to 31-3-2013. Following documents were demanded from the Office of DEO(F) but could not be provided: 1. NOC accorded to the accused and availability of post. 2. Copy of pay print wef. 07/2013 to 09/2013. 3. Statement of count r/o accused. Copies of change form(Source). Total amount Paid/drawn from Govt. Treasury in term of the pay of the accused wef 01-09-2012 to 31-12-2014. Brief History: Mst Faiza Musharraf is permanent resident of Distt. Mansehra Tehsil Balakot as per domicile. But in her service book her permanent address has been found recorded as Bairkund Mansehra and she is close relative of Ex. EDO Kohistan Mr. Mukhtiar Khan Swati. She was appointed as PST without having certificate of PTC in Distt. Kohistan in 2009. Her Cadre was changed from PST to DM(BPS-9 to 12). Both the orders were passed by Mukhtiar Khan as EDO Kohistan. On 27-07-2012 with the help of the same officer she was posted at GGMS Ali Abad through inter district transfer by Director E&SE Peshawar. The record of NOC for availability of post is not available in the office of DEO(F) Abbottabad. She bitterly failed to comply with the order and did not resume her charge at GGMS Ali Abad Abbottabad. For the first time she appeared on scene in the month of Jan 2013 when she approached to I/C school at home during winter

vocation for resumption of charge but I/C School refused to hand over charge for being too late and brought the matter into the notice of DEO(F) Office. In this way her transfer order became infructuous automatically. Office sources revealed that Mr. Mukhtiar Khan has been visiting DEO(F) office and found sitting with Ex-Dealing Clerk M. Shafique. A bogus charge report was prepared, perhaps in the

month of April 2013 and sent it to DAO for activation of her pay. But DAO raised objection on change of Cadre. DDO Abida Shaheen recorded a certificate in the S/Book of the teacher regarding the change of Cadre from PST to DM under her signature. After compulsory retirement of Mr. Shafique D/A and shifting of DDO ship to DEO(F) Samina Iltaf, the matter was disclosed.

Fact/Findings:

The situation was analyzed, the record, questionnaires and service record of the teacher were minutely perused. The enquiry reached to the following facts:

1. Basically, her appointment as PST and later on change of

Cadre are doubtful and illegal.

- 2. Her transfer from Distt. Kohistan to Distt. Abbottabad is malafide for the reason that she was appointed in Distt. Kohistan through low merit /illegal means to serve in said Distt. whereas for appointment in Distt Abbottabad needs very high merit and tough competition, Secondly she belonged to Distt. Mansehra not Distt. Abbottabad and thirdly the record of NOC for availability of post is not available in DEO(F) and no body is ready to shoulder the responsibility thereof. She is liability for Distt: Abbottabad.
- 3. She did not resumed her charge with in stipulated time and her transfer order had become infructuous when she made effort for charge with delay of about 6 months. It is further added that she was relieved from Distt: Kohistan on 29-08-2012 wef 31-08-2012 but she tried to get the charge of the post in Distt: Abbottabad wef 02-08-2012 i-e retrospective date as mentioned on the body of so called called charge report. It is clear cut forgery case.

4. Drawal of her pay wef. 01-09-2012 and upgradation from BPS-09 to 15 is illegal and responsibility therof rests on the shoulder of dealing hand and concerned DDO as valid record of handling over charge is not available in paper and in her

service book.

5. It is astonishing to observe that her pay was activated on 15-04-2013 as her record of sevice book, by DAO but drawn manually in the months of April, May and June 2013 and embezzled as it was neither paid to concerned nor recorded in Cash Book.

6. Arrear of the pay of the teacher was drawn wef. 01-09-2012 to 31-03-2013 (07) month Rs. 117487/= but neither paid to the teacher nor recorded in Cash Book and bungled by the

dealing hands.

7. Rs. 42354/= found recorded in S/Book with receipt by the teacher concerned but she totally denies the receipt, it is fake entry which was not to be made in S/Book otherwise the amount has been embezzled.

8. Record of pay wef 01-07-2013 to 31-10-2013 is not available anywhere in the office of DEO(F). It is assumed that pay of these three months have also been drawn and embezzled.

9. In the month of Sep 2013, Dy DEO Mst Abida Shaheen was transferred to Distt. Haripur. It is noteworthy that just after one month of her transfer the pay of the teacher was drawn through pay print and sent to her bank account.

10. The teacher confessed that she, for the first time received her

pay wef 01-11-2013 to 12/2014. She was ignorant of the amount drawn as her salary wef 01-09-2012 to 31-10-2013. It means that her pay was drawn through illegal means wef 01-09-2012 to 31-10-2013 that was not paid to her and embezzled by Dealing hands and DDO herself.

11. The teacher as well as DDO are ready to refund the salary drawn from Govt. treasury without handing/taking over charge to the teacher in Distt Abbottabad(Questionnaire).

- 12. All this happened due to the incompetence of the DDO Mst Abida Shaheen who is occupying very responsible position but not ready to shoulder the responsibility, thereof. She has failed to provide cogent reasons about the charge of the teachers and drawl of her illegally and unlawfully and shifting the responsibility to the dealing hands and the teachers concerned.
- 13. The DDO is of the opinion that the teacher has unlawfully drawn the pay, she forgets that no individual employee can draw her pay by herself. It is DDO who draws/disburse the salary observing the coddle formalities. She, as DDO, bitterly failed to do her job demanded by her position. She shares equal responsibility with dealing hands. Furthermore, her reply of questionnaire is not satisfactory and relevant to the questions asked (Copy annexed)

Recommendations:

1. The teacher has not taken over charge in Distt. Abbottabad. Her transfer order has become infructuous, she may not be considered on the strength of DEO(F) Abbottabad, and be sent back to Distt Kohistan for disciplinary proceeding.

 The salary of the teacher drawn wcf 01-09-2012 to 31-10-2013 be recovered from dealing hand Mr. M.Shafique and

DDO Mst Abida Shaheen to the Govt treasury.

3. Salary drawn wef 01-11-2013 to 31-12-2014 be recovered from the teacher concerned to the Govt. treasury.

4. Manually drawn pay and arrears during the DDO ship of Mst Abida Shaheen and M. Shafique as dealing clerk should be investigated and reconciled from the recipients to make sure the payment to the concerned.

5. Mr. Shafique, the dealing clerk should be dismissed from service without any benefit rather to make him proceed on compulsory retirement. His case should be referred to anticorruption department for legal proceedings.

6. It is not a single case of corruption and embezzlement, there is chain of corrupt practices being carried on making the DEO(F) office, a bargain centre, the matter should be brought into the notice of Director E&SE and Secretary E&SE KPK for necessary measures/steps while posting/transferring the officers against such a important positions.

7. The appointments made in Distt: Kohistan are mostly through bargaining/out of merit and without having proper educational qualifications, should be restricted to the Distt: concerned. All the teachers appointed at PST/CT/DM/TT/Qari/AT etc, the Distt: Cadres, appointed in Distt: Kohistan. And posted/transferred to Distt: Abbottabad should be sent back to their respective Distt, on the strength of which they got their appointments. They are liabilities for Distt: Abbottabad and should be disposed off. The

opportunity should given to candidates nighly qualified, waiting for appointment from Distt: Abbottabad against the vacant post on merit in the best interest of generation to come. As it is commor business to get employment in Distt: Kohistan and later on neek transfer to the other Districts vacating the in Distt: Kohistan for further business. This is illegal practice and should be stopped.

And whereas, the DEO (F) Dassu (Upper) Kohistan regretted provision of the official record pertaining to the case as the same was claimed to be non-available/non-existing in his office and also doubted the genuineness of her appointment as PST and change of cadre to DM.

And whereas, the Appellate Authority after having considered the appeal of Faiza Musharraf, the inquiry report, the reports and point of views of the DEOs (F) Abbottabad and Dassu (Upper) Kohistan is of the view that the case may be remanded back to the DEO (F) Abbottabad for proper fact-finding inquiry being the competent authority. :

Now, therefore, the Appellate Authority the Director Elementary and Secondary Education Khyber Pakhtunkhwa places Mst. Faiza Musharraf back at the disposal of the DEO (F) Abbottabad with the following further directions:

a. The authenticity as to the genuineness of the service record, her appointment as PST and then change of cadre to DM may be verified and determined from the DEO (F) Dassu (Upper) Kohistan through a formal inquiry and proceed accordingly



If proved bogus she may be reported to law-enforcing agencies and all the salaries drawn fraudulently be recovered from her.

c. If proved genuine then she may be proceeded against under the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 for non-reporting/non-performance of duty while regularly and fraudulently drawing salaries from 01/9/2012 to 30/11/2014.


