**APPEAL UNDER SECTION 4 OF THE SERVICE TRIBUNAL ACTS, 1974, AGAINST ILLEGAL STOPPAGE OF SALARY, AND AGAINST NOT DECIDING DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN STATUTORY PERIOD OF 90 DAYS.**

**PRAYER:**

**THAT ON ACCEPTANCE OF THIS APPEAL, THE RESPONDENT MAY BE DIRECTED TO RELEASE THE SALARY OF THE APPELLANT WITH ALL BACK BENIFITS. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT**

**RESPECTFULLY SUBMITTED:**

**FACTS:**

1. That the appellant was appointed as Junior Clerk against the vacant post vide order dated 20.04.2017 on proper recommendation of departmental selection committee under deceased son Quota and posted at GHS Amir Muhammad wali. The appellant properly submitted his charge report/Arrival report and medical fitness certificate. **(Copy of appointment order and medical certificate is attached as Annexure-A)**
2. That the appellant has performed his duties assigned to him with zeal and devotion and there was no complaint, what so ever regarding his performance. **Copy of attendance register is attached as annexure-B.**
3. That the appellant performing his duties till September 2020 and suddenly the salary of the appellant has been stopped, when the appellant inquire about the stoppage of salary the clerk verbally told him the inquiry was constituted against the appellant but neither the inquiry nor the suspension order if any was communicated to the appellant, which is against the law, against which appellant filed departmental appeal which was not responded within statutory period of 90 days . **(copy departmental appeal is attached as Annexure-C.)**
4. Hence the appellant constrained to file the instant service appeal on the following grounds amongst others.

**GROUND:**

- A. That the verbal order and stoppage of salary are against the law, facts, norms of justice, and material on record, therefore not tenable and liable to be set aside.
- B. That the whole proceeding conducted by the respondent department is against the law and rules.
- C. That the appellant has been condemned unheard and has not been treated according to law and rules.



- D. That neither charge sheet, statement of allegation, show cause notice was served upon the appellant nor inquiry was conducted against the appellant, which was necessary and mandatory in law before taking adverse action which is violation of law, rules and norms of justice.
- E. That the appellant has not been treated under proper law despite he was a civil servant of the province, therefore, the impugned order is liable to be set aside on this score alone.
- F. That not paying the monthly salaries to the appellant despite that the appellant was on the strength and performed his duty, actually amounts to an arbitrary act on the part of the respondents which is not tenable in the eyes of law.
- G. That the appellant has not been treated according to law and rules and has been deprived from the monthly salaries despite proper performance of duty, thus the action of the respondents is totally illegal and without lawful authority.
- H. That being a civil servant, the appellant is entitled to the salaries of the post in accordance with Section-17 of the Civil Servant Act, 1973.
- I. That according to superior court judgment the department cannot upheld the salary of the appellant for indefinite period.
- J. That the appellant has been condemned unheard and no prior chance of defenses or hearing was provided to the appellant while stopping his monthly salaries.
- K. That the stoppage of salary for such a long period without any sufficient reason is illegal against the law and natural justice.
- L. That the appellant has been condemned unheard in violation of Article 10-A of the Constitution of Islamic republic of Pakistan and in violation of maxim "Audi Alterum Partum" and has not been treated according to law and rules. That according to reported judgment cited as *2019 CLC 1750* stated that Audi Alterum Partum" shall be read as part and parcel of the every statute. The same principle held in the Superior Court judgments cited as *2016 SCMR 943, 2010 SCMR 1554 and 2020 PLC(cs) 67.*

4

M. That the appellant have not been treated in accordance with law hence the appellant right secured and guaranteed under the law are badly violated.

N. That the charges leveled against the appellant were never proved in the enquiry, the enquiry officer gave his findings on surmises and conjectures.

O. That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for

**PRAYER:**

**THAT ON ACCEPTANCE OF THIS APPEAL, RELEASE THE SALARY OF THE APPELLANT W.EFROM SEPTEMBER 2020 WITH ALL BACK BENIFITS.**

**RESPECTFULLY SUBMITTED:**

**FACTS:**

1. That the appellant was appointed as Junior Clerk against the vacant post vide order dated 20.04.2017 on proper recommendation of departmental selection committee under deceased son Quota and posted at GHS Amir Muhammad wali. The appellant properly submitted his charge report/Arrival report and medical fitness certificate.(Copy of appointment order and medical certificate is attached as Annexure-A).
2. That the appellant has performed his duties assigned to him with zeal and devotion and there was no complaint, what so ever regarding his performance. Copy of attendance register is attached as annexure-B.



3. That the appellant performing his duties till September 2020 and suddenly the salary of the appellant has been stopped, when the appellant inquire about the stoppage of salary the clerk verbally told him the inquiry was constituted against the appellant but neither the inquiry nor the suspension order if any was communicated to the appellant, which is against the law.
4. Hence feeling aggrieved appellant now filling this departmental on the following grounds amongst others .

**GROUND:**

- A. That the stoppage of salary are against the law, facts, norms of justice, and material on record, therefore not tenable and liable to be set aside.
- B. That the whole proceeding conducted by the respondent department is against the law and rules.
- C. That the appellant has been condemned unheard and has not been treated according to law and rules.
- D. That the appellant have not been treated in accordance with law hence the appellant right secured and guaranteed under the law are badly violated.
- E. That the stoppage of salary for such a long period without any sufficient reason is illegal against the law and natural justice
- F. That not paying monthly salaries to the appellant despite that the appellant was on the strength and performed his duties, actually

amounts to an arbitrary act on the part of the respondents which is not tenable in the eyes of law.

- G. That the appellant has not been treated according to law and rules and has been deprived from the monthly salaries despite proper performance of duty, thus the action of the respondents is totally illegal and without lawful authority.
- H. That being a civil servant, the appellant is entitled to the salaries of the post in accordance with Section-17 of the Civil Servant Act, 1973.
- I. That according to superior court judgment the department cannot uphold the salary of the appellant for indefinite period.
- J. That the appellant has been condemned unheard and no prior chance of defenses or hearing was provided to the appellant while stopping his monthly salaries.
- K. That the stoppage of salary for such a long period without any sufficient reason is illegal against the law and natural justice.
- L. That the appellant has been condemned unheard in violation of Article 10-A of the Constitution of Islamic republic of Pakistan and in violation of maxim "Audi Alterum Partum" and has not been treated according to law and rules. That according to reported judgment cited as *2019 CLC 1750* stated that "Audi Alterum Partum" shall be read as part and parcel of the every statute. The same principle held in the Superior Court judgments cited as *2016 SCMR 943, 2010 SCMR 1554 and 2020 PLC(cs) 67.*
- M. That the appellant have not been treated in accordance with law hence the appellant right secured and guaranteed under the law are badly violated.
