SERVICE APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICES TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED NOTIFICATION DATED 06.01.2023 WHEREBY THE APPELLANT IS PROMOTED TO THE POST OF PHC TECHNOLOGIST (BPS-17) WITH IMMEDIATE EFFECT AND NOT W-E-F 24.08.2021 WHEN JUNIORS TO THE APPELLANT HAS BEEN PROMOTED, AGAINST THE IMPUGNED SERVICE RULES NOTIFIED ON 04.11.2020 TO THE EXTENT OF NOTE IN COLUMN NO. 5 WHEREBY SENIORITY OF CLINICAL TECHNOLOGIST AND PHC TECHNOLOGIST (BPS-17) HAS BEEN COMBINED FOR PROMOTION TO THE POST SENIOR TECHNOLOGIST (BPS-18) AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINTY DAYS.

PRAYER:-

That on acceptance of the instant service appeal the impugned notification dated 06.01.2023 may very kindly be modified to the extent that the appellant may be promoted w-e-f 24.08.2021 with all back benefits including seniority and the service rules notified on 04.11.2020 may very kindly be modified to the extent that note in column No. 5 be expunge from it. Any other remedy which this august Tribunal deems fit that may also be awarded in favour of the appellant.

Respectfully Sheweth:

1. That appellant being a qualified for Technician was appointed as Lady Health Visitor (BPS-09) in the respondent department vide

order dated 31.10.2010. Copy of the diplomas and appointment order are attached as Annexure**A&B.**

2. That during service the appellant improved her education and obtained Master of Public Administration from a recognized university the year 2018. Copy of the degree is attached as annexure**C.**
3. That it is pertinent to mention here that on the basis of improved qualification the appellant along with other were consider by the Departmental promotion committee for promotion to the post of PHC Technologist (MCH) (BPS-17) in 2021 however surprisingly vide the impugned notification dated 06.01.2023 the appellant was promoted with immediate effect and junior to the appellant were promoted w-e-f 24.08.2021 thereby making them seniors to the appellant. That in response to the promotion notification the appellant was posted/ adjusted vide notification dated 29.03.2023 Copies of the notification dated 06.01.2023, posting notification dated 29.03.2023 and office order dated 30.03.2023 along with seniority list are attached as annexure**D, E & F.**
4. That the services rules infield since 10.05.2016 were amended vide impugned notification dated 04.11.2020 whereby a note was inserted in column No. 5 of maintain joint seniority list of Clinical Technologist and PHC Technologist for promotion to the post of Senior Clinical Technologist and Senior PHC Technologist (BPs-18) which is detrimental to the seniority and promotion. Copy of the services rules are attached as annexure**G.**
5. That it is worth mentioning that there are 20 number of posts of senior PHC Technologist (MCH) (BPS-18) are laying vacant. Copy of the vacancy breakup are attached as annexure**H.**
6. That the appellant feeling aggrieved from the impugned notification of promotion and service rules, preferred departmental appeal. Copy of the departmental appeal is attached as Annexure**I.**
7. That appellant feeling highly aggrieved and having no other remedy but to file the instant service appeal on the grounds inter alia.

GROUND S:

- A- That the impugned notification dated 06.01.2023 whereby the appellant is promoted to the post of PHC Technologist (BPS-17) with immediate effect and not w-e-f 24.08.2021 when juniors to the appellant has been promoted and the impugned service rules notified on 04.11.2020 to the extent of note in column no. 5 whereby seniority of Clinical Technologist and PHC Technologist (BPS-17) has been combined for promotion to the post Senior Technologist (BPS-18) are against the law, facts, norms of natural justice and materials on the record.

- B- That the appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondents acted in arbitrary and mala fide manner by not promoting the appellant w-e-f 24.08.2021 when juniors to the appellant has been promoted with all back benefits including seniority by violating Section 8 of the Khyber Pakhtunkhwa Service Act 1973, read with Rule 17 of the Khyber Pakhtunkhwa (Appointment, Promotion & Transfer) Rules 1989.
- D- That according to Article 38 (e) of the Constitution of Islamic Republic of Pakistan, 1973 the state is bound to reduce disparity in the income and earning of individuals including persons in the services of the federation, therefore in light of the said Article the appellant is fully entitled for promotion at par with her colleagues.
- E- That the appellant has been discriminated on the subject noted above and as such the respondents violated the principle of natural justice.
- F- That by not allowing antedated promotion to the appellant from the date when he was supposed to be promoted is also violative of Section 9 of the Khyber Pakhtunkhwa Service Act 1973, read with Rule 7 of the Khyber Pakhtunkhwa (Appointment, Promotion & Transfer) Rules 1989.
- G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that the instant service appeal may kindly be accepted as prayed for.





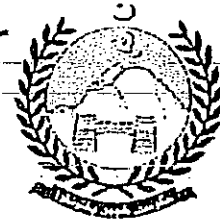

That the services rules in field since 10.05.2016 were amended vide impugned notification dated 04.11.2020 whereby a note was inserted in column No. 5 of maintain joint seniority list of Clinical Technologist and PHC Technologist for promotion to the post of Senior Clinical Technologist and Senior PHC Technologist (BPs-18) which is detrimental to the seniority and promotion

That it is worth mentioning that there are 20 number of posts of senior PHC Technologist (MCH) (BPS-18) are laying vacant.

That the appellant feeling aggrieved and having no other remedy preferred this departmental appeal.

It is therefore, most humbly prayed that on acceptance of the instant appeal the impugned notification dated 06.01.2023 may very kindly be modified to the extent that the appellant may be promoted w-e-f 24.08.2021 with all back benefits including seniority and the service rules notified on 04.11.2020 may very kindly be modified to the extent that note in column No. 5 be expunge from it.
