



APPEAL UNDER SECTION 4 OF THE KPK SERVICES TRIBUNAL ACT, 1974 BY DIRECTING THE RESPONDENTS TO ASSIGN/ADJUST THE APPELLANT IN ANY SCHOOL AS PER APPOINTMENT ORDER AND ALSO RELEASE THE SALARIES OF APPELLANT WITH ALL BACK BENEFITS.

PRAYER

On acceptance of this appeal, the respondents may graciously be directed to assign the duty to the appellant and also issue the salaries with all back benefits which are illegally stopped by the respondents.

Note: Addresses given above shall suffice the object of service. All necessary and proper parties have been arrayed in the panel of respondents.

Respectfully Sheweth;


1. That the appellant is law abiding citizen of Pakistan and is enjoying well reputation in the society. Copy of the CNIC of petitioner is annexed as **Annexure-A**.
2. That the appellant was appointed as Chowkidar in the Education Department Dera Ismail Khan vide office order No. 304-8 dated 06/10/2003 after observing all the legal requirements. Copy of appointment order is annexed as **Annexure-B**.
3. That thereafter the appellant submitted charge report in GGPS Baddar Tehsil Kulachi and performed his duties with full satisfaction of his superiors, in this respect service record is evident. Copies of service record are annexed as **Annexure-C**.
4. That during service, the appellant transferred so many times in different schools of the District and lastly transferred at GGPS Garra Alam and performed his duty but the respondents appointed another person against the post of appellant and when appellant tried to perform his duties in the said school the newly appointed chowkidar restrained the appellant from performing the duties. The appellant approached the respondent #3 for redressal of his grievance but the respondent #3 in spite of redressal of grievance of appellant, stopped the salaries of appellant without any lawful justification. Copy of the application DEO (F) Dera Ismail Khan is annexed as **Annexure-D**.
5. That meanwhile a young son of appellant was passed away in a road accident and the appellant remained in shock/Trauma

due to sudden death of his young son and remained unable to approach the respondents.

6. That Feeling aggrieved from the above mentioned illegal behaviour of the respondent#3, the appellant preferred departmental appeal to respondent No.2/Director E&S Education KPK being appellate authority on 28/03/2023. Copy of departmental appeal is annexed herewith as **Annexure-E**.
7. That up-till now no response has been shown from the respondents and after the laps of statutory limitation of departmental appeal, cause of action has been accrued to the appellant for the instant appeal, Hence the instant service appeal.
8. That jurisdiction of this worthy service tribunal is being invoked in attending circumstances against the illegal acts of respondents, inter alia on the following grounds amongst others;

GROUND S

- a. That the act of the respondents and indecision of appellant's departmental appeal is illegal, against services Law and rules, without jurisdiction, in violation of the precedents of Honourable apex courts of the country and is not justifiable for any reason whatsoever.
 - b. The act/refusal/omission on the part of respondents is not grounded in reason nor does it smack of sensible or saner approach.
 - c. That the appellant was appointed in the Education Department after fulfilling all the legal procedure and performed his duties with great zeal and zest but the respondents illegally stopped the salaries of appellant

since August 2017 and also not assigning the duty to the appellant which act of respondents is against law and service rules.

- d. That the service of appellant is sole source of income of the appellant and due to stoppage of salaries the appellant is suffering from financial crises and the education of appellant's children is also discontinued due to illegal behaviour of respondents.
- e. That appellant being citizen of Pakistan deserves to be dealt in accordance with law and the treatment meted out to him is in violation of Article 4 of our Constitution.
- f. That this Honourable Tribunal has got vast and ample powers to accept the instant appeal.
- g. That counsel for appellant may kindly be allowed to raise additional ground at the time of arguments.

It is thus most respectfully prayed that on acceptance of this appeal, this worthy Tribunal may graciously be pleased to direct the respondents to assign/adjust the service of appellant and also release the salaries of appellant with all back benefits.

Any other relief deemed appropriate in circumstances of the case may also be allowed in favour of appellants as against respondents with costs.



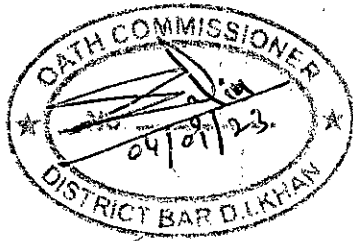

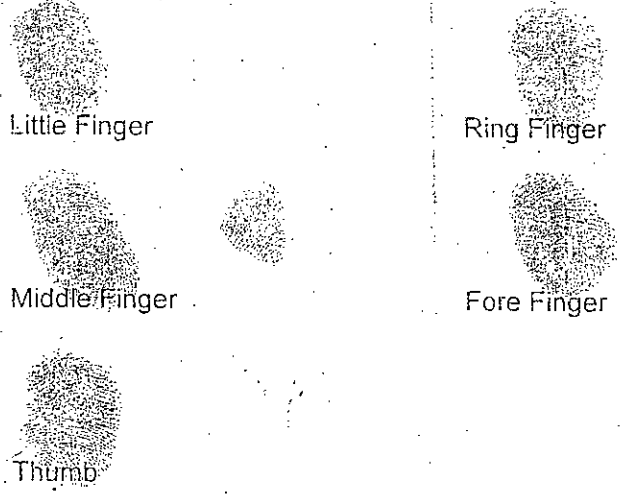
