

**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED NOTIFICATION DATED 22.05.2023 WHEREBY JUNIORS TO THE APPELLANT HAVE BEEN PROMOTED TO THE POST OF SST (Maths/Phy) (BPS-16) WHILE THE APPELLANT HAS BEEN IGNORED FROM THE SAME INSPITE OF HAVING SENIORITY AND ELIGIBILITY AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.**

**PRAYER:**

That on acceptance of this appeal the impugned Notification dated 22.05.2023 may very kindly be rectified/modified and be promoted the appellant to the post of SST (Maths/Phy) with all consequential benefits. Any other relief which this august Tribunal deems fit that may also be awarded in favor of the appellant.

**R/SHEWETH:**

**ON FACTS:**

*Brief facts giving rise to the present appeal are as under:-*

- 1- That the appellant was initially inducted in the respondent Department as PST (BPS-07 now BPS-12) vide order dated 02.12.1992. That after appointment the appellant took over the charge against the said post and started performing his duty quite efficiently and upto the entire satisfaction of his superiors. Copies of the appointment order and educational testimonials are attached as annexure.....A & B.

- 2- That during service the appellant was promoted to the post of CT (BPS-15) vide Notification dated 25.08.2016 and since then the appellant is performing his duties against the same post with all zeal and zest. Copy of the Notification dated 25.08.2016 is attached as annexure.....C.
- 3- That the appellant is the senior most employee of respondent department and having the seniority position at serial No.25 of the seniority list of Certified Teachers in District Nowshera. Copy of the Seniority list is attached as annexure.....D.
- 4- That it is pertinent to mention that the respondent Department issued impugned promotion Notification dated 22.05.2023 whereby many junior colleagues of the appellant have been promoted to the post of SST (Maths/Phy) while the appellant has been ignored from the same benefit of promotion without any reason and lawful justification. Copy of the impugned Notification dated 22.05.2023 is attached as annexure.....E.
- 5- That being a senior most and having eligibility the appellant was quite hopeful for his promotion to the post of SST (Maths/Phy:) but the respondent department intentionally ignored the appellant from his due right of promotion.
- 6- That feeling aggrieved from the impugned Notification dated 22.05.2023 the appellant preferred departmental appeal before the appellate authority but no reply has been received so far. Hence the present appeal on the following grounds amongst the others. Copy of the Departmental appeal is attached as annexure.....F.

**GROUND:**

- A- That the impugned Notification dated 22.05.2023 by ignoring the appellant from promotion to the post of SST (Maths/Phy) is against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be rectified/modified to the extent of promotion of appellant.
- B- That the appellant has not been treated by the respondent department in accordance with law and rules on the subject noted above and as such the respondents violated Article-4, 25 and 27 of the Constitution of Islamic Republic of Pakistan, 1973.
- C- That inspite of having seniority and eligibility for promotion to the post of SST (Maths/Phy) the respondent department ignored the appellant from promotion without any reason and lawful justification and as such promoted colleagues and junior colleagues of the appellant to the said post.

- D- That the appellant is fully entitle for promotion to the post of SST (Maths/Phy) w.e.f 22.05.2023 while the respondent department ignored the appellant and promoted his juniors colleagues which is discriminatory in nature, therefore, the same is liable to be rectified/modified to the extent of promotion of the appellant.
- E- That the impugned Notification dated 22.05.2023 is violative of the Principle of natural justice, hence the same is liable to be rectified/modified.
- F- That by not promoting the appellant to the post of SST (Maths/Phy) is clear violation of Section-9 of the Civil Servant Act, 1973 read with Rule-7 of the Civil Servant Appointment, Promotion and Transfer Rules, 1989.
- G- That the appellant is the senior most employee of Education Department and has served the department for more than 30 years, therefore, the appellant having the due right of promotion to the post of SST (Maths/Phy) w.e.f 22.05.2023 when his junior colleagues were promoted.
- H- That the impugned Notification is violative of Article-38(e) of the Constitution of Islamic Republic of Pakistan, 1973.

It is, therefore, most humbly prayed that the appeal of the appellant may very kindly be accepted as prayed for.

APPOINTMENT OF PTC TRAINED TEACHERS.

A-5

The following PTC trained candidates are hereby appointed as PTC teachers on Rs:1095/-PM in BPS NO:7 of Rs:1095-60-1995 plus usual allowances as admissible under the rules with effect from the date of their taking over charge in the school noted against their names under the following terms and conditions:-

CONDITIONS.

1. Charge reports in duplicate should be submitted to all concerned.
2. No joining time is allowed except what is absolutely necessary for transit.
3. No TA/DA is allowed being First appointment.
4. The appointment is purely to temporary basis and subject to the termination at any time without assigning any reasons and prior notice.  
In case they wishes to leave the post they shall have to submit one month's prior notice in lieu there of one months pay will be forfeited to the Government of NWFP. Their Educational qualifications should be checked before the handing over the charge of the post.
5. They should produce their health and Age certificate from the Civil Surgeon concerned within Seven days of reporting arrival for duty as required under the rules (F.R.10 S.R.4).
6. In case the candidate fails to take over the charge within 10 days from the date of issue of this letter their appointment will stand cancelled automatically.
7. The verification rule of character and antecedent should be obtained from the candidate concerned on the prescribed form and submit to this office for further verification and record.
8. The candidate should be not be handed over the charge if their ages does not between 18.25 years.
9. They should execute necessary security bond in case they are required to handle Govt:money or property.
10. The pay scale and Service Rules would be subject to revision in accordance with orders to be passed by the Govt:NWFP from time to time.

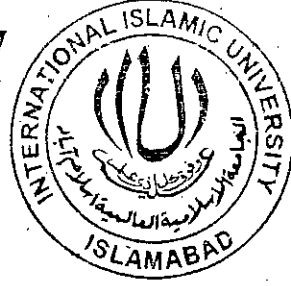

**Terms & Conditions:**

1. They will be on probation for a period of one year extendable for another one year.
2. They will be governed by such rules and regulation as may be issued from time to time by the Government.
3. Their services can be terminated at any time; in case their performance is found unsatisfactory during probation period. In case of misconduct, they shall be proceeded under the rules framed from time to time.
4. The Principals / Head Master / Drawing & Disbursing Officers should check their original documents (Academic Professional) before handing over charge.
5. The Principals / Head Masters / Drawing & Disbursing Officers are required to submit their necessary documents for verification to District Education Officer (Male), Nowshera along with original payee receipt.
6. The Principals / Head Masters / Drawing & Disbursing Officers should not release their pay in BPS-15 until and unless their necessary documents are verified from the Universities concerned. During the verification process, if any Degree / Certificate is found fake / bogus, their promotion shall stand cancelled.
7. The District Education Officer (Male), Nowshera will issue Clearance Certificate after the verification process.
8. Charge Report should be submitted to all concerned.
9. Their Inter-Se-Seniority on lower post will remain intact.
10. No TA / DA is allowed for joining their new post.
11. They will give an undertaking to be recorded in their Service Books to the effect that if any overpayment is made them in light of this order will be recovered and if anyone is wrongly promoted he shall be reversed.


