SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICES TRIBUNAL ACT, 1974, READ WITH ALL ENABLING PROVISIONS OF LAW, GOVERNING THE SUBJECT, AGAINST OFFICE ORDER NO.S/1478-88/2023, DATED: 31.05.2023 OF RESPONDENT NO.3, VIDE WHICH APPELLANT HAS BEEN AWARDED MAJOR PENALTY OF DISMISSAL FROM SERVICE.

PRAYER-IN-APPEAL:

On acceptance of instant appeal, impugned order dated: 31.05.2023 of Respondent No.3, alongwith pre / post proceedings thereto, may be set aside and appellant may be re-instated in service with all consequential benefits.

* = = = = = = =

Respectfully Sheweth;

- 1. That appellant is law abiding peaceful citizen of Pakistan and permanent resident of District Kohat.

 (Copy of CNIC is attached as Annexure "A").
- 2. That appellant, being qualified, was enlisted as Constable, in the Khyber Pakhtunkhwa Police Department, by the Competent Authority, vide order dated: 17.05.1995 and promoted, time to time, after completion of requisite courses, and lastly promoted, on the recommendations of departmental promotion committee in its meeting held on 28.12.2021, as Officiating Assistant Sub Inspector (BPS-11), against the existing vacancy of Kohat Region, vide order No.475-85/EC, dated: 10.01.2022.

(Copies of CV, commendation certificate dated: 01.09.2021 & order dated: 10.01.2022 are attached as Annexures "B, C & D" respectively).

- 3. That Appellant, while posted in Recruiting Training Wing (RTW) Kohat, was subjected to disciplinary action, evident from charge sheet with the following allegations:
 - "i. Chaudhry Shahzad Ahmad, owner of Multazim Filling Station (contractual of PTS Kohat for POL) submitted an application to Director PTS Kohat for the payment of pending bills amounting to Rs.16,759,749/-. He further stated that he met several time with you and the then Director PTS Kohat regarding payment of pending bills but still no payment has been made. The preliminary inquiry into the allegations was conducted by AIG enquiry CPO. During the inquiry the following allegations have been established:



a. Record provided by the owner of the Filling Station clearly reflected that the POL was used almost in private vehicles.

b. You denied from signature available over the vouchers. In order to verify his stance, all the vouchers were sent to FSL for forensic examination of the signatures available on the vouchers.

c. On receipt of forensic examination it was clearly established signatures on 38 vouchers was one and the same hand, while the remaining two vouchers did not match.

d. You committed embezzlement of a huge amount (Rs.16,759,749/- in shape of POL) from Multazim Filling Station with the connivance of the then Director PTS, Kohat (Mr. 1brahim Azhar)

By reason of the above, you appear to be guilty of misconduct under the Khyber Pakhtunkhwa Police Rules, 1975 and have rendered yourself liable to all or any of the penalties specified in the said rules."

Appellant submitted detailed reply to the charges ibid within the stipulated time. (Copies of charge sheet, statement of allegations & reply, are attached as Annexures "E, F & G" respectively).

- 4. That Respondent No.3, without conducting proper / regular inquiry into the alleged charges leveled against appellant, issued final Show Cause Notice No.S/794/23 dated: 03.04.2023, which reads as under:
 - "1. WHEREAS, you Mr. Zahoor Iqbal S.I, while posted as MTO PTS Kohat committed gross misconduct as defined in Rule 2 (ill) Khyber Pakhtunkhwa Police Rules, 1975 (amended 2014), resultantly you were Charge Sheeted and served with the Statement of allegations and Enquiry Committee comprising Mr. Ashfaq Anwar, RPO Bannu and Mr. Asif Bahadar, DPO Hangu was constituted to conduct enquiry into the matter.
 - 2. WHEREAS, the Enquiry Committee finalized the Enquiry proceedings, giving you full opportunities of defense j.e. cross examination of the witnesses besides audience of relevant record and personal hearing. Consequent upon the completion of Enquiry proceeding the charges against you were established beyond any shadow of doubt and you were recommended for punishment. A copy of the finding is enclosed.
 - 3. AND WHEREAS, ongoing through the finding and recommendation of Enquiry Officers, the material placed on record and other connected papers including your defense before the said Enquiry Committee, the undersigned is satisfied that you have committed gross misconduct within the meaning of Rules ibid and held guilty of the charges leveled against you as per statement of allegations conveyed to you vide No.S/2784-86/22, dated: 16.11.2022.
 - 4. NOW THEREFORE, 1, Sabir Ahmed PSP, Additional Inspector General of Police-Headquarters, Khyber Pakhtunkhwa Peshawar, being Competent Authority have tentatively decided to impose upon you, any one or more penalties including the penalty of "Dismissal from Service" under the Rules ibid.

You are therefore, requested to Show Cause within Seven (07) days of the receipt of this Notice, as to why the aforesaid penalty should not be imposed upon you, falling which it shall be presumed that you have no defense to offer and an exparte action shall be taken against you. Meanwhile also intimate whether you desire to be heard in person or otherwise."

As no document relating to the alleged enquiry proceedings, including enquiry report / statements of witnesses alongwith ancillary documents, was communicated to the appellant alongwith the final Show Cause Notice ibid, as contemplated in para-2 whereof, therefore, appellant requested for the entire record of the enquiry proceedings through applications dated: 07.04.2023, 10.04.2023, 18.04.2023 (two in numbers), 31.05.2023 (two in numbers).

(Copies of final Show Cause Notice dated: 03.04.2023, applications dated: 07.04.2023, 10.04.2023, 18.04.2023 (two in numbers) 31.05.2023 (two in numbers), are attached as Annexures "H, I, J, K, L, M & N" respectively).

- 5. That the Competent Authority / Respondent No.3, instead to issue the requisite documents / evidence related to the alleged enquiry proceedings, in order to enable appellant to submit proper reply to the final Show Cause Notice dated: 03.04.2023 supra, issued impugned order No.S/1478-88/2023, dated: 31.05.2023, vide which major penalty of dismissal from service has unilaterally been imposed upon appellant.

 (Copy of impugned order dated: 31.05.2023 is attached as Annexure "O")
- That appellant, being aggrieved of impugned order dated: 31.05.2023, preferred Departmental Appeal to the Competent Authority/ Respondent No.2, which was received in the office, vide Diary / CR No.12075/SB, dated: 16.06.2023, however, to no avail and, after elapse of statutory period of 90 days, appellant left with no other option but to approach this Hon'ble Tribunal through Instant Service Appeal, inter-alia, on the following grounds:

 (Copy of departmental appeal dated: 16.06.2023 is attached as Annexure "P")

GROUNDS:

- A. That impugned order dated: 31.05.2023 of Respondent No.3, is against the law and peculiar facts / circumstances of the case of appellant, hence carry no legal weight.
- B. That Appellant, while posted as Officiating Assistant Sub Inspector (Regular IHC), while posted in RTW, Kohat, was proceeded against for the charges which are not commensurate with his job description, moreover, Respondent No.6 and Director PTS, Kohat executed an Agreement/ Igrar Nama dated: 18.02.2020 for supply of Petrol / Diesel to the Police Training School (PTS) Kohat, it is worth to mention that name of appellant is nowhere mentioned / reflected from the said agreement / Igrar name, either in the column of executants or witnesses, but this factum of the case has escaped sight of the Competent Authority, hence erred in jurisdiction.

(Copy of Agreement / Iqrar Nama dated: 18.02.2020 is attached as Annexure "Q")

- C. That neither regular inquiry into the guilt of appellant was conducted nor appellant was provided opportunity of proper hearing, rather he has been refused excess to the record of alleged enquiry proceedings, hence has been condemned unheard, which attracts the doctrine of audi alteram partem.
- D. That, admittedly, Respondent Department has no lawful authority to punish Appellant for no wrong, rather they are duty bound to treat him in accordance with law and to provide him equal protection of law, but the Respondent Department, instead to follow the law/rules on the subject, issued the impugned order in a clandestine and surreptitious manner, which has caused grave miscarriage of justice.
- E. That major penalty of dismissal from service has been imposed upon Appellant, mare on the basis of presumptions, that too, without adopting proper mode and manner for substantiating the alleged charges, moreover, the Competent Authority did not appreciate the available record of the case of Appellant in its true perspective, hence arrived at a wrong conclusion.
- F. That appellant served the Respondent Department with honesty, to the best of his abilities and having about 28 years' spotless career as his credit, however, he has been unilaterally proceeded against, that too, for the erroneous allegations and awarded major penalty of dismissal from service, which has caused grave miscarriage of justice.



G. That Respondent Department instead to mind their way and pass appropriate order on departmental appeal of appellant, in accordance with law / rules governing the subject, issued yet another summon bearing No.1723-24/CPO/IAB, dated: 21.08.2023, to proceed further in the enquiry and directed to attend the office of Respondent No.4, on 23.08.2023 at 10:00 a.m., in order to humiliate and pressurize appellant to surrender before their wrong deeds, particularly to save skin of the then Director, who entered into an agreement with Respondent No.6, hence indulgence of this Hon'ble Tribunal is solicited for smooth administration of justice.

(Copy of summon dated: 31.08.2023 is attached as Annexure "R")

- H. That appellant is neither Drawing & Disbursing Officer (DDO) nor entered into an Agreement / Iqrar Nama dated: 18.02.2020 with Respondent No.6 for sale / purchase of Petrol / Diesel, rather the sole Responsible Officer i.e. the then Director PTS, Kohat, was not only DDO but also executed an Agreement / Iqrar Nama dated: 18.02.2020 with Respondent No.6 for supply of Petrol / Diesel, but astonishingly he has been exonerated from the charges and appellant has been scapegoat, in order to camouflage their wrong deeds, which is unjust, unfair and against the law / rules governing the subject.
 - That any other ground, with the permission of this Hon'ble Tribunal, will be taken at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of instant appeal, impugned order dated: 31.05.2023 of Respondent No.3, alongwith pre / post proceedings thereto, may be set aside and appellant may be re-instated in service with all consequential benefits.

Any other relief, not specifically prayed for and deemed appropriate by this Hon'ble Tribunal in circumstances of the case, may also be granted.





 - a) One Choudhry Shehzad, owner of Multizan Filling Station (Contractual of PTS Kohat for POL) submitted an application to Director PTS Kohat for Payment of Pending Bills amounting to Rs 16,759,749/-. When inquiry was conducted by AlG-Inquiry, It came to surface that the said POL was used in private vehicles. The vouchers were also found dubious hence embezzlement has been committed of the above stated
 - 2) The Competent Authority formed an enquiry committee consisting of DIG Ishfaq Awan
 - 3) The appellant submitted his detailed reply to the Charge Sheet and Statement of Allegations denying the allegations vehemently. The appellant asserted that PTS MTO has 08 government Vehicles who's overall in-charge is Director while the appellant obeys his orders as per the law. The appellant further asserted that an agreement to purchase POL dated 18-02-2020 has been executed with the said Petrol Pump. It was categorically written in the said agreement that POL is to be provided to government vehicles. Furthermore, all the pending bills shall be liable to paid till three months where after, the Petrol Pump shall stop providing POL. The appellant assisted the said vouchers are fraud and forged. As per the complainant, the POL was provided to private a vehicle which was not the mandate of the agreement. The said vouchers are prepared by the petrol pump owner with mala fide intentions and ulterior motives to misappropriate

The appellant further provided the record of the legal payment to the petrol pump and money from government treasury. nothing is outstanding against the department. Lastly, the said amount was never paid to the petrol pump owner hence the allegation of misappropriation is uncalled for and unjustified.

4) That the Inquiry Committee, in violation of the rules and judgments of superior Courts, instead of providing opportunity to the appellant to defend his stance and crossexamine the witnesses if any, instead conducted the inquiry in questionnaire form. Superior Courts have time and again declared the said procedure as unjust, unlawful hence null and void. The inquiry committee submitted its manifest illegal finding whereupon, the Competent Authority issued Final Show cause Notice dated 03-04-2023. The appellant, was shocked and submitted an application that copy of the inquiry Report, Vouchers, and any evidence that has been taken on record as he has not been confronted with any evidence during the inquiry.



5) That the Competent Authority, instead of paying heed to the genuine and fundamental request of the appellant, passed the impugned order dated 31-05-2023of "Dismissal from Service" hence this departmental appeal to this worthy forum.





GROUNDS OF APPEAL

- a. That the impugned order as well the proceedings suffer from grave irregularity and illegality, hence, the are liable to be set-aside. There is no denying of the fact that the appellant performed his duties in the four corners of law.
- b. That the respondents have also regarded the sacred principle "that punishment should always commensurate with the offense' but in the instant case they have treaded the path illegally by imposing a penalty where the appellant is not at fault in anyway.
- That the appellant was never provided any opportunity to cross-examine the witnesses nor was provided any material hence he is condemn un-heard. The procedure adopted by the inquiry committee cannot be justified as it has resulted in meting injustice to the appellant.
- d. That the final show cause notice is mis-statement as it mentions that the inquiry report is enclosed whereas the same was never provided to the appellant, the appellant initially approached the department who illegally withhold the same where after he was forced to approach the appropriate forum / right of access to information who also tried their best but the inquiry committee did not provide the same. The appellant again approached the concerned officers but they refused without any rhyme and reason, the appellant has been meted major penalty but was not provided with alleged evidence which was used against him which makes the whole inquiry a "sham process".
- e. That the impugned order has destroyed the career of the appellant without any fault or omission hence it is requested that the same be set-aside.




- f. That the stance of the appellant was never brought on record rather he is dismissed from service when even there is no embezzlement. It was never proved that the vouchers provided by the petrol pump owner was ever signed by the appellant, nor their signatures were compared with the approved / genuine vouchers already in the possession of the department.
- g. That the whole process of inquiry culminated in the dismissal order is tainted with Mala fide.

It is, therefore, respectfully prayed that the instant departmental appeal may kindly be accepted, the impugned order dated 31-05-2023 be set aside being based on extraneous considerations, mala fide, devoid of law and natural justice.
