Learned counsel for the appellant present and argued that appellant earlier approached this Tribunal for his promotion which was accepted vide order dated 24.09.2019 with direction to respondents to consider the case of the appellant for promotion to the post of Naib Tehsildar from the date of his erstwhile juniors were promoted. Consequent upon order of Service Tribunal mentioned above respondents was promoted as Naib Tehsildar w.e.f 25.11.2009 till the date of his retirement from service i.e 04.04.2021 against which departmental representation for grant of proforma promotion to the post of Tehsildar (BPS-16) and Assistant Commission (BPS-17) on the ground that his juniors were promoted to the post of Tehsildar and Assistant departmental appeal Appellant filed Commissioner. 22.02.2023, which was not responded within statutory period of 90 days, thereafter, he filed instant service appeal on 12.06.2023. Thus, appeal in hand is admitted to full hearing subject to all legal objections. The appellant is directed to deposit security fee within 10 days. Thereafter, notices be issued to respondents for submission of written reply/comments. Respondents be summoned through TCS the expenses of which be deposited by the appellant. To come up for written reply/comments on 18.09.2023 before S.B. P.P given to learned counsel for the appellant.
