

Respectfully Sheweth,

Preliminary Objections:

1. The appellant has got cause of action and locus standi as her right of promotion has been violated and the appeal is very much maintainable as she has been discriminated.
2. The appeal is within time as she has been kept in dark. In fact the promotion of R. No. 05 being most junior. Even this date the promotion Notification has not been brought on record. Besides appellant has got a continuous cause.
3. Nothing has been concealed from this hon'ble Tribunal more over this hon'ble Tribunal has got the jurisdiction as junior has been promoted against the rules and regulation and appellant has not been considered for promotion being senior.
4. No reason has been advanced as to why the appeal is based on malafide, intentions otherwise malafide of the respondents is apparent on the record. The referred judgment is not applicable in the instant case.
5. The appellant came to the hon'ble Tribunal with clean hands being senior has a right to be promoted, allowing the appeal for the ends of justice.
6. The appellant is very much entitled for relief being senior from R. No. 05. Irregularity is apparent from the record, most junior has been promoted.

7. The appeal is very much in accordance with law as appellant has been discriminated by promoting the most junior. More so, R. No. 05 is impleaded because appellant has a right to be promoted on SS Pak-Study post.
8. The R. No. 05 has been illegally promoted from which the appellant has been kept in dark. The appellant been senior has a right to be promoted. The process of promotion has been illegally conducted for which appellant cannot be held responsible. The appeal is not for gaining illegal service benefits but for due right of promotion of the appellant.
9. The appeal is maintainable as junior most R. No. 05 has been promoted. More over all the necessary parties has been arrayed as respondents.

ON FACTS

1. Incorrect and irrelevant. The appellant is MSC Pak-Study, fully eligible and qualified to be promoted to B-17 as subject specialist. The official respondents reply is strange, the Notification dated 13-04-2018 is regarding posting where as the promotion Notification is dated 15-03-2018. The official respondents must have attached the Minutes of the Meeting regarding the promotion of R. No. 05 the rules on the subject, promotion order dated 15-03-2018, by not doing so, the malafide intentions of the respondents is proved beyond any shadow of doubt. (Copy of promotion order dated 15-03-2018 is attached)
2. Admitted correct by R. No. 01-04 where as R. No. 05 reply is strange, how R. No. 05 had no knowledge when appellant is figured at S. No. 1966 and R. No. 05 at S. No. 2518 of the Tentative Seniority List of 2012 of SST which is a Provincial Cadre.
3. Admitted correct by R. No. 1-4 regarding Tentative Seniority List of 2012. The R. No. 1-4 has a duty to maintain proper Seniority List and they must have attached latest seniority list of SST on which the promotion has been affected, besides how can R. No. 05 deny the fact that she is most junior from appellant as appellant is

appointed on 05-01-2012 where as R. No. 05 was appointed on 30-05-2012 so most junior.

4. Incorrect. The appellant is senior in the seniority list, the Final Seniority is not attached by R. No. 1-4, to show how is R. No. 05 senior and how R. No. 05 is promoted after due process of law, what rules are applied nothing has been attached with reply by R. No. 1-4 even the promotion order dated 15-03-2018 is not attached with the reply. Reply of R. No. 05 is shooting in the air, what relevant law no clue has been given by R. No. 05, the malafide of both the official as well as private R. No. 05 is apparent on the face of record.
5. Incorrect. The R. No. 01-04 even after appearance in the KP Information Commission did not submitted the latest seniority list and promotion order dated 15-03-2018 but only submitted Tentative Seniority List of 2012 which the appellant has impugned in the hon'ble Tribunal, R. No. 05 has not replied to the para and only denied the para.
6. Incorrect. No documents has been provided to appellant by R. No. 01-04. The order of Commission is ample proof of the same, besides even to this date the document i.e. latest seniority list, Minutes of the Meeting regarding promotion order dated 15-03-2018 of SST Teacher of the Province of KP and promotion order dated 15-03-2018 has not been submitted with the reply nor brought on the record which shows their malafide. R. No. 05 has not replied the para and only denied on the ground of lack of knowledge.
7. Incorrect. The appellant has been denied her right of promotion being senior in violation of law and rules and judgments of superior courts, the appellant preferred departmental appeal through duly noted dairy numbers of official respondents which cannot be denied. In matters of promotion limitation does not comes in way of aggrieved official as being a continuous cause. The official respondents must have decided the departmental appeal of the appellant with speaking order but failed to do so as they have favored a most junior in violation of merit, law and rules on the

subject. The R. No. 05 did not replied and only denied on the ground of lack of knowledge.

GROUND:

All the grounds of appeal are legal and correct while that the respondents are illegal and incorrect. The same are adopted once again.

Furthermore, it is to be noted that the respondents conducted two DPCs in which the appellant was not considered and junior most were promoted in violation of merit. (Copies of DPCs are attached)

It is, therefore, most humbly prayed that the appeal be accepted as prayed for.




