#### PARA WISE COMMENTS ON BEHALF OF RESPONDENT 05

#### **PRELIMINARY OBJECTIONS:-**

- 1. That the appellant has got locus standi/causes of action to file instant appeal.
- 2. That the appellant has come to the Tribunal with clean hands.
- 3. That the appellant has concealed the material facts from this honourable tribunal.
- 4. That the appellant is estopped by his own conduct to sue the respondents.
- 5. That appeal of appellant is not maintainable in the present form.
- 6. That this honourable has no jurisdiction to entertain the present appeal.
- 7. That the present appeal is bad for non-joinder & mis-joinder of necessary parties.
- 8. That the appeal is based by law and limitation.

## FACTS: -

1. That this para is correct to the extent that appellant is serving against SST (B/C) post in Distt: Education Department Hangu. He has been deputed to Education Office Hangu as ADEO wide E&SE order No.

- nakhtukh - Sunal 7728 19-09-23

4938-45/F.No. 43/ADEO (M) dated Peshawar 22/11/2018 and served in various capacities. (copy annexed "A")

- 2. That this para is partially incorrect. Appellant is concealing material facts. He served as ADEO (Estab) (M/F) Hangu for five years approximately. The appellant have served in DEO offices (Male & Female) District Hangu from 22/11/2018 to 09/08/2023 total service approximately five years. The appellant was transferred to school concerned from where he came to Education Office Hangu but this time he is leveling charges of the premature transfer. He had never objected when the appellant used to transfer with in the same office to various posts. (copies attached as Annexures B, C, D, E, F)
- 3. That this para is incorrect appellant is concealing material fact from the Honorable Tribunal. The competent authority has power to place the services of the civil servant anywhere in the province.
- 4. That this para is incorrect stop-gap arrangement transfer is need based. The said/reference transfer policy shall be applicable when the appellant take over charge in school not in an office. He never label it political transfer when he was transferred from one post to another in office rendering less than three years service in that regard.
- 5. That this para is incorrect. He did not preferred appeal to the competent authority i.e respdt. 01 secretary E&SE dept. Peshawar. Therefore, the present appeal is not maintainable & resultantly this Tribunal has got no jurisdiction to entertain the present appeal.

## <u>GROUNDS: -</u>

- a. That this para is incorrect. The notification issued by respondent No. 1&2 are as according to policy & rules and regulations. The subsequent orders of respondent 3,4 has not been challenged by the appellant. In this regard relief clamed is against law. Therefore the present appeal is liable to be dismissed.
- b. That this para is not correct. Respondent are law abiding servants. They never violated said articles of constitution.
- c. That this para is incorrect. They never violated any law & constitution of the country.



- d. That this para is incorrect. The respondent never violated the posting transfer policy. The notification dated 09/08/2023 & subsequent notification are as according to law, rules and regulation (Annexure H, G)
- e. That this para is incorrect. Respondent issued notifications in best interest of public and never violated fundamental rights of the constitution.
- f. That this para is incorrect. Transfer notification has been issued in public interest as according provincial posting & transfer prevailing policy on the basis of stop gape arrangements.
- g. That this para is incorrect. In the present transfer, allegation of political interference are baseless & false. The appellant served in the education office since 28/11/2018 and never completed the transfer tenure but when the appellant was transferred out of education office, started leveling of allegation of political interference which is baseless & has been framed to satisfy his own interests. Service is not rendered on choice but public interest.
- h. That this para is incorrect. The appellant should not conceal facts from the Tribunal. Noting can new be introduced out from his pleadings.

Since there is no weight in the present appeal, the appellant is concealing material facts from this Honourable Tribunal, disserve no relief. Therefore, present appeal be dismissed with costs.



Athar Minallah, J.- Dr. Muhammad Saleem ('petitioner') has sought leave against judgment, dated 27.4.2022, of the Baluchistan Service Tribunal ('Tribunal').

The controversy stems from the transfer order of Dr. Shamsullah Bazai ('respondent') from the post of Principal, Loralai Medical College ('College'). The respondent was posted as Principal of the College vide notification, dated 04.12.2020. The competent authority, vide notification dated 17.10.2021, directed the respondent to report to the Specialized Healthcare and Medical Education Department, but the notification was later withdrawn vide notification, dated 26.10.2021. He was transferred from the post of the Principal of the College and to the post of Professor (B-20) and Head of Ophthalmology Department, Bolan Medical College, vide notification dated 11.02.2022, while the petitioner replaced him as

orders. He had taken the stance in his departmental representation that allowing him to continue to hold the post of the Principal of the College was in the public interest. Likewise, the Tribunal had concluded that the transfer of the respondent from the latter post was not in the public interest. The Tribunal had raised concerns regarding the status of governance, besides placing reliance on the judgments of this Court, so as to justify interference with the executive functions in connection with posting/transfer of The judgments employees. relied upon were distinguishable, while the principles enunciated in the context of the executive domain with respect to transfer and postings of employees/civil servants appears to have been excluded from consideration.

This Court has already highlighted the scope of

interference with the executive function of postings and transfers of government officials.<sup>1</sup> It has been held that the transfer of a government official from one place or post to another to meet the exigencies of service was within the exclusive domain and competence of the competent authorities of the executive organ of the State and, ordinarily, it is not amenable to interference except in extraordinary circumstances. This principle is subject to the

condition that the terms and conditions of service are not adversely affected. Moreover, an official has no vested right to claim to be posted/transferred to any particular place of his choice, nor is there a vested right to continue to hold a particular post at a particular place. The transfer and posting of a government servant is limited to the given tenure, if any, or at the pleasure of the competent authority. The question of whether the posting and transfer made by the competent authority was in the public interest is not open to judicial review by a tribunal or

court and utmost caution and restraint ought to be exercised in interfering with or encroaching upon the exclusive domain of the executive authorities. The decisions in connection with posting and transfer of government servants must not be subjected to judicial scrutiny unless a law has been clearly violated or mala fide and malice is established without the need for making an inquiry. The interference of the Tribunal or courts in matters relating to postings and transfers is, therefore, an encroachment upon the executive domain and in breach of the seminal principle of separation of powers embedded in the Constitution. The Tribunal interfering justified not was in with the posting/transfer orders of the respondent nor was it in consonance with the settled principles relating thereto. The impugned judgment is, therefore, setaside and with leave of this Court the petition is converted into an appeal and allowed.
