Learned counsel for the appellant argued that the appellant is aggrieved of the impugned order dated 04.08.2021, whereby departmental appeal of the appellant as well as termination from service order dated 22.06.2018 were declared as valid, hence, the instant service appeal has been submitted on 25.08.2021. It was further argued that the appellant was appointed as Process Server (BS-05) after due process of selection. He was served with a show cause notice dated 14.06.2018 to which the appellant submitted his reply on 22.06.2018. However, his services were terminated vide impugned order of respondent No.1 dated 22.06.2018 on the ground that he was not eligible to be appointed against 25% quota reserved for the retired Class-IV employees sons. 



- 4) That after appointment the petitioner performed his duty to the satisfaction of his superiors with dedication and received salary for the Month of May, 2018. (Copy of pay slip is Annexure "D").
- 5) That in the meanwhile an office order No.956-SCJ/ NSR dated 14.06.2018 was served upon the petitioner which was accordingly replied. (Copies of office order and reply are Annexure "E and F").
- 6) That in light of the above mentioned order dated 14.06.2018 the petitioner's services were terminated, which is illegal and against the law and facts.
- 7) Tipat petitioner filed an appeal before District and Sessions Judge,
 Newshera on 12.07.2018 and the same was dismissed on 13.10.2018.
 (Copy of appeal along with order are Annexure "G and H").
- 8) That petitioner is aggrieved from the said illegal order and having no other alternate and efficacious remedy, approaches this hon'ble court and filing the instant constitutional petition, inter alia, on the following grounds:

GROUNDS:

- A) Because the impugned order dated 13.10.2018 is illegal, against law, fact and material available on the record of the case.
- B) Pecause the respondents are bent upon appointing their blue-eyed on the said post as visible from their conduct.
- C) Because the malice of the respondents is further apparent as the sérvices of the petitioner were terminated just after one month without any legal justification.
- D) Because when petitioner is already satisfactorily performing his duties, his services were terminated with immediate effect, is totally inconceivable and against the natural justice.





- Because petitioner has not committed any offence and without any show cause notice, charge sheet, statement of allegation, inquiry and even without personal hearing, which is deemed to be enshrined in every statue whether specifically provided or not. So, solely on this ground, the impugned order is liable to be struck down and the petitioner ought to continue his service as Process Server in BPS-5.
- F) Because the petitioner is being discriminated and he is being treated against the law and thus deprived of equal protection of law, which is mandated by Articles 4 and 25 of the constitution of Pakistan, 1973.
- G) Because the impugned order is lacking reasons which is mandatory as per Section 24-A of the General Clause Act as well as 3rd Maxim/ Principle of Natural Justice i.e. speaking order which means that the order should speak by itself or it should be a well-reasoned order, which is necessary for judicial scrutiny as the judicial authority can easily come to know whether the order is arbitrary, whimsical, oppressive, one sided or just order.
- II) Because the impugned order is arbitrary, whimsical, oppressive, one sided and non-sustainable in the eye of law.
- Because petitioner is innocent and has not committed any offence.
- J) Gecause punishment is too harsh.
- K) Decause any other ground may be adduced during the course of orguments, with the kind permission of this hon'ble court.

It is, therefore, humbly prayed that on acceptance of this writ petition the impugned order dated 13.10.2018 may please be declared as illegal, unlawful, without lawful authority and ineffective upon the rights of petitioner and petitioner may please be permitted to continue his services.

MUHAMMAD NASIR MAHFOOZ, J:-. Through the instant petition filed under Article 199 of the Constitution of Islamic Republic of Pakistan, 1973, petitioner seeks the following relief:-

> . "It is, therefore, humbly prayed that on acceptance of this writ petition, the impugned order dated 13.10.2018 may please be declared as illegal, unlawful, without lawful authority and ineffective upon the rights of petitioner and petitioner may please be permitted to continue his services."

Brief facts of the case as per contents of the 2. writ petition are that the petitioner applied for the post of process server advertised by the respondent No.1. He appeared in test and interview, after qualifying the same,

he was appointed as Process Server vide office order dated 30.04.2018. On 14.06.2018, he was served with a show cause notice, for recalling of his appointment order being made under 25% retired employees son quota, which was replied accordingly. On 22.06.2018, his services were terminated. An appeal before the learned District and Sessions Judge, Nowshera was preferred, which was also dismissed on 13.10.2018. Feeling aggrieved therefrom, petitioner, having no other alternate, adequate and efficacious remedy, has filed the instant constitutional petition.

- On behalf of the respondents, Registrar, Peshawar High Court, submitted comments and raised several legal and factual objections, besides supporting the impugned order of learned District and Sessions Judge who exercised powers as an Appellate Authority and dismissed the departmental appeal of the petitioner.
- 4. We have heard arguments of learned counsel for the petitioner as well as learned AAG for the respondents and have perused the documents available on the file.
- 5. Petitioner is alleged not to be the son of retired employee but was appointed as Process Server in BPS-5 in the said 25% quota. This is apparent from the

office order dated 28.04.2018 passed by learned Senior Civil Judge, wherein, it is specifically mentioned that the present petitioner and one Asadullah Shah were appointed as Process Server and Naib Qasid on the retired employees' son quota while keeping in view the Notification dated 23.5.2000. Afterwards, realizing the said mistake, a show cause notice was issued to the petitioner on 14.06.2018 for recalling the appointment order and finally recalled on 26.07.2018.

- 6. In case the appointment order of the petitioner was erroncously issued when the petitioner did not fall within the quota reserved for the retired employees then whether recalling of order would suffice or could be declared void ab initio. This aspect was not dealt with by the learned District and Sessions Judge.
- 7. We, without going into further merits of the case, would partially allow the instant petition with the observation that the appeal of petitioner shall be decided albeit above observation. If petitioner is still aggrieved, he may avail proper remedy as available to him under the law subject to limitation as provided by law.



The Para-1 is true and needs no comments.

1. **Para No 2**, Yes it is correct show cause notice was served upon the appellant which was dully replied by him. In response of show cause notice issued by the appointing authority, the respondent No -1 found his reply as unsatisfactory through his brief order which was properly served upon the appellant, bearing No- 976-81/SCJ Nowshera dated 22-6-2018.


