





"Senterity:- Except the employees mentioned in the proviso to section 4 of this Act, whose services are to be regulated by their respective laws and rules, all other employees whose services are regularized under this Act or in the process of attaining sprices at the commencement of this Act, shull rank junior to all civil servants belonging to the same services or cadre, as the case may be, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission or Departmental Selection Committee, as the case may be, made before the commencement of this Act, are to be appointed to the respective service or dadre, irrespective of their actual date of appointment.

(2) The senjority inter-se of the employees, whose services are regularized under this Act within the same services or cadre, shall be determined on the basis of their continuous officiation in such service or cadre:

Provided that if the date of continuous officiation in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one". Annex-V

Therefore, it is quite clear that the claim of the applicant is not justified.


