APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL, 1974 AGAINST THE NOTIFICATION DATED 26.08.2022 WHEREBY THE ADJUSTMENT WAS MADE W-E-F 26.08.2022 AND NOT FROM THE DATE OF PROMOTION I.E. W-E-F 25.04.2022 AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:

That on acceptance of this appeal the impugned adjustment notification may be kindly be rectified to be effected from 25.04.2022 and not from 26.08.2022 and the financial protection be allowed to him. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

- 1- That appellant is the employee of the respondent Department and is serving as Principal (BS-19) quite efficiently and up to the entire satisfaction of his superiors.

2- That during service the appellant was promoted from BPS-18 to BPs-19 vide Notification dated 25/04/2022 on the proper recommendation of Provincial Selection Board. Copy of the notification dated 25-04-2022 is attached as annexureA.

3- That vide Notification dated 26.08.2022 the appellant upon was adjusted w-e-f 26.08.2022 against the post of Principal (BPS-19) GHSS Nagerai Buner. Copy of the notification is attached as annexure.....B.

4- That appellant feeling aggrieved from the impugned notification dated 26.08.2022 preferred departmental appeal but the same has not been decided within the statutory period of ninety days. Copy of the Departmental appeal is attached as annexure.....C.

5- That appellant feeling aggrieved and having no other remedy but to file the instant service appeal on the following grounds amongst the others.

GROUND:

A- That the impugned adjustment notification is against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be set aside.

B- That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.

C- That the respondent Department acted in arbitrary and malafide manner by issuing the impugned adjustment whereby not adjusting the appellant w.e.f 25.04.2022.

D- That the impugned notification is in violation of Article-38 (e) of the Constitution of Islamic Republic of Pakistan, 1973.

E- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of appellant may be accepted as prayed for.


Respected Sir,


