# Inquiry Report 07" Oct 2022

## BACKGROUND

Mst. Rani Naz W/O Javed House # 07 DHQ Hospital Mardan was appointed as Dai (BPS-02) on regular basis at Mardan Medical Complex Mardan by the Executive District Officer Health Mardan via Appointment Order No.9371-74/EDO (H) Mardan Dated the 11/07/2007 (Copy attached as annexure A). She was removed from service via office order No.3591-96/MMC, Dated 7/5/2014, (Copy attached as annexure B), on the charges of a) Inefficient in duties, b) Guilty of misconduct, c) Guilty of habitually absenting herself from duty without prior approval of the competent authority, specified in Charge sheet via letter NO.3261/MMC, Dated 24/4/2014, by the then Ghief Executive Officer of MMCTH Mardan, (Copy attached as annexure C). She filed a case before the Khyber Pakhtunkhwa Service Tribunal Peshawar via service appeal No. 1241/2014, dated 16.10.2014, in which the judgment was passed on 05.03.2018 in favor of Mst. Rani Naz W/O Khan Masih Dai (BPS-02) by reinstating her into service, (Copy attached as annexure D). Her arrival report was accepted by the Hospital Director via letter No.4842-43/MMC/MTI Dated 19/7/2019 (Copy attached as annexure G1) while relieved again to Director General Health Services Khyber Pakhtunkhwa Peshawar via letter No.5054-55/MMC/MTI Dated 30/7/2019 (Copy attached as annexure G2). Mst. Rani Naz (Dai) was reinstated into Govt. service in the light of service appeal No.1241/2014 dated .05.03.2018, at BHU Baghicha Dheri Mardan by the District Health Officer Mardan via office order No.1113-18/DHO Dated Mardan the 19/7/2019 (Copy attached as annexure H). Now she has requested for regularization of gap period multiple times, (Copy attached as annexure I1-2) and The Director ADMN of the Director General Health Services Khyber Pakhtunkhwa Peshawar has directed District Health officer to implement the judgment of the Honorable Khyber Pakhtunkhwa Peshawar Service Tribunal Peshawar in letter & Spirit via letter No.2738/Personnel Dated 01/06/2022 (Copy attached as annexure J). In Compliance to the directions of Director ADMN, District Health Officer constituted an inquiry committee vide Officer Order No.14078-80/DHO dated Mardan the 18/08/2022, to probe into this matter and submit a fact finding report (Copy attached as annexure K).

#### PURPOSE

 Regularization of Gap Period for Mst. Rani Naz Dai BPS-04 previously working at MMCTH Mardan now at the disposal of District Health Officer Mardan, w.e.f 08/05/2014 to 18/07/2019.

#### INQUIRY OFFICER

- Dr. Muhammad Ishaq, District Coordinator LHWs Program Mardan.
- Dr. Sadia Liaqat, Surveillance Officer-DHO office Mardan.

#### METHODOLOGY

i IDistri

The inquiry officer outlined the following strategic points to be executed during the collection and analysis of evidence for a transparent procedure.

- Visit Mardan Medical Complex and Teaching Hospital Mardan Physically and Collect the personal file of the Mst. Rani Naz (Dai) from record section for collecting information relevant to this inquiry.
- Collect verbal and written statement of Mst. Rani Naz (Dai) BPS-04 for her point of view.
- Collect verbal and written statement of HR Manager at MMCTH Mardan.
- Collect verbal and written statement of the Hospital Director of MMCTH Mardan.
- Collect verbal and written statement of the accountant at DHO Office Mardan.

#### PROCEDURE

The inquiry officers visited the Record section of the Mardan Medical Complex Teaching Hospital Mardan to collect the personal file of Mst. Rani Naz (Dai) BPS-04. Then the inquiry officers collect the verbal and written statement of Mst. Rani Naz (Dai) (Copy attached as annexure P). However, the inquiry officers could not collect the verbal and written statement of the HR Manager and Hospital Director at MMCTH Mardan due to the reason that it the Hospital Director was newly appointed on temporary basis and the HR Manager had only record of MTI employees. Then the inquiry officers collected the verbal and written statement of the accountant at DHO Office Mardan (Copy attached as annexure P2).

#### FINDINGS

After all the procedures were followed, the inquiry officers outlined the following findings by going through all the relevant documents

- After a comprehensive study of the personal file of Mst. Rani Naz (Dai) BPS 04 it was found that she was reinstated back into service by The Khyber Pakhtunkhwa Service Tribunal Peshawar in a judgment passed on 05.03.2018 (Copy attached as annexure D), however she resumed her services on 19/07/2019.
- 2. In the same judgment, it was also stated that, the respondent-department is at liberty to conduct de-novo inquiry against the appellant in accordance with law and rules within a period of three months from the date of receipt of the judgment and the issue of back benefits was subjected to the outcome of the de-novo inquiry (Page 3 of annexure D).
- 3. The inquiry was conducted by the Hospital Director MMCTH Mardan in compliance to the judgment passed by the Honorable Khyber Pakhtunkhwa Service Tribunal Peshawar. During the de-nove inquiry Mst. Rani Naz (Dai) was called for Personal Hearing via letter No.6807-08/MMC/MTI Dated 24/9/2018 and letter No.7629-30/MMC/MMC/MTI Dated 29/10/2018 (Copy attached as annexure F1 & F2 respectively), but she did not appear before the inquiry committee.
- 4. The inquiry was submitted by the Hospital Director MMCTH Mardan to the Registrar, via letter No.7487-91/MTI/MMC Dated 22-10/2018 (Copy attached as annexure E).

Herter Herter

. A letter No.8918-19/MTI/MMC Dated 29/12/2018, was sent by the Hospital Director to Director General Health Services Khyber Pakhtunkhwa Peshawar outlying the points as,

- a) The posts of Dais are filled by MTI, MMC whereas her arrival cannot be accepted at this hospital.
- b) It is requested to adjust Mst. Rani Naz out of MTI, MMC as per honorable court orders (Copy attached as annexure X1).
- Another letter No.3556-57/MTI/MMC Dated 12/06/2019, was sent by the Hospital Director to Director General Health Services Khyber Pakhtunkhwa Peshawar outlying the points as,

a) Honorable Khyber Pakhtunkhwa Peshawar has directed that the judgment to be implemented by Respondent No.2 i.e. Director General Health Services Khyber Pakhtunkhwa Peshawar as the appellant is a civil servant,

b) As per Para No.04, of the decision of the Honorable Khyber Pakhtunkhwa Service Tribunal that the appellant is a civil servant therefore, competent authority is the District Health Officer and not the Chief Executive/HD MTI-MMC Mardan.

c) MMC Mardan is declared as MTI in 2016, wherein the HD has filled all the position of Dai at MTI-Mardan (Copy attached as annexure X2).

- 7. It was found from the record of MMCTH Mardan that there was no recruitment done on the post of Dai BPS-02 since the removal from service of Mst. Rani Naz Dai BPS-02 till August 2015.
- 8. It is worth mentioning here that The Chief Executive MMCTH Mardan was not the competent authority as per there letter of the Hospital Director specified in annexure X1, still the post of civil servant of Dai BPS-02 were filled in August 2015, by the Chief Executive Mardan.
- 9. It was also found that the arrival of Mst. Rani Naz Dai BPS-02 was accepted by the Hospital Director MMCTH Mardan post re-instatement on 19-07-2019, while relieved to Director General Health Services Khyber Pakhtunkhwa Peshawar on 30-07-2019 (Copy attached as annexure G1-G2), surprisingly Mst. Rani Naz was re-instated by the District Health Officer into service on 19/07/2019 (as in annexure H).
- 10. In her written statement Mst. Rani Naz (Dai) has said that, She was terminated by the MS MMCTH Mardan on false allegations without fulfilling all the Codal formalities and that The Khyber Paklitunkhwa Service Tribunal Peshawar in their judgment have reinstated her with the directions to pay the arrears of the gape period i.e 5 years (Highlighted in annexure P).
- 11. It was also found in the personal file of Mst. Rani Naz BPS 04 that she was called upon explanations multiple times for her willful absence post re-instatement, the detail of which is further elaborated in the following table-1. (Copy of each is attached as annexure Z1-5)

#### CONCLUSION

Keeping in view the above findings the inquiry officers have reached the following conclusion

- The inquiry officers concluded that Mst. Rani Naz was recruited by the Executive District Officer Health in July 2007 when he was the competent authority for the whole District Health Department including MMCTH Mardan and DHQ Hospital Mardan. However, the Chief Executive was the competent authority for MMCTH Mardan since 01/07/2010 till 2016 when MTI act was implemented when Mst. Rani Naz was removed from service.
- It was concluded that Mst. Rani Naz was reinstated by the District Health Officer Mardan 1 year 4 months and 14 days later then the date of Judgment was passed i.e. 05.03.2018 by The Khyber Pakhtunkhwa Service Tribunal Peshawar as there were no post vacant both in MMCTH-MTI and at the disposal of DHO.
- It was also concluded that the gap period was from 8/5/2014 to 18/07/2019 i.e. 5 years 2 months and 11 days.
- In the opinion of the inquiry officers, the recruitment done in MMCTH Mardan on the posts of Dai in August 2015 are illegal if he was not the competent authority.
- It was also concluded that the de-novo inquiry ordered by the Honorable Khyber Pakhtunkhwa Service Tribunal Peshawar was never completed and the record of recommendations outlined by the committee were not followed (as on 2<sup>nd</sup> page of annexure E).
- It was concluded that Mst. Rani Naz (Dai) in her statement misinterpreted the judgment of the Honorable Khyber Pakhtunkhwa Service Tribunal Peshawar about the back benefits of the gap period.
- <u>Mst. Rani Naz (Dai)</u> is not regular in her duties after her re-instatement and has been found absent multiple times without prior permission of the reporting officer/competent authority, as elaborated in table 1.

It was also concluded that the post of Dai-BPS 02 under the control of the District Health Officer was not vacant prior to 04/07/2019.

Finally the inquiry officers are of the opinion that there exist gaps and loop holes in the roles and responsibilities of the competent authorities in different sections of the Health Department during transition periods i.e. from the transition of Executive District Officer Health to District Health Officer and Chief Executives (On 01-07-2010, MMCTH was declared autonomous) and the fate of civil servants during the transition phase of MMCTH Mardan to MTL.

### RECOMMENDATIONS

- As Mst. Rani Naz Dai was removed from service at MMCTH Mardan by the Chief Executive Mardan and the post was supposed to be vacant until August 2015, it is recommended that her back benefits may be withdrawn from MMCTH for the period 8/5/2014 to 07/08/2015 i.e. 1 year 3 months and 0 days.
- As Mst. Rani Naz Dai was irregular in her duties and she is still irregular, the inquiry officers are of the opinion that the rest of the Gap period i.e. from 08/08/2015 to 18/07/2019, 3 years, 11 months and 10 days may be adjusted / considered as leave without pay, however, if the Director General Health Services Khyber Pakhtunkhwa deems indispensable on humanitarian grounds, her back benefits can be withdrawn against a vacant post of Dai from anywhere in the Province.





Perusal of the record reveals that departmental inquiry proceed

neither charge sheet and statement of allegation were served on her nor the inquiry officer has recorded the statement of any witness during the inquiry proceeding nor opportunity of cross examination and defence was provided to the appellant during the inquiry proceeding. Meaning thereby that the inquiry proceeding was not conducted by the inquiry officer according to the prescribed rules and law. Furthermore, the appellant is admittedly a civil servant therefore, the Chief Executive who is not competent authority to issue any removal order of the appellant from service rather District Health Officer is the competent authority therefore, the impugned order has been passed by the incompetent authority is void and liable to be set-aside. As such we are constrained to accept the appeal and reinstate the appellant into service. However, the respondent-department is at liberty to conduct de-novo inquiry against the appellant in accordance with law and rules within a period of three months from the date of receipt of this judgment. 
