**On Facts:**



- E. **Incorrect & denied:** All Government employees are bound to perform their duties according to law/rules/instructions given by the Government from time to time in the interest of public.
- F. **Incorrect & denied:** The appellant has been treated by applying the rules / policy in vogue and just exerting illegal pressure on the respondent department on ill well.
