

PARAWISE COMMENTS ON BEHALF OF RESPONDENTS 1,2,3 & 4

Respectfully Sheweth:-

Preliminary Objections:-

- i. That the appellant has got no cause of action to file the instant appeal.
- ii. The appellant has got no locus standi to file the instant appeal.
- iii. That the appellant is estopped by his own conduct to file the instant appeal.
- iv. That the appeal is bad in eyes of law and not maintainable.
- v. That the appellant has not approached the honorable Tribunal with clean hands.
- vi. That the appeal is barred by law and limitation.

Facts:-


1. Correct to the extent that the appellant was charge sheeted for making deceit/fraud in recruitment as Constable in Police department. The appellant had qualified ETEA test for recruitment as Constable for the year 2020-21 and was not recommended in the psychological assessment/ final interview by the Regional Selection Board on account of his mental health condition. The Review Board held at CPO had also not recommended him. Pertinent to mention here is that the recommendation list received from CPO Peshawar at district Karak contained his name as "recommended" while another list provided from SSU (CPEC) CPO Peshawar contained his name as "not recommended". Similarly, the list requisitioned from CPO Peshawar by the Regional Police Officer, Kohat vide 16869/EC dated 25.11.2022 and under the DPO Karak diary No. 14699-720/ E-IV dated 29.12.2021 did not contain his name as "recommended".. He fraudulently succeeded in getting his appointment order on the basis of tempered recommendations. (The letters are attached as Annexures-A1, A2 & A3)
2. Incorrect, proper departmental enquiry was initiated against the delinquent official by issuing him charge sheet. Enquiry was entrusted to SDPO Takht-e-Nasrati who conducted the enquiry by fulfilling of all codal formalities, recorded statements and collected necessary evidence on record. After concluding the enquiry proceedings, the enquiry officer submitted his finding report wherein the delinquent official was held guilty of gross misconduct and recommended him for major punishment. The respondent No.3 being competent authority heard the appellant, personally. However, he failed to defend himself. The allegations leveled against him were proved during enquiry. Thus, respondent No.3 awarded major punishment after fulfilling all procedural and legal formalities. (Copy of charge sheet, statement of allegations and enquiry report are attached as Annexure-B1, B2, B3).
3. Incorrect, the respondents No.2 rejected the appeal of the appellant after perusal of the entire record received from District Karak and CPO as well. Hence, upheld order passed by the respondent No.03.
4. That the allegation against appellant had been proved as established in the enquiry findings. Therefore, the appellant's plea is not maintainable under the law, and is liable to be dismissed on the following grounds.

Grounds:

- A. Incorrect, the impugned order was passed in accordance with law & rules as the allegations against the appellant had been proved as established by the enquiry officer in his findings. No malafide on part of respondents is involved.
- B. Incorrect, charges against the appellant were proved during course of enquiry. The appellant was dealt in accordance with law and rules and was also provided proper opportunity of personal hearing.
- C. Incorrect, reply already submitted as para-B above.
- D. Incorrect, the appellant fraudulently succeeded in getting his appointment order on the basis of tempered recommendations and thus, he tried to deceive Police department through such fake appointment. Therefore, he was removed from service in the very start of his appointment.
- E. Incorrect, the list requisitioned from CPO Peshawar by the Regional Police Officer, Kohat vide 16869/EC dated 25.11.2022 and under the DPO Karak diary No. 14699-720/ E-IV dated 29.12.2021 did not contain his name as "recommended". The appellant was terminated from service on the basis of evidences established regarding his fraudulent act.
- F. Incorrect, the competent authority in the light of enquiry findings passed the order according to rules.
- G. Incorrect, the appellant was dealt in accordance with law and rules and has been duly provided opportunity of hearing. The competent authority passed the order after fulfilling of all proceedings and codal formalities.
- H. Incorrect, reply already submitted as para-D above.
- I. Incorrect, the respondents No.2 after perusal of available record received from district Karak and CPO, by hearing the appellant and after fulfilling all the codal formalities and legal procedure, rejected appeal of the appellant and upheld the order of respondent No.2.
- J. Incorrect, the appellant was well informed regarding proceedings of his appeal and the impugned order therein as he was personally called by the appellate authority in his office.
- K. Incorrect, reply already submitted as para-G above. The respondents may also be allowed to advance additional grounds at the time of hearing.

Prayer:-

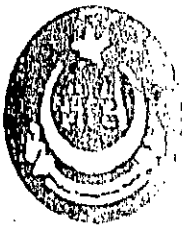
In the light of the above facts and circumstances it is therefore, requested that the appeal, being devoid of merits, may kindly be dismissed with costs, please.

In compliance with the Worthy Inspector General of Police, Khyber Pakhtunkhawa Peshawar letter Endst: No. 2847-90/E-IV, dated 03.03.2021 and No. 2810-46/E-IV dated 03.03.2021, No. 11336-46/E-IV, dated 04.11.2021 & No. 12601/E-IV, dated 23.12.2021, regarding recruitment of constables through ETEA merit list-2021, and Regional level review board Kohat Region, Kohat vide Memo: No. 18658-64/EC, dated 22.11.2021 and CPO level review board vide Memo: No. 14699-720/E-IV, dated 29.12.2021, out of 130 candidates of ETEA list-2021 in which two (02) candidates at serial No. 58 & 128 were not recommended due to psychological assessment & suitability test by CPO Review Board and one (01) candidate at serial No. 28 remained absent before Regional Selection Board while three (03) candidates at serial No. 90, 110 & 118 were deficient in height as per required criteria/policy in vogue. One hundred twenty four (124) candidates were declared fit as per required criteria. Therefore, the following one hundred twenty four (124) candidates are hereby enlisted/recruited as Constables BPS-07 (10990-610-29290) against 53 vacancies of SSU (CPEC), 51 vacancies of this district Police & 20 vacancies of FRP as noted against each their names subject to medical fitness and verified to be good moral characters/antecedents from local Police as well as Special Branch Karak and academic verification. 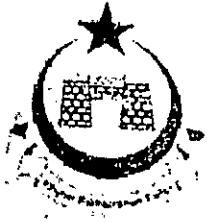
