

PRAYER:-

respondents 01 & 02 may directed to release the monthly
salaries of the appellant already stopped since February, 2013
till to date on different without pretext any solid &
comprehensive reasons

And may also direct the Respondent 03, 04 to take
disciplinary action against the Respondent No. 01 & 02 and.

who ever due to which appellant mentally, physically and financially shocked till date due to their illegal stoppage of monthly salary since February 2013 till date to meet the ends of law, justice and equity.

Also grant / award any other relief for which not specifically prayed for as this it able tribunal deems fit.

Respectfully Sheweth,

The appellant states as under: inter alia:

I. FACTS:-

1. That the appellant being bonafide resident of D.I.Khan, was appointed as a Junior Clinical Tecnician Surgery (BPS-09 now 12) by the Medical Superintendent DHQ Hospital D.I.Khan into DHQH D.I.Khan. (Copies of CNIC & Appointing order dated 25.04.2012 of the appellant are attached as annexure "A, B Pages _____).
2. That in after performing duty for about one year a one Rukhsana Kiran FJCT Surgical was transferred from Khalifa Gul Nawaz Teaching Hospital Bannue to Respondent No.I Hospital by the respondent No.3 on 02.01.2013 through letter # 180-86/FU. (Copies of the said letter is attached as annexure "C" page _____).
3. That into the light of said letter # 180-86/FV dated 02.01.2013 through letter # 941-45/PF appellant duty was relieved from respondent 01 and 02 Hospital to Khalifa Gul Nawaz Hospital on 11.02.2013. (Copy of the said letter is attached as annexure "D" page _____).

4. That on 27.09.2013 through letter # 25329-34/E.V respondent No.3 Re-transferred the appellant from Khalifa Gul Nawa Khan Teaching Hospital Bannue to Respondent No.1 & 2 Hospital i.e D.I.Khan. (Copies of the said letter is annexed as annexure "E" Page _____).
5. That since February, 2013 the appellant monthly salary was stopped without assigning any solid reason by the respondents 01 & 02 and in this connection for the release of the salary several application addressed to respondent No.3 which were forwarded through M.S DHQ on 10.03.2013, 31.03.2014 and on 10.05.2015 by the appellant. (Copies of said applications are attached as annexure "F" Page _____).
6. That about the performing of certificate was given by the respondents through dairy No.1586 dated 14.03.2013 which is attached as annexure "G" page _____.
7. That the service book pay slips are hereby attached as annexure "H" pages _____ of the appellant.
8. That the attendance register of the appellant from December 2015 to July 2020 total 51 pages are hereby attached as annexure "I" pages _____).
9. That being aggrieved and fully disappointed from the attitude behavior of the respondent No. 01, 02, 03 at last on 18.09.2020 the appellant moved writ petition # 727-D/2020 titled "Miss Reema Vs Govt of KPK etc" which was finally disposed

on 02.06.2021 with the remarks that appellate Tribunal has been established for the redressal of grievances of the all employees of Medical Teaching Institution employees, so the said petition alongwith annexures was sent to said appellate Tribunal for its decision according to law. (Copy of the said petition No.727-D/2020 and its order dated 02.06.2021 are attached as annexure "J" pages _____).

10. That after converting the said writ petition # 727-D/2020 into appeal No.142/2021 finally the appellate Tribunal Medical Teaching Institution KPK disposed the said appeal that being a Civil Servant the Tribunal have no power to dispose and the proper forum is the service tribunal, so the said appeal is hereby withdrawn to be placed before the proper forum on 01.06.2023. (Copies of the MTI Tribunal order is attached as annexure "K" Pages _____)

11. That in the meanwhile on 22.06.2023 the appellant moved a departmental appeal to respondent No.3 & 04 respectively. (Copies of the said Departmental Appeal is attached as annexure "C" page _____).

Now being aggrieved from the said illegal tactics of the respondents No.01 to 04, the appellant relies on the given below grounds which are!

GROUND:-

A. That the Appellant is a Civil Servant as evident from appointing letter already annexed with on appeal.

B. That already appellant performing duty in the respondent Hospital as evident from the attendance register and other slips already have been verified by the respondent No.01 hospital.

C. That the transfer retransfer and stoppage of the monthly salary of the appellant are the clear cut ill will, malafide intentions personal bias on the part of the respondents No.03 which indicated from their dualism attitudes /rales.

D. That from date of appointment i.e 25.04.2012 till date appellant performed duty with great efficiency and to stop salary since 2013 till date are the clear cut indications of the bad objectives /designs of the respondents that now, through which process the weak employees specially females are harassed.

E. That the reply submitted to MTI Tribunal KPK Peshawar by the respondent 03 & 04 into appeal No.142/2021 this thing has been admitted at the bar that appellant is a civil servant and the proper forum for appellant is 'the service Tribunal and not MTI

Tribunal. (Reply copy of the respondent 03, 04 as annexed as "M" Page _____).

F. That the respondents are not legally authorized to stop/ban upon the monthly salary since 2013 till to date instead of performing duty regularly till to date without assigning any solid and comprehensive cause / reasons nor any proper explanation in written was conveyed till date i.e 26.06.2023.

G. That if any other facts, grounds found later on will be raised with the prior permission of this August Tribunal at the time of any stage of the instant appeal.

It is, therefore, humbly prayed that on acceptance of the instant Appeal, the monthly salaries stopped illegally by the respondents 01, 02 & 03 since 2013 till date may be released alongwith outstanding after calculations if any and also ordered to take a disciplinary actions against respondents 01, 02 and any who found responsible breath the whole paly to meet the ends of law, justice into true sense.

At this juncture, learned counsel for the respondent pointed out that order dated 27.09.2013 was withdrawn by DGHS on 31.03.2014. Then she was never transferred to DI Khan. We won't like to delve in to all these factual and legal question , on account of lack of jurisdiction. Admittedly MTI reforms Act 2015 was not enforced by then and the appellant was civil servant. Since then till filling of writ petition before Peshawar High Court DI Khan Bench in 2020, she never filed any representation before any judicial forum. In the circumstances she was civil servant when she was transferred from Khalifa Gul Nawaz Hospital to DI Khan, and order was, then withdrawn. Since then till date, there is no order of any competent authority relating to her absorption in MTI Hospital which may confer jurisdiction on this Tribunal, deeming her to be the employee of MTI. When learned counsel for the appellant was</p>

confronted with this legal position he frankly conceded and requested for Withdrawal of the instant appeal, with permission to file the same before the proper forum. Thus, this appeal stands Returned for lack of jurisdiction. Office shall make necessary endorsement on the face of memo of the appeal, retain the copy thereof and original shall be returned to the appellant, with all its annexures.

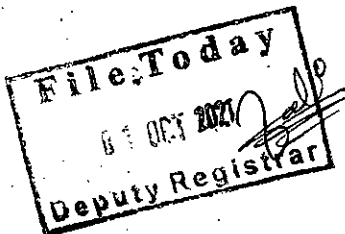

Respectfully Sheweth:

Preliminary Objections:

1. That the instant appeal, is not maintainable under section 16 (A) of the MTI Act, 2015 (Amended) 2020. (Copy of section 16 (a) is attached as ***annexure A***).
2. That the appellant is a civil servant and have the remedy to approach the KPK Services Tribunal under section 3 (A) of the MTI, Act, 2015 for re-dressal of her grievance. (Copy of Section 3 (A) is attached as ***annexure B***).
3. That civil servants who do not opt for absorption in MTI Institution are to be considered on deputation.

FACTS:

1. The contents are correct that the appellant was appointed in DHQ Hospital D. I Khan on 25.04.2012 by the Health Department.
2. That contents relates to the Respondents No. 01 & 02, however, the appellant remained absent from duty since 11.02.2013 till date from Khalifa Gul Nawaz Teaching Hospital, Bannu.
3. The contents relates to Respondents No. 01 & 02, however, the appellant was transferred to Khalifa Gul Nawaz Teaching Hospital Bannu, vide order dated 11.02.2013; but she did not assume the duty & remained absent. (Copy of order is attached as **annexure C**).
4. That contents are incorrect, because appellant was transferred to Khalifa Gul Nawaz Teaching Hospital Bannu on 11.02.2013 and since then never remained on the strength of DHQ Hospital D. I Khan. Later, Respondents No. 01 & 02 issued letter dated 27.09.2013 where appellant was transferred from Khalifa Gul Nawaz Teaching Hospital Bannu to DHQ Hospital D.I Khan, however, Respondents No. 01 & 02 cancelled the said

transfer order vide letter dated 03.03.2014. (Copy of office order dated 27.09.2013 & 03.03.2014 are attached as **annexure D&E**).

5. That the contents are incorrect and not based on true facts because since 2013, the appellant was not on the strength of the DHQ Hospital D.I Khan therefore, salary cannot be issued released.
6. That the appellant has the remedy to approach the proper forum i.e. KPK Services Tribunal being a civil servant for redressal of her grievance.

GROUND:

I. Incorrect, because as admitted being a civil servants, remedy lies before the KPK Service Tribunal and against the Respondent No. 01 & 02.

II&III. Incorrect, because appellant from absent for duty in Khalifa Gul Nawaz Teaching Hospital Bannu since 2013, therefore, cannot claim salary from Respondents No. 03 & 04 being not remained on the strength of its employees

IV. Incorrect, because being a civil servants the appellant is to address her grievance against the respondent No. 01 & 02 and before the KPK Service Tribunal, having jurisdiction.


