Reply/Comments on behalf of Respondent No.4 (Mr. Habib Ullah)

Respectfully Sheweth:-

Preliminary Objections.

- 1. That the appellant is having not cause of action to file the instant service appeal.
- 2. That the service appeal of the appellant is not maintainable in its present form in the light of facts and circumstances of the case.
- 3. That appellant has not come to this Hon,ble Tribunal with clean hands.
- 4. That the appellant has concealed necessary and material facts from this Hon, ble Tribunal, even Respondent No.04 has assumed charged and performing his duty in light of Notification dated: 11-05-2023, hence the appeal of the appellant is infructuous.
- 5. That the appellant is estopped by his own conduct to file the instant appeal.

- 6. That appellant is having BS-16 (ADEO), whereas the post of SDEO pertain to BS-17, further as per notification dated:07-10-2021, whereby the appellant was mentioned at serial No.05, the following remarks are mentioned "SDEO (Male) Town-III, Peshawar in OPS" as such appellant was posted on the bases of own pay scale, hence appellant cannot claim posting on the said post as matter of right.
- 7. That appellant has failed to point out any malafide, ill-will or illegality on part of education department regarding issuing transfer & posting order dated: 11-05-2023, hence the appeal is liable to be dismissed.
- 8. That as far as performing duties in Digital Census of Pakistan, 2023, the said process has already been completed which fact is even mentioned in order of the Hon'able Peshawar High Court passed in Writ Petition No.2361-P/2023, and to the extent of that plea of the appellant writ petition has been dismissed, hence appellant cannot take refugee under the said plea further.
- 9. That as per Election Commission letter dated: 15-09-2023 process of "Updation of Electoral Rolls According to Census Scheme 2023" has been started and Respondent No.04 has been assigned duties as Assistant Returning Officer of different areas of District Peshawar being as SDEO, Town-III, Peshawar to supervise and Verify work pertaining to updation of electoral rolls for electoral areas mentioned against their names, hence the appeal is merit less and liable to be dismissed.

ON FACTS.

1. Para 1 of the appeal is correct to the extent that appellant is the employee of E & SE department, while as far as performance of the appellant is concern the same is subject to prove.

2. Para 2 of the appeal is correct to the extent that appellant was transfer & posted vide notification dated: 07-10-2021 to the post of SDEO (Male) Town-III, Peshawar, but appellant has concealed real facts, as per notification dated:07-10-2021, whereby the appellant was mentioned at serial No.05, the following remarks are mentioned "SDEO (Male) Town-III, Peshawar in OPS" as such appellant was posted on the basis of own pay scale, hence appellant cannot claim posting on the said post as matter of right even there is different seniority list of SDEO (BS-17) and ASDEOs/ADEOs (BS-16) and the name of the appellant is mentioned in the seniority list of BS-16 at Serial No.14, while name of the appellant is not mentioned in the seniority list of BS-17, hence when the post of SDEO pertain to BS-17, how an employee of BS-16 could claim the same as matter of right to be posted on the said post.

(Copy of Seniority list of SDEO "BS-17" and ADEOs "BS-16" are annexed as R-1 & R-2 Respectively)

3. That Para 3 of the appeal is totally misconceived as far as performing duties in Digital Census of Pakistan, 2023, the said process has already been completed which fact is even mentioned in order of the Hon'able Peshawar High Court passed in Writ Petition No.2361-P/2023, and to the extent of that plea of the appellant writ petition has been dismissed, hence appellant cannot take refugee under the said plea before this Hon'able Tribunal, even as per Gazette Notification dated: 07-08-2023 the official results of Digital Census has been issued now, and the said process has been completed, hence appellant has no locus standi to challenge his transfer posting order dated: 11-05-2023 on the bases of aforesaid plea.

(Copy of Gazette Notification of Digital Census 2023 are annexed as R-3)

4. Para 04 of the appeal of the appellant is totally incorrect against law & facts, the transfer of a government official from one place or post of another is to meet the exigencies of service which fall within the exclusive domain of competence of the competent authorities of the executive organ of the state and ordinarily it is not amenable to

interference except in extraordinary circumstances, but the appellant failed to point out any extraordinary circumstances, nor any malafide, ill-will or illegality on part of education department regarding issuing transfer & posting order dated: 11-05-2023, even , while in light of the said notification appellant as well as Respondent No.04 has assumed charged, made his arrival report at their respective posting while respondent No.04 pay release order has been issued and since June Respondent No.04 and appellant are receiving their salaries on the said new posting, hence the appeal of the appellant is meritless and has become infructuous and the same is liable to be dismissed.

5. Para 5 of the appeal is correct to the extent that Writ Petition of the appellant on the analogy of performing duties at the Digital Census has been not considered by the Worthy Peshawar High Court & dismiss the Writ petition of the appellant, while as far as approaching before this Hon'able Tribunal the appellant is having no right to challenge the transfer & posting Notification dated: 11-05-2023 which was issued in accordance with law & rules, even the Election Commission of Pakistan vide letter dated: 15-09-2023 has started process of "Updation of Electoral Rolls According to Census Scheme 2023" and Respondent No.04 has been assigned duties as Assistant Returning Officer of different areas of District Peshawar being as SDEO, Town-III, Peshawar to supervise and Verify work pertaining to updation of electoral rolls for electoral areas mentioned against their names, hence any order at this stage could create further complication, hence the appeal at this stage in not maintainable and liable to be dismissed.

(Copy of Election Commission of Pakistan letter dated: 15-09-2023 & duties assigned to respondent No.04 at the areas mentioned against his name are annexed as R-5)

6. Para 6 of the appeal of the appellant is also incorrect, since no vested right of the appellant has been infringed therefore he is not an aggrieved person hence having no locus standi to file the instant service appeal.

issued in accordance with law and with the executive authority domain, hence appellant has no right to challenge the said notification.

- B. Ground B of the appeal is incorrect, as the transfer & posting notification dated: 11-05-2023 is neither violation of any law or any fundamental rights (i.e Article 04 & 25 of Constitution of Pakistan 1973), rather the same is will the official capacity of the education department, and for the progress and best public interest the competent authority can issued transfer & posting orders, even no official of education department could refuse his posting from one place to another on his own whim & wishes, rather the same is sole prerogative of the competent authority, hence the plea of the appellant is baseless.
- C. Ground C of the appeal of the appellant is totally misconceived and incorrect, firstly appellant failed to show any violation of law & policy and even appellant has failed to point out any malafide on part of education department, even appellant cannot claim post of SDEO (BS-17) as matter of right, while appellant is currently working on the post of ASDEO (BS-16), hence when proper procedure of promotion is available, the stance of the appellant is legally and factually not sustainable and not warranted under the law.
- D. In response to Ground D of the appeal, it is submitted that the appellant was posted only on the base of Own Pay Scale on the bases of Notification dated: 07-10-2021, hence the case of the appellant does not fall within the violation of Clause-I to IV of the transfer/posting Policy of the Provincial Government, rather appellant has tried to interpret the said policy under misconception, hence appellant failed to point out any illegality in the Notification dated: 11-05-2023.
- E. Ground E of appeal of the appellant is legally and faculty incorrect, appellant has file department appeal, approached the Worthy Peshawar High court by filling writ petition which

accordingly dismissed, and even appellant has approached this Hon'able Tribunal, as such the appellant defence under the principle of Natural Justice is not sustainable.

F. Ground F of the appeal is misconceived; no one can be allowed to plead beyond his pleading.

> It is therefore most humbly prayed that in the light of the above submission & written comments on behalf of Respondent No.04, the appeal of the appellant may graciously be dismissed with cost throughout.




