8. That, a theft took place at Range office Shergarh in 2012 in which a Govt Kalashnikov and cash amount Rs. 120,000/-, (recovered

from defaulters), was stolen. An FIR dated 17/10/2012, was lodged with Police Station Ogi to this effect. The petitioner deposited an amount of Rs. 120,000/- from his own pocket to make good the amount which was stolen from the Range Office, Shergarh.

- vii. That, the petitioner's pension / post retirement emoluments are held by the respondents illegally for which petitioner needs to be compensated at the current rate of interest as prevailing in the commercial banks.
- viii. That, petitioner also reserves a legal right to claim heavy damages against the Forest Department/Respondents for illegally / unlawfully delaying his pension / post retirement emoluments thereby causing the petitioner an extreme financial loss / hardship

and severe mental agony.

ix. That, without conducting any formal enquiry, how can forest depart charge sheet the petitioner and blamed the petitioner for an unfounded and baseless allegation of missing timber as well as

stolen Kalashnikov for which an FIR had already been registered with the concerned Police Station.





- No, the appellant alongwith SDFO Shergarh of that era would have provided the 5. exact detail of timber in question.
- Correct to the extent of explanation given in para-1 consented with para-3
- Correct to the extent that now present incharge of Central Sale Depot Mansehra can 6. 7. exactly locate the position of the consignment under reference.

To sum up and connect above paras, it is easily concluded that:-

- 1. The contentious consignment has been surely transported to its destiny at Central Sale Depot Mansehra
- 2. The contents of the appeal of the appellant carry weight in the eyes of law and merit/ qualify for sympathetic consideration.
- 3. The whereabouts of the missing timber (21 Kail Scants = 72.49-Cft) need to be ascertained from the concerned corner.

Hence keeping in view above exposition, it is requested/ recommended that:-

BRIEF HISTORY OF THE CASE

Consequent upon detection of shortage in timber transported from various localities of Agror Tanawal Forest Division to Central Timber Sale Depot Mansehra through Form-D, Mr. Dost Muhammad Forester was charge sheeted vide DFO Agror Tanawal Forest Division endorsement No.3871-73/GE, dated 16/02/2016 and Mr. Muhammad Riaz DFO Siran was appointed as an Enquiry Officer to initiate disciplinary proceedings against the accused official.

After detail enquiry under the domain of Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011 and in pursuance with the recommendation of Enquiry Officer contained in enquiry report, the DFO Agror Tanawal in the capacity of Authority after completion of coddle formalities imposed recovery of Rs.72490/- on the accused Forester on account of shortage of 72.49 Cft Kail timber at prevailing market rates of Rs.1000/- vide office order No.396, dated 15/6/2017.

Being aggrieved, Mr. Dost Muhammad Forester preferred an appeal dated 06/7/2017 before the undersigned being Appellate Authority which was sent to DFO Agror Tanawal vide Conservator of Forests, Upper Hazara Forest Circle letter No.240/GE, dated 11/7/2017 for comments. In compliance, the DFO Agror Tanawal Forest Division Oghi vide his letter No.630/GE, dated 10/8/2017 furnished para-wise comments with the following recommendations:

- a. The instant appeal may be valued and thumbed up.
- b. In order to ascertain the factual position of the missing timber, DFO Siran may be approached to get the matter probed through present Incharge Sale Depot Mansehra.

The appellant also heared in person on 8/9/2017 as per provision of rules during which he substantiated and reviewed his stance as mentioned in the appeal.

DISCUSSION

According to the rules and procedure in vogue, it was the prime responsibility of SDFO Shergarh to arrange transportation of seized/confiscated or departmentally procured timber either from Sub-Divisional headquarter or elsewhere to Timber Sale Depot at Mansehra through Form-D to be signed under his own signature and then assigned the task to any official to

accompany the vehicle loaded with timber upto the mentioned destination and get the said consignment acknowledged from Depot Incharge on Form-F. Thereafter it was sole responsibility of SDFO Shergarh to prepare lot and transmit lot-wara to Divisional Office for its further processing for disposal/sale under the settled procedure. The appellant in compliance with the directives of his incharge, SDFO Shergarh, has transported 21 Kail Scants=73.29 Cft from Shergarh Forest Sub-Division to Central Sale Depot Mansehra alongwith other consignment through Form-D bearing No.28 and handed over the same in Central Sale Depot Mansehra by obtaining proper Form-F bearing No.99/20 on 23/6/2012 which indicates that the appellant Mr. Dost Muhammad Forester accomplished the assigned task most swiftly. It was the liberty of SDFO Shergarh to prepare proper sizewara of timber/lot for submission to Divisional Office and to ensure its disposal through open auction on scheduled date but he failed.

CONCLUSION

The crux of the above discussion invariable concludes that the appellant has accomplished the assigned task properly and dedicatedly therefore the punishment so awarded by the DFO Agror Tanawal is not justified. It was the liberty of SDFO Shergarh to follow the matter with regard to disposal of mentioned consignment after its receipt in Central Timber Sale Depot Mansehra for which he shall be asked for.

ORDER

Keeping in view the above discussion and conclusion, the undersigned in the capacity of Appellate Authority do hereby order that:

- 1. The DFO Agror Tanawal Forest Division Oghi office order No.396, dated 15/6/2017 hereby set-aside and Mr. Dost Muhammad Forester is exonerated from the charges which resulted into the recovery of Rs.72490/-.
- 2. The Depot incharge as recommended by the DFO Agror Tanawal in his referred letter is not responsible for the mentioned timber. The SDFO Shergarh shall have to consult record pertaining to the said timber and its further status. In case of failure recovery should be made from the then SDFO Shergarh after fulfillment of prerequisites as per rules.



Upon search of room he found that some articles i.e weapon, bullets 7.62 bore & amount 18:1,20,000/- were missing, hence the instant application and upon the said application the instant FIR was lodged.

After completion of investigation, complete challan against the accused

was submitted before the court.

Mohammad Gulzar IHC PS Oghi appeared before the court and recorded his statement as PW-3 who premared site plan Ex:PW3/1, recovery memo Ex:PW3/2 and he also prepared card of arrest of the accused which is Ex:PW3/3.

After closing the evidence of prosecution, statement of accused recorded Ruls:342 Cr.PC. The accused facing that neither willing to produce any defense nor desired to be examined on outh. So the case was fixed for argument

After hearing the arguments and from perusal of the record it was observed that the complainant himself did not see the accused facing trial wh committing the offence. Further there is no eyewitness of the occurrence and Acres of the PWs deposed before the edurt that he saw the accused facing trial committing the theft. Similarly when LO appeared before the court he recorded his statement as PW-3 who deposed during cross examination that complainant is not eyewitness of the occurrence. NON PREPARATION OF LOT OF CONFISCATED TIMBER OF SHERGARH FOREST SUB-DIVISION- RECOVERY THEREOF.

The timber i.e 21 Kail Scants = 72-49 of Form- D No. 28 dated 1-6-2012 was transported from Shergarh Forest Sub-Division to Central Sale Depot Mansehra by you, but lot was not prepared due to which the timber was missed without auctioning, in this regard disciplinary proceedings was initiated against M/S Zulfaqar Khan Forester the then Incharge Shergarh Forest Sub-Divison, Mr. Dost Mohammad and Mr. Sher Badhar Foresters and appointed Mr. Muhammad Ríaz Divisional Forest Officer Siran Forest Division Mansehra as enquiry officer to initiate disciplinary proceedings against the accused official. After detail enquiry under the domain of Khyber Pakhtunkhwa Government Servant (E&D) Rules 2011 and in pursuance with recommendation of Enquiry Officer contained in enquiry report, imposed recovery of Rs. 72490/- on Mr. Dost Mohammad Forester on account of shortage of 72.49-Cft Kail timber at prevailing market rates of Rs. 1000/- vide office order No. 396 dated 15-6-2017.

The Forester preferred an appeal to the appellate authority (Conservator of Forests Upper Hazara Forest Circle Mansehra, who decided the case vide office order No. 02 dated 15-9-2017 (Copy enclosed) that according to the rules and procedure in vogue, it was the prime responsibility of SDFO Shergarh to arrange transportation of seized/ confiscated or departmentally procured timber either from Sub-Divisional headquarter or elsewhere to timber Sale Depot at Mansehra through Form-D to be signed under his own signature and then assigned the task to any official to accompany the vehicle loaded with timber upto the mentioned destination and get the said consignment acknowledged from Depot Incharge on Form-F. Thereafter it was sole responsibility of SDFO Shergarh to prepare lot and transmit lot-wara to Divisional Office for its further processing for disposal/ sale under the settled procedure. The Forester namely Dost Muhammad in compliance with your directives has transported 21 Kail Scants = 72.49-Cft from Shergarh Forest Sub-Division to Central Sale Depot Mansehra alongwith other consignment through Form-D bearing No. 28 and handed over the same in Central Sale Depot Mansehra obtaining proper Form-F bearing No. 99/20 on 23-6-2012 which indicates that the Forester accomplished the assigned task swiftly. It was your responsibility being Incharge Sub-Division to prepare proper sizewara of timber / lot for submission to Divisional Office and to ensure its disposal through open auction on scheduled date but you failed to do so.

The above detail was provided to the officials for clarification about its disposal with the directives to intimate lot number of each consignment through which it was disposed off vide DFO Agror Tanawal Forest Division letter No. 5275-77/GB dated 15.6.2015 but despite issuance of reminders they failed to clarify the position which lead their Inefficiency, Misconduct & Corruption.

PROCEEDINGS

The DFO Agror Tanawal in the capacity of authority served Charge Sheet vide letter No. 3868-70/GE with statement of allegation vide No. 3856-58/GE dated 16.2.2016 respectively upon Mr. Zulfiqar Khan Forester the then incharge Shergarh Forest Sub-Division, Charge Sheet No. 3871-73/GE and statement of allegation vide No. 3859-61/GE dated 16.2.2016 upon Dost Muhammad Forester and charge sheet vide No. 3865-67/GE alongwith statement of allegation vide No. 3862-64/GE dated 16.2.2016 upon Sher Bahadar Forester and appointed the undersigned as an enquiry officer to initiate disciplinary proceedings against the accused officials under the rules and submit the report.

DISSCUSSION

After issuance series of reminder, the accused officials furnished their replies to the charge sheets separately. The crux of their replies is as under:

ZULFIQAR KHAN FORESTER

605 scants= 2587.55 cft timber transported through incharge Shergarh Block, after counting, verification according to the record issued Form-F which was delivered to incharge Lease Branch of Divisional Officer through concerned incharge Range Officer Shergarh. The entire timber has been disposed off through open auction which accordingly authenticated in Form-5 & 6.

During the period from 1.5.2012 to 31.1.2015 various officer worked as SDFO Shergarh. Most probably these officers accompanied the DFO Agror Tanawal during auction and the detail of auction value would exist in the Cash Book of Divisional Accountant or Head Clerk. Such huge amount neither could retain with the Chowkidar nor without approval of DFO is timber released without signature of DFO. The allegations leveled against him are void and just discoloration him.

DOST MUHAMMAD FORESTER

- 1. That the enlisted timber seized from various Beats/Blocks and transported to Shergarh Range Office by them which subsequently on the directives of SDFO Shergarh transported to Central Sale Depot Mansehra through Form-D. After acknowledging the timber on Form-F, thereafter he was responsible for preparation of size-wara/lot-wara and its delivery to SDFO Shergarh which he did most prominently. Out of the enlisted timber, some timber has been transported to Central Sale Depot under the supervision of Sher Bahadar Forester and some of Ghulam Muhammad Forest Guard.
 - That after issuance of Form-F it was the sole responsibility of depot incharge to protect the timber through Depot Chowkidar. The timber lying in Mansehra Depot is auctioned by the respective DFO with the collaboration of Depot incharge.
- 3. In case the staff of Divisional Office Agror Tanawal analyze the timber transported with that disposed off through auction in shape of small lots and thereafter released to purchaser after recovery of government dues, the instant enquiry will not be required.
 - 4. That he diverted the attention of the concerned staff of DFO office to carryout proper verification of the record with regard to timber auctioned in order to elaborate the factual position yet he has

been held responsible irrespective of the facts that he has recorded full particulars on the lot-

That entire timber transported to Central Sale Depot Mansehra has been released to the purchaser but instead of scrutinizing the record action has been initiated against him.

Entire relevant record is available in Divisional Office for which dealing hands are informed but his request has not been entertained. The allegations leveled against him are not justified, therefore he may be absolved.

CONCLUSION

The replies furnished by all the three accused officials have been analyzed critically with the record provided by the DFO Agror Tanawal after lengthy correspondence. The factual position is as under:

I may like to mention here regarding contemptible role of prosecution. Despite issuance of repeated reminders in writing as well as telephonic contacts the desired record/information has not been supplied by the office dealing hand well in time due to which proceeding delayed therefore he deserve for appropriate action.

However, the lots files received by the undersigned have been thrashed very minutely and whereabouts of following timber has not been known:

The above detail concluded that:

- 1. According to the rules and procedure, it was the sole responsibility of SDFO/RFO to record necessary entry on Form-17 as and when any timber seized either by him or by lower staff. After appropriation of seized timber, the SDFO/RFO has to transfer the seized timber to Timber Form-7 and arrange its transportation to Central Sale Depot Mansehra for disposal. Thereafter it was the responsibility of SDFO to prepare proper lot of transported timber either in accordance with quantum of timber mentioned in Form-D or Form-F issued by the depot incharge and then forward to DFO Office duly certified but in the instant case rules/procedure has totally been violated and whole responsibility has been shifted on the shoulder of lower staff which proves his inefficiency.
- 2. Mr. Zulfiqar Khan Forester the then incharge Shergarh Forest Sub-Division has mentioned in his reply that entire detail of timber is available in the Cash Books of Head Clerk and Accountant. Such blemish sentence of the official hold the charge of BPS-17 is very shocking rather indicating that he is totally ignorant about the rules/procedure. In fact all the reports submitted by the SDFOs/RFOs are compiled in Divisional Office but here the incumbent badly failed to supply the desired information with documents which otherwise proved his inefficiency.
- 3. Mr. Dost Muhammad Forester (the accused officials) failed to provide any documentary proof showing the detail of lot-wara through which the consignment of Form-D i.e 21 Kail scants = 72.49 cft has been disposed off hence charge of Inefficiency stand proved and is liable to pay value of timber on prevailing market rates on which the timber of said species disposed off at the time i.e June 2012. However charges of Misconduct & Corruption could not find proved.

Mr. Sher Bahadar Forester has provided detail of timber transported under his supervision and subsequently disposed off. Hence the charges leveled against him are not proved.

It was the sole responsibility of SDFO Shergarh to issue Form-D under his own signature authorizing any Forester or Forest Guard to transport the timber to Central Sale Depot Mansehra. Thereafter being custodian of state property, the SDFO Shergarh was required to prepare proper size wara of timber showing the particular of timber i.e Species, logs/scants, volume. Destination

from where obtained/seized, Damage Report No. with date, Form-D No & Form-F No. after completion of documentation but he failed to discharge his obligatory duty in appropriate manner.

6. It is the responsibility of incharge Lease Branch to analyze the contents of timber transported to Central Sale Depot on Form-D after recording proper entries on Timber Form-7 and 17 with the detail of timber put to open action after preparation of size-wara as well as with monthly progress report with regard disposal of timber but he failed to-do-so.

RECOMMENDATIONS

Keeping in view the above conclusion the undersigned in the capacity of enquiry officer hereby recommend:

1. Recovery of cost of timber i.e **21 Kail scants = 72.49 cft** as mentioned above shall be recovered on prevailing market rates at the time the timber transported to Central Sale Depot Mansehra from Mr. Dost Muhammad Forester who transported the timber through Form-D but he failed to process further for its disposal according to the procedure in vogue. The SDFO Shergarh holding the charge during the month of 6/2012 shall also explain regarding his failure in maintenance of relevant record and furnishing of lot-wara of this timber to DFO Agror Tanawal for disposal of timber.

2. M/S Zulfiqar Khan Forester the then incharge Shergarh Forest Sul Division and Sher Bahadar Forester may be exonerated from the charges.



- 5. No, the appellant alongwith SDFO Shergarh of that era would have provided the exact detail of timber in question.
- 6. Correct to the extent of explanation given in para-1 consented with para-3
- 7. Correct to the extent that now present incharge of Central Sale Depot Mansehra can exactly locate the position of the consignment under reference.

To sum up and connect above paras, it is easily concluded that:-

- The contentious consignment has been surely transported to its destiny at Central Sale Depot Mansehra.
- 2. The contents of the appeal of the appellant carry weight in the eyes of law and merit/qualify for sympathetic consideration.
- 3. The whereabouts of the missing timber (21 Kail Scants = 72.49-Cft) need to be ascertained from the concerned corner.

Hence keeping in view above exposition, it is requested/ recommended that:-

a. The instant appeal may be valued and thumbed up.

b. In order to ascertain the factual position of the missing timber, DFO Siran may indly be approached to get the matter probed through present Incharge Sale Depot Mansehra.

BRIEF HISTORY OF THE CASE

Consequent upon detection of shortage in timber transported from various localities of Agror Tanawal Forest Division to Central Timber Sale Depot Mansehra through Form-D, Mr. Dost Muhammad Forester was charge sheeted vide DFO Agror Tanawal Forest Division endorsement No.3871-73/GE, dated 16/02/2016 and Mr. Muhammad Riaz DFO Siran was appointed as an Enquiry Officer to initiate disciplinary proceedings against the accused official.

After detail enquiry under the domain of Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011 and in pursuance with the recommendation of Enquiry Officer contained in enquiry report, the DFO Agror Tanawal in the capacity of Authority after completion of coddle formalities imposed recovery of Rs.72490/- on the accused Forester on account of shortage of 72.49 Cft Kail timber at prevailing market rates of Rs.1000/- vide office order No.396, dated 15/6/2017.

Being aggrieved, Mr. Dost Muhammad Forester preferred an appeal dated 06/7/2017 before the undersigned being Appellate Authority which was sent to DFO Agror Tanawal vide Conservator of Forests, Upper Hazara Forest Circle letter No.240/GE, dated 11/7/2017 for comments. In compliance, the DFO Agror Tanawal Forest Division Oghi vide his letter No.630/GE, dated 10/8/2017 furnished para-wise comments with the following recommendations:

- a. The instant appeal may be valued and thumbed up.
- b. In order to ascertain the factual position of the missing timber, DFO Siran may be approached to get the matter probed through present Incharge Sale Depot Mansehra.

The appellant also heared in person on 8/9/2017 as per provision of rules during which he substantiated and reviewed his stance as mentioned in the appeal.

DISCUSSION

ATTESTED

According to the rules and procedure in vogue, it was the prime responsibility of SDFO Shergarh to arrange transportation of seized/confiscated or departmentally procured timber either from Sub-Divisional headquarter or elsewhere to Timber ar Mansehra through Form-D to be signed under his own signature and then assigned the task to any official to

accompany the vehicle loaded with timber upto the mentioned destination and get the said consignment acknowledged from Depot Incharge on Form-F. Thereafter it was sole responsibility of SDFO Shergarh to prepare lot and transmit lot-wara to Divisional Office for its further processing for disposal/sale under the settled procedure. The appellant in compliance with the directives of his incharge, SDFO Shergarh, has transported 21 Kail Scants=73.29 Cft from Shergarh Forest Sub-Division to Central Sale Depot Mansehra alongwith other consignment through Form-D bearing No.28 and handed over the same in Central Sale Depot Mansehra by obtaining proper Form-F bearing No.99/20 on 23/6/2012 which indicates that the appellant Mr. Dost Muhammad Forester accomplished the assigned task most swiftly. It was the liberty of SDFO Shergarh to prepare proper sizewara of timber/lot for submission to Divisional Office and to ensure its disposal through open auction on scheduled date but he failed.

CONCLUSION

The crux of the above discussion invariable concludes that the appellant has accomplished the assigned task properly and dedicatedly therefore the punishment so awarded by the DFO Agror Tanawal is not justified. It was the liberty of SDFO Shergarh to follow the matter with regard to disposal of mentioned consignment after its receipt in Central Timber Sale Depot Mansehra for which he shall be asked for.

ORDER

Keeping in view the above discussion and conclusion, the undersigned in the capacity of Appellate Authority do hereby order that:

- 1. The DFO Agror Tanawal Forest Division Oghi office order No.396, dated 15/6/2017 is hereby set-aside and Mr. Dost Muhammad Forester is exonerated from the charges which resulted into the recovery of Rs.72490/-.
- The Depot incharge as recommended by the DFO Agror Tanawal in his referred letter is not responsible for the mentioned timber. The SDFO Shergarh shall have to consult record pertaining to the said timber and its further status. In case of failure recovery should be made from the then SDFO Shergarh after fulfillment of prerequisites as per rules.



BRIEF HISTORY OF THE CASE

Consequent upon detection of shortage in timber transported from various localities of Agror Tanawal Forest Division to Central Timber Sale Depot Mansehra through Form-D, Mr. Dost Muhammad Forester was charge sheeted vide DFO Agror Tanawal Forest Division endorsement No.3871-73/GE, dated 16/02/2016 and Mr. Muhammad Riaz DFO Siran was appointed as an Enquiry Officer to initiate disciplinary proceedings against the accused official.

After detail enquiry under the domain of Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011 and in pursuance with the recommendation of Enquiry Officer contained in enquiry report, the DFO Agror Tanawal in the capacity of Authority after completion of coddle formatiles imposed recovery of Rs.72490/- on the accused Forester on account of shortage of 72.49 CR Kail timber at prevailing market rates of Rs.1000/- vide office order No.396, dated 15/6/2017

Being aggrieved, Mr. Dost Muhammad Forester preferred an appeal dated 06/7/2017 before the undersigned being Appellate Authority which was sent to DFO Agror Tanawał vide Conservator of Forests, Upper Hazara Forest Circle letter No.240/GE, dated 11/7/2017 for comments. In compliance, the DFO Agror Tanawal Forest Division Oghi vide his letter No.630/GE, dated 10/8/2017 furnished para-wise comments with the following recommendations:

- a. The instant appeal may be valued and thumbed up.
- b. In order to ascertain the factual position of the missing timber, DFO Siran may be approached to get the matter probed through present Incharge Sale Depot Mansehra.

The appellant also heared in person on 8/9/2017 as per provision of rules during which he substantiated and reviewed his stance as mentioned in the appeal.

DISCUSSION

According to the rules and procedure in vogue, it was the prime responsibility of SOFO Shergarh to arrange transportation of seized/confiscated or departmentally procured tember either from Sub-Divisional headquarter or elsewhere to Timber Sale Depot at Mansenra through Form-D to be signed under his own signature and then assigned the task to any official to

company the vehicle loaded with timber upto the mentioned destination and get the said tonsignment acknowledged from Depot Incharge on Form-F. Thereafter it was sole responsibility of SDFO Shergarh to prepare lot and transmit lot-wara to Divisional Office for its further processing for disposal/sale under the settled procedure. The appellant in compliance with the directives of his incharge, SDFO Shergarh, has transported 21 Kail Scants=73.29 Cft from Shergarh Forest Sub-Division to Central Sale Depot Mansehra alongwith other consignment through Form-D bearing No.28 and handed over the same in Central Sale Depot Mansehra by obtaining proper Form-F bearing No.99/20 on 23/6/2012 which indicates that the appellant Mr. Dost Muhammad Forester accomplished the assigned task most swiftly. It was the liberty of SDFO Shergarh to prepare proper sizewara of timber/lot for submission to Divisional Office and to ensure its disposal through open auction on scheduled date but he failed.

CONCLUSION

The crux of the above discussion invariable concludes that the appellant has accomplished the assigned task properly and dedicatedly therefore the punishment so awarded by the DFO Agror Tanawal is not justified. It was the liberty of SDFO Shergarh to follow the matter with regard to disposal of mentioned consignment after its receipt in Central Timber Sale Depot Mansehra for which he shall be asked for.

ORDER

Keeping in view the above discussion and conclusion, the undersigned in the capacity of Appellate Authority do hereby order that:

 The DFO Agror Tanawal Forest Division Oghi office order No.396, dated 15/6/2017 is hereby set-aside and Mr. Dost Muhammad Forester is exonerated from the charges which resulted into the recovery of Rs.72490/-.

2. The Depot incharge as recommended by the DFO Agror Tanawal in his referred letter is not responsible for the mentioned timber. The SDFO Shergarh shall have to consult record pertaining to the said timber and its further status. In case of failure recovery should be made from the then SDFO Shergarh after fulfillment of prerequisites as per rules.
