This order shall dispose of the departmental appoil proferred by Mr. Bakht. Biland, ex- Assistant Accounts Officer, Office of the Accountant General (AG). Khyber Pakhtunkhwa (KPK), Pestawar, against major penalty of 'reduction to lower post' of Senior Auditor (BPS-10) from the substantive post of Assistant Accounts Officer (BPS-17) w.o.f. 15-09-2022 for a period of three years, as specified under Rule 4(3)(b) of Civil Servants (Efficiency and Discipline) Rules. 2020, Imposed upon him by the Controller General of Accounts (CGA) (Authority In this case).

- The Appellant was proceeded against on the charges of inefficiency. 2. misconduct and corruption within the meaning of Rule 3(a)(b) \$ (c) of Civil Servants (E&D) Rules, 2020. The Appellant was served with Charge Sheet, dated 01.11.2021. and Mr. Muharrimad Tahir, Accounts Officer, Office of the AG (KPK), Peshawar, was appointed as Inquiry Officer Linder Rule 9(1) of the Rulk's 10/11. After completion of inquiry, the Appellant was served with Show Cause Notice dated 28.02.2022, providing therewith a copy of inquity report. Subsequently, the Appellant was afforded personal hearing by the Authority on 15.09.2022. After hearing arguments of the Appellant during personal hearing and considering the available record, the Authority i.e. Controller General of Accounts (CGA), in exercise of powers conferred upon him under Rule /6(7)(b) of Civil Servaçts (Efficiency and Discipline) Rules. 2020, imposed major/penalty of freduction to lower post of Senior Auditor (BPS-16) from the substantive post of Assistant Accounts Officer (BPS-17) w.e.f. 15-09-2022 for a period of three years', as specified under Rule 4(3)(b) of the Rules ibid, upon the Appellant vide notification, dated 20.09.2022.
- 3. Being aggrieved, the Appellant preferred the representation/departmental appeal, to Pinanca Secretary/Appellate Authority against the order of the Authority. The Appellant was afforded personal hearing on 25.01.2023. Departmental representative of the office of CGA also attended the hearing.
