AMENDED SERVICE APPEAL UNDER SECTION 04 **OF** THE **SERVICE ACT** TRIBUNAL READ WITH ARTICLE 212 **OF** THE CONSTITUTION OF **ISLAMIC** REPUBLIC OF PAKISTAN OF 1973.

Respectfully Sheweth:

- That the appellant is bonafide resident of Village Malak Khel Kotkay District Shangla.
- 2. That basically appellant was appointed as Forest Guard in Alpuri Forest Division.
- 3. That the appellant served for almost 08 years in forest sub division Alpuri in district Shangla.
- 4. That respondent No. 07/DFO Alpuri district Shangla dismissed appellant through office order No. 02 dated 06.07.2017.
 - (Copy of Order No. 02 dated 06.07.2017 is attached as annexure " \mathbf{A} ")
- 5. That earlier a complaint was preferred by a civilian (Mr. Usman Ghani) before Chief Conservator of forests

Malakand alleging illicit cutting of trees in Bazarkot Forest block of District Shangla.

(Copy of complaint is attached as annexure "B" and better copy as annexed "B-1")

- 6. That the petitioner, being Forest Guard working in the said forest block was implicated on the plea of connivance, consequent to checking report of DFO patrol squad forest division Swat/respondent No. 05.
- 7. That DFO Alpuri/respondent No. 07 without the slightest resort to any law (in terms of proper enquiry as provided under E&D rules 2011) issued a show cause notice to the petitioner. The petitioner denied in his reply to the show cause notice but the respondent No. 7 issued his dismissal order No. 02 dated 06.07.2017 straight away.
- 8. That in addition to above, the Range Forest Officer Alpuri was charge sheeted for the same charge and one other Forest Guard and one forester were also dismissed for alleged charge.
- 9. That respondent No. 06 was appointed as enquiry officer as provided under the relevant rule to conduct proper enquiry against the Range Officer Alpuri regarding the alleged stance.

- 10. That after detailed investigation/inquiry the charges leveled in the case could not be proved/established against the Range Forest Officer Alpuri. It was also reported by the enquiry officer that the forest damage could not be found and that he time and again requested DFO Patrol Squad Swat and DFO Alpuri to join the enquiry committee in order to verify the trees that were cut but they failed to join the inquiry. (Copy of letter is attached as annexure "C")
- 11. That the complaint had implicated 15 respondents apart from staff of forest department as responsible for alleged forest damage, on the plea of personal agony regarding forest royalty issues while seeking support from department. DFO Alpuri and others, unfortunately, could not investigate the matter and issued the impugned orders in utter self defense and in violation of laws of the country.
- 12. That the Range Officer Alpuri was implicated on identical grounds leveled against the appellant but charges could not be established against him, and the appellant, therefore, stood discriminated.
- 13. That DFO Patrol Squad Swat, who was entrusted the checking of forest complaint, but he instead acted on behalf of DFO Alpuri, issued transport pass in respect of the reported timber. It is very strange that he

reported 12514 CFT of fresh timber cut but he recovered only 1256.54 CFT of old timber procured from dry/wind fallen trees.

- 14. That the DFO Alpuri/Respondent No. 07 worked as prosecutor which is against the law and he acted illegally by inflicting harsh punish by dismissing the petitioner with colorful exercise of powers.
- 15. That earlier a show cause notice was served upon appellant, in the said show cause notice it was alleged that a huge amount of illegal trees were cut down due to negligence of forest staff.

 (Copy of show cause notice is attached as any area #D#

(Copy of show cause notice is attached as annexure "D" and better copy as annexure "D-1")

- 16. That in response to the show cause notice it was replied by the appellant that the allegation was baseless and trees were not cut down in the said compartment 1 to 12 block Bazar Kot of Alpuri Forest Division.
- 17. That the appellant submitted a departmental appeal before respondent No. 04 on dated 25.7.2017.(Copy of appeal is attached as annexure "E")

- 18. That apart from appellant one other forest guard and one forester were also dismissed by respondent No. 07.
- 19. That in the same matter Range Forest Officer Mr. Alamgir was also charge sheeted.
- 20. That respondent No. 02 appointed respondent No. 6 as inquiry officer in order to find out the reality of the matter concerned.
- 21. That the inquiry officer/respondent No. 06 through its inquiry report declared Mr. Alamgir Range Forest Officer Alpuri as innocent and declared that no illegal cutting of trees were observed by him. The inquiry officer also observed that a small amount of timber of about 1256.54 Cft was recovered from dry and fallen trees.

(Copy of Inquiry report is attached as annexure "F")

22. That respondent No. 8 illegally showed a huge amount of 12514 CFT of timber in his report. While no such kind of recovery was made while it is clearer from show cause notice that about twelve thousand CFT of fake recovery, by reproducing one recovery again in the said show cause notice.

- 23. That the applicant acted blindly by implicating a dead person named *Nakhood* son of *Naqshay* in the FIR No. 23 dated 9.5.2017 of police station Alpuri district Shangla lodged in this respect as accused No. 13. (Copy of FIR No. 23 dated 9.5.2017 of police station Alpuri district Shangla is annexed as annexure "G", better copy of FIR as annexure "G-1" and Death certificate as annexure "H")
- 24. That in the previous years it was recommended by petrol squad that a large number of trees are fallen due to heavy snow fall and the said timber is required to be recovered.

(Copy of report is attached as annexure "I")

- 25. That in the inquiry report, the inquiry officer exonerated all concerned staff including appellant and recommended them to be reinstated.
- 26. That range officer Mr. Alamgir latter on joined his duty on the basis of inquiry report while the appellant along with other forest guards are still waiting the decision.
- 27. That the appellant is a poor person and has no meanings to earn bread for his family.

- 28. That the appellant filed departmental appeal/ presentation but the respondent failed to consider the said departmental appeal therefore the instant writ petition is being filed before this honourable court for to treat appellant with range officer Mr. Alamgir who was reinstated as range forest officer on the basis of inquiry conducted by inquiry officer.
- 30. That the appellant also filled a writ petition before the honorable Peshawar High court Mingora bench on dated 22.11.2017 which was dismissed on dated 29.11 2017 as without jurisdiction and the appellant was directed to file a departmental appeal before service tribunal. While the respondent were directed to considered it as departmental appeal/presentation.
- 31. That the appellant is entitling for condonation of delay / limitation from 22. 11. 2017 till 29. 11. 2017 as writ petition No. W.P 827-M of 2017 was pending before the August Peshawar high court Mingora Bench. Copy of judgment Peshawar High Court Mingora Bench will be produced at the time of final argument or will be annexed with rejoinder.

(Application of condonation is attached as annexure "J")

32. That letter on during the pendency of the instant service appeal, Conservator Forest Malakand Division through

its order modified the order of dismissal from service to removal of service through office order No. 58 dated 18.01.2018.

(Copy of removal order is attached as annexure "K")

- 33. That the petitioner was condemned unheard he was not called for personal hearing and without any reason the petitioner was removed from service.
- 34. That the action of Conservator of Forest Malakand Division is against law and equity because the earlier primary fake and sham inquiry was also conducted by Mr. Muhammad Yousaf Khan when he was posted DFO Petrol Squad and on the basis of said adventurism he was promoted to the post of Conservator Forest it shows that he protected his illegal acts by removing petitioner from service. It is against the principle of law that no one should be a judge of its own cause.
- 35. That the Forest Department play a vital part in the local politics of district Shangla and the present government/ local politicians want to depute their loyal persons and exert political pressure on the people and get vote from them as the petitioner denied to work for political gains on local bases for the ruling class.

36. That being aggrieved and dissatisfied, the petitioner seeking the indulgence of this honorable court through this service appeal/petition inter alia on the following grounds: -

GROUNDS: -

- A. Because the appellant was condemned unheard.
- B. because the appellant was not properly charge sheeted.
- C. Because no opportunity was given to appellant to defend himself.
- D. Because no evidence was collected to involve appellant in any illegal activity committed by the appellant.
- E. Because article 04 of the constitution has been violated as the appellant has not been treated in accordance with law.
- F. Because article 25 of the constitution has also been violated as the appellant has been discriminated and has not been treated equally.
- G. Because norms of article 27 of the constitution has also been discriminated in their service matter.

- H. Because rules of article 10 A of the constitution has also not been fulfilled. As no proper inquiry has been conducted in regards to appellant.
- G. Because the appellant was not treated in accordance with law as provided by constitution of Islamic Republic of Pakistan 0f 1973.
- H. Because an article 4 has also been violated as the appellant discriminated against.
- I. Because the behavior adopted by respondent No.7 is against legal expectation.
- J. Because the respondents by their action and inaction have violated the principal of natural justice.
- K. Because the respondents by their practice have violated the golden principle of equity as enshrined by Islam.
- L. Because the appellant deserved to be treated at par with that of Range Forest Officer Mr. Alamgir deserve to be exonerated from all charges.

- M. Because the respondents have violated the principle laid down E and D rules 2011 and Khyber Pakhtunkhwa service rule/ act by not treating appellant in accordance with law.
- N. Because there is clear difference between facts and figures of recovered timber show cause notice and dismissal order.
- P. Any other ground not specifically prayed for in the body of instant Appeal shall be argued at the time of arguments.

It is therefore, most humbly prayed that on acceptance of the instant service appeal this honorable court may be pleased to,

- 1) To direct respondents to reinstate appellant with all back benefits and to withdraw the earlier dismissal order and latter removal from service order.
- 2) To pay all kind of money/salaries with compound interest.

- 3) Not to harm appellant in further.
- 4) Any other remedy deemed fit by this August court may also be granted in favor of appellant against respondents.

Whereas, undersigned as a competent authority, had served you Amjad Ali Forest Guard with show cause notice for un-reported damage of 35 trees=12514cft, standing volume detected by SDFO Petrol Squad Malakand East along with his staff during inspection of Bazarkot Compartment No.8,9, 11 and 12 on 4.4.2017. In addition to this 15 Logs (12 in Compartment No.12 and 3 in Compartment No.11) were seized by the SDFO Patrol Squad and handed over to Malk-e-Rokhan Block Officer Bazarkot while 29scants=32.22Cft were found stored in Compartment No.9 and case compounded by SDFO Patrol Squad by realizing compensation etc. worth Rs.48700/- vide D.R. No.256/3 dated 5.4.2017.

You were required to show cause for your in-action against the offenders since the same amounting to mis-conduct, in-efficiency and corruption on your part. You were also given opportunity of personal hearing vide letter No.2959-61/G, dated 16.5.2017.

You in your defense vide your written reply had taken the plea that you remained busy in various activities assigned to you under BTAP. However you failed to give the exact period during which you executed those activities by documentary evidences in its support. Besides Forest Protection is the first and fore most duty of a Forest Guard in his jurisdiction and if any negative impact on protection by BTAP activities had been feared in past, you should have reported the same in writing, but you failed to do so.

You also took the plea that Bazarkot Compartment No.8-12 are situated at far-flung places where access during winter season due to heavy snowfall was not possible. However, this explanation is not tenable in the back drop of the fact that the culprits had cut down 35 trees = 12514Cft and were also able to convert and transport the major portion of the said timber to the adjoining areas of the Swat and Puran, meaning thereby that the access to these compartments was possible for at least one month before 4th and 5th April, 2017 when the damages were finally detected by the SDFO Patrol Squad and his team.

You also claimed to have chalked out damage report No.80/11,85/11,62/3,30/24 and 31/24. However this explanation is no more than an attempt to cover up your in-efficiency and corruption since same were chalk out by you after the damages were detected by the patrol squad. Also, as per your reply, they were chalked out only one or two days prior to the inspection by patrol squad team. If they had been timely chalked out, the Damage Report number would have been carved out on the stumps of the damaged trees, which was not so done in the instant

You also negate the damages of 35 trees by relating the same to huge quantity of dry/wind fallen trees in the nullah of Bazarkot C.No.9 to 15. However you and your block officer were along with the patrol squad team during their checking and signatures of both of you were taken by them on their on-spot checking proformas and the converted scants were also properly handed over to you and your block officer on spot. Hence this vary fact also negates your stance.

Hence in the light of above mentioned facts it is crystal/clear that you could not justify your in-action against the culprits involved in extensive illegal cutting of trees in your jurisdiction, thereby the charges of mis-conduct, in-efficiency, corruption and connivance against you stand substantiated.





INQUIRY REPORT IN COMPLIANCE TO OFFICE ORDER NO. 100 DATED 11.05.2017 ISSUED BY CHIEF CONSERVATOR OF FOREST SOUTHERN FOREST REGION-1 PESHAWAR

BRIEF-HISTORY

A complaint dated 20/03/2017 (Annexure-A) was preferred by one Mr. Usman Ghani s/o Fazal Rahim of Village Amnavi District Shangla before the Chief Conservator of Forests-III, Swat. Alleged stance reflected in said complaint was that heavy forest clamage had occurred in Bazarkot Forest Compartments No. 8, 9, 11-15 with connivance of incharge forest staff and 15 Civilians.

Chief Conservator of Forest Region-III vide No: 5956/GB dated 21/03/2017 (Annexure-B) asked DFO Patrol Squad Swat to investigate contents of the complaint and submit detailed report! DFO Patrol Squad vide No: 331/PS dated 06/04/2017_submitted_list of 84 trees = 29745 cft standing volume as 'Illicitly cut' (Annexure-C).

Departmental stance, however, accusation of field staff as a preliminarily step. Therefore, Range Officer Mr. towards Alamgir has been served with instant Memo in light of office order No: 100 dated 11/05/2017 of Chief Conservator of Forest-I.

FACTS OF THE CASE

- a. The accused officer was asked vide No: 5350/Actt dated 19/05/2017 to file written defence to alleged stance reflected in the charge sheet. The accused officer accordingly, submitted his written defence on 25/05/2017 (Annexure-D).
- b. The accused officer vide his roply has negated extent of the damage reported by the DFO Patrol Squad, least to talk of his connivance. Mr. Alamgir, however, has raised following reservations to the alleged Mengo:-
 - The complaint has not been interpreted and investigated in the real context and diverted merely against the lower staff on the basis of no evidence and in a haste.
 - The extent of forest damage reported by Patrol Squad has not been verified by the Department prior to initiation of disciplinary action.

The complaint is potentially encompassing vested interest and personal grievance between the complainant himself and civilian respondents. It rather appears that floor of the department is being used by the complainant to boost his personal objective of royalty issues in above forests.

It is astonishing to note that Respondent No: 13 (Nakhood s/o Nagshi) has been implicated in the complaint who in fact is not Man About Salowy, alive (death certificate is Annex as E) This proves hollowness of the complaint and therefore, maliciously conceived.

That standing volume reported by Divisional Forest Officer Patrol Squad worth 29745 cft has been calculated on the basis of stump height which is not understandable therefore, not maintainable. That as per report of Divisional Forest Officer Patrol Squad the

damage had occurred during my predecessors' era.

Advocate High Court

- Out of total reported damage worth 29745 cft, DFO Patrol Squad has reported total extraction worth 605 scants= 1256.54 cft vide NO. 384-87/PS, dated 27/04/2017 (Annext-J). This reveals out turn percentage of 4.2%.

On the basis of record and facts narrated above chairman of the Enquiry committee proceeded to office of DFO Alpuri on 1977/2017, for consultation and checking of Bazarkot forests as well. As already infimated vide No. 153, dated 07/07/2017 forests in Bazarkot were checked on 19-7-2017 as under.

(a) Compartment No. 11-15 were traversed in major and photographed as well (Annex-K)/the-reported-damage could not be verified on spot.

(b) DFO Alpuri and DFO Petrol Squad Swat were requested vide above reference of 07/07/2017 but DFO Patrol Squad or his staff could not Join the checking/damage verification process. Two Forest Guards representing DFO Alpuri and the accused officer, however, Joined the checking team.

(c) It_was_observed_that_wind_fallon-trees have been sawn by staff of patrol Squad and mostly transported to Road side instead of any green tree.

The complainant, Mr Usman Ghani S/O Fazai Karim of Arnhavi was called on at office of DFO Alpuri on 20/7/2017 for seeking certain clarification. He came to the office but when asked some questions in line of his complaint, he ran away. Next day he contacted the undersigned on phone but when asked to record his statement before the Enquiry committee he switched off his cell no 0343-9606993.

Timber out turn to the tune of 1256.54 Cft visa-vis 29745 cft standing volume is unbelievable. It was verified on spot that mostly wind fallen/old trees were Achbora sawn and converted by staff of Patrol Squad Swat. The reported damage High Count seems more exaggeration and not existed on spot

Timber pertaining to transport pass No. 01 dated 17/4/2017, issued by DFO Petrol Squad Swat per se is out come of dry wind fallen trees.

Damage list submitted by DFO Patrol Squat lacks remarks column. The volume has been calculated on the basis of stump height which is ridiculous. If the volume was calculated on the basis of DBH then the green trees felled illicitly should have been lying in the forests. The low out turn of 4.2% therefore, is surely unjustified

CONCLUSION

- 1. Forest Damages reported vide DFO Patrol Squad No. 331/PS dated 06/04/2017 could not be verified on ground as under.
- The checking party have inspected major portion of Bazarkot forests compartment No. 11-15 but could not detect the reported damage. (ii)
- DFO Patrol Squad was requested twice to Join OR depute his party to locate the damage which he is avoiding till date. .(III).
- The fotal damage reported by DFO Patrol Squad i,e extracted timber i,e 1256.54 are not matching any way. 29745 cft and total
- DECLAIDURE and DEO Patrol-Squad Swathbove avoided to co-ordinate in line or the enquiry and not responding to question communicated to them.
- Timber Trail on the part of DFO Alpuri is not in existence and DFO Patrol
- Action against the staff at Alpuri was taken by DFO Alpuri without any proof guilt and seems enforced rather than based on conscious lawful
- The prosecution (DFO Alpuri) and DFO Patrol Squad have falled to defend

RECOMMENDATION

Charges against the accused officer could not be established on any accepted grounds. Therefore, the officers recommended for exoneration.

It is submitted that as per instructions contained vide your goodself office order on the subject noted above, the undersigned alongwith the field staff of Patrol Squad Forest Division visited Apuri (District Shangla) for checking of Bazar kot Forests, on 16/06/2014 to 18/06/2014.

FINDINGS

(By.

The Bazarkot Forest Compartments were checked thoroughly along with the local field staff of Alpuri Forest Division. During checking/inspection of Bararkot Forest Compartment No.23, it was noticed that there is a jot of reported damage in the said compartment. The application preferred by the inhabitants/elders of Malak, Rhel kotkai viliage submitted to DFO Alpuri dated 10/06/2014 which is self explanatory (attested copy enclosed herewith).

However, the matter was enquired/investigated from the locals Med to be of the area and it was learned that (1) Mr. Sanobar S/O Rahberin, (2) Mr. Alam S/O Daulatmand and (3) Mr. Shair S/O Siraj Residence of Drad Puran (offenders) were actively involved in illicit cutting of Kail trees in the said compartment. The local field staff has taken action against the above named culprits /offenders, accordingly and chalked damage report vide No.85/81 dated 06/06/2014 and arrested them and were sent to prison.

The Forest Compartment No. 9 to 16 and 17 to 22 were my Abdul Salwyjointly checked/inspected with the local field staff and the damage for local/domestic use was found covered under damage!

No38/5 dated 18/06/2014, 39/5 dated 23/06/2014 and No.40/5 dated 23/06/2014.

> While checking these compartments, it was noticed that a large number of wind fallen trees were found lying in the nullahas particularly in Bazarkot compartment No.9,10 to 17, which need to be transported to CTD Shagai for auction.

> It is therefore recommended that the timber lying in these compartments needs early disposal, otherwise it will become rotten and deteriorated with out bringing any revenue to the department as well as to the royalty holders/ local concessionits.

Moreover, an illegal stock was apprehended at saboonal and realized the compensation of Rs.43000/-(Forty three thousand only) from the offenders/stock holders.

Similarly the Kail and fir scants=(73 =58Cft) and illicit cutting of Kail/Fir trees (3 Nos) were apprehended in Bazarkot beforest Compartment No.13,14.15 and handed over the cut materials to the local field staff under proper superdari and to bring it to the monthly auction to CTD Shagai (attested copies of Damage Report enclosed.

Similarly lilonal west Forest Compartments No. (1 to 18) were thoroughly checked/inspected on 24/06/2014 to 26/06/2014 and it was noticed that an effective measures for control of illicit cutting in lilownal west Block has been made by the owners/local concessions and local field staff of Apuri Forest Division. For this purpose Block head quarter has been established at Shesharhn valley, and the duty by number is performed in groups on day/night basis.

RECOMMENDATIONS

1. Wind fallen trees lying in Bazarkot Forest Compartments No.9.10 and 11 at Sabononai and Trikand nullahas should be marked/enlisted for further transportation to CTD Shagai.

2. A block Head Quarter should be established at Yakhtangi (Old Rest House) for the field staff of Bazarkot block because it is far away from Alpuri and for the effective control over the illicit cutting and illegal movement of

The report is therefore, submitted for favour of further necessary action please.



WHEREAS, Mr. Amjad Ali Forest Guard was proceeded against under the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules 2011, for the charges mentioned in show cause notice served vide DFO Alpuri endst. No. 2549-51/G, dated 11.4.2017 which he replied and provided him opportunity of personal hearing.

WHEREAS, the competent authority (DFO Alpuri) after having considered the charges, evidence on record, the explanation of the accused official and hearing him in person and exercising his powers under Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules 2011, imposed major penalty of dismissal from service vide office order No.2 dated 06.7.2017.

WHEREAS, the Ex-official being aggrieved preferred departmental appeal before the appellate authority (Conservator of Forests, Malakand Circle East) and prior to decision of the appellate authority, he approached Honorable Peshawar High Court Mingora Bench/Darul Qaza Swat through a writ petition in violation Article 212 of the constitution of Islamic Republic of Pakistan, Civil Servants Act and Civil Servants appeal Rules. - That the petitioner is bonafide resident of Village Malak Khel Kotkay District Shangla.
- 2. That basically petitioner was appointed as Forest Guard in Alpuri Forest Division.
- 3. That the petitioner served for almost years in forest sub division in Alpuri district Shangla.
- That respondent No. 07/DFO Alpuri district Shangla dismissed petitioner through officer order No. 02 dated 06.07.2017.

(Copy of Order No. 02 dated 06.07.2017 is attached as annexure "A")

5. That a complaint was preferred by a civilian (Mr. Usman Ghani) before Chief Conservator of forests Malakand alleging illicit cutting of trees in Bazarkot Forest block of District Shangla.

That the petitioner, being forest guard/incharge beat guard of said forest block was implicated on the plea of connivance, consequent to checking report of DFO patrol squad forest division Swat/respondent No. 05.

That DFO Alpuri/respondent No. 07 without the slightest resort to any law (in terms of proper enquiry as provided under E&D rules 2011) show caused the petitioner and issued his dismissal order No. 02 dated 06.07.2017 straight away.

That in addition to above, the Range Forest Officer Alpuri was charge sheeted for the same charge one other Forest Guard and one forester were also dismissed for alleged charge.

That respondent No. 06 was appointed as enquiry officer as provided under the relevant rule to conduct proper enquiry against the Range Officer Alpuri regarding the alleged stance.

That after detailed investigation/enquiry the changes all and court gench leveled in the case could not be proved/established

against the Range Fcrest Officer Alpuri. It was also reported by the enquiry officer that the forest damage could not be found and that he time and again requested DFO Patrol Squad Swat and DFO Alpuri to join the enquiry committee in order to verify the trees that were cut but they failed to join the inquiry. - 11. That the complaint had implicated 15 respondents apart from staff of forest department as responsible for alleged forest damage, on the plea of personal agony regarding forest royalty issues while seeking support from department. 

Preliminary Objection.

- 1. That the instant service appeal is not maintainable in its present form.
- 2. That the appellant has not come to the Tribunal with clear hands.
- 3. That the appellant has concealed material facts from this Hon'able tribunal.
- 4. That the appeal is badly time barred.
- 5. That the appellant has got no cause of action.

PARAWISE COMMENTS (FROM SERIL NO.1 TO 5 AND 7 TO 9)

Respectfully Sheweth:

- 1. The statement pertains to the record.
- 2. The appellant had been serving as Forest Guard in Alpuri Forest Division.
- 3. The statement pertains to the record.
- 4. That the respondent No.7 (Divisional Forest Officer Alpuri) dismissed appellant through office order No.2 dated 06-07-2017 as (Annexure-A)



- Correct that the application was preferred by the complainant Mr. Usman Ghani to The Conservator of Forest Malakand Forest Circle East Saidu Sharif Swat for illegal cutting of trees in Bazarkot Block of Alpuri Forest Division as (Annexure-B).
- 6. In correct hence denied. That being concerned official and for not taking any legal action against the Forest offenders, the concerned Forest Guard (Appellant) was issued show cause notice consequent upon the report of Divisional Forest Officer Patrol Squad and after ground verification by Conservator of Forest Malakand Forest Circle East Saidu Sharif Swat. (Show Cause Notice as Annexure-C).
- 7. That after issuance of the show cause notice the appellant failed to prove his innocence and to give any satisfactory explanation for his inefficiency and connivance with the forest offenders. Hence he was dismissed from the service vide office order No.2 dated 06-07-2017.
- 8. That, it is correct that in addition to the appellant the Range Officer Alpuri and Block Officer /Forester were also charge sheeted for the inefficiency and alleged connivance/damages in areas/compartments under their jurisdiction.
- 9. The Respondent No.6 was appointed as Chairman Inquiry Committee beside Mr.Rizwan Shah (SDFO) member inquiry committee against the then Range Forest Officer Alpuri.
- 10. That the inquiry report by the Chairman Inquiry Committee (Respondent No.6) was challenged by the Conservator of Forest Malakand Forest Circle East Saidu Sharif Swat vide his letter No.3429/E, dated 18-10-2017 on account of it being partial and also for not being signed by the other member of the inquiry Committee. (Photo Copy annexed as Annexure-D)
- 11. That grievances of the complainant Mr.Usman Ghani were verified by the Divisional Forest Officer Petrol Squad during his field inspection and statement of the recorded damages was also duly signed by the appellant. (Photocopy annexed as Annexure-E)
- 12. As mentioned in Para 10 above the interim inquiry report of the respondent No.6 were challenged by Conservator of Forest Malakand Forest Circle East Saidu Sharif Swat for its being partial and lacking in requirements of a balanced inquiry.

- 13. The Divisional Forest Officer Petrol Squad acted in accordance with Forest Ordinance 2002 and no illegality was perpetrated as the list of damage also acknowledged and signed by the appellant (The then Incharge Forest Guard).
- 14. That the dismissal order of the appellant was issued after proper show cause notice and affording opportunity of being heard to the appellant. No illegality has been perpetrated.
- 15. That the show cause notice was issued to the appellant for illegal damage in his beat due to his inefficiency and connivance.
- 16. That the written reply of the appellant in response to show cause notice was not based upon facts and he could not justify his in action against culprit, inefficiency and connivance.
- 17. Correct.

- 20. Already explained in Para No.9 above.
- 21. Already explained in Para No.10 that the inquiry report of Respondent No.6 was impugned by the Conservator of Forest Malakand Forest Circle East Saidu Sharif Swat and the Divisional Forest Officer Alpuri. (Annxure-F).
- That no illegality was perpetrated by the Divisional Forest Officer Petrol Squad (Respondent No.8). Since damage list prepared by the Divisional Forest Officer Petrol Squad was duly acknowledge/signed by the appellant.
- 23. That the application/FIR by the complainant i.e Mr.Usman Ghani against Mr.Nakhood son of Naqshay in FIR No.23 dated 09-05-2017 has nothing to do with damages in the jurisdiction of the appellant due to his inefficiency and corruption.
- 24. That the damage reported by the Divisional Forest Officer Petrol Squad relates to fresh damage and not to the dry standing and wind fallen trees.
- 25. As already explained in Para No.10 and Para No.21 above that the inquiry report of the inquiry Officer concerned related to the Range Officer Alpuri and have been challenged/questioned for being partial and unilateral.





- 26. That the decision of the competent authority on the basis of the inquiry report is still awaited. Similarly Mr.Alamgir was also transferred from Alpuri Forest Division to Working Plan Unit –IV Kanju Swat by the competent authority for his poor performance in territorial Sub Division.
- 27. No comments.
- That the appeal preferred by the appellant to Conservator of Forest Malakand
 Forest Circle East Saidu Sharif Swat was properly heard by respondent No.4

 (Conservator of Forest Malakand Forest Circle East). However the appellate authority changed the penalty imposed by the Divisional Forest Officer Alpuri from dismissal from service to removal from service, keeping in view his future career and employment in other department. (Photocopy of office order No.58 dated 18-01-2018 is annexed as Annexure-G)
- 30. That the appellant wrongfully and illegally filed a writ petition before Honorable Peshawar High Court as 22-11-2017 which has dismissed on 29-11-2017 as it was without jurisdiction.
- 31. In correct. Time spent before wrong forum, could not condone delay as held by the August Supreme Court of Pakistan 2016 PLD(Supreme Court) page-872. That the appellant is not entitled for condonation of delay, since they had deliberately chose the wrong forum without first availing the remedy of appeal before Conservator of Forest Malakand Forest Circle East Saidu Sharif Swat. Since ignorance of law is no excuse hence the plea of petitioner for condonation of delay is not tenable.
- 32. Already explained in Para No.28 above also appellant could not have recourse to High Court or Service Tribunal during pendency of appeal before the Conservator of Forest Malakand Forest Circle East.
- 33. That Conservator of Forest Malakand Forest Circle East had afforded all the reasonable opportunity of personal hearing to the petitioner/appellant before issuance of office order No.58 dated 18-01-2018.
- 34. That the Conservator of Forest Malakand Forest Circle East by virtue of his official designation was the rightful appellate authority and the fact that he earlier





- remain as Divisional Forest Officer Petrol Squad could not prejudice his capacity as appellate authority.
- 35. The plea by the petitioner/appellant that he has been inflicted penalty due to political pressure is totally unfound and baseless.
- 36. That the grievances of the appellant are not genuine and liable to be set aside on the following grounds.

GROUNDS:

- A. Because the appellant was given all reasonable opportunity of being heard.
- B. That proper show cause issued to the appellant under E&D Rules.
- C. As explained in Ground-A appellant was given opportunity to defend himself.
- D. In correct hence denied. Sufficient evidence was available in the physical verification by the Divisional Forest Officer Petrol Squad of illegal cutting in the beat/jurisdiction of the appellant which was also acknowledged/signed by the appellant.
- E. Because no violation of Constitution has been perpetrated.
- F. Because no discrimination against the appellant has been committed in violation of Article 25 of the Constitution.
- G. Because no discrimination as per Article 27 has been committed.
- H. Because after proper inquiry by the Divisional Forest Officer Petrol Squad duly acknowledged by the appellant show cause notice was issued.
- G. Because no violation of the Constitution of Islamic Republic of Pakistan of 1973 was committed.

- I. That no illegality perpetrated by Respondent No.7.
- Because no violation of the principal of natural justice has been done. J.

Whereas, undersigned as a competent authority, had served you Amjad Ali Forest Guard with show cause notice for un-reported damage of 35 trees=12514cft. standing volume detected by SDFO Patrol Squad Malakand East along with his staff during inspection of Bazarkot Compartment No.8,9, 11 and 12 on 4.4.2017. In addition to this 15 Logs (12 in Compartment No.12 and 3 in Compartment No.11) were seized by the SDFO Patrol Squad and handed over to Malk-e-Rokhan Block Officer Bazarkot while 29scants=32.22Cft were found stored in Compartment No.9 and case compounded by SDFO Patrol Squad by realizing compensation etc. worth Rs.48700/- vide D.R. No.256/3 dated 5.4.2017.

You were required to show cause for your in-action against the offenders since the same amounting to mis-conduct, in-efficiency and corruption on your part. You were also given opportunity of personal hearing vide letter No.2959-61/G, dated 16.5.2017.

You in your defense vide your written reply had taken the plea that you remained busy in various activities assigned to you under BTAP. However you failed to give the exact period during which you executed those activities by documentary evidences in its support. Besides Forest Protection is the first and fore most duty of a Forest Guard in his jurisdiction and if any negative impact on protection by BTAP activities had been feared in past, you should have reported the same in writing, but you failed to do so.

You also took the plea that Bazarkot Compartment No.8-12 are situated at far-flung places where access during winter season due to heavy snowfall was not possible. However, this explanation is not tenable in the back drop of the fact that the culprits had cut down 35 trees explanation is not tenable to convert and transport the major portion of the said timber to the adjoining areas of the Swat and Puran, meaning thereby that the access to these compartments was possible for at least one month before 4th and 5th April, 2017 when the damages were finally detected by the SDFO Patrol Squad and his team.

You also claimed to have chalked out damage report No.80/11,85/11,62/3,30/24 and 31/24. However this explanation is no more than an attempt to cover up your in-efficiency and corruption since same were chalk out by you after the damages were detected by the patrol squad. Also, as per your reply, they were chalked out only one or two days prior to the inspection by patrol squad team. If they had been timely chalked out, the Damage Report number would have been carved out on the stumps of the damaged trees, which was not so done in the instant case.

You also negate the damages of 35 trees by relating the same to huge quantity of dry/wind fallen trees in the nullah of Bazarkot C.No.9 to 15. However you and your block officer were along with the patrol squad team during their checking and signatures of both of you were taken by them on their on-spot checking proforms and the converted scants were also properly handed over to you and your block officer on spot. Hence this vary fact also negates your stance,

Hence in the light of above mentioned facts it is crystal/clear that you could not justify your in-action against the culprits involved in extensive illegal cutting of trees in your jurisdiction, thereby the charges of mis-conduct, in-efficiency, corruption and connivance against you stand substantiated.





The learned High Court disposed off the writ petition in terms that it is converted into representation and asked the Department for lawful consideration of the grievance of the petitioner in respect of his reinstatement as Forest Guard in Alpuri Forest Division strictly within the legal framework vide order dated 29.11.2017.

WHEREAS, in compliance to the above judgment, opportunity of personal hearing was provided and the Ex-Forest Guard was heard in person on 10.01.2018. During personal hearing he pointed out that he remained busy in various activities assigned under BTAP. The same is not different but includes in his duties. BRIEF HISTORY

A complaint dated 20/03/2017 (Annexure-A) was preferred by one Mr. Usman Ghani s/o Fazal Rahim of Village Amnavi District Shangla before the Chief Conservator of Forests-III, Swat. Alleged stance reflected in said complaint was that heavy forest damage had occurred in Bazarkot Forest Compartments No: 8, 9, 11-15 with connivance of incharge forest staff and 15 Civilians.

Chief Conservator of Forest Region-III vide No: 5956/GB dated 21/03/2017 (Annexure-B) asked DFO Patrol Squad Swat to investigate contents of the complaint and submit detailed report. DFO Patrol Squad vide No: 331/PS dated 06/04/2017 submitted list of 84 trees = 29745 cft standing volume as 'illicitly cut' (Annexure-C).

Departmental stance, however, remained inclined towards accusation of field staff as a preliminarily step. Therefore, Range Officer Mr. Alamgir has been served with instant Memo in light of office order No: 100 dated 11/05/2017 of Chief Conservator of Forest-I.

FACTS OF THE CASE

- a. The accused officer was asked vide No: 5350/Actt dated 19/05/2017 to file written defence to alleged stance reflected in the charge sheet. The accused officer accordingly, submitted his written defence on 25/05/2017 (Annexure-D).
- b. The accused officer vide his reply has negated extent of the damage reported by the DFO Patrol Squad, least to talk of his connivance. Mr. Alamgir, however, has raised following reservations to the alleged Memo:-
 - (i) The complaint has not been interpreted and investigated in the real context and diverted merely against the lower staff on the basis of no evidence and in a haste.
 - (ii) The extent of forest damage reported by Patrol Squad has not been verified by the Department prior to initiation of disciplinary action.
 - (iii) The complaint is potentially encompassing vested interest and personal grievance between the complainant himself and civilian respondents. It rather appears that floor of the department is being used by the complainant to boost his personal objective of royalty issues in above forests.
 - (iv) It is astonishing to note that Respondent No: 13 (Nakhood s/o Naqshi) has been implicated in the complaint who in fact is not alive (death certificate is **Annex as E**). This proves hollowness of the complaint and therefore, maliciously conceived.
 - (v) That standing volume reported by Divisional Forest Officer Patrol Squad worth 29745 cft has been calculated on the basis of stump height which is not understandable therefore, not maintainable.
 - (vi) That as per report of Divisional Forest Officer Patrol Squad the damage had occurred during my predecessors' era.

RECORD CONSULTED

Office record pertaining to instant enquiry was sought form DFO Alpuri vide No. 7502/G&L dated 1.6.2017 (Annex-E) which was partially provided vide No.3139/G, dated 15/06/2017 of DFO Alpuri (Annex-F).

DFO Alpuri has also been nominated as prosecutor for the instant enquiry vide No. 8134/E, dated 22/6/2017 of CCF-III Malakand Region (Annex-G).

- Illicit damage to the tune of 84 tree=29745 cft in Bazarkot forests was detected and submitted before Conservator of Forests East Circle vide DFO Patrol Squad No. 331/PS, dated 06/04/2017 (Anne-H) No Remarks Column existed in above list.
- Out of total reported damage worth 29745 cft, DFO Patrol Squad has reported total extraction worth 605 scants= 1256.54 cft vide NO. 384-87/PS, dated 27/04/2017 (Annext-J). This reveals out turn percentage of 4.2%.

Following observations, therefore are required to be attended.

- The low out turn percentage coupled with no timber trail in terms of Field book, farm A, farm-5 etc would render the quantum of reported damage as (i) . extremely doubtful.
- Warranted Role of DFO Alpuri in the Situation is missing. (ii)
- Identification of compartment boundaries Assessment of Quantum of damage, timber account for reported damage, transportation and Marketing (iii) after due process etc are the responsibilities of DFO Alpuri which have been Omitted in the circumstances.
- Seizure of reported timber by DFO Patrol Squad Swat and issuance of TP (iv) towards CTD Swat has rendered following short comings.
- (a) The difference between illicit timber detected and net timber procured is manifold.
- (b) The culprits could not be identified by staff of Patrol Squad and cases registered against un-known offenders.
- (c) The prevailing situation has rendered DFO Alpuri as silent spectator. He has not even bothered to verify the reported damage till date which, in fact, does not exist at all.
- (d) DFO Alpuri, without resorts to law, has blindly issued dismissal order of three staff members without conducting proper investigation on the complaint. He has rather acted in self defense. The instant accusation has, therefore, been preferred as based on above dismissal orders.

PROCEEDINGS-

On the basis of record and facts narrated above chairman of the Enquiry committee proceeded to office of DFO Alpuri on 19/7/2017, for consultation and checking of Bazarkot forests as well. As already intimated vide No. 153, dated 07/07/2017 forests in Bazarkot were checked on 19-7-2017 as under.

(a) Compartment No. 11-15 were traversed in major and photographed as well (Annex-K). the reported damage could not be verified on spot.

(b) DFO Alpuri and DFO Petrol Squad Swat were requested vide above reference of 07/07/2017 but DFO Patrol Squad or his staff could not Join the checking/damage verification process. Two Forest Guards representing DFO Alpuri and the accused officer, however, Joined the checking team.

(c) It was observed that wind fallen trees have been sawn by staff of patrol Squad

and mostly transported to Road side instead of any green tree.

(d) Member of the inquiry committee Mr, Rizwan Kazmi Could not Join the checking/verification process.

The complainant, Mr Usman Ghani S/O Fazal Karim of Amnavi was called on at office of DFO Alpuri on 20/7/2017 for seeking certain clarification. He came to the office but when asked some questions in line of his complaint, he ran away. Next day he contacted the undersigned on phone but when asked to record his statement before the Enquiry committee he switched off his cell no 0343-9606993.

DFO Alpuri (the Prosecutor), DFO Patrol Squad swat were finally asked vide No. 262-273/Silva dated 24/7/2017, to furnish certain necessary clarification. Their responses' could not be received till date. This was followed by two reminders but to no avail. (Annex-L)

RATIONALE/ARGUMENT

The real contention to be resolved in the instant enquiry is:-

Whether the reported forest damage in Bazarkot Forest comport No. 8,9,11-1/8 has been verified and whether the instant accusation really warranted for. Express reply to above is No because the committee conducting the probe could not verify the damage on spot.

The committee have requested DFO Patrol Squad Swat twice to depute his team help investigate the reported damage but same could not be made possible. Factual investigation by necessary implication is deduced below.

DFO Patrol Squad has avoided to Join verification of reported damage on (i) ground.

Complainant absconded to record a single word in support/ furtherance of his (ii) complaint.

DFO Alpuri (prosecutor) and DFO Patrol Squad are reluctant to respond to (iii) clarifications sought vide No. 262-273/Silva dated 24/7/2017 till date.

Timber out turn to the tune of 1256.54 Cft visa-vis 29745 cft standing volume is unbelievable. It was verified on spot that mostly wind fallen/old trees were sawn and converted by staff of Patrol Squad Swat. The reported damage seems mere exaggeration and not existed on spot

Timber pertaining to transport pass No. 01 dated 17/4/2017, issued by DFO

Petrol Squad Swat per se is out come of dry wind fallen trees.

Damage list submitted by DFO Patrol Squat lacks remarks column. The (vi) volume has been calculated on the basis of stump height which is ridiculous. If the volume was calculated on the basis of DBH then the green trees felled illicitly should have been lying in the forests. The low out turn of 4.2% therefore, is surely unjustified

LIMITATIONS

Member of the enquiry committee Mr, Rizwan Kazmi DFO Haripur could not join the proceeding despite regularly contacted for every date fixed. He was requested vide No. 5350/Accdtt date 19-5/2017, No.5702/GL dated 01/06/2017 and NO. 414/Silva at and finally vide No. 487-90, dated 07/03/2017. He could not Join on a single date and the report has been finalized by the chairman alone.

CONCLUSION

- 1. Forest Damages reported vide DFO Patrol Squad No. 331/PS dated 06/04/2017 could not be verified on ground as under.
- (i) The checking party have inspected major portion of Bazarkot forests compartment No. 11-15 but could not detect the reported damage.
- (ii) DFO Patrol Squad was requested twice to Join OR depute his party to locate the damage which he is avoiding till date.
- (iii) The fotal damage reported by DFO Patrol Squad i,e 29745 cft and total extracted timber i,e 1256.54 are not matching any way.
- (iv) DFO Alputi and DFO Patrol Squad Swat have avoided to co-ordinate in line of the enquiry and not responding to question communicated to them.
- (v) Timber Trail on the part of DFO Alpuri is not in existence and DFO Patrol Squad has acted extraneously.
- (vi) Action against the staff at Alpuri was taken by DFO Alpuri without any proof of guilt and seems enforced rather than based on conscious lawful justification.
- (vii) The prosecution (DFO Aipuri) and DFO Patrol Squad have failed to defend maintainability of their respective action.

RECOMMENDATION

- 1. Charges against the accused officer could not be established on any accepted grounds. Therefore, the office is recommended for exoneration.
- 2. The complainant has a claim of concessionary rights to the Bazarkot Forest. Therefore same may be investigated with regard to other civilian respondent (15 NO) so that real facts could be arrived at.

REJOINDER ON PART OF THE APPELLANT / PETITIONER.

Respectfully Sheweth:

Preliminary objections: -

- a. Para wise comments submitted the respondents are not tenable, hence liable to be dismissed.
- b. The orders passed by the respondents are illegal, hence not tenable.

- c. The petition is not time barred and the stance taken by the respondents is illegal.
- d. The Para wise comments submitted by the respondent is liable to be dismissed with cost and the appellant/petitioner is entitled to be reinstated with all back benefits.
- e. The precedent/case law quoted by respondent is not relevant.

OBJECTION OF FACTS: -

- 1. Para No. 01 is correct.
- 2. Para No. 02 is correct.
- 3. Para No. 03 is correct.
- 4. Para No. 04 is incorrect, the appellant was dismissed in total restraint of law and facts on record.
- 5. Para No. 05 is incorrect. The complaint by the complainant was preferred before Chief Conservator of Forests, Malakand Forest Region-III and not Conservator of Forests, Malakand East (Already annex-"B"). Moreover,

the trees reported to have been cut at the instance of the appellant could not be proved even in the departmental enquiry against the RO Alpuri. But since no proper enquiry as provided under E&D Rules, 2011 was conducted in case of the appellant, therefore, contention of Respondents is incorrect.

- 6. Para No. 06 is ridiculous. The show cause notice was issued by Respondent No. 07 on sheer arbitrariness and extreme wishful consideration. No enquiry, as provided in E&D Rules 2011, was conducted for factual verification of the alleged stance. Infact, the same charges have totally been unfound in a departmental enquiry against R.O Alpuri conducted by Respondent No. 06. Even otherwise Respondent No. 07 purposely omitted facts of reply to the show cause submitted by the appellant.
- 7. Para No. 07 is incorrect, the charges relied for infliction of punishments against the appellant have totally been unfounded by the Enquiry Committee in a probe against the Range Officer Alpuri who was similarly implicated in same offence.
- 8. Para No. 08 is incorrect, Range Officer Alpuri who was similarly placed but the reported forest damage was

unfounded by the Enquiry Committee. He stood, therefore, exonerated vide office order No. 141 dated 12.04.2018 of the competent authority. Therefore, the appellant has been charged and punished for no valid reason except arbitrariness.

- 9. Para No. 09 require no answer.
- 10. Para No. 10 is incorrect, the said inquiry was properly conducted by respondent No. 06, while other members of the inquiry committee deliberately failed to participate. The said inquiry was upheld by the competent authority (Chief Conservator Forest) through office order No. 141 dated 12.04.2018.
- 11. Para No. 11 is incorrect, no illegal cutting was observed hence no valid record have so far been presented. The concerned authority has maliciously involved the appellant for their personal gains. It is also clear from the inquiry report conducted against Range Forest Officer Alpuri in same case (in Para No. vi of the inquiry report) that damage list/Report submitted by D.F.O Patrol squad was arbitrary and lacking proper entries in remarks column. The damage could not be verified on spot in said enquiry. Appellant never signed the damage report/the list of trees but only signed the affidavit. It was never mentioned that fresh trees/timber have been recovered while the rest of

the record prepared is fake and the appellant never signed the said record.

It is also worth mentioning that the record prepared by enquiry officer clearly shows that only timber from dried and windfall trees have been recovered and not total amount of timber as required by law has not been recovered. Legally it was incumbent on respondents to recover 40% to 50% timber while they recovered only 4.2% timber from the said trees which clearly shows that the trees not freshly cut.

- 12. Para No. 12 is incorrect; the said inquiry report was conducted in much detail and was upheld by Chief Conservator Forest (the competent authority) through office order No. 141 dated 12.04.2018. (Copy of order No. 141 dated 12.4.2018 is attached as annexure "BB")
- 13. Para No. 13 is incorrect, the matter has sufficiently been explained in Para No. 11 above.
- 14. Para No. 14 is incorrect, proper enquiry as per E&D Rules, 2011 was deliberately avoided just to escape the real facts. The show cause was issued on the basis of fake report of respondent No.0 8. Respondent No. 07 and Respondent No. 08 have failed to prove any forest damage relied for

dismissal of the appellant before the committee conducting enquiry against the Range Officer Alpuri.

- 15. Para No. 15 is incorrect, since no forest damage was detected on spot so as to involve/ prove connivance of the appellant.
- 16. Para No. 16 is incorrect, proper reply was submitted by the appellant which was not considered by the respondent. It is the primary duty of the respondents to prove guilt/ charge against appellant.
- 17. Para No. 17 is not answerable.
- 18. Para No. 18 is not answerable.
- 19. Para No. 179 is not answerable.
- 20. Para No. 20 is not answerable.
- 21. Para No. 21 is incorrect, detailed answer is given above. The enquiry report conducted and submitted by Respondent No. 6 was upheld by the authority and as such has got

finality since not challenged/agitated against within the statutory period.

- 22. Para No. 22 is incorrect, the appellant never admitted his guilt, statement/affidavit would clearly shows the same. The damage list relied by the respondents, on the face of record, could not be ve4rified on ground despite sufficient chances provided by the Enquiry Committee.
- 23. Para No. 23 is incorrect, the said FIR has profound affect on the instant case and would show hollowness of the complaint relied by the respondents where the appellant was singled out quite wishfully. Substance of the charge has already been disproved in the enquiry against Range Officer Alpuri and upheld by the competent authority as well. When the charges could not be found on ground, it is discriminatory and the appellant was wrongly punished.
- 24. Para No. 24 is incorrect, the detail answer is given above.
- 25. Para No. 25 is incorrect, the inquiry officer has also exonerated the appellant, and the whole story fabricated by respondent is baseless, the inquiry conducted in this regard has been approved by the Chief Conservator Forest-I through office order No. 141 dated 12.4.2018.

- 26. Para No. 26 is incorrect, office order No. 141 dated 12-4-2018 of Respondent No. 2 referred above is quite evident. Through said order charges against Mr. Alamgir (Range Officer Alpuri and of course the appellant) have already been set aside. By same token and being implicated in same casa the appellant deserves to be treated at par with Mr. Alamgir Range Officer warranting his exoneration and reinstatement in service with all back benefits.
- 27. Para No. 27 is not answerable.
- 28. Para No. 28 is incorrect. The appellate authority (Conservator of Forests Malakand East) modified penalty of the appellant from dismissal from service to compulsory retirement from service through officer order No. 59 dated 18.1.2018 which provided fresh cause of action as the order was issued during pendency of the service appeal. Rest of the Para is baseless hence denied.
- 30. Para No. 30 is incorrect, the appellant filled a writ petition on dated 22.11.2017 which was decided on 29.11.2017 and the departmental appeal was filed on 30.11.2017 Oin order to be treated in accordance with law. The said writ petition was not dismissed but direction issued to respondents to consider the appeal of appellant properly.

- 31. Para No. 31 is incorrect, there are too much case laws on the said point, it is also to mention here that under what kind of situation limitation could be condoned or not, when the basic order is illegal then limitation does not run against illegal order, the appellant filed a writ petition in High Court Mingora Bench with the aims to treat appellant similar to that of Mr. Alimgir (Range Forest Officer) while latter on conservator forest modified the order of dismissal to that of compulsory retirement on 18.1.2018 which gives fresh cause of action or even cause of action can arise during the pendency of appeal/suit.
- 32. Para No. 32 is incorrect, the appellant filled his departmental appeal before Chief Conservator of Forest but after filling departmental appeal respondent No. 03 was promoted to the post of conservator forest. First he conducted preliminary inquiry and latter on heard the appeal of the appellant as appellate forum which is against the rules of law as no one can proceed to be an inquiry officer and also to become a judge. It is the rule of law that no man should be a judge in his own cause.
- 33. Para No. 33 is not correct as the petitioner/ appellant filed departmental appeal on right time dated 25.07.2017 and waited for ninety days. And filed departmental appeal on 30.11.2017 after decision in writ petition filed by the

appellant on dated 22.11.2017 by the learned High Court Peshawar Mingora Bench on dated 29.11.2017. it means that the appellant filed departmental appeal on the same next day when the writ petition was decided on 29.11.2017 the department appeal was not responded by the respondent within 03 months and latter on, on dated 18.01.2018 through office order number 58 the dismissal order of respondent was modified to that of removal from service. Which gives fresh cause of action during the pendency of service appeal. The law does not prevent appellant to wait till the final decision of the appellate forum.

- 34. Para No. 34 is incorrect, the petitioner has been politically victimized.
- 35. Para No. 35 is incorrect, the petitioner has been politically victimized.
- 36. Para No. 36 is incorrect, the appeal filed by the appellant is genuine and the Para wise comments submitted by respondents are liable to be set aside inter alia on the following legal grounds:-
 - (A) Because the appellant has been condemned un hard.

- (B) Because no proper inquiry has been conducted in the instant case and the appellant cannot be punished only on the basis of show cause notice.
- (C) Because the reply submitted the appellant has not been consider by the respondents.
- (D) Because no fresh cutting was observed by the enquiry officer hence the petitioner/appellant has not showed any kind of disability or profession misconduct.
- (E) Because the petitioner has not been treated in accordance with the norms of the constitution of 1973, of the Islamic Republic of Pakistan.
- (F) Because no one can be punished on the basis of preliminarily inquiry conducted mala fide intention.
- (G) Because the Khyber Pakhtunkhwa service rules has been violated.
- (H) Because no fresh wood has been recovered from the spot.
- (I) Because the wood recovered from the spot was of dry windfall trees. The fact is evident since the same was soled/sanctioned at a very low rate, moreover, wood species also do not tally. This shows that no fresh cut timber was recovered on spot.

It is therefore, requested that on acceptance of this rejoinder in response to Para wise comments the appellant may kindly be reinstated with all back benefits and the Para wise comments submitted may also be discarded.
