

1. That the petitioner/appellant, instituted, the title Service Appeal, in this Hon; Service Tribunal, on 12/07/2023, which was ultimately admitted and ad interim relief was also granted, while allowing application of the petitioner/appellant, in favour of the petitioner/appellant, on dated 09/08/ 023, for suspension of the order impugned End No. 2065 dated 26/12/023 actually issued on 06/03/2023 by the DEO Female Buner. Copy of the apex Order, is annexed as "A".
2. That earlier, attested Copy of the said Order was handed Over and served up on the Respondent No. 1, No.4 & No.5, on 26/07/2023 to the respondent by hand and then on 28/8/2023 again in his office but when non complied the same, then sent a written Notice to the respondent No.1, and No.4 and then on dated 31/08/2023, through postal registered AD. Copies of Notice and Registered Slip is annexed for ready reference.
3. That despite the same notices, all oral written (without providing any receipt intentionally and purposely) the respondent No.1, did not complied with the apex order of this Hon; Service Tribunal of dated 09/08/2023 and as a result thereof, the monthly salary of the petitioner/appellant, being low paid Govt; Employ, has been kept attached as such, in violation of the aforesaid apex order of this tribunal, and also violating the Fundamental Rule 54, the petitioner has not been paying her salary just from the 01/06/2023 up till now.
4. That in violation of the apex order of this Tribunal as mention above in contents No.3 , the Respondent No.1 and No.4 and No.5 , have wrongly drawing, monthly

salary of their eye blued Mst, Tawheed STT(Senior Theology Teacher) BPS 16, who has wrongly been adjusted, against the TT BPS 15, despite having been filled legally by this Hon; Tribunal by suspending the impugned order dated 26/12/2022, actually passed and communicated on 06/03/2023, so the monthly salary of the petitioner after suspension of the order impugned should be paid like routine w.e.from 01/06/2023 continue. Copy of the salary payment slip is annexed for ready reference.

5. That the respondent No. 4 on mala fide intention and ill will with the verbal instructions of the respondent No.1 do not leave the petitioner/appellant to sign in the attendance Register of the teaching staff despite the petitioner/appellant has regularly been performing her duty punctually and teaching her classes.

Therefore, it is most humbly prayed that on acceptance of this Execution Petition the relief sought may graciously be granted and directed the respondents to release the salary of the petitioner/appellant just from the 01/06/2023 on ward regularly without any illegal break. And further relief to which the petitioner/appellant is otherwise entitle may also be granted though not specifically prayed for.

Learned counsel for the appellant present and argued that appellant was transferred to GGHSS Shalbandai Buner from GGMS Shangra Buner vide order dated 26.12.2022, as a result of which appellant relinquished charge on 26.12.2022 and assumed charge at GGHSS on 27.12.2022. As a result of which change alert of DDO Code BD6007 to B.D6064 was sent to the appellant by employee service. He argued that appellant performed duties in GGHSS Shalbandai Buner from 26.12.2022 to 07.03.2023 which is evident from her duty certificate signed by the Principal of said school on 15.03.2023. He further argued that impugned order was malafiedly shown to be issued on 26.12.2022 in back date which in fact was issued on 06.03.2023 vide which transfer/posting order dated 26.12.2022 withdrawn. He submits that just to accommodate respondents No.7, said order was issued and respondent No.7 was posted vide order dated 15.05.2023, while appellant is still performing her duties in the said school. Points raised need consideration. Instant appeal is admitted for regular hearing subject to all legal objections. The appellant is directed to deposit security fee within 10 days. Thereafter, notices be issued to respondents for submission of written reply/comments. Respondents be summoned through TCS the expenses of which be deposited by the appellant within 3 days. 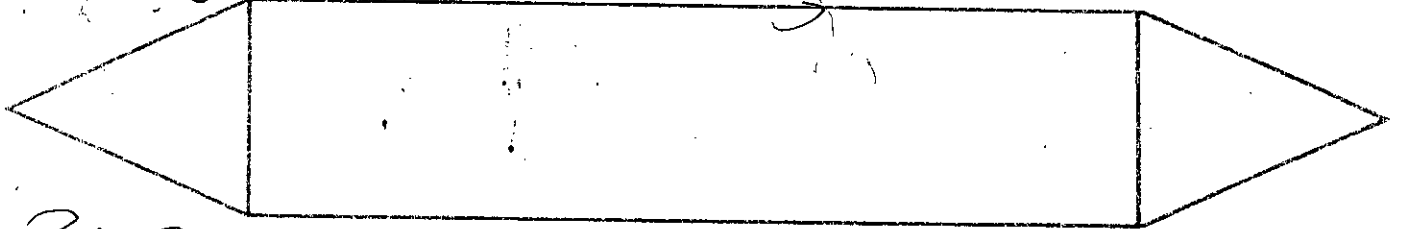
