Respectfully Sheweth:

Preliminary Objections

- 1. That the appeal in hand is not maintainable and incompetent in the eyes of law.
- 2. That the appellant has got no cause of action and locus standi to file the instant appeal.
- 3. That the appellant has not come to the tribunal with clean hands.
- 4. That the appellant has suppressed all the relevant and material facts.
- 5. That the appeal is mis-constructed and mistakenly drawn, hence liable to be rejected.
- 6. That the appeallant is estopped by his own conduct to file the appeal.
- 7. That as stated in the objection supra, the appeal is bereft of cause of action and is liable for dismissal.

8. That the respondents have the power to change the rules any time for better running of its department and the rules mentioned in the instant appeal have been made for the whole province, not for any specific person/individual.

<u>On Facts</u>

- 1. Para No.1 is correct to the extent of filing of earlier appeal, i-e SA NO.-500/2022. Similarly, the appeal was disposed off.
- 2. Pertains to record, needs no comments.
- 3. Correct to the extent that Govt. of Khyber Pakhtunkhwa Finance Department vide notification No. FD(SO SR-II)2-5/2021 /IT Prof Allow dated 07-07-2021 sanctioned IT Professional Allowance to the tune of one initial basic pay per month as per basic pay scale of 2017 to the IT officers (BPS -17 & above) having designations mentioned in the notification w.e.f 01-07-2021 (copy of notification attached as annexure A)
- 4. Incorrect hence denied. IT allowance has been sanctioned by the Provincial Government having designations with required qualification mentioned in the notification.
- 5. The case was placed at the agenda of GRC meeting held on 02-08-2023 the Chairmanship of Minister Finance. Minutes of meeting have been submitted for approval of competent authority.


