Service Appeal Under section 4 of the Khyber Pukhtoon servicetribunal act 1974 against the impugned final seniority list dated 30/4/2023 whereby the private respondents no 4 and 5 were placed at high pedestal of the seniority list in total derogation of law and rules.

The appellant submits as follows:

- 1. That the appellantwas appointed as drawing master (DM) vide appointment order dated 24/2/2011 on open merit Basis and after his appointment he took the charge of his duties whereas the respondent No 4 and 5 applied as batch wise candidates pursuance to the same advertisement but were not appointed on the ground of having drawing certificate from jamshoro university Sindh.(appointment order of the appellant and charge report attached as anx A and B)
- 2. That the respondents then filled a writ petition in the Peshawar high court Mingora bench against their non-appointment on the batch wise qutawhich writ petition was accepted vide order and judgment dated 28/6/2012 where against the CPLA filled by the education department was also dismissed and the respondent No 1 issued their appointment order dated 20/6/2013 pursuance to the aforesaid judgment of the pehawar high court.(appointment order of the respondents attached as anx C).
- 3. That the respondent No 4 and 5 did not file any review petition challenging their appointment on 20/6/2013 .
- 4. That it is pertinent to mention here that some of the colleagues of the respondent No 4 and 5 who were also of the same status (i.e bach wise candidate) filled writ petitions before the high court Mingora bench and sought their appointment on the principle of consistency where after their writ petitions were accepted and were appointed as similarly placed with respondent no 4 and 5 vide judgment dated 12/2/2015 in w/p no 148 M of



2011 and some other judgment of same nature and official respondents were directed to appoint them from 26/2/2011 and prepare joint seniority list and the official respondent acted upon the order and their order of appointment dated 26/2/2011 was issued (judgment, 1st appointment order and appointment order dated 26/2/2011 pursuance to order on petition of other colleagues attached as anx D,E and E1)

- 5. That it is also worth mentioning that the respondent No 4 and 5 had also approached the service tribunal for their retrospective appointment which appeal was accepted and the benefit of the review petition mentioned therein in the judgment was extended to them and the official respondents were directed to prepare the seniority list as per rules (order of the worthy service tribunal attached as Anx F).
- 6. That the official respondents then prepared a tentative seniority list which was objected by the appellant and some other persons through different application as irrelevant persons had been included in the seniority list.(applications attached as anx G and H)
- 7. That a final seniority list was issued which again contain the names of irrelevant persons as some of them had retired, some died and some had left the service moreover respondent No 4 and 5 had been placed on high pedestal of seniority list despite the fact that they were junior to the appellant, hence the appellant challenged it within the prescribed time through a department appeal. (final seniority list and department appeal attached as anx I and J)
- 8. That an inquiry was also conducted in the matter pursuance to the notification of the DEO upon the Departmental appeal which was concluded in favor of the appellant but the respondent No 1 is reluctant to correct the seniority list as per recommendation of the inquiry officer. (Notification of DEO and inquiry committee recommendations attached as anx J1 and J2)
- 9. That as the departmental appeal of the appellant was not decided within the prescribed statutory period, hence this service appeal, before this worthy tribunal, on the following ground inter alia.

GROUNDS:

- 1. That the impugned seniority list dated 30/4/2023 has not been prepared according to law and rules and irrelevant persons have also been included in the same which have resulted into wrong placement and position of the appellant in the seniority list.
- 2. That the appellant have not been given his due seniority position on the pedestal of impugned seniority list and his juniors have been shown on the high position which actions and inactions of the respondents are violative of law and rules.



- 3. That the respondent No 4 and 5 are also juniors to the appellant but they have been placed senior to the appellant in total derogation of law, rules and judgment of the service tribunal in their favor.
- 4. That as per law and rules, if candidates are appointed on the same date, their inter Se seniority is fixed on the basis of merit assigned to them in the merit list of appointment and despite the fact that the appellant is meritorious in the appointment order he has been placed junior which action is illegal and unwarranted under the law.
- 5. That withholding the promotion of the appellant, on the pretense of seniority issue despite the fact that posts for promotion to SDM are available with the department, is also illegal and the appellant is entitled to anti-date promotion and in this regard proper appeal will be filed with solid data and evidence.
- 6. That as per law and rules and legitimate expectancy the appellant is entitled to due seniority position and appointed to the post of SDM laying vacant.
- 7. That the appellant has not been treated according to the law and natural jutice, hence the impugned seniority list is against the spirit of the law and the appellant should be declared senior then the respondents and any other candidate having low merit than the appellant in the interse seniority.
- 8. That an inquiry was also conducted in the matter which was concluded in favor of the appellant but the respondent No 1 is reluctant to correct the seniority list as per recommendation of the inquiry officer (inquiry officer recommendations attached as anx J1)
- 9. That the appellant seek the permission of this worthy tribunal to rely on additional grounds at the time of arguments.

It is therefore kindly prayed that on acceptance of this appeal the impugned seniority list may kindly be corrected and amended by placing the appellant on higher position then the respondents and may be given his due seniority position as per law and rules keeping in view the merit positions of the appellant and other candidates of the same advertisement with all back benefits.

Any other relief not specifically prayed for and which this worthy tribunal deem fit and appropriate in the facts and circumstances of the instant case may also kindly be granted for the end of justice.

HAIDER ALI KHAN, J.- Through this single judgment we intend to dispose of the instant W.P No. 148-M/2011 as well as the connected writ petitions bearing W.P No. 409-M/2012 and W.P No.531-M/2012, as same question of law is involved in all these petitions.

Education Department District Buner invited applications through advertisement in the national newspapers for appointments against certain posts lying vacant in different schools of District Buner in the year 2010. As per policy of the Government, the appointments were to be made on the basis of 25% on open merit and 75% on batch-wise quota. The

petitioners of all the three writ petitions (hereinafter to be referred as the petitioners), having the requisite qualification received from Sindh, also applied for the vacant posts of D.M. After test and interview, final merit list was drafted and the departmental selection committee (DSC) recommended some of the candidates including the petitioners for their appointment against the vacant posts of D.M subject to verification of their certificates from the concerned authorities. However, only candidates, three on open merit and one on batchwise quota, were appointed against the policy vide the impugned order dated 24.2.2011 and the petitioners were ignored despite the fact that letters of verification had been received on 12.2.2011. Feeling aggrieved, the petitioners have approached this Court through the instant writ petition and the connected writ petitions bearing W.P No. 409-M/2012 and W.P No.531-M/2012.

- 3. Para-wise comments were called from the respondents, which were so submitted wherein plea of the petitioners was refuted.
- 4. Learned counsel for the petitioners referred to judgment of this Court reported in 2013 PLC (CS) 142 (Khaista Rehman and others

Vs. EDO and others) and contended that through the said consolidated judgment, several other writ petitions including W.P. No. 2288/2011 and W.P. No.159/2011 have been decided wherein the same issue has been clarified which is involved in the instant three writ petitions. He further contended that appointment of the petitioners has been declined on the ground that Inter Grade Drawing Certificates obtained by the petitioners from Sindh are subjected to verification of the concerned authority with regard to equivalency thereof with the certificates issued by the recognized institutions of Khyber Pakhtunkhwa. It was argued that the issue has been resolved by this Court through the above referred reported judgment, which has been upheld by the august Supreme Court, wherein it has been held that distinction could not be drawn between the award of degrees or services by the institutions of Jamshoru and Karachi and that of this province. It was further argued that in compliance of the above judgment, petitioners of W.P No. 2288/2011 and W.P No. 159/2011 namely Gul Rasool Khan and Sherin Zada, who were also candidates alongwith the present petitioners under the same advertisement, have been appointed by the

- 5. On the other hand, learned A.A.G., appearing on behalf of the respondents, contended that all the appointments were made in accordance with law and policy of the Government and no discrimination, whatsoever, has been committed on behalf of the respondents.
- 6. Arguments heard and record perused.
- that the main issue prevailing in the instant cases is that of credence of the certificates obtained by the petitioners from Sindh, but the issue has already been decided by this Court vide the judgment *ibid*, wherein certificates issued from the recognized institutions of Sindh and Khyber Pakhtunkhwa have been given the same status and discrimination between the same has been condemned. Relevant para of the judgment *ibid* is reproduced as under:-

"In the present case, the D.M certificate qualify from all corners as genuine certificate issued by the recognized institution, which was the requirement of the recruitment policy as mentioned above. We have gone through the merit list which clearly indicates that the

petitioners have been deprived on lame excuse on the ground of delaying tactics regarding the verification of D.M. certificates obtained by the petitioners. It was also pointed out that respondents : in subsequent appointment had also appointed other condidates who obtained D.M certificates from the same institutions whereas, petitioners have been deprived though they have also qualified from the same institutions, hence of. respondents discriminatory and is violation of Article 25 of the Constitution Instead petitioners who were at better pedestal in the merit list, the other candidates who were below at the merit list as compared to the petitioners have been appointed which apparently shows mala fide on the part of respondents. After thrashing the entire record, we have come to the conclusion that petitioners have wrongly been deprived for appointment against the posts of D.M. which requires interference by this Court.'

The issue has also been resolved though a judgment delivered by Abbotabad Bench of this Court reported in NLR 2001 Service 14 (Babar Elahi & others Vs. The Director of Education and others) whereby it has been held that the preferential treatment to the certificates issued by the Government of Khyber Pakhtunkhwa vis-à-vis those issued by other institutions of the country was

discriminatory and hence violative of Article 25 of the Constitution of the Islamic Republic of Pakistan. Record reveals that certificates of the petitioners have duly been verified by the institutions concerned and only on the pretext of verification, their appointment was withheld by the respondents. Moreover, it was also pointed out that in the subsequent processes of recruitment, candidates qualified from the same institutions of Sindh were appointed, therefore, in case of the petitioners too, discrimination on the part of the respondents is apparent as the petitioners ought to have been appointed on the basis of parity with the other appointed candidates.

- 8. Perusal of the record also reveals that the petitioners were on the top of the merit list prepared by the respondents and verification has been carried out in respect of the credentials of the petitioners from the concerned quarter of the Sindh Government, therefore, in view of the judgments of the superior Courts, they are entitled to be appointed against the posts of D.M.
- 9. For what has been discussed above, all the three writ petitions are allowed and the respondents are directed to appoint the petitioners


