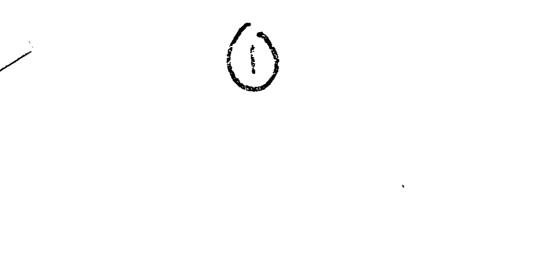

The Committee along with the executive Engineer, C&W Division Handu visited on 20.01.2011 and submitted their inspection report wherein they observed that there were deficiencies/shortcomings in Master plan and also the construction work found sub-standard. The committee recommended that the master plan be revised. Consequently the Secretary home department requested the Chief Secretary Khyber Pakhtunkhwa to direct PIT to carry out inspection of the under construction building of District Jail Hangu and Secretary Khyber Pakhtunkhwa referred the case to PIT.

That, on request of PIT vide letter dated 28.03.2011, Executive Engineer C&W Division Hangu on 16.04.2011 only partial record provided to PIT because whole record was lost due to bomb blast.

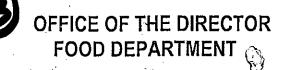

Phase-i of the scheme was reflected vide ADP No.420 (2008-2009), the administrative approval was accorded for Rs. 1.067 million vide Section Officer (Prison), Home & T.As Department bearing No.4/23-60 Prs)HD/09 Vol-JJ cated 19/2/2009.

The scheme "Construction of District Jail at Hangu" was again reflected in ADP at Sr. No.1022/80466 (2011-12) estimated cost of Rs.263.757 Million was approved by the PDWP, Administrative approval for the scheme was issued by the Home & Tribal Affairs Department for implementation of the scheme ADP No.408 (2010-2011) i.e. Construction of District Jail Hangu, 50% cost sharing basis with FATA at a revised cost of Rs.264.391 millica dated 18/5/2011 and technical sanction was issued by the Chief Engineer (Centre) C&W Department vide to 386/2-CE dated 2/10/2014 for Rs.263.757 million (Flag-B). During the proceedings of the inquiry and while examining the charges leveled against the officers/officials and replies thereof of all the accused and their personal explanation during the personal hearing heid before the inquiry committee and consequent upon the visit/inspection of the members of the inquiry committee to the project, it was found that the project under inquiry i.e. Construction of District Jail Hangu is still in progress and is on-going the so called irregularities are in general practice of the Works Department, all payments are considered as advance payments under CPW Code and GFR, the contractor is responsible for any

deficiencies/shoricomings arised auring the construction work; the supervising staff held responsible to ensure the quality/specification of the project work. Which had been done to their entire efforts during execution of the project. The expenditure shown as advance payment without technical sanction has been regularized by obtaining technical sanction of the revised administrative approval cost of the project. The expenditure shown in advance mentioned in the charge sheed statement of allegations had been regularized by the department in to-to. It is further, mentioned that the C&W Department is the executing agency whereas the Client Department is prison department, any deviation during the construction from the approved PC-I are being made by the project in charge officer/officials as per requirement of the Client Department, which has been regularized through Revised Administrative Approval reconical service OF estimated cost of the project. Lab tests were properly carried out through Engineering Universit.

CONCLUSION

Threatbare inquiry committee after treatbar, examining the record of the divisional office, charges leveled in the charge select/statement of allegation against the accused officers/officials, replies thereof to the charge sheet/statement a allegations is of the considerable view that since technical sanction has been accorded by the competent authority, the work was executed as per requirement of the Client Department, being running project, any shortcomings deficiencies can be removed by the supervisory staff of the project, before the completion of the project, resultantly the charges leveled against all the accused cannot be attributed to be proved against any one, as all advance payments in the running projects are considered as advance payments as per para 224 (b) CPWA Code Vol-III and 144, are required to be regularized by subsequent action to be taken in the on going scheme/Project (Flag-O).

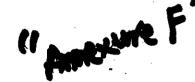

With reference to C&W Department letter bearingNo.SOE/C&WD/8-20/2014 dated 05.10.2015, vide which show cause notice containing tentative minor penalty of "withholding of one increment for two years" has been served upon the undersigned to furnish reply within stipulated period and be intimate for personal hearing. In this regard charge wise replies may be perused as under:

- As per record, the undersigned has never made payment to the contractor in advance which can be verified from the attached vouchers; rather the amount in question has been calculated on the basis of mala-fide intention. I am further clarified the issue that the so-called advance payment i.e. Rs.0.111939 million on the part of undersigned has been alleged without any justification and finally that amount i.e. Rs.0.111939 million shown as recovered (report is enclosed). Therefore trust me that I have never approached to my successors for recovery in shape of work done on the basis of my non-involvement. Hence this charge is not based on realistic grounds.
- The scheme "Construction of District Jail Hangu" approved by PDWP in its meeting held on (03-06).01.2009 and accordingly administrative approval (A.A) for amounting to Rs.161.867 million issued on 19.02.2009. However the scheme revised at a total cost of Rs.264.391 million. The Competent Authority has been accorded technical sanction for the subject project vide their letter dated 02.10.2014 (copy enclosed). Hence the expenditure cannot be termed as irregular. Therefore, this charge is also not proven upon me, which may be withdrawn.
- In this regard it is also clarified that I have been served as XEN C&W Division Hangu for a short period of 06 months. During my tenure I never allowed the payment to the contractor on substandard work; rather the payment made to the contractor after proper site visits. Besides this, there is a set procedure/criteria exists in C&W Department for payment to the contractors. Finally the bills are placed before XENs C&W Department. Owning to this way this charge may also be withdrawn.

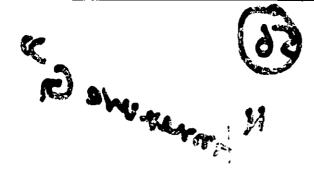
