

Respectfully Sheweth: -

The appellant humbly submits as under: -

1. That the department of the respondents floated an advertisement in daily "Aaj" newspaper dated 25-10-2012 about the posts of PET, CT, Lab Assistant etc (Copy of Advertisement is attached as annexure-A)
2. That the appellant was Lance Naik No. 107842 in Kurram militia and applied for the post of physical education teacher (PET BPS-09). The requirement of the above post is B.A or BSC with JDPE (Junior Diploma in physical education) or equivalent certificate from Army or other equivalent qualification as per advertisement. Thus the appellant possessed the required criteria for the above post. (Academic records as annexed as B1 to B4).
3. That the appellant was interviewed and after going through the prescribed procedure, he was on the recommendation of Departmental selection Committee appointed as such vide order/ letter dated 15-01-2013 (appointment letter is annexed as "C")
4. That the appellant has performed his duties with full devotion, after carrying out their medical examination and taking charge on the above post. (Copy of medical certificate, charge repost and attendance sheet are attached as annexure D, E, F respectively).



5. That after taking charge by the appellant, the respondent No. 4 has sent the academic documents of the appellant to the concerned authority for its verification and the same has been verified without any objection (verification reports is attached as "G").
6. That the appellant alongwith other petitioner moved a writ petition in November, 2014 against the respondents for the release of his salary, but during its pendency the appellant has been terminated from his service by the respondent No. 2 vide impugned order/letter dated 11-12-2015, on the ground that having no professional document, without providing opportunity to the appellant for hearing (copy of the impugned termination order is attached as annexure "H").
7. That the appellant was constrained to prefer his departmental appeal before the authorities but the same has neither been accepted nor rejected. Hence, the appellant being aggrieved, approached this Honorable Tribunal, inter alia, on the following grounds (Copy of Appeal Annexed as "I")

**GROUND.**

- A. That the impugned order is illegal and void ab-initio.
- B. That the appellant has not been treated in accordance with law and rules and has been condemned unheard.

- C. That no charge sheet and show cause notice was communicated to the appellant.
- D. That no inquiry was conducted to find out the true facts and circumstances.
- E. That the appellant was not provided opportunity of personal hearing.
- F. That the appellant was duly appointed after fulfilling the requisite procedure on the recommendation of the Departmental selection committee.
- G. That the appellant couldn't be punished for lapses of the respondents as per the dictums of August Supreme Court of Pakistan.
- H. That the appellant has performed duties for about two and a half years and thus valuable rights have occurred in his favour which could not be snatched of him.
- I. That the impugned termination order is against the terms and conditions because lacking of professional documents is a pre-selection question and it is to be determined before the selection and appointment. Hence the present impugned termination order is based on malafide so liable to be struck down.
- J. That it is evident that in another case some unskilled teachers had been employed in the respondents department, so that instead of their termination from service, the respondent No. 4 allowed them for acquiring the required training or education through office order dated 22-05-2013 as below.

The untrained teacher will acquire the requisite professional training and academic qualification within 02 years after the date of their regularization, other wise their appointment order will stand cancelled automatically.

Hence, the appellant is entitled to be allowed for acquiring the required professional Education. (Copy of order dated 22-05-2013 is annexed as J).

- L. That the impugned terminations<sup>order is</sup> against rules of natural justice, therefore, such order is without lawful authority and needs to be struck down.
- M. That the appellant has about two and a half years of service and is jobless since his illegal termination from service.

It is, therefore prayed that on the acceptance of this appeal the impugned order dated 11-12-2015 may kindly be set aside and the appellant may kindly be ordered to be reinstated in his service with all back benefit.

vacant post, the applicant/ appellant will suffer from irreparable loss. (Copy of Newspaper is annexed "K").


- C. That due to the peculiar circumstances of the case in hand, balance of convenience also lies in favour of allowing this application.
