



**Grounds:-**


- A. Incorrect, pension of the appellant has been moved to the quarter concerned for further consideration.

- F. Respondents may also be allowed to raise additional grounds at the time of arguments.



Keeping in view of the above stated facts, it is humbly prayed that the service appeal, being devoid of merits may kindly be dismissed with costs, please.

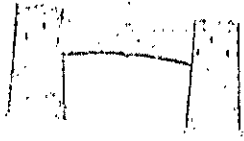

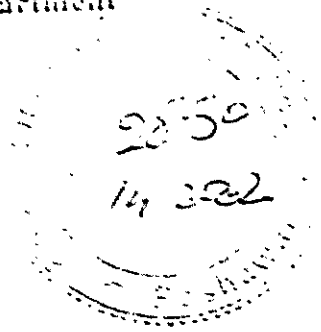

QAISER RASHID KHAN, J:- Through the petition in hand, the petitioner, Azam Din, has prayed as under;

*"It is, therefore, most humbly prayed that on acceptance of instant writ petition, inactions of Political Agent (Khyber Agency/ Commandant Khyber Khassadar Force/respondent No.3, regarding premature retirement of petitioner from service, may be declared as illegal and action without jurisdiction, hence be set at naught and the respondent department may further be directed to either allow petitioner to complete his lawful tenure of service in accordance with Rules of Service of Khyber Khassadars, 1950 and may not be retired from service prior to his actual date of retirement i.e. 28.02.2021 or he may be paid all the remunerations which he ought to have incurred in case he was not forcefully removed from service with from 13.09.2009 to 30.11.2012, so as to strike fair balance between equity and justice."*

The learned counsel for the petitioner, at the very outset, referred to the judgments of this court in W.P Nos. 4698-P of 2017, 4803-P of 2017



and 5021/2017 dated 21.11.2017, 30.11.2017 and 20.12.2017 respectively and requested that the present petition be also disposed of in the light thereof.
