#### PRELIMINARY OBJECTIONS:-

- i. That appellant herein has not come to the court with clean hands and has not stated the facts of the case.
- ii. That no *legal right* vests of the appellant which could possibly be enforced through the process of court and that too in its constitutional jurisdiction.
- iii. That the appellant does not come within the definition of **aggrieved person** by any stretch of imagination.
- iv. The appellant herein is not entitled to any of the reliefs listed in the prayer.
- v. The appellant has got no lucus standi to file the service appeal.

Incorrect, as per procedure the judgment of Service Tribunal dated 17.12.2015 forwarded to Law Department with the request to place the same before Scrutiny Committee of Law Department as to whether the case is fit for filing of CPLA before the Supreme Court of Pakistan against the said judgment dated 17.12.2015. After threadbare discussion, the committee was decided with consensus that it is a fit case for filing CPLA/Appeal before the Supreme Court of Pakistan (Annex-I). Accordingly, the Department filed CPLA/Appeal before the Supreme Court of Pakistan on 11.02.2016 (Annex-II). After lapse of more than 07 years, the appellant has filed Execution Petition in Services Tribunal on 31.07.2023 (Annex-III). Therefore the Department taken-up case with Law Department for advice. The Law Department tendered advice with the wordings that the instant Execution Petition No 500 of 2023, has been filed, beyond the statutory period provided under Section 48 of Code of Civil Procedure, 1908 for Execution of order and judgment of Services Tribunal dated 17.12.2015 in service appeal No 1508 of 2012. There the Law Department has advised to file and objection petition under Section 47 of Code of Civil procedure, 1908 on maintainability of Execution petition through the Law Officer concerned. (Annex-IV)

- 5. Incorrect, there is no mala-fide, no discrimination and violation of rights of the appellant has been made. In fact, the Department followed rules/ regulation/policy strictly in such like cases. As explained above, the Department processed the case and submitted / forwarded the judgment of the Services Tribunal dated 17.12.2015 for placing before the scrutiny Committee. The Law Department declared the case fit for filing before the Supreme Court of Pakistan. Accordingly, the Department filed CPLA before the Supreme Court of Pakistan on 11.02.2016. Hence-the-claim of the appellant is not justified.



SERVICE APPEAL NO.1508/12 ENGINEER INAYATULLAH VS GOVERNMENT OF KHYBER PAKHTUNKHWA THROUGH SECRETARY C&W DEPARTMENT AND OTHERS.

A meeting of the Scrutiny Committee on the above titled subject was held on 29-01-2016 under the Chairmanship of Secretary Law Department in order to determine the suitability / Fitness of the subject case for filing of CPLA /appeal in the upper forum or otherwise...

- 3. When the subject case was placed before the S: Committee for discussion the representative of C&W Department apprised the Committee about the background of the case and stated that besides other charges, the appellant had also been charged for absence from duty since 21-05-2011 without proper intimation / prior approval and all the codal formallies have been fulfilled by the Administrative Department before imposition of major penalty against him.
- 4. The Scrutiny Committee size observed that honorable Services Tribunal also admitted the guilt of appellant i.e. absence from the duty while stating that after carefully perused the record and as the appellant has not categorically denied absence from duty from certain time meaning thereby the charge of absence was proved against the appellant before the Tribunal too but surprisingly the honorable court instead of maintaining the penalty modified the same unintentionally from removal into compulsory retirement with effect from the date of issuance of impugned order i.e. 01-10-2012.
- 5. The Scrutiny Committee after threadbare discussion was of the view that besides the admission of appellant regarding absence from the duty the modification of penalty was not necessary in the given circumstances of the case, hence why it was decided with consensus that CPLA is to be filled in the subject case before the Apex Court of Pakistan.
- 6. The representative of C&W Department was directed to approach the office of Advocate General alongwith complete record of the case which may include certified copy of judgment, grounds of appeal, and annexur's (if any) for doing the needful within the period of limitation under intimation to this department.
