1. That appellant/applicant preferred the subject appeal in respect of his seniority, which is pending adjudication before this honorable tribunal.
2. That during the pendency of the instant appeal another seniority list was floated against which the applicant preferred a representation.

3. That the said representation was turned down by the respondents on 16/09/2023 and communicated the same to the appellant on 02/10/2023.

6. That these actions of the respondents speak volumes of the extreme high handedness towards the appellant, and amounts to usurping the rights of the appellant.

7. That it is pertinent to mention herein that the applicant/appellant is occupying the post of Chief Planning Officer since May 2020, and this post is a BPS-20 post. The appellant has also undergone the Senior

Management Course (from Nov 2021 till March 2022) which is a prerequisite for promotion to BPS-20. Also the salary of the appellant stands fixed in BPS-20.

- 8. That the applicant/appellant now seek the indulgence of this honorable tribunal to seek directions for placing the name of the appellant in the working paper for promotion to BPS-20. In the alternate the appellant seeks indulgence of the tribunal to forthwith stay the PSB proceedings till the final disposal of the instant appeal.

It is therefore most humbly prayed that on the acceptance of the instant CMA, may it please this honorable court to so kindly direct the respondents to place the name of the appellant/applicant before the Provincial Selection Board for consideration of his case for promotion to BPS-20. In the alternate may it please this honorable tribunal to forthwith issue directions to stay the proceedings of the PSB and not to issue any notification of promotion till the final disposal of the instant appeal.

Dear Sir,

I am directed to refer to your department's letter No. SO (E) P&D/087/1-74/2017/Vol-III dated 18-04-2021 on the subject noted above and to convey concurrence of Finance Department to the grant of pay of higher post to Mr. Qaisar Alam (PPS BS-19), for holding charge of the post of Chief Planning Officer in Health Department w.e.f 05.03.2022 (i.e the date of completion of SMC) till his promotion/relinquishment of higher post whichever is earlier subject to the following conditions:-

- i. The pay of the higher post will be fixed presumptively w.e.f 05-03-2022 and it will include the increments of the pay scale of the higher post for the period of higher post appointment on that post. In such cases premature increment shall not be admissible. However, the officer will be entitled to the arrears of pay and allowances from the date he assumes the charge of the higher post.
- ii. On relinquishment of charge of the higher post or on transfer or on regular promotion to that higher post, the pay will be re-fixed with reference to original scale of pay of the post, held by the officer and increments carried (if any) on higher post will count for increments in his original scale as per provisions of FR-26.
- iii. The pay of the higher post shall not be accounted for the calculation of emoluments towards the pension.


