PARAWISE COMMENTS OF RESPONDENT NO. 03 & 04

RESPECTFULLY SHEWETH:-

PRELIMINARY OBJECTIONS:

- The appellant has got no cause of action / locus standi to file the instant appeal.
- Instant appeal is based on illegal demands against the competent authority. 2.
- No discrimination / injustice has been done to the appellant. 3.
- 4. That instant appeal is not sustainable in the eyes of law.
- That the appellant failed to establish an arguable case in her favour. 5.
- 6. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
- That the appeal is barred by Law and Limitation. 7.

ON FACTS:

- 1. Needs no comments.
- 2. Subject to proof.
- 3. Pertains to personal information of the appellant.
- 4. The Khyber Pakhtunkhwa Public Service Commission invited applications for four (04) posts of Female Assistant District Officer (BPS-16) (Disable Quota) vide Advertisement No.05/2009 Serial No. 10 with the following qualification:-

B.A/ B.Sc 2nd Div with B.Ed and five years teaching / administrative experience in Govt recognized Education institutions / office.

Age Limit

21 to 35 years

Pay Scale

BPS-16

Eligibility

Female.

Allocation

Merit.

Note: Experience wherever prescribed shall be counted after the minimum qualifications for the post(s), if not specifically provided otherwise against the advertised post(s).

(Annex A)

- 5. Incorrect. As per diary record of the Commission no entry of application of the appellant was found for the post of Assistant District Officer (BPS-16) rather Diary No. 11863 shows that one Sobia of District Mardan applied for the post of District Officer (BPS-18) (Annex-B).
- 6. Incorrect. No Written Examination was conducted. Dispatch No 25917 letter dated 27.05.2010 tally with the Commission record, however, no record of the interview on 07-06-2010 of the appellant was found. Moreover, the competent authority carried out a fact finding inquiry into the recommendation or otherwise of the appellant vide order dated 04-02-2020. Findings of the said inquiry are as follows:-

"Though, Mr. Masood Zaman, the then Deputy Secretary, owns the recommendation letter of Miss Sobia issued to Secretary Elementary and Secondary Education Department, still neither there is any record of her being interviewed by a panel of the Commission nor record of her submission of application for the post of ADO is available. Moreover, the Ex-Officer who owns the recommendation to be signed by him has himself been penalized under Khyber Pakhtunkhwa E&D rules 2011 in a similar case of recruitment of Male ADOs. Therefore his statement and the recommendation letter signed by him in the absence of other proofs / record cannot be relied upon".

(Annex-C)

The original file / record of the Advertisement No. 05/2009 female disabled quota is not available with the Commission and besides the aforementioned Inquiry, a formal inquiry into the matter was also conducted, recommendations of which are as under:

"Claim of Mst. Sobia that she is a Public Service Commission recommendee for the post of Female ADO Disabled Quota is not genuine. There is no reliable record of her case available. All the indicators point-out that she managed a foul play in connivance with certain employees of the Public Service Commission and managed placing on record the above mentioned application form and got communicated her fake recommendation letter to the Elementary & Secondary Education Department. Since there was no such genuine record existing at all with the Public Service Commission no such record can ever be found. We may press for her pending writ petition as based on a false claim and such record being not existing."

- 7. Incorrect. As explained above no record of the interview of the appellant on 07-06-2010 was found as referred by the appellant. Rest of the para pertains to respondent No. 2.
- 8-12. Pertains to Elementary and Secondary Education Department.
 - 13. Correct to the extent of submission of application on 16.03.2019. Subsequently, on 24.06.2019 the appellant submitted another application annexing copy of recommendation

letter No. SR-I-NO.58881 dated 11.12.2010 (Annex-E), though issued from Public Service Commission and owned by the signatory, the then Deputy Secretary III who has been compulsorily retired from service on account of an inquiry conducted against him in the Assistant District Officer (Male) cases.

14. Pertains to Respondent No. 5 and 6.

15. Pertains to respondent No. 2 and 6. Furthermore, Commission has got no nexus with the mentioned removal order and notification. Moreover, appellant has no locus standi to file the instant appeal.

GROUNDS:

Pertains to Elementary and Secondary Education Department.

Incorrect as explained in Para 6 & 7 of facts. Further, even the alleged recommendation letter dated 11.12.2010 bears no mention of other recommendees, rather in para 4 thereof re-advertisement of the remaining 3 posts has been mentioned.

E. Incorrect. The inquiry report clearly and with solid proof negates the claim of the appellant, Report is already annexed as Annex-D and detail reply is given in Para 6 ibid.

F to J.Pertains to the record of the Elementary and Secondary Education Department.

K. The respondents may be allowed to raise additional grounds during the arguments.

Hence it is respectfully prayed that on acceptance of the submission made herein above, the instant appeal may please be dismissed being without merits.

Four posts of female Assistant District Officer Disable Quota were advertised in Four posts 1. Sold Vertisement No. 05/2009, S. No. 10. Miss Sobia D/O Said Karim hailing from Mardan claims to be the recommendee / selections 1. Said Karim hailing from Advertisement Advertisement of the recommender of the Service Commission against Disable Ouota Selectee for the post in question by the public Service Commission against Disable Quota.

In order to know as to whether she had applied for the post in question or in order is in order in the inad applied for the post in question or or in the indication (Annexure-B), which transpired that administration of Public Service commission (Annexure-B), which transpired that Diary No. 11863 allotted to Sobia District Mardan for the post of District Officer BPS-18 instead of Assistant pistrict Officer BPS-16. The candidate, Sobia relied on the call letter issued to her for post in question on 27.05.2010 wherein she had been given 07.06.2010 as her date of interview. Perusal of the ADO Female file transpired that no such interview record of Miss Sobia was found rather Miss Shagusta D/O Muhammad Hussian was

Apart from the above facts Miss Sobia after filing writ petition No. 2206p/2019, before the Peshawar High Court Peshawar on 25.03.2019 also submitted an application on 24.06.2019 annexing a recommendation letter No. 58881 dated 11.12.2010 signed by the then Deputy Secretary-III, Mr. Masood Zaman (Annexure-D). Although the dispatch number mentioned in the said letter has been verified by the administration / dispatch section of Public Service Commission, however, the signatory of the recommendation letter has already been compulsorily retired from the service on account of a disciplinary case and inquiry conducted against him in recruitment of Assistant District Officers (Male). It is also added that Masood Zaman, the then Deputy Secretary-III was also called to the Commission Office in connection with the subject case / record. His written reply is at (Annexure-E). It is also worth mentioning that the then dealing Assistant Mr. Hazrat Khan was also asked about the said record / file of ADO female disable quota. His reply is at (Annexure-F). Wherein he states that no record / file of disable quota was handed over 10 him by the high ups except the general quota file.

Findings:-

Mr. Masood Zaman the then Deputy Secretary owns the Recommendation letter of Miss Sobia issued to Secretary Elementary and Secondary Education Department, still neither there is any record of her being interviewed by a panel of the Commission nor record of her submission of application for the post of ADO is available. Moreover, the Ex-Officer who owns the recommendation to be of records him has himself been penalized under KP E&D rules 2011in a similar case of recruitment of Male ADOs. Therefore his statement and the recommendation letter signed by him in the absence of other proofs /record cannot be relied upon.

INQUIRY REPORT


The undersigned was entrusted the instant inquiry vide order No.KP/PSC/Admn/RF/00582 dated 09.03.2020. However, due to Covid-19 pandemic / lock down, proceedings could not be completed within the stipulated time.

BACKGROUND:

Mst. Sobia working as ADO (BPS-16) in Elementary & Secondary Education Department. She got appointed on 28.02.2012 as recommendee / selectee of Public Service Commission. She along with Three (03) other were terminated as a result of enquiry conducted by a committee of Directorate of E&SE. It was found out that her appointment was fake etc. Resultantly she filed writ petition No. 2206-P/19 before the Peshawar High Court, Peshawar which is still pending. The other three approached the Service Tribunal. During preparation of reply / comments it was noticed that her record is not available hence detailed enquiry was ordered. This fact has been mentioned in the comments submitted to the honorable high court. Mst Sobia alleges that she was recommended by Public Service Commission in the year 2010 as against Disabled Quota advertisement No. 05/2009 serial No. 10.

PROCEEDINGS:

1. In this regard the candidate, Miss Sobia was summoned for 29.06.2020. Her statement so recorded is at (Annx-A). According to her statement the application form was filled by her teacher and that never applied for any post before ADO through PSC. She claimed that her attendance was taken before interview. Miss Sobia and one other candidate were interviewed, while she requested to change her interview date from 07.06.2010. Interview panel was chaired by a female member of PSC. She indicated the room No. 134, 135 and 136 where she was interviewed in one of these rooms along with Inquiry Officer and she waited in front room for interview. According to her statement during her interview, the Chairperson of interview panel received a telephone call that her son was coming from America. She insisted that she was interviewed by Public Service Commission 3 member panel. She is disabled, over-age and requested for mercy.



- 2. The dealing assistant, Hazrat Khan was also summoned for statement on 08.07.2020. However, he appeared on 15.07.202 because Sobia was again summoned for the subject inquiry on 15.07.2020. Mr. Rustam Khan Superintendent concerned was retired from the service therefore he could not be summoned. Reply of Mr. Hazrat Khan dealing assistant is at (Annx-B). He affirmed the call letter issued to Miss Sobia was signed by him for the post of Female ADO, and stated that there was a general file for the post of ADO but no record was found i.e. attendance sheet and descriptive sheet etc. According to him it may be possible that her application form might have been rejected or may be as she provided a disability certificate; therefore he issued her an interview call letter under the general quota seat. Male ADO category of the post was dealt with by Assistant Mr. Amir Ilyas. He added that being dealing assistant he was taking attendance at that time and had taken attendance of another candidate Miss Shagufta but Miss Sobia he do not remembered. That the result was prepared by the then Deputy Secretary without my presence with the help of Mr. Shahab KPO and Mr. Feroz Khan Naib Qasid. He endorsed a note regarding two misplaced application forms which was found from the scattered record of Mr. Masood Zaman (late). While the second reply of Miss Sobia is at (Annx-C). According to her statement she claimed experience from 18.03.2004 to 31.05.2011 in application form. In her 2nd appearance she affirmed endorsed that she signed the attendance sheet which was found from the scattered record of late Mr. Masood Zaman.
- 3. Since, the case pertains to year 2010, therefore, it was necessary to associate the dealing hands that remained in the concerned branch/ section. The private secretary to member concerned who conducted the interview for the post of ADO female was also summoned for 15.07.2020. His reply is at (Annx-D).

FINDINGS:

4. There is no doubt that 04 posts of female ADO (BPS-16) Disabled Quota were requisitioned by Elementary and Secondary Education Department which were advertised through Public Service Commission advertisement No. 05/2009 at serial No. 10 copy is at





(Annx-E). Miss Sobia D/O Said Kareem of district Mardan claims to be the recommendee / selectee for the post in question by the Public Service Commission on the basis of recommendation letter No.SR-I/5888 Dated 11/12/2010 signed by the then DS-III, late Mr. Masood Zaman. In order to examine the application form of Miss Sobia D/O Said Kareem, the Secretary Elementary & Secondary Education Department was requested Vide our letter No. PSC/DD-II/007444 dated 10.08.2020 (Annx-F) to provide the application form and record of female ADO Disabled quota Advertisement No. 05/2009 which the candidate, Miss Sobia relied upon. In response, photo copy of the application form and other relevant papers were provided Vide (Annx-G). District wise record of application forms of the Public Service Commission issued to the main branches of the National Bank of Pakistan was asked from the administration section, the same is at (Annx-H). After examining and perusal of her application form it transpired that neither the application form was obtained from the concerned National Bank nor the diary stamp with signature of the then Secretary Public Service Commission affixed there-on as the practice then it was. It was further noticed that she neither applied against Serial No. 10 (Disabled Quota) nor claimed any sort of disability in column No. 9 as well as did not claim any service / experience in column No. 16. It is, astonishing that diary No. 11863 was found on the left corner of the instruction page of application form whereas serial No. 6 was mentioned therein, which was meant for Deputy District Education Officer (BPS-17). Copy of a genuine application form of one of the selectees of Public Service Commission for the post in question bearing bank stamp, serial number, diary number, signature and stamp of Secretary PSC for ready reference and comparison is at (Annx-I).

- In the entire episode apart from the role of dealing section, allotment of diary No.11863 to her application form for the post of District Officer (BPS-18) by diary branch without bearing bank stamp and diary stamp of Public Service Commission which was not obtained from NBP, is also beyond understandings. As per written reply of diary branch (Annx-J).
- 6. During the course of inquiry proceedings on 15.07.2020, Miss Sobia was asked as to whether she was in possession of five (05)

years teaching experience etc mandatory for the post of ADO. She replied in affirmative statement that she will produce the certificate. Although she did not claim any experience in her application form in relevant column, however subsequently on 28.07.2020 she provided a tempered with certificate showing an experience of Islamabad Model School Mardan w.e.f 18.03.2004 or 2005 is at (Annx-K).

- 7. As regard her disability she stated that it was due to a road accident which causes lower part of her leg broken/ fractured. Disability certificate is at (Annx-L)
- Miss Sobia claims to be interviewed on 07.06.2010 by the 8. concerned panel of Public Service Commission. Her stance required solid proof / record of her descriptive sheet wherein she had been marked as qualified or failed. While as per statement of Mr. Hazrat Khan, the dealing assistant, he was not handed over ADO Female Disabled Quota file by the then Deputy Secretary concerned Mr. Masood Zaman (late), if her descriptive sheet bearing marks on it, had been found, even then it would be of no use. During search of the office record, two tempered with attendance sheets of Miss Sobia were found from the scattered record/files etc in the room of the late Mr. Masood Zaman (Annx-M). Although, her statement / reply indicates that she managed by some inside facilitator to appear before the interview panel however, her recommendation letter signed by the then Deputy Secretary along with her application form (which was liable to be rejected for the reasons stated in proceedings Paras) conveyed to the requisitioning department cannot be considered a genuine recommendation letter. Her recommendation would have been endorsed/owned if she had followed the laid down procedure. For example obtaining of application form from the designated branch of National bank of Pakistan, properly filling the application form, duly affixing the diary stamp of PSC etc. Whereas in her case all these mandatory steps are missing. Opting for an unlawful way of doing certain ostensibly lawful act or thing essentially makes that act or thing suspicious itself.

CONCLUSION:



- Ommission recommendee for the post of Female ADO Disabled Quota is not genuine. There is no reliable record of her case available. All the indicators point-out that she managed a foul play in connivance with certain employees of the Public Service Commission and managed placing on record the above mentioned application form and got communicated her fake recommendation letter to the Elementary & Secondary Education Department. Since there was no such genuine record existing at all with the Public Service Commission no such record can ever be found. We may press for her pending writ petition as based on a false claim and such record being not existing.





INQUIRY REPORT

The undersigned was entrusted the instant inquiry vide order No.KP/PSC/Admn/RF/00582 dated 09.03.2020. However, due to Covid-19 pandemic / lock down, proceedings could not be completed within the stipulated time.

BACKGROUND:

Mst. Sobia working as ADO (BPS-16) in Elementary & Secondary Education Department. She got appointed on 28.02.2012 as recommendee / selectee of Public Service Commission. She along with Three (03) other were terminated as a result of enquiry conducted by a committee of Directorate of E&SE. It was found out that her appointment was fake etc. Resultantly she filed writ petition No. 2206-P/19 before the Peshawar High Court, Peshawar which is still pending. The other three approached the Service Tribunal. During preparation of reply / comments it was noticed that her record is not available hence detailed enquiry was ordered. This fact has been mentioned in the comments submitted to the honorable high court. Mst Sobia alleges that she was recommended by Public Service Commission in the year 2010 FILE DODAY against Disabled Quota advertisement No. 05/2009 serial No. 10.

PROCEEDINGS:

In this regard the candidate, Miss Sobia was summoned for 29.06.2020. Her statement so recorded is at (Annx-A). According to her statement the application form was filled by her teacher and that never applied for any post before ADO through PSC. She claimed that her attendance was taken before interview. Miss Sobia and one other candidate were interviewed, while she requested to change her interview date from 07.06.2010. Interview panel was chaired by a female member of PSC. She indicated the room No. 134, 135 and 136 where she was interviewed in one of these rooms along with Inquiry Officer and she waited in front room for interview. According to her statement during her interview, the Chairperson of interview panel received a telephone call that her son was coming from America. She insisted that she was interviewed by Public Service Commission 3 member panel. She is disabled, over-age and requested for mercy.

- The dealing assistant, Hazrat Khan was also summoned for statement on 08.07.2020. However, he appeared on 15.07.202 because Sobia was again summoned for the subject inquiry on 15.07.2020. Mr. Rustam Khan Superintendent concerned was retired from the service therefore he could not be summoned. Reply of Mr. Hazrat Khan dealing assistant is at (Annx-B). He affirmed the call letter issued to Miss Sobia was signed by him for the post of Female ADO, and stated that there was a general file for the post of ADO but no record was found i.e. attendance sheet and descriptive sheet etc. According to him it may be possible that her application form might have been rejected or may be as she provided a disability certificate; therefore he issued her an interview call letter under the general quota seat. Male ADO category of the post was dealt with by Assistant Mr. Amir Ilyas. He added that being dealing assistant he was taking attendance at that time and had taken attendance of another candidate Miss Shagufta but Miss Sobia he do not remembered. That the result was prepared by the then Deputy Secretary without my presence with the help of Mr. Shahab KPO and Mr. Feroz Khan Naib Qasid. He endorsed a note regarding two misplaced application forms which was found from the scattered FILED TODA record of Mr. Masood Zaman (late). While the second reply of Miss Sobia is at (Annx-C). According to her statement she claimed Deputy Registrar experience from 18.03.2004 to 31.05.2011 in application form. In her 2nd appearance she affirmed/ endorsed that she signed the attendance sheet which was found from the scattered record of late Mr. Masood Zaman.

3. Since, the case pertains to year 2010, therefore, it was necessary to associate the dealing hands that remained in the concerned branch/ section. The private secretary to member concerned who conducted the interview for the post of ADO female was also summoned for 15.07.2020. His reply is at (Annx-D).

FINDINGS:

4. There is no doubt that 04 posts of female ADO (BPS-16) Disabled Quota were requisitioned by Elementary and Secondary Education Department which were advertised through Public Service Commission advertisement No. 05/2009 at serial No. 10 copy is at

(Annx-E). Miss Sobia D/O Said Kareem of district Mardan claims to be the recommendee / selectee for the post in question by the Public Service Commission on the basis of recommendation letter No.SR-I/5888 Dated 11/12/2010 signed by the then DS-III, late Mr. Masood Zaman. In order to examine the application form of Miss Sobia D/O Said Kareem, the Secretary Elementary & Secondary Education Department was requested Vide our letter No. PSC/DD-II/007444 dated 10.08.2020 (Annx-F) to provide the application form and record of female ADO Disabled quota Advertisement No. 05/2009 which the candidate, Miss Sobia relied upon. In response, photo copy of the application form and other relevant papers were provided Vide (Annx-G). District wise record of application forms of the Public Service Commission issued to the main branches of the National Bank FILED TODAY Pakistan was asked from the administration section, the same is at Registr (Annx-H). After examining and perusal of her application form it transpired that neither the application form was obtained from the concerned National Bank nor the diary stamp with signature of the then Secretary Public Service Commission affixed there-on as the practice then it was. It was further noticed that she neither applied against Serial No. 10 (Disabled Quota) nor claimed any sort of disability in column No. 9 as well as did not claim any service / experience in column No. 16. It is, astonishing that diary No. 11863 was found on the left corner of the instruction page of application form whereas serial No. 6 was mentioned therein, which was meant for Deputy District Education Officer (BPS-17). Copy of a genuine application form of one of the selectees of Public Service Commission for the post in question bearing bank stamp, serial number, diary number, signature and stamp of Secretary PSC for ready reference and comparison is at (Annx-I).

- In the entire episode apart from the role of dealing section, allotment of diary No.11863 to her application form for the post of District Officer (BPS-18) by diary branch without bearing bank stamp and diary stamp of Public Service Commission which was not obtained from NBP, is also beyond understandings. As per written reply of diary branch (Annx-J).
- 6. During the course of inquiry proceedings on 15.07.2020, Miss Sobia was asked as to whether she was in possession of five (05)

years teaching experience etc mandatory for the post of ADO. She replied in affirmative statement that she will produce the certificate. Although she did not claim any experience in her application form in relevant column, however subsequently on 28.07.2020 she provided a tempered with certificate showing an experience of Islamabad Model School Mardan w.e.f 18.03.2004 or 2005 is at (Annx-K).

- 7. As regard her disability she stated that it was due to a road accident which causes lower part of her leg broken/ fractured. Disability certificate is at (Annx-L)
- Miss Sobia claims to be interviewed on 07.06.2010 by the 8. concerned panel of Public Service Commission. Her stance required solid proof / record of her descriptive sheet wherein she had been marked as qualified or failed. While as per statement of Mr. Hazrat Khan, the dealing assistant, he was not handed over ADO Female Disabled Quota file by the then Deputy Secretary concerned Mr. Masood Zaman (late), if her descriptive sheet bearing marks on it, had been found, even then it would be of no use. During search of the office record, two tempered with attendance sheets of Miss Sobia were found from the scattered record/files etc in the room of the late Mr. Masood Zaman (Annx-M). Although, her statement / reply indicates that she managed by some inside facilitator to appear before the interview panel however, her recommendation letter signed by the then Deputy Secretary along with her application form (which was liable to be rejected for the reasons stated in proceedings Paras) conveyed to the requisitioning department cannot be considered a genuine recommendation letter. Her recommendation would have been endorsed/owned if she had followed the laid down procedure. For example obtaining of application form from the designated branch of National bank of Pakistan, properly filling the application form, duly affixing the diary stamp of PSC etc. Whereas in her case all these mandatory steps are missing. Opting for an unlawful way of doing certain ostensibly lawful act or thing essentially makes that act or thing suspicious itself.



CONCLUSION:

- Ommission recommendee for the post of Female ADO Disabled Quota is not genuine. There is no reliable record of her case available. All the indicators point-out that she managed a foul play in connivance with certain employees of the Public Service Commission and managed placing on record the above mentioned application form and got communicated her fake recommendation letter to the Elementary & Secondary Education Department. Since there was no such genuine record existing at all with the Public Service Commission no such record can ever be found. We may press for her pending writ petition as based on a false claim and such record being not existing.
