

**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORDER DATED 01-09-2022 WHEREBY THE APPELLANT HAS BEEN REVERTED TO CONSTABLE (BPS-07) FROM THE POST OF ASSISTANT SUB INSPECTOR (BPS-11) AND AGAINST THE INACTION OF THE RESPONDENTS BY NOT DECIDING THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.**

**PRAYER:**

That on acceptance of this appeal the impugned orders dated 01.09.2022 may very kindly be set aside and the appellant may please be restored on the post of Assistant Sub Inspector (BPS-11) with all back benefits. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

**R/SHEWETH:**

**ON FACTS:**

- 1- That initially the appellant was serving in Levis/Khasadar force of Sub-Division Wazir and subsequently merged in Khyber Pakhtunkhwa Police Department Sub Division Wazir Bannu in the year 2019 and still working quite efficiently to the entire satisfaction of his high-ups. Copy of Service Book is attached as Annexure .....A.
- 2- That the appellant was absorbed in Khyber Pakhtunkhwa Police as ASI (BPS-11) vide Notification dated 08.01.2021 issued by Secretary Home and Tribal Affairs Department with the prior approval of the cabinet on

recommendation of the Provincial Police Officer. Copy of the Notification Dated 08.01.2021 is attached as Annexure .....**B.**

- 3- That after absorption the appellant started performing his duties as ASI and was regularly receiving monthly salaries till August, 2022 whereafter his salaries were stopped. Copy of Pay Slips are attached as Annexure.....**C.**
- 4- That on 11.08.2021, the appellant was selected for 03 months Basic Police Training by the District Police Officer (DPO) Bannu and the said list was forwarded to the Assistant Inspector General of Police (Training). Copy of letter dated 11.08.2021 is attached as Annexure .....**D.**
- 5- That on 17.08.2021, the District Police Officer Bannu sent letter to Assistant Inspector General of Police (Training) regarding provision of data of Head Constables/ASI/Constables and Inspectors of newly merged districts which in response was forwarded to the DPO Bannu vide letter dated 03.09.2021 and the name of the appellant was duly verified as Assistant Sub Inspector (BPS-11). Copies of the Letter Dated 17.08.2021 and 03.09.2021 are attached as Annexure.....**E & F.**
- 6- That the then Regional Police Officer (RPO) Bannu constituted an inquiry committee regarding absorption of members of Levies/Khasadar force in the Khyber Pakhtunkhwa Police. Copy of the Inquiry report is attached as Annexure.....**G.**
- 7- That consequently the then District Police Officer (DPO) Bannu suspended the service of the appellant vide order dated 25.11.2021 till the arrival of proper verification from Home Department, Peshawar. Copy of order dated 25.11.2021 is attached as Annexure ..... **H.**
- 8- That subsequently the then District Police Officer (DPO) Bannu constituted a committee vide order dated 01.12.2021 for the purpose of verification of the notifications issued by the Home & Tribal Affairs Department Khyber Pakhtunkhwa, Peshawar regarding absorption of Levies/Khasadars to Police Force. Copy of order dated 01.12.2021 is attached as Annexure .....**I.**
- 9- That vide office order dated 06.12.2021, the ibid committee was provided relevant record and the same was verified. Copy of the order dated 06.12.2021 is attached as Annexure .....**J**
- 10- That in response, a letter dated 23.02.2022 was received from RPO office Bannu Region Bannu with the following remarks by the RPO Bannu Region Bannu;  
*"As they have been lawfully absorbed in Police Department in BPS-11 by Home Department, therefore proceed as per law on the subject"*  
Copy of the order dated 23.02.2022 is attached as Annexure .....**K.**
- 11- That in compliance with the Worthy RPO order dated 23.02.2022 and in the light of the proper verification carried out, the appellant was thereby restored

w.e.f (Suspension date) i.e. 25.11.2021 by the then District Police Officer Bannu vide order dated 25.02.2022. Copy of Restoration order dated 25.02.2022 is attached as Annexure .....L.

- 12- That it is worth mentioning that the appellant received different appreciation certificates from his high-ups and it is evident that the appellant is a hardworking employee of the department. Copy of appreciation certificates are attached as Annexure .....M.
- 13- That all of a sudden once again, the District Police Officer Bannu constituted a committee in order to probe into suspicious/controversial notifications regarding absorption of Levies/Khasadars to Police Force. Copy of the Impugned 2<sup>nd</sup> Inquiry committee recommendations dated 24.08.2022 is attached as Annexure .....N.
- 14- That in the light of the recommendations by the inquiry Committee, the District Police Officer Bannu issued an impugned order dated 01.09.2022 and awarded the major penalty by reverting the service of the appellant from ASI (BPS-11) to Constable (BPS-07). Copy of impugned reversion order dated 01.09.2022 is attached as Annexure ..... O.
- 15- That the appellant filed departmental appeal against the impugned inquiry committee recommendations dated 24.08.2022 and impugned reversion order dated 01.09.2022 before the worthy Regional Police Officer Bannu Region Bannu through proper channel. Copy of Departmental Appeal is attached as Annexure .....P.
- 16- That the appellant filed Writ Petition No. 761-B/2022 before the Hon'ble Peshawar High Court Bannu Bench, for setting aside the impugned Notification dated 10/11/2022 but the same was disposed of with direction to the respondents for deciding the departmental appeal not later than thirty days. Copy of order/judgment dated 29.11.2022 is attached as Annexure Q
- 17- That after filing departmental appeal the appellant was quite hopeful to be re-instated into service with all back benefits but astonishingly during the pendency of the said departmental appeal, the respondent No.2 conducted an 3<sup>rd</sup> inquiry regarding the absorption order of the appellant. Copy of the 3<sup>rd</sup> inquiry committee dated 10.11.2022 is attached as Annexure .....R.
- 18- That the appellant being aggrieved by the inaction of the respondents by not deciding the departmental appeal of the appellant within statutory period of Ninety days and having no other remedy, appellant approached this Honorable Tribunal on the following grounds inter alia.

**GROUND:**

- A- That the impugned reversion orders dated 01.09.2022 is against the law, facts, norms of natural justice and materials on the record hence liable to be set aside.
- B- That appellant has not been treated by the respondents in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of Islamic Republic of Pakistan 1973.
- C- That no charge sheet and statement of allegation has been issued to the appellant.

- D- That no chance of personal hearing/defense has been provided to the appellant before issuing the impugned reversion orders dated 01.09.2022.
- E- That the respondent Department acted in arbitrary and mala fide manner by imposing major punishment of reduction in rank without providing the opportunity of fair trial.
- F- That the impugned reversion orders dated 01.09.2022 was passed in a hasty manner and without making recourse to the Rules and thus against the Law and Rules on the subject as well as against the principle of natural justice.
- G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

The induction of 11 officials in the rank of ASIs (BPS-11) consisting of —10 officials vide notification No.SO(Police)HD/SMY 2019 merged Area/S7-97, dated 08.01.2021 (from serial No. 1 to serial No. 10) and 01 official (Muhammad Tahir) vide notification No.SO(Police)HD/SMY 2019 merged Area/2410-20, dated 16.10.2020 mentioned at serial No. 5 is totally wrong, fake and forged (Though verified from the Home and Tribale Affairs Department as true) on the following grounds:

1. Neither the DPO office Bannu had sent/recommended the under-discussion 11 names of individuals of Khasadar Force of Wazir Sub-Division for their absorption in the Rank of ASI (BPS-11) nor their names had been recommended by the DC/AC/PA office, Bannu for their absorption in the rank of ASIs. The induction of 11 officials in the rank of ASIs (BPS-11) consisting of 10 officials vide notification No.SO(Police)HD/SMY 2019 Merged Area/87-97, dated 08.01.2021 (from serial No.1 to Serial No.10) and merged Area/2410-20, dated 16.10.2020 mentioned at serial no.5 is totally wrong, fake and forged (Through verified from the Home and Tribal Affairs Department as True) on the following grounds.

1. Neither the DPO Office Bannu had sent/recommended the under discussion 11 names of individuals of Khasadar Force of Wazir Sub Division for their absorption in the Rank of ASI (BPS-11) nor their names had been recommended by the DC/APA office, Bannu for their absorption in the rank of ASIs. Some hidden hands of the CPO clerical staff and Home Department with mutual conviance and mala-fide intention have included these (11) names for their (illegal, illogical and irrational) absorption in the rank of ASIs. Similarly, no scrutiny, committee (comprising of DPO/DC/AC./APA & DAO) had recommended these names for their absorption in the ranks of ASIs. Perhaps the hidden hands have also prepared their fake scrutiny committee reports bearing fake signatures of the committee members for giving it a legal cover.

2. Soon after the merger, the Assistant Commissioner, Sub-Division Wazir, Barina vide his office letter No.162-63/APA/LC/F-36, dated 17 October, 2019 sent the list of Levies and Khasadar of Sub-Division Wazir for their absorption in Police (copy attached). This list consists of 1021 individuals out of which 776 are Khasadars and 245 are Levies. This list denotes:
  - i. Abdullah S/O Abdul Janan on serial No. 186 for absorption in the rank of Head Constable;
  - ii. Hamayun Khan S/O Rawal Khan on serial No. 105 for absorption in the rank of Head Constable;
  - iii. Hassar Gul S/O Adam Gul on serial No. 106 for absorption in the rank of Naik;
  - iv. Shah Hussain S/O Akhtar Munir on serial No. 119 for absorption in the rank of Constable;
  - v. Mukhtar Ullah S/O Mashat Khan on serial No. 172 for absorption in the rank of Constable;
  - vi. Javid Iqbal S/O Dawood Khan on serial No. 179 for absorption in the rank of Constable;
  - vii. Hafeez ur Rehman S/O Nazar Gul on serial No. 421 for absorption in the rank of Constable;
  - viii. Mushahid ul Wadood S/O Fazal Wadood on serial No. 425 for absorption in the rank of Constable;
  - ix. Rahmat Ali S/O Zakim Khan on serial No. 439 for absorption in the rank of Constable;
  - x. Zar Ali S/O Mir Qazi Bat Khan on serial No. 131 for absorption in the rank of Constable (service changed with Muhammad Tahir S/O Khushdil Khan).

Note: Ironically, the name of Saddam Hussain S/O Akhtar Munir does not exist in this list, at all.

3. In light of the above mentioned letter No. 162-63/APA/LC/F-36, dated 17.10.2019, the government of Khyber Pakhtunkhwa Home & Tribal Affairs Department issued notification No.SO(Police)HD/SMY 2019 Merged Area/483-93, dated 18.02.2020 (copy attached) regarding the absorption of 614 individuals of Khasadar Force. This list bears the names of:
  - i. Hamayun Khan S/O Rawal Khan on serial No. 20 and his absorption in the rank of Head Constable (BPS-09);
  - ii. Abdullah S/O Abdul Janan on serial No. 27 and his absorption in the rank of Head Constable (BPS-09);

After that a notification No.SO(Police)HC/SMY 2019 Merged Area 2410-20, dated 16.10.2020 was received from Home and Tribal Affairs Department which wrongly bears the name of Muhammad Tahir S/O Khushdil Khan on serial No. 5 and his absorption in the rank of ASI (BPS-11) (copy attached) as the DPO office had not recommended his name for his absorption in the rank of ASI. Muhammad Tahir is neither a member of Khasadar Force/Levy Force nor Police Force. The above mentioned facts had already been communicated to CPO vide DPO office, Bannu, letter No. 13924 dated 28.10.2020 (copy attached) but in vain. He is an outsider and has managed his induction in Police Force as ASI through back doors. He is also involved in forgery and cheating. For giving legal cover to his illegal gotten Police service vide notification mentioned above dated 16.10.2020, he managed his service change with one Zar Ali S/O Mir Qazi Bat Khan after 04 days i.e on 20.10.2020. The service of Zar Ali has already been terminated vide DPO office, Bannu, letter No. 3639/SRC/OHC.SDW, dated 29.04.2021 (copy enclosed).

CONCLUSIVE SUMMARY REPORT REGARDING PARA 2:

1. Though verified as true from the Home and Tribal Affairs Department, KP, yet notification No.SO(Police)HD/SMY 2019, Merged Area/691-700, dated 07.05.2021, regarding the absorption of 31 Khasadar Force of Sub-Division Wazir into KP Police is totally wrong, fake and fabricated. These names had neither been recommended by the DPO office or any scrutiny committee nor sent by the APA/DC office, Bannu, for absorption in police. Some hidden hands of the CPO clerical staff and Home Department with mutual connivance and mala-fide intention have prepared a fake, illegal and illogical list of 31 individuals for their absorption in the rank of Constables. No scrutiny committee (comprising DPO, DC/AC/APA & DAO) had recommended these names for their absorption in police. Perhaps the hidden

hands had also prepared their fake scrutiny committee reports bearing fake signatures of the committee members.

RECOMMENDATIONS:

Keeping the above facts and figures in view, the committee members unanimously recommend the following recommendations:

- I. The Home and Tribal Affairs Department, Khyber Pakhtunkhwa may please be approached through proper channel to issue corrigendum in notification No.SO(Police)HD/SMY 2019, Merged Area/87-97, dated 08.01.2021 and exclude the names from serial No. 1 to 10, as their absorption has already been notified in their original/actual ranks. Second absorption is absurd and any absorption above the original ranks is in contrary to the dictum of equivalency of Khasadar Act. While the remaining names from serial No. 11 to 54 are correct.
- II. Similarly, a corrigendum is required by the Home and Tribal Department in notification No.SO(Police)HD/SMY 2019, Merged Area/2410-20, dated 16.10.2020, regarding the exclusion of the name of Muhammad Tahir S/O Khushdil Khan (mentioned at serial No. 5).
- III. Likewise, the Home and Tribal Department, KP may please be approached to issue cancellation of the notification No.SO(Police)HD/SMY 2019, Merged Area/691-700 dated 07.05.2021 regarding the absorption of 31 men, being totally wrong.
- IV. The Worthy DPO, Bannu is requested not to take any step regarding the absorption of 31 individuals in police department as the concerning notification No.SO(Police)HD/SMY 2019, Merged Area/691-700, dated 07.05.2021 is falsely prepared by some secret hands with mala fide intention.
- V. The worthy DPO, Bannu, is also requested to withdraw/rescind the consequential proceedings on the unauthorized second absorption of the officials mentioned at serial No.1 to 9 vide Home and Tribal Affairs Department notification No.SO(Police)HD/SMY 2019, Merged Area/87-97, dated 08-01-2021 and official mentioned at serial No.05 vide Home and Tribal Affairs Department notification No.SD(Police) HD/SMY 2019, Merged Area/2410-20, dated 16-10-2020 in the rank of ASIs. The ranks and salary of individuals mentioned at serial No. 1 to 9 may please be fixed in accordance with the original ranks of first absorption vide notification No.SO(Police) HD/SMY 2019, Merged Area/483-93, dated 18-02-2020 tabulated as under:


10. That all of a sudden once again when the matter was resolved by high-ups, the District Police Officer Bannu vide impugned order dated 11/08/2022 constituted the committee regarding probe into suspicious/controversial notifications and they recommended that the absorption of the appellant is contrary to the Khasadar Act. That in the light of the recommendations raised by the inquiry committee, the District Police Officer Bannu issued an impugned order No. 3897-3906 dated 01/09/2022 and awarded the major penalty by reverted the service of the appellant from ASI (BPS-11) to Head Constable (BPS-09). 12. That the impugned order No. 3897-3906 dated 01/09/2022 is illegal, unlawful, unnatural, void-ab-initio, null and void in the eye of law, hence liable to be declared so.

13. That the fundamental rights of the appellant has blatantly violated by issuing the impugned order No. 3897-3906 dated 01/09/2022 and the appellant has been discriminated and has been denied his due rights under the Constitution of Islamic Republic of Pakistan, 1973.

14. That without given any notice or given an opportunity of personal hearing and issuance of impugned order No. 3897-3906 dated 01/09/2022 is the clear cut violation of Right to fair trial i.e. Article 10-A of the Constitution of Islamic Republic of Pakistan, 1973 and also against the settled norms of service laws/rules prescribed for all the institutions.

7. The merger of the Appellant was found not proper, therefore the services of the Appellant was suspended on 25.11.2021 till arrival of proper verification from Home Department.
