SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE IMPUGNED NOTIFICATION NO. SO(S/M) E&SED/1-3/2013/Promotion BS-17 to BS-18 DATED 25/04/2014 WITH REGARD TO TEACHING CADRE OF ELEMENTARY & SECONDARY EDUCATION DEPARTMENT FROM BS-17 TO BS-18 ON REGULAR BASIS WITH IMMEDIATE EFFECT i.e. 25/04/2014 INSTEAD OF 01/07/2012 WHEN THE SAID POSTS WERE ACTUALLY UPGRADED AND THE APPELLANT MAY BE GIVEN PROMOTION/UPGRADATION FROM THE DATE OF ACTUAL UPGRADATION OF THE POSTS i.e. 01/07/2012.

PRAYER:

On acceptance of the instant appeal, the Impugned Notification dated 25/04/2014 may graciously be set aside to the extent of **“With Immediate Effect”** and the Appellant may be given promotion/upgradation with effect from 01/07/2012 i.e. the date of actual upgradation of the posts.

Respectfully Sheweth,

1. That the Appellant was appointed as CT (BS-14) in the year 1988 and then was posted to Govt. High School, Sufaid Dheri, Peshawar.
2. That lateron, the Appellant was promoted to the post of SET (BS-16) through Public Service Commission and was posted to Govt. High School, Sheikhan, Peshawar.
3. That it was the year 2000, when the Appellant was again promoted to the post of Subject Specialist (BS-17) through Departmental Promotion Committee and then was posted/adjusted to Govt. Higher Secondary School No. 4, Peshawar City and is still serving on the above said post and in the above said school.
4. That the Appellant has been serving the department for more than about 26 years with honesty and has never given any

chance of complaint to his high-ups and the student community.

5. That on 28/2/2012, a Notification No. BOV/FD/2-112/2011/04-Tier Formula was issued by the respondent No. 4 with regard to the upgradation of 04 Tier Formula whereby a total number of 374 (male) posts were upgraded from BS-17 to BS-18. Furthermore, it was observed in the said Notification that the upgradation of first phase will be effective from 1/7/2012. **Copy of Notification dated 28/02/2012 is enclosed as Annexure-A.**
6. That the above said Notification for the upgradation of 04 Tier Formula was given practical implementation through another impugned Notification dated 25/04/2014 and through this impugned Notification, the services of all the concerned 353 officers of teacher cadre of Elementary & Secondary Education Department were upgraded from BS-17 to BS-18 on regular basis with effect

from 25/4/2014. Copy of impugned Notification dated 25/4/2014 is enclosed as Annexure-B.

7. That it is pertinent to bring into the kind notice of this Honourable Court that it was the duty of the respondent's department to fill up the posts upgraded with effect from 1/7/2012 as soon as possible, however, the said posts were left vacant for no good reasons by the respondent's department whereas the Appellant and his other colleagues are working over the said posts which were duly upgraded.
8. That because of no cogent/valid reason, the case of upgradation has been kept pending for more than two years and finally the impugned Notification dated 25/4/2014 was issued.
9. That in this respect, the Appellant has filed a Departmental Appeal to the respondent No. 01/Chief Secretary, Govt. of KPK thereby

requesting for his anti-dated promotion with effect from 1/7/2012 instead of 25/4/2014, however, no head whatsoever was paid to the said departmental appeal of the Appellant. **Copy of Departmental Appeal of the Appellant is enclosed as Annexure-C.**

10. That the Appellant having got no other efficacious/adequate remedy, now approaches this Honourable Tribunal on the following grounds amongst the others:-

GROUND:

- A. That the said impugned Notification dated 25/04/2014 with regard to promotion/upgradation of the Appellant and his other colleagues of the Teaching Cadre of the Elementary & Secondary Education Department from BS-17 to BS-18 on regular basis with effect from 25/4/2014 is quite illegal, unlawful, without authority/jurisdiction, being on the basis of malafide

intention of the respondent's department, hence, is liable to be set aside.

B. That the above said posts were created/upgraded through a Notification dated 28/2/2012 whereby the effect of upgradation from BS-17 to BS-18 has been given from 1/7/2012 as according to the said Notification, the respondent's department was duty bound to act upon the said Notification as soon as possible, however, the matter has been delayed without any cogent/valid reason, hence, the Appellant has to suffer for the unreasonable delay of the respondent's department.

C. That it has been observed in so many cases by the Apex Courts that if a person is working on an upgraded post and the department is not making his promotion and delaying the matter without any cogent reason, in such like situation the Notification for the promotion/upgradation will be

issued when the post is fallen vacant and when the Civil Servant has taken the charge of the said post, however, all such instructions/directions of the Apex Courts has been bulldozed by the respondent's department and no plausible reason whatsoever has been mentioned in the Notification for unreasonable delay.

- D. That the Appellant and his other colleagues have been just punished for delaying their promotion process without any fault at their part and it has been observed by the Apex Courts that delaying of promotion of a Civil Servant will amount to punish him, hence, the Appellant and his colleagues have been punished without any fault on their parts.
- E. That it is the right of the Appellant to be given the promotion/upgradation from BS-17 to BS-18 from the date when the post has been created/upgraded and when he is serving on the said posts in BS-17 and the posts were upgraded to BS-18, hence, the

respondent's department is liable and duty bound to give effect to the upgradation of the Appellant from 1/7/2012 and not from 25/4/2014 which is the date of the issuance of impugned Notification.

- F. That the Appellant and his other colleagues have been treated in malafide manner and have been punished without any fault on their parts.
- G. That Respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973 and unlawfully issued the impugned Notification, which is unjust, unfair and hence not sustainable in the eye of law.
- H. That the impugned Notification is also against the principle of natural justice, hence, is liable to be set aside.

- I. That the Appellant has constitutional right to struggle for a better profession/livelihood, however, the above said constitutional right has been snatched from him by the respondents.
- J. That the said act of the respondents is not only illegal and unlawful but is also very much violative of the fundamental rights of the Appellant as mentioned in the Constitution of Islamic Republic of Pakistan.

It is, therefore, humbly prayed that On acceptance of the instant appeal, the Impugned Notification dated 25/04/2014 may graciously be setaside to the extent of **"With Immediate Effect"** and the respondents may please be directed to give upgradation/promotion to the Appellant from 01/07/2012 i.e. the actual date of the upgradation/promotion of the post and not from 25/04/2014.

Any other relief as deemed appropriate in the circumstances of case not specifically asked for may also be granted to appellant.

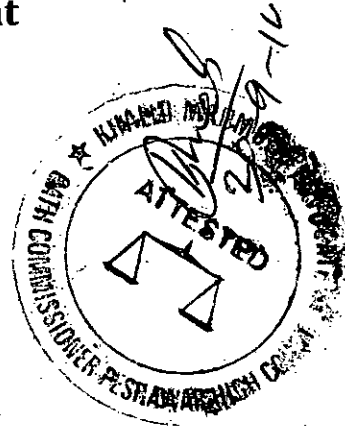



It is, therefore, humbly requested that our case may be considered sympathetically so that we may be served of Financial loss inflicted on us.

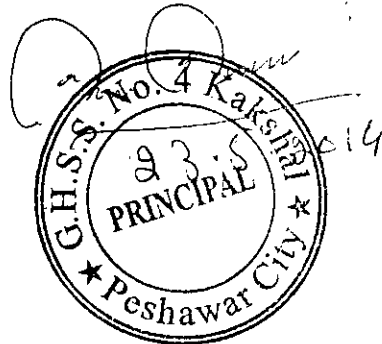

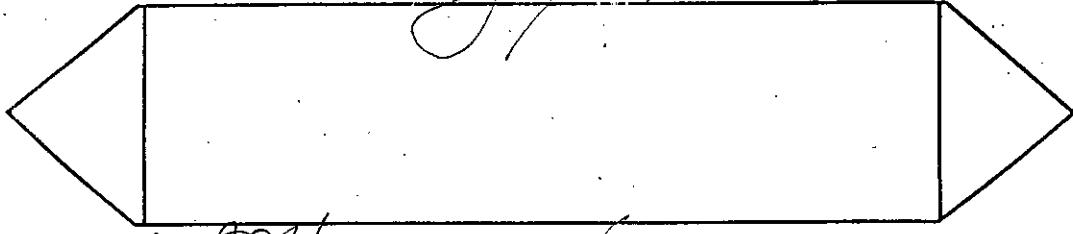

Respectfully Sheweth :-

The Respondents Submit as under :-

Preliminary Objections.

- 1 The appellant has got no cause of action/locus standi.
- 2 The appellant has concealed the material facts from this Honorable Tribunal, hence liable to be dismissed.
- 3 The instant appeal is badly time barred, hence is liable to be dismissed.
- 4 That the appellant is not an aggrieved person under article 212 of the constitution of Islamic Republic of Pakistan, 1973.
- 5 That the instant appeal is against ~~the~~ relevant provisions of law.
- 6 That the appellant has filed the instant case on malafide intentions just to put/extend ordinary pressure on the Respondents for the grant of illegal and even unauthorized service benefits.
- 7 That the appellant has not come to this Honorable Tribunal with clean hands.
- 8 That the instant appeal is liable to be dismissed for mis-joinder & non-joinder of the necessary parties to the present appeal.
- 9 That the appellant is estopped by his own conduct to file the instant appeal.
- 10 That the instant service appeal is not maintainable in ~~the~~ present circumstances of the case.
- 11 That the order dated 25.4.2014 is legally competent and is liable to be maintained in favour of the Respondents in the interest of justice.
- 12 That this Honorable Tribunal has got no jurisdiction to entertain the instant service appeal.
- 13 That the appellant has been treated as per law, rules & relevant policy in the instant case.
- 14 That the appellant is not entitled for the grant of the relief he has sought from this Honorable Tribunal.
- 15 That the promotion / up gradation is always ^{granted} with immediate effect, under the ~~approval~~ of the competent authority.

ON FACTS


1. That Para-1 needs no comments being pertains to the service record of the appellant.
2. That Pra-2 also needs no comments being pertains to the service record of the appellant.
3. That Para-3 also needs no comments.
4. That Para-4 is also out of the context in the given circumstances, hence no further comments.
5. That Para-5 is incorrect and misleading to the extent that the Govt: of Khyber Pakhtunkhwa, has approved 4-tier formula vide Notification No.SO(S)/7-34/91 dated 9.12.1992 & subsequently the same policy/criteria was updated vide another Notification No.BOV/ FD/ 2-112/2011 dated 28.02.2012. The Respondent Department has implemented the same policy/formula in its true letter & spirit vide Notification dated 25.4.2014 and has thus granted promotion to the eligible civil servant under the mandate of the said policy vide Notification dated 25.4.2014 issued by the Respondent No.2 on the recommendation of the Public Service Commission, Khyber Pakhtunkhwa.
6. That Para-6 is correct, hence no further comments.
7. That Para-7 is incorrect & misleading. The Notification dated 25.4.2014 of the Respondents No.2 is legally correct and is within the prescribed criteria/formula as mentioned above with immediate effect. Hence the stand & plea of the appellant regarding his promotion w.e.f 01.7.2012 is illegal & without solid foundation, hence baseless.
8. That Para-8 is also incorrect & denied. Promotion is always granted with immediate effect & not with retrospective effect(Annexure-A), hence the Notification dated 25.4.2014, is within legal sphere.
9. That Para-9 is also incorrect & denied, on the ground that the stand & plea of the appellant regarding the grant of his promotion in BPS-18 is baseless & without any solid foundation in the presence of the Notification dated 25.4.2014, which is not only legal but is also liable to be maintained in favour of the Respondents.
10. That Para-10 needs no comments, however the Respondents further rely on the following grounds inter alia:-


ON GROUNDS


- A) Incorrect & denied. The Notification dated 25.4.2014 of the Respondent No.2 to the extent of upgradation/promotion of the appellant & his colleagues is within legal sphere as well as in the light of the 4-tier formula, hence the plea of the appellant is mainly based on malafide intention just to put extra pressure on the Respondents for gaining illegal & un-authorized service benefit against the said post. As such the appellant has been treated as per law, rules & policy in the instant case vide Notification dated 25.4.2014 & the same is liable to be maintained in favour of the Respondents.
- B) That ground-B is also incorrect & misleading. Respondent No.2 has acted as per law, rules & policy & on the basis of the same, the appellant has been upgraded from BPS-17 to 18 having no aspect of any kind of delay in processing the cases of eligible candidates.
- C) That ground-C is also incorrect & denied. Every case has its own nature & Parameter, hence the appellant has been treated as per law, rules & relevant policy vide Notification dated 25.4.2014 of the Respondent No.2.
- D) That ground-D is incorrect & denied. The appellant has been treated as per law, rules & relevant policy in the instant case by the Respondent No.2 vide Notification dated 25.4.2014.


- E That ground-E is also incorrect & denied. Detail reply of this Para has already been given in the forgoing paras, hence no further comments.
- F That ground -F is incorrect & denied, hence no further comments.
- G That Para-G is also incorrect & denied on the grounds that the Respondents No: 2 has acted as per law, rules & policy in the instant case.
- H That Para-H is also incorrect & denied, the Notification dated 25.4.2014 is within legal sphere & relevant policy.
- I That ground-I is incorrect & denied, hence no further comments.
- J That ground-J is incorrect & denied, detail reply has been given in the forgoing paras, hence no further comments.

In view of the above made submissions, it is humbly requested that this Honorable Tribunal may very graciously be pleased to dismiss the instant appeal with cost in favor of the respondent Department.

Subject: - PROMOTION POLICY OF THE PROVINCIAL GOVERNMENT.

Sir,

I am directed to say that as a general principle, appointment by promotions takes effect from the date of approval by the competent authority or assumption of charge whichever is later. The Provincial Government have, however, been allowing promotion to higher Basic Scale with retrospective effect on specific recommendations of the Departmental Promotion Committee/ Selection Board in cases of grant of selection grade where promotions do not involve assumption of charge of the post with higher responsibilities and where change in duties is not involved. It has, however, been noticed with concern that some of the departments have notified promotions with retrospective effect in violation of the aforesaid Government policy.



It is hereby clarified that appointments by promotions against posts may invariably be made with immediate effect in the prescribed manner in accordance with the provisions of Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, and instructions issued from time to time by the Government.




